About Your Project

1. Please describe the project you are asking for grant funding to undertake.

We are on our Modeshift Stars journey and wish to reduce parking congestion around the school gates and encourage our pupils and parents to find greener ways to travel to and from school. The school council have pinpointed a number of initiatives that we are going to run and hope that the grant will be used for.

In order to encourage cycling and scooting, we need to offer safe storage facilities onsite for bikes and scooters as well as storage for cycling accessories such as bike helmets.

To reduce parking congestion, we wish to purchase several child size bollards so that cars can not park directly outside the school gates or on the yellow zig zags.

The school council have also run a poster competition and the children have designed posters that we wish to turn into signs/banners to be displayed around the perimeter of the school building to discourage parking and driving above 20mph.

We also run Bikeability and Scooterbility sessions to support using greener transport methods safely.
