## 1. Purpose of report:

To consider the objection notices to Temporary Event Notices (TENs), which seeks to permit the provision of licensable activities on the dates and times as detailed in each TEN attached to this report as an Appendix.

#### 2. Recommendation:

To consider the objection notices made by West Midlands Police and Environmental Health.

### 3. Brief Summary of Report:

Temporary Event Notices were submitted by Matthew Goode and received on 17<sup>th</sup> June 2021 in respect of The Deli in Boldmere, 60B – 60C Boldmere Road, Sutton Coldfield, B73 5TJ.

Objection notices have been received from West Midlands Police and Environmental Health.

## 4. Compliance Issues:

When carrying out its licensing functions, a licensing authority must have regard to the Guidance issued by the Secretary of State under section 182 of the Licensing Act 2003.

## 4.1 Consistency with relevant Council Policies, Plans or Strategies:

The report complies with the City Council's Statement of Licensing Policy and the Council's Corporate Plan to improve the standard of all licensed persons, premises and vehicles in the City.

## 5. Relevant background/chronology of key events:

Matthew Goode submitted on 17<sup>th</sup> June 2021, Temporary Event Notices in respect of The Deli in Boldmere, 60B – 60C Boldmere Road, Sutton Coldfield, B73 5TJ.

The Temporary Event Notices are attached as Appendices 1 to 2.

Objection notices have been received from West Midlands Police and Environmental Health, which are attached at Appendices 3 to 4.

The current premises licence is attached at Appendix 5.

Site location plans are attached, see Appendix 6.

Under the licensing system of TENs, no actual permission is required to carry out a licensable activity on a temporary basis. An applicant must merely give notice of his intentions to operate a licensable activity to the licensing authority.

However, the police or local authority exercising environmental health functions may intervene to prevent such events taking place or agree a modification of the proposed arrangements, and their intervention may in some cases result in the licensing authority imposing conditions on each TEN.

Where TENs are submitted, and objection notice(s) are maintained, the licensing authority must consider the objection(s) at a hearing before a counter notice, or a notice including a statement of conditions can be issued.

When giving TENs, consideration should be given to the following four licensing objectives:

- 1. The prevention of crime and disorder
- 2. public safety
- 3. The prevention of public nuisance; and
- 4. The protection of children from harm

If the TENs are in connection with licensable activities at licensed premises, the licensing authority may also impose one or more of the existing licence conditions on the TENs if it considers that this is appropriate for the promotion of the licensing objectives.

No supply of alcohol may be made under the premises licence (a) at a time when there is no designated premises supervisor in respect of the premises licence, or (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.

Every retail sale or supply of alcohol made under this licence must be made or authorised by a person who holds a personal licence.

The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises. In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises— (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to— (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or (ii) drink as much alcohol as possible (whether within a time limit or otherwise); (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective; (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective; (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner; (e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).

The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.

The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol. The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy. The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either— (a) a holographic mark, or (b) an ultraviolet feature.

The responsible person must ensure that— (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures— (i) beer or cider: ½ pint; (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and (iii) still wine in a glass: 125 ml; (b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and (c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available."

(1) A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price. (2) In this condition: - (a) "permitted price" is the price found by applying the formula P = D + (D x V), where- (i) P is the permitted price, (ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol; (b) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979; (c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence— (i) the holder of the premises licence, (ii) the designated premises supervisor (if any) in respect of such a licence, or (iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence; (d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and (e) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994. (3) Where the permitted price would not be a whole number of pennies, the permitted price shall be taken to be the price rounded up to the nearest penny. (4) Where the permitted price on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax, the permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

#### Annex 2 - Conditions consistent with operating schedule

## 2a) General conditions consistent with the operating schedule

The DPS will take full responsibility of ensuring all staff are trained and have full knowledge of all licensing issues concerning them under the 2003 Licensing Act including the Challenge 25 rule.

#### 2b) Conditions consistent with, and to promote the prevention of crime and disorder

No enforceable conditions identified from operating schedule.

## 2c) Conditions consistent with, and to promote, public safety

No enforceable conditions identified from operating schedule.

#### 2d) Conditions consistent with, and to promote the prevention of public nuisance

The DPS will also monitor the exterior of the premises to ensure litter is kept to a minimum.

The garden terrace seating area and external bar shall only be used between the hours of 09.00am and 21.00pm.

There shall be no amplified music in the outdoor areas.

An acoustic fence shall be erected to the rear of the garden area.

No tables/chairs or customer access shall be allowed within 20 metres of the rear boundary of the premises.

### 2e) Conditions consistent with, and to promote the protection of children from harm

The DPS will be responsible for ensuring all staff working within the premises will be fully trained and aware of the Challenge 25 Rule. The premises will only accept valid forms of identification such as photo driving licence, passport and home office approved ID cards displaying the national proof of age standard scheme (PASS hologram). All customers who look under the age of 25 shall be challenged to prove their identity when purchasing alcohol.

Any children on the premises must be accompanied by a responsible adult.

The premises will also have a refusals register, which will be kept at the premises at all times and all refusals by any member of staff shall be recorded. The register will be made available to Responsible Authorities on request.

#### Annex 3 - Conditions attached after hearing by licensing authority

#### 3a) General committee conditions

Licensing Sub Committee C resolved to GRANT the application on Wednesday 25th July 2018, subject to the following conditions:

The premises shall arrange for door staff to be employed at the premises; the premises shall conduct an inhouse written Risk Assessment to decide the hours during which door staff shall be deployed.

### 3b) Committee conditions to promote the prevention of crime and disorder

CCTV shall be installed to cover the whole of the licensable area, to the satisfaction of West Midlands Police.

#### 3d) Committee conditions to promote the prevention of public nuisance

There shall be no regulated entertainment involving live or recorded music, sound or speech in the outdoor area to the front of the building on the Boldmere Road façade.

There shall be no regulated entertainment involving recorded music, sound or speech in the outdoor area to the rear of the building.

There shall be no live amplified music, sound or speech in the outdoor area to the rear of the building.

Live music in the outdoor area to the rear of the building shall not be provided between the hours of 21.00 and 10.00.

There shall be no speakers used for amplified music, speech or sound outside the building.

The outside area to the rear of the building shall only be used between the hours of 09.00 and 21.00 hours and the DPS or other nominated person/staff, shall monitor the external areas and ensure that all patrons vacate the area by 21.00.

The bar in the outside area to the rear of the building shall only be used for the sale of alcohol between the 09.00 and 20.30.

All external doors and windows shall be kept closed after 22.00 during regulated entertainment except as necessary for safe and effective access and egress.

No drinks shall be removed from the premises (as defined by the plan delineating the licensed area) in open containers.

No waste or recyclable material, including bottles, shall be moved, removed or placed in areas outside the premises building between the hours of 22.00 and 08.00.

There shall be no tables, chairs or customer access within 20 metres of the boundary with 1 Redacre Road.
