3. Brief Summary of Report:

An application for a Premises Licence was received on 12^{th} February 2021 in respect of Brits Food and Wine, 15-17 Stapleford Croft, Kings Heath, Birmingham, B14 5QB.

5. Relevant background/chronology of key events:

Janarththanan Vadivel applied on 12th February 2021 for the grant of a Premises Licence for Brits Food and Wine, 15 – 17 Stapleford Croft, Kings Heath, Birmingham, B14 5QB.

It has come to my attention that the shop on Stapleford Croft B14 5QB has put in an application to extend their alcohol licensing hours from 8am-9pm to 7am-11pm 7 days a week. As the resident who lives the shop I am deeply opposed to this application been awarded.

It has been suggested by our local Councillor Julien Pritchard that representations should be made before March 12th to stop the application from going through. On those grounds I would like to highlight how the shop and surrounding area does not satisfy the following objectives;

1. Prevention of crime and disorder

The police have been called several times over the past year with matters relating to the shop and shoplifters, I can only presume that with extended hours this problem will become more of an issue. Local groups of adolescents congregate on wall outside of the shop, at times they have damaged property belonging to the shop, residents cars and litter the area constantly, they have not been abusive to me personally, but have been verbally aggressive towards other residents and I feel that extended hours will only increase our worries more. I am confident that if West Midlands police are contacted they can confirm that they have visited the area regularly and with the summer months approaching this is likely to increase, this is a low poverty area with a raised crime rate, the introduction of being able to access alcohol more readily is only going to fuel the situation, this is something neither the shop or residents can control, so for the safety of the local area the current hours should not be extended.

2. Public safety

As highlighted in my previous point, the extended hours could potentially increase the amount of crime related incidents within our local community, therefore public safety would be compromised, as the person who lives the shop and who already feels intimidated at times by the groups outside, I feel that this situation will only get worse. I do not feel that residents safety should be put at risk for an extended alcohol license.

3. Prevention of public nuisance

Again the shop is a central point for local gangs to meet, as I have already highlighted, living the shop these gangs frequently sit on wall, litter, make noise, fight, scream and play loud music. Adults tend to use the shop as a meeting place to meet socially to avoid 'breaking the lockdown rules', this should not be allowed and by increasing opening times and again with alcohol being made more readily available this will only increase. As a resident I should not have to put up with this until 9pm let alone 11pm, it is an infringement of my rights and an absolute public nuisance for myself and all other residents living close by.

4. The protection of children from harm

Although my children have had no direct threats, the noise outside can become to much for my children, one of which is awaiting autistic assessment. I feel that the extension of these hours will be putting my children at harm as there harmony will be affected, more noise outside until later times in the evening will affect their sleep pattern, which will affect their ability to concentrate and focus at school the next day, this is an infringement of their rights to basic needs and to other local children within direct ear shot of the shop. Why should our children suffer for the sake of an extended license?

I would also like to add that I do support my local businesses, but as a single parent with 2 children at home I feel this extension will only expose myself and local residents to more issues that we will be unable to resolve. The local gangs are very intimidating even though as previously stated I have received no threats so far, walking past 6 or more adolescents to access your own property is not a safe feeling at any time of night, let alone at the proposed times being given. The shop has no control over who sits, stands or meets outside of it and have very little CCTV in place, with crime already in place within the area, this application is going to encourage people to congregate more.

I feel that if this application is accepted will an infringement of my Human Rights, more specifically Article 8 - Respect for your private and family life. Therefore, I would like the licensing committee to consider my representation in opposing this application to protect my family, my neighbours and local community and help us to reduce noise, pollution and crime within our area.

I would like to ask, that I remain anonymous in any reports given and that if your team would like to contact me further that you do so via email or mobile. Thank you.

I live doors away from the shop and we already have lots of Anti social behaviour from the youth hanging around the shop front. Having extra hours will cause even more anti social behaviour. Also as we emerge from lockdown and being the only shop on the estate open until 11 pm we will have the potential of lots of addicts etc flooding the shop and causing more noise and nuisance till very late hours when in effect everyone should be tucked up in bed and not going to a shop at 11PM at night. It is absolutely ridiculous to think that it is a suitable time to open till considering there are houses positions all around the shop. I will fear for our safety as many users of the shop at that time of the night could potentially commence fights and arguments, therefore putting the public at risk.

As stated above our house is doors away from the shop and this is a very high risk factor of safety for the foster children that live in our house. They have suffered enough trauma without being woken out of their sleep to possible arguments, knife crime and fights happening, which I am sure you will appreciate could damage them even more.

Druids Heath is one of the most deprived areas in the country and has lots of drug and alcohol users as it is. This will encourage so much devastation to the estate and poverty, as parents and others will have even more time to buy alcohol and cause more harm and suffering in either their children's lives or to their loved ones around them. I am shocked that the people who now run this shop do not stick to the proper opening hours already as they are supposed to close at 8 pm and yet they are open until 9 pm evry evening. They already cause enough trouble as it si.

Please consider the above and do not grant an extension of license please. A very troubled resident

If any tobacco products purchased for or on behalf of the business does not have UK Duty Paid fiscal mark or are otherwise suspicious, the licensee and/or designated premises supervisor shall notify the supplier to Birmingham City Council Trading Standards and HMRC as soon as possible.

Protecting Children from Harm

All persons involved in the sale of alcohol, who are not presonal licence holders, will receive initial and subsequent 6 monthly refresher training by the Designated Premises Supervisor or an appropriately accredited training provider with regards to the law in relation to the sale of alcohol. This will be recorded in a staff training register and will include, signature of the member of staff, the DPS or an appropriately accredited training provider together with the date. TRAINING RECORDS WILL BE MAINTAINED AT THE PREMISES AND MADE AVAILABLE TO ALL RESPONSIBLE AUTHORITIES ON REQUEST

b) The prevention of crime and disorder

- The CCTV system must be installed and operate internally to cover all areas that licensable activities take place and

- An incident register of all occurrences and ejections from the premises will be maintained at the premises and all

- At any time when there is no Personal License holder on the premises there must be at least one member of staff on duty inside the premise who has been authorised by the DPS.

e) The protection of children from harm

A Challenge 25 policy will be adopted in order to reduce the potential for underage sales of age restricted products including alcohol. If a customer appears to be under 25 years of age and cannot prove that they are eligible to purchase the age restricted item with a valid UK or Ireland Photocard Driving Licence, a valid Passport or PASS accredited proof of age scheme card, they will be refused service.

☑ Challenge 25 posters will be displayed at the premises to reinforce this policy. Posters will be placed at; each till, each area alcohol is stocked and at the point of entry into the store. The posters will be displayed prominently and in sight of customers and staff.

A Refusals Register is to be used to record all incidents when a sale
is refused. The register is to be kept in the store at all times unless it

NOTES ON DEMONSTRATING ENTITLEMENT TO WORK IN THE UK

Entitlement to work/immigration status for individual applicants and applications from partnerships which are not limited liability partnerships:

A licence may not be held by an individual or an individual in a partnership who is resident in the UK who:

- does not have the right to live and work in the UK; or
- is subject to a condition preventing him or her from doing work relating to the carrying on of a licensable activity.

Any premises licence issued in respect of an application made on or after 6 April 2017 will become invalid if the holder ceases to be entitled to work in the UK.

Applicants must demonstrate that they have an entitlement to work in the UK and are not subject to a condition preventing them from doing work relating to the carrying on of a licensable activity. They do this by providing with this application copies or scanned copies of the following documents (which do not need to be certified).

Documents which demonstrate entitlement to work in the UK

- An expired or current passport showing the holder, or a person named in the passport as the child of the
 holder, is A British citizen or a citizen of the UK and Colonies having the right of abode in the UK [please see
 note below about which sections of the passport to copy].
- An expired or current passport or national identity card showing the holder, or a person named in the passport
 as the child of the holder, is a national of a European Economic Area country or Switzerland.

- A Permanent Residence Card issued by the Home Office to the family member of a national of a European Economic Area country or Switzerland.
- A current Biometric Immigration Document (Biometric Residence Permit) issued by the Home Office to the holder indicating that the person named is allowed to stay indefinitely in the UK, or has no time limit on their stay in the UK.
- A current passport endorsed to show that the holder is exempt from immigration control, is allowed to stay
 indefinitely in the UK, has the right of abode in the UK, or has no time limit on their stay in the UK.
- A current Immigration Status Document issued by the Home Office to the holder with an endorsement
 indicating that the named person is allowed to stay indefinitely in the UK or has no time limit on their stay in
 the UK, when produced in combination with an official document giving the person's permanent National
 Insurance number and their name issued by a Government agency or a previous employer.
- A full birth or adoption certificate issued in the UK which includes the name(s) of at least one of the holder's
 parents or adoptive parents, when produced in combination with an official document giving the person's
 permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A birth or adoption certificate issued in the Channel Islands, the Isle of Man or Ireland when produced in combination with an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A certificate of registration or naturalisation as a British citizen, when produced in combination with an
 official document giving the person's permanent National Insurance number and their name issued by a
 Government agency or a previous employer.
- A current passport endorsed to show that the holder is allowed to stay in the UK and is currently allowed to
 work and is not subject to a condition preventing the holder from doing work relating to the carrying on of a
 licensable activity.

- A current Biometric Immigration Document (Biometric Residence Permit) issued by the Home Office to the holder which indicates that the named person can currently stay in the UK and is allowed to work relation to the carrying on of a licensable activity.
- A current Residence Card issued by the Home Office to a person who is not a national of a European Economic
 Area state or Switzerland but who is a family member of such a national or who has derivative rights or
 residence.
- A current Immigration Status Document containing a photograph issued by the Home Office to the holder
 with an endorsement indicating that the named person may stay in the UK, and is allowed to work and is not
 subject to a condition preventing the holder from doing work relating to the carrying on of a licensable activity
 when produced in combination with an official document giving the person's permanent National Insurance
 number and their name issued by a Government agency or a previous employer.
- A Certificate of Application, less than 6 months old, issued by the Home Office under regulation 17(3) or 18A
 (2) of the Immigration (European Economic Area) Regulations 2006, to a person who is not a national of a European Economic Area state or Switzerland but who is a family member of such a national or who has derivative rights of residence.
- Reasonable evidence that the person has an outstanding application to vary their permission to be in the UK
 with the Home Office such as the Home Office acknowledgement letter or proof of postage evidence, or
 reasonable evidence that the person has an appeal or administrative review pending on an immigration
 decision, such as an appeal or administrative review reference number.
- Reasonable evidence that a person who is not a national of a European Economic Area state or Switzerland but
 who is a family member of such a national or who has derivative rights of residence in exercising treaty rights in
 the UK including:-
 - evidence of the applicant's own identity such as a passport,
 - evidence of their relationship with the European Economic Area family member e.g. a marriage certificate, civil partnership certificate or birth certificate, and
 - evidence that the European Economic Area national has a right of permanent residence in the UK or is one
 of the following if they have been in the UK for more than 3 months:
 - working e.g. employment contract, wage slips, letter from the employer,
 - (ii) self-employed e.g. contracts, invoices, or audited accounts with a bank,
 - (iii) studying e.g. letter from the school, college or university and evidence of sufficient funds; or
 - (iv) self-sufficient e.g. bank statements.

Family members of European Economic Area nationals who are studying or financially independent must also provide evidence that the European Economic Area national and any family members hold comprehensive sickness insurance in the UK. This can include a private medical insurance policy, an EHIC card or an S1, S2 or S3 form.

Original documents must not be sent to licensing authorities. If the document copied is a passport, a copy of the following pages should be provided:-

- (i) any page containing the holder's personal details including nationality;
- (ii) any page containing the holder's photograph;
- (iii) any page containing the holder's signature;
- (iv) any page containing the date of expiry; and
- (v) any page containing information indicating the holder has permission to enter or remain in the UK and is permitted to work

If the document is not a passport, a copy of the whole document should be provided.

Your right to work will be checked as part of your licensing application and this could involve us checking your immigration status with the Home Office. We may otherwise share information with the Home Office. Your licence application will not be determined until you have complied with this guidance.

NOTES ON REGULATED ENTERTAINMENT

In terms of specific regulated entertainments please note that:

- Plays: no licence is required for performances between 08:00 and 23.00 on any day, provided that the audience does not exceed 500.
- Films: no licence is required for 'not-for-profit' film exhibition held in community premises between 08.00 and 23.00 on any day provided that the audience does not exceed 500 and the organiser (a) gets consent to the screening from a person who is responsible for the premises; and (b) ensures that each such screening abides by age classification ratings.
- Indoor sporting events: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000.
- Boxing or Wrestling Entertainment: no licence is required for a contest, exhibition or display of Greco-Roman
 wrestling, or freestyle wrestling between 08.00 and 23.00 on any day, provided that the audience does not
 exceed 1000. Combined fighting sports defined as a contest, exhibition or display which combines boxing or
 wrestling with one or more martial arts are licensable as a boxing or wrestling entertainment rather than an
 indoor sporting event.
- Live music: no licence permission is required for:
 - o a performance of unamplified live music between 08.00 and 23.00 on any day, on any premises.
 - a performance of amplified live music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - a performance of amplified live music between 08.00 and 23.00 on any day, in a workplace that is not licensed to sell alcohol on those premises, provided that the audience does not exceed 500.
 - o a performance of amplified live music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
 - o a performance of amplified live music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school or (iii) the health care provider for the hospital.
- Recorded Music: no licence permission is required for:
 - any playing of recorded music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - o any playing of recorded music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
 - o any playing of recorded music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school proprietor or (iii) the health care provider for the hospital.

- Dance: no licence is required for performances between 08.00 and 23.00 on any day, provided that the
 audience does not exceed 500. However, a performance which amounts to adult entertainment remains
 licensable
- Cross activity exemptions: no licence is required between 08.00 and 23.00 on any day, with no limit on audience size for:
 - any entertainment taking place on the premises of the local authority where the entertainment is provided by or on behalf of the local authority;
 - any entertainment taking place on the hospital premises of the health care provider where the entertainment is provided by or on behalf of the health care provider;
 - any entertainment taking place on the premises of the school where the entertainment is provided by or on behalf of the school proprietor; and
 - any entertainment (excluding films and a boxing or wrestling entertainment) taking place at a travelling circus, provided that (a) it takes place within a moveable structure that accommodates the audience, and (b) that the travelling circus has not been located on the same site for more than 28 consecutive days.


