To consider representations that have been made in respect of an application for a Premises Licence which initially sought to permit the Sale of Alcohol (for consumption on the premises) to operate from 11:00am until 02:00am (Monday to Sunday).

After discussions with West Midlands Police the applicant has agreed to amend the scope of the application. The Sale of Alcohol (for consumption on the premises) will operate from 11:00am until 12:00midnight (Monday to Friday) and 11:00am until 02:00am (Saturday & Sunday). Their agreed conditions and times are attached to the report at Appendix 52.

The applicant initially sought the provision of Regulated Entertainment consisting of live music and recorded music, to operate indoors only, from 11:00am until 02:00am (Monday to Sunday). After discussions with Environmental Health, the applicant has agreed to cease live and recorded music at 11:00pm (Monday to Sunday). The agreement is attached to this report at Appendix 53.

To permit the provision of Late Night Refreshment, to operate indoors only, from 11:00pm until 12:00midnight (Monday to Friday), and 11:00pm until 02:00am (Saturday and Sunday).

Premises to remain open to the public from 11:00am until 12:00midnight (Monday to Friday) and 11:00am until 02:00am (Saturday & Sunday).

Lime and Chilli have requested that their hours of business is to be Monday to Sunday, 11.00am to 2.00am, each day. This includes selling alcoholic beverages.


Lime and Chilli can be found on Soho Road between Ivy Road and Whitehall Road.

As a long standing resident of Whitehall Road i have the following reasons for objection:-

1. Anti social behaviour - previously there have incidents of violence at the establishment (see link below) with subsequent damage to residents property including vehicles

A number of people were injured with some requiring treatment in hospital, police say.

The restaurant had to deploy security on the door however recently this has stopped.

When people leave the restaurant, those intoxicated often already leave in a 'boisterous' manner late at night disturbing residents. Changing closing to 2.00am would worsen this problem.

2. Increased noise and pollution - when functions are held at the restaurant, there is increased cars in and around the vicinity which makes it difficult for residents to park. This includes for disabled residents on Whitehall Road. There is 3 disabled spaces on section of Whitehall Road by Soho Road and when functions are held, it has been noted that residents disabled bays are taken by customers of Lime and Chilli. There is already a high level car pollution in and around the area due to schools, places of worship, Jobcentre and people using Soho Road to get to the motorway towards the West Bromwich junction, and an increased customer base will make this worse.

When Lime and Chilli hold functions there is also noise pollution with the letting off of fireworks - this usually continues late into the night and no doubt increase with later opening hours.

3. Prostitution - there is a major prostitution issue on junctions of Ivy / Soho Road and Whitehall / Soho Road. Vulnerable women 'hang around' in and around Lime and Chilli and it is highly likely this will increase. It is already visible that this happening earlier and earlier in the day and will continue longer into the night. In a residential area, close to schools and places of worship, this is totally unacceptable.

I do not feel Lime and Chilli extending their opening their hours will be beneficial for the residents, Soho Road and community, it will actually worsen the living experience of all.

This area of Handsworth is already under pressure due to antisocial behaviour and the extended opening hours of this establishment will increase these problems.

Once again, I object to the extended licencing of Lime and Chilli.

The Lime and Chilli Restaurant is located at premises that have been used as a Licenced Restaurant (under different ownerships) and formerly as a Public House since approximately 1980. Alcohol is sold to meet customer's expectations. In most cases, it consists of table wine or larger/beer with meals. Since the Lime and Chilli Restaurant opened it has not experienced any crime and disorder, public safety, or public nuisance issues that the owners were held responsible for preventing. In the future we expect that the sale of alcohol will continue to accompany the serving of meals. Customers for the events room at the premises will be allowed to bring their own alcohol onto the premises to be consumed by their guests.

b) The prevention of crime and disorder

If a customer appears to be intoxicated either when he or she arrives at the Lime and Chilli Restaurant or because of consuming alcohol with a meal, we will not serve them anymore. In addition, we would ask how they had travelled to the restaurant. If this was by car and they intended to drive back, we would strongly recommend them not to do so. If a customer who orders alcohol with their meal appears to be under 21 years old, they will be asked for proof of their age before they are served. All our members of staff who come into direct contact with customers are aware of this policy which is enforced at the discretion of the Designated Premise Supervisor and Personal License Holder(s) present at the time.

c) Public safety

No bottles of any kind are allowed to be taken outside by customers. All paths and walkways are kept clean, dry, and free of any obstructions. External steps are highlighted by white paint.

d) The prevention of public nuisance

The nearest residential properties are approximately 200 yards away from the restaurant entrance and it has a small private car park. Therefore, it is very unlikely that our neighbours or any other members of the public using Bell Lane will be disturbed by any type of public nuisance caused by the sale of alcohol the Lime and Chilli Restaurant. There is a sign near to the main entrance/exit that requests that customers leave the premises quietly so that they don't disturb residents especially late at night. However due to the size and location of the premises this is unlikely to be a problem as far as we are aware.

e) The protection of children from harm

The Lime and Chilli Restaurant has a Child Protection Policy which is registered with "Thirtone:Eight" who are a well-known expert organization in this field. In accordance with this policy our members of staff receive training in child protection issues including how to obtain expert advice in the event of an emergency. We consider that children are protected from any harm associated with the sale of alcohol because of our "Challenge 25" Proof of Identity policy and the limitations that we place on the sale of alcohol to persons who appear to be intoxicated, especially if they are car drivers with vehicles on

our car park. There is a "Challenge 25" notice which advises customers that people who appear to be under 25 will be asked for proof of identity if they ask to be served alcohol.

Applicants must demonstrate that they have an entitlement to work in the UK and are not subject to a condition preventing them from doing work relating to the carrying on of a licensable activity. They do this in one of two ways: 1) by providing with this application copies or scanned copies of the documents listed below (which do not need to be certified), or 2) by providing their 'share code' to enable the licensing authority to carry out a check using the Home Office online right to work checking service (see below).

- An expired or current passport showing the holder, or a person named in the passport as the child of the holder, is a British citizen or a citizen of the UK and Colonies having the right of abode in the UK [please see note below about which sections of the passport to copy].

- A **current** passport endorsed to show that the holder is exempt from immigration control, is allowed to stay indefinitely in the UK, has the right of abode in the UK, or has no time limit on their stay in the UK.
- A **current** Immigration Status Document issued by the Home Office to the holder with an endorsement indicating that the named person is allowed to stay indefinitely in the UK or has no time limit on their stay in the UK, **when produced in combination with** an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A birth or adoption certificate issued in the UK, **when produced in combination with** an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A birth or adoption certificate issued in the Channel Islands, the Isle of Man or Ireland **when produced in combination with** an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A certificate of registration or naturalisation as a British citizen, **when produced in combination with** an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.

- A **current** passport endorsed to show that the holder is allowed to stay in the UK and is currently allowed to work and is not subject to a condition preventing the holder from doing work relating to the carrying on of a licensable activity.
- A **current** Biometric Immigration Document (Biometric Residence Permit) issued by the Home Office to the holder which indicates that the named person can currently stay in the UK and is allowed to work relation to the carrying on of a licensable activity.
- A **current** Residence Card issued by the Home Office to a person who is not a national of a European Economic Area state or Switzerland but who is a family member of such a national or who has derivative rights or residence.
- A **current** Immigration Status Document containing a photograph issued by the Home Office to the holder with an endorsement indicating that the named person may stay in the UK, and is allowed to work and is not subject to a condition preventing the holder from doing work relating to the carrying on of a licensable activity **when produced in combination with** an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A Certificate of Application, **less than 6 months old**, issued by the Home Office under regulation 18(3) or 20(2) of the Immigration (European Economic Area) Regulations 2016, to a person who is not a national of a European Economic Area state or Switzerland but who is a family member of such a national or who has derivative rights of residence.
- Reasonable evidence that the person has an outstanding application to vary their permission to be in the UK with the Home Office such as the Home Office acknowledgement letter or proof of postage evidence, or reasonable evidence that the person has an appeal or administrative review pending on an immigration decision, such as an appeal or administrative review reference number.
- Reasonable evidence that a person who is not a national of a European Economic Area state or Switzerland but who is a family member of such a national or who has derivative rights of residence in exercising treaty rights in the UK including:-
  - evidence of the applicant's own identity – such as a passport,
  - evidence of their relationship with the European Economic Area family member – e.g. a marriage certificate, civil partnership certificate or birth certificate, and
  - evidence that the European Economic Area national has a right of permanent residence in the UK or is one of the following if they have been in the UK for more than 3 months:
    - (i) working e.g. employment contract, wage slips, letter from the employer,
    - (ii) self-employed e.g. contracts, invoices, or audited accounts with a bank,
    - (iii) studying e.g. letter from the school, college or university and evidence of sufficient funds; or
    - (iv) self-sufficient e.g. bank statements.

Family members of European Economic Area nationals who are studying or financially independent must also provide evidence that the European Economic Area national and any family members hold comprehensive sickness insurance in the UK. This can include a private medical insurance policy, an EHIC card or an S1, S2 or S3 form.

**Original documents must not be sent to licensing authorities.** If the document copied is a passport, a copy of the following pages should be provided:-

- (i) any page containing the holder's personal details including nationality;
- (ii) any page containing the holder's photograph;
- (iii) any page containing the holder's signature;
- (iv) any page containing the date of expiry; and
- (v) any page containing information indicating the holder has permission to enter or remain in the UK and is permitted to work.

Your right to work will be checked as part of your licensing application and this could involve us checking your immigration status with the Home Office. We may otherwise share information with the Home Office. Your licence application will not be determined until you have complied with this guidance.

#### **Home Office online right to work checking service**

As an alternative to providing a copy of the documents listed above, applicants may demonstrate their right to work by allowing the licensing authority to carry out a check with the Home Office online right to work checking service.

To demonstrate their right to work via the Home Office online right to work checking service, applicants should include in this application their 9-digit share code (provided to them upon accessing the service at <https://www.gov.uk/prove-right-to-work>) which, along with the applicant's date of birth (provided within this application), will allow the licensing authority to carry out the check.

- Indoor sporting events: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000.
- Boxing or Wrestling Entertainment: no licence is required for a contest, exhibition or display of Greco-Roman wrestling, or freestyle wrestling between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000. Combined fighting sports – defined as a contest, exhibition or display which combines boxing or wrestling with one or more martial arts – are licensable as a boxing or wrestling entertainment rather than an indoor sporting event.
- Live music: no licence permission is required for:
  - o a performance of unamplified live music between 08.00 and 23.00 on any day, on any premises.
  - o a performance of amplified live music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
  - o a performance of amplified live music between 08.00 and 23.00 on any day, in a workplace that is not licensed to sell alcohol on those premises, provided that the audience does not exceed 500.
  - o a performance of amplified live music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
  - o a performance of amplified live music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school or (iii) the health care provider for the hospital.
- Recorded Music: no licence permission is required for:
  - o any playing of recorded music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
  - o any playing of recorded music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
  - o any playing of recorded music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school proprietor or (iii) the health care provider for the hospital.

- Dance: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 500. However, a performance which amounts to adult entertainment remains licensable.
- Cross activity exemptions: no licence is required between 08.00 and 23.00 on any day, with no limit on audience size for:
  - o any entertainment taking place on the premises of the local authority where the entertainment is provided by or on behalf of the local authority;
  - o any entertainment taking place on the hospital premises of the health care provider where the entertainment is provided by or on behalf of the health care provider;
  - o any entertainment taking place on the premises of the school where the entertainment is provided by or on behalf of the school proprietor; and
  - o any entertainment (excluding films and a boxing or wrestling entertainment) taking place at a travelling circus, provided that (a) it takes place within a moveable structure that accommodates the audience, and (b) that the travelling circus has not been located on the same site for more than 28 consecutive days.

Reference the above application below are additional operating conditions agreed with the premises.

With these additions West Midlands Police have no objection to the issue of the premises license. The applicant has been copied into this email.

1. Staff involved in the sale of alcohol are to be trained under the Licensing Act 2003 prior to being allowed to sell/ supply alcohol. All training is to be documented and signed by the Premises Licence Holder and the trainee. All training records are to be made available to any of the responsible authorities on request. Staff involved in the sale/ supply of alcohol are to receive documented refresher training every six months.

The premises will have at least one SIA registered door staff on duty in the function room when there is an event/party in that room

2. The premises will hold the name, address and contact number of any persons booking the function room. This will be confirmed by photographic ID, such as a driving licence or passport. These details will be made available to West Midlands Police on request for the purpose of investigating a crime

I hope you're well.

I have reviewed your licence application and do not deem it appropriate at this site to have regulated entertainment or live music in the form you've described past 11pm. I believe this to be out of character to the nature of the area and other businesses in the locality, and my priority here is to protect the licensing objective of preventing public nuisance. There is of course also residential premises proximate to this site. My suggestion here would be as follows:

Regulated Entertainment & Live Music until 11pm.

Operating Hours until 2am.


This will allow your business to stay open until the later time you have requested but will ensure that no loud music will disturb residents post-11pm which I estimate to be no further than 200yards away. I would also accept quiet background music until the later time but you will have to update your application to show this and commit to dissolving your comments around live music and allowing customers to play their own music through amplified speakers post 11pm.


My suggestion here would be to apply for Temporary Event Notices should you wish to run in the way that you have applied for here – There will be some overlap of hours on the elements of regulated entertainment should you wish to provide anything but quiet background music post-11pm. This means that you'll have to commit to the licence as is but apply for the TEN to provide live music or louder music in the venue post-11pm for events and so on.
