#### 1 Executive Summary

1.1 This report provides details of the planned procurement activity for the period July 2019 – September 2019 and all contract award decisions made under Chief Officer's delegation during the previous quarter. Planned procurement activities reported previously are not repeated in this report.

- 1.2 The report enables Cabinet to identify whether any reports for procurement activities should be brought to this meeting for specific executive decision, otherwise they will be dealt with under Chief Officer delegations up to the value of £10m, unless TUPE applies to current Council staff.
- 1.3 Appendix 4 informs Cabinet of the contract award decisions made under Chief Officers delegation during the period January 2019 March 2019.

#### 3 Background

- 3.1 At the 1 March 2016 meeting of Council changes to procurement governance were agreed which gives Chief Officers the delegated authority to approve procurement contracts up to the value of £10m over the life of the contract. Where it is likely that the award of a contract will result in staff employed by the Council transferring to the successful contract under TUPE, the contract award decision has to be made by Cabinet.
- 3.2 In line with the Procurement Governance Arrangements that form part of the Council's Constitution, this report acts as the process to consult with and take soundings from Cabinet Members and the Resources Overview & Scrutiny Committee.
- 3.3 This report sets out the planned procurement activity over the next few months where the contract value is between the EU threshold (£181,302) and £10m. This will give members visibility of all procurement activity within these thresholds and the opportunity to identify whether any procurement reports should be brought to Cabinet for approval even though they are below the £10m delegation threshold.
- 3.4 It should be noted that the EU threshold has changed from £164,176 to £181,302 and will apply from 1<sup>st</sup> January 2019 for a period of 2 years.
- 3.5 Individual procurements may be referred to Cabinet for an executive decision at the request of Cabinet, a Cabinet Member or the Chair of Resources Overview & Scrutiny Committee where there are sensitivities or requirements that necessitate a decision being made by Cabinet.
- 3.6 Procurements below £10m contract value that are not listed on this or subsequent monthly reports can only be delegated to Chief Officers if specific approval is sought from Cabinet. Procurements above £10m contract value will

still require an individual report to Cabinet in order for the award decision to be delegated to Chief Officers if appropriate.

- 3.7 A briefing note with details for each item to be procured is listed in Appendix 2. The financial information for each item is detailed in Appendix 3 – Exempt Information.
- 3.8 Award decisions made under Chief Officers delegation during the period January 2019 March 2019 is shown in Appendix 4

Briefly describe the service required	The provision of minor landscape construction works. The type of works include construction of new paths and resurfacing of existing paths; planting trees, hedges and shrubs; construction of play areas and multi-use games areas; installation of drainage, street furniture, signage and fencing.
Is the Council under a statutory duty to provide this service? If not what is the justification for providing it?	There is not a statutory duty for these works to be delivered. However, the works are required to support the Council's Capital Programme, Section 106 agreements, lottery and grant funded projects.
What are the existing arrangements? Is there an existing contract? If so when does that expire?	The existing framework will expire on 10 <sup>th</sup> May 2019 which was approved by Cabinet Member for Commissioning, Contracting and Improvement Jointly with the Strategic Director of Place on 13 April 2015.
What budget is the funding from for this service?	The projects delivered through the framework will be funded through a mixture of Birmingham City Council capital budgets, external grants, Lottery funding, Town and Country Planning Act 1990 Section 106 agreement contributions and direct government funding.
What is the proposed procurement route?	Contract extension in accordance with Standing Order 11.7.
If single /multiple contractor negotiations are proposed, what is the reason for not tendering the requirement, how do we ensure value for money and compliance with the Birmingham Business Charter for Social Responsibility (BBC4SR)?	N/A - however a contract extension is being sought under Standing Order 11.7 (Contract extension report) The tender process for the replacement framework agreement is currently underway but has been delayed by 3 months due to the number of tender documents required to be produced and the added time that has been needed for consultation with other local authorities. The framework agreement was awarded via a competitive process to ensure value for money. All terms and conditions including pricing will remain the same for the duration of the contract extension. All the contractors are signed up to & will continue to adopt the principles of the BBC4SR.

Title of Contract	Waste Technical Advisors – Essential Works
Briefly describe the service required	In January 2019, the waste services contract with Veolia ES was extended by 5 years by way of an interim agreement. The contract extension through single contractor negotiation for these new requirements will provide the necessary technical support for the re-procurement of the various waste disposal services as set out in the report to Cabinet on 20 <sup>th</sup> December 2018 and the development of a programme to enable certain Essential Works to be completed at Tyseley Energy Recovery Facility (ERF) and potentially Lifford Lane and Perry Barr sites.
	<ol> <li>The following technical advice is required:         <ol> <li>Assist the Council's lawyers and their external support in the drafting of a Works Variation pro forma for the essential works being carried out at the ERF,</li> <li>Chairing quarterly meetings and site inspections with the Council and Veolia ES, to advance, audit and progress the Essential Works at Tyseley ERF;</li> <li>Developing and drafting the agreements for the various ERF Renewal Works;</li> </ol> </li> <li>Monitor key aspects of the annual maintenance outage at the ERF, paying specific attention to any Essential Works being undertaken;</li> <li>Undertake annual site condition surveys at the various sites, identifying any works needing to be completed, as applicable to the Site Survey Principles;</li> </ol>
	<ol> <li>Working with the Council and Veolia ES to develop design concepts for the redevelopment and improvement of the Lifford Lane and Perry Barr sites; and</li> <li>Provide engineering support on an ad hoc basis, in support of the various handback activities.</li> </ol>
Is the Council under a statutory duty to provide this service? If not what is the justification for providing it?	The Council has a duty to act as both a Waste Collection Authority and Waste Disposal Authority under the Environmental Protection Act 1990. This role will support the Council in discharging this responsibility, in particular to act as a Waste Disposal Authority.
What are the existing arrangements? Is there an existing contract? If so when does that expire?	There is not a contract in place for the services required. However, a contract for Specialist Technical support to the Future Waste Strategy was awarded to Fichtner Ltd approved by Chief Officer on 12th April 2017 that was for the initial support to the waste project.
What budget is the funding from for this service?	The cost will be funded from the approved budget for Waste Services.
What is the proposed procurement route?	To enter into single contractor negotiations with Fichtner Ltd.
If single /multiple contractor negotiations are proposed, what is the reason for not tendering the requirement, how do we ensure value for money and compliance with the Birmingham Business Charter for Social Responsibility (BBC4SR)?	Fichtner as the incumbent provider commenced services in 2017 has provided consultancy support to the Council in assessing potential life extension options for the different facilities, undertaking condition assessments of the different sites, identifying the Essential Works, and supporting the negotiation of the interim agreement with Veolia.
	There is an urgent need to negotiate with and appoint a specialist consultant capable of undertaking this work. Given Fichtner's previous experience and involvement in the development of the future municipal waste strategy it is logical and expedient to enter into negotiations with them to undertake this work.
	The current provider is already a signatory for the Business Charter and an updated action plan will be a requirement of the new contract.

Proposed start date and duration of the	June 2019 for duration of 5 years with the option to extend for a
new contract	further 12 months.

Title of Contract	Survey Services to determine works required to highways on Birmingham Municipal Housing Trust (BMHT) sites
Briefly describe the service required	There is a requirement for professional services to assess works necessary to highways on historic BMHT housing developments to achieve adoption of the highways on those sites into Highway Maintaintable at Public Expense (HMPE). There are 66 BMHT housing development sites that require assessment and remedial works to enable the highways to be adopted into HMPE. As all the contracts for these historic sites are now closed, there is a need for all the highways to be assessed by a suitable and competent contractor to detail all necessary work required to achieve adoption. Subsequently, any remaining works required would be undertaken utilising the existing call off contracts managed through Highways and those highways then being adopted as HMPE.
Is the Council under a statutory duty to provide this service? If not what is the justification for providing it?	There is a statutory duty to provide this service. The professional services and the works are required to enable the completion of schemes by the adoption of the infrastructure into HMPE
What are the existing arrangements? Is there an existing contract? If so when does that expire?	This is a new contract.
What budget is the funding from for this service?	The service is funded from the Housing Revenue Account.
What is the proposed procurement route?	The procurement route for the assessment works will be to carry out a procurement process advertised on OJEU, ( <u>www.finditinbirmingham.com</u> and Contracts Finder. The procurement route for the works will be to use the Council's Highways and Infrastructure Works framework agreement in accordance with its protocol.
If single /multiple contractor negotiations are proposed, what is the reason for not tendering the requirement, how do we ensure value for money and compliance with the Birmingham Business Charter for Social Responsibility (BBC4SR)?	Not applicable
Proposed start date and duration of the new contract	1 <sup>st</sup> August 2019 for a duration of 2 years.

Title of Contract	Electronic Bill Payment and Prepaid Cards
Briefly describe the service required	<ul> <li>A service is required to provide:-</li> <li>Electronic bill payment allows citizens and businesses to make payments to the Council for Housing Rent, Council Tax and Sundry Debts at either the Post Office or retail outlets who offer the PayPoint network.</li> <li>Direct Payment (DP) Prepaid Cards to enable citizens who receive care packages to pay providers for the services they choose.</li> <li>A pre-paid non-personalised card used for one-off payments including discretionary payments, emergency payments, crisis loans and social fund payments.</li> </ul>
Is the Council under a statutory duty to provide this service? If not what is the justification for providing it?	The Council does not have a statutory duty to provide this service. However, in order to maximise income to the Council, it must give citizens access to make easily accessible payments using a variety of methods.
What are the existing arrangements? Is there an existing contract? If so when does that expire?	The current contracts are with Allpay Limited and were awarded calling off via 3 separate frameworks agreements; Northern Housing Consortium Services Framework, Surrey Council Framework and the North East Procurement Organisation (NEPO) Framework. These contracts are due to expire in June 2019.
What budget is the funding from for this service?	<ul> <li>Projected usage funded from:-</li> <li>Electronic Bill Payment costs is met by Shared Services and recharged to directorates.</li> <li>DP Pre-Paid card costs are associated with Adult Social Care packages and also the Children's Trust and sit with these directorates.</li> <li>Pre-paid cards for one-off payments is met by Shared Services and recharged to directorates.</li> </ul>
What is the proposed procurement route?	It is proposed that a direct award is made to Allpay Limited using the Crown Commercial Services GCloud 10 Payment Services Framework Agreement in accordance with its protocol.
If single /multiple contractor negotiations are proposed, what is the reason for not tendering the requirement, how do we ensure value for money and compliance with the Birmingham Business Charter for Social Responsibility (BBC4SR)?	Not Applicable.
Proposed start date and duration of the new contract	The proposed start is 1 <sup>st</sup> July 2019 for a duration of 4 years.

Title of Contract	Arboriculture Services (non-highways) (P0560)
Briefly describe the service required	This PPAR entry replaces what was reported to Cabinet on 26 January 2019. The Council has approximately 736,000 trees within its tree stock on land which it is responsible for (excluding highways which is included within the Amey contract). Works under this proposed framework agreement (FA) will maintain these trees, as determined by the Council and will ensure that any emergency works are carried out to ensure that the Council adheres to its legal obligations.
Is the Council under a statutory duty to provide this service? If not what is the justification for providing it?	Section 164 of the Public Health Act 1875 gives the Council power to plant and maintain trees on land it is responsible for. The Council must maintain the trees on its land in order to avoid harm being caused to people and property which could result in claims for damages under the laws of negligence or an offence being committed under the Corporate Manslaughter and Corporate Homicide Act 2007. Section 23 of the Local Government (Miscellaneous Provisions) Act 1976 also gives the Council powers to make safe dangerous trees on privately-owned land.
What are the existing arrangements? Is there an existing contract? If so when does that expire?	There is an existing Framework Agreement (P0252) (Lot 1 – South & Lot 2 – North) that is due to expire on 16 <sup>th</sup> July 2022. Both lots were awarded to Idverde Ltd. By mutual consent the Council & the contractor Idverde Ltd have agreed to the early termination of the Framework Agreement on 31 <sup>st</sup> May 2019. More details are provided in the Appendix 3 – exempt information.
