**1. Purpose of report:**

To consider representations that have been made in respect of an application for a Premises Licence which initially sought to permit the Sale of Alcohol (for consumption on the premises) to operate from 11:00am until 11:30am (Sunday to Thursday) and 11:00am until 1:30am (Friday and Saturday).

To permit the provision of Late Night Refreshment to operate from 11:00pm until 1:30am (Friday and Saturday).

Premises to remain open to the public from 11:00am until 12:00midnight (Sunday to Thursday) and 11:00am until 2:00am (Friday and Saturday).

After discussions with West Midlands Police, the applicant has agreed to amend the scope of the application. The applicant has agreed to terminate licensable activities at 1:00am (Friday to Saturday) and 11:00pm (Sunday to Thursday). The agreed conditions with West Midlands Police are attached to this report at Appendix 5.

**2. Recommendation:**

**3. Brief Summary of Report:**

An application for a Premises Licence was received on 24<sup>th</sup> August 2020 in respect of Flamingo Café & Restaurant, 104 Villa Road, Lozells, Birmingham, B19 1NN.

Representations have been received from other persons.

Samsom Kahsay applied on 24<sup>th</sup> August 2020 for the grant of a Premises Licence for Flamingo Café & Restaurant, 104 Villa Road, Lozells, Birmingham, B19 1NN.

Conditions have been agreed with West Midlands Police and the applicant, which are attached at Appendix 5.

**Re: Objection to Licensing Application 117139 – Flamingo Cade & Restaurant, 104 Villa Road, Lozells, Birmingham, B19 1NN**

I am formally writing to object to the licensing application 117139 made to Birmingham City Council for the premises at 104 Villa Road, Birmingham, B19 1NN in the Lozells Ward which I represent as a local councillor.

12 years ago, West Midlands Police shut down The Bulls Head at these premises following 'Operation No Deal' where the local neighbourhood police team were tasked to clean up Villa Road. Villa Road remains a priority for the West Midlands Police.

Historically, the premises were known for drug dealing and gang activity with a fatal shooting within yards from these premises which instigated the closure of this pub.

My understanding from the conversations I have had with West Midlands Police officers is that the closure order for these premises included the statement that there should never be the sale of alcohol from these premises.

The community welcomed the closure and this statement in relation to these premises which has been a game changer for the neighbourhood.

Whilst some would argue that this was 12 years ago; I would respectfully state that these premises, if granted a license, could return to old ways if there is the sale of alcohol from this site.

Very near this site on Villa Road, there was a serious incident less than a year ago where two individuals were stabbed. I am also aware that the West Midlands Police Violence Reduction Unit have deployed extra resources in this neighbourhood to tackle the rise of serious crime.

The parking situation on Villa Road is already challenging and will be further challenged if a license is granted.

Due to these concerns, I fear that if this license was to be approved for the sale of alcohol, the residents of Lozells, particularly those living nearby would face issues around the prevention of crime and disorder, public safety and the prevention of public nuisance.

Only a few months back, after a long campaign led by the local residents and supported by West Midlands Police, the Licensing Committee revoked a public house license on Barker St and furthermore, a similar application for an alcohol license at the African Village was rejected at Villa Cross by the licensing committee a few weeks back.

It would be incorrect of me to link the premises as there is no direct link, but I fear that the environment created at the Observatory Pub, which had a huge impact on the quality of life for the local residents, would be repeated at these premises. The relief that many residents felt from the revoking of that license has been followed by fear and disbelief that the situation could reappear if this application is granted.

There is a strong risk the premises would not be able to cater for the demand and their customers would spill on to the streets whilst consuming alcohol. This would lead to anti social behaviour and have an impact on community cohesion.

Over the years, there has been a real issue of house parties spilling over until the early hours of the morning and attracting hundreds of people parking illegally and partying on the streets of Lozells.

There have been parties which have occurred only recently in Lozells during the Covid pandemic that both Birmingham City Council and West Midlands Police have had to deal with.

The repeat of this environment in Lozells would generate anti social behaviour, crime and disorder and public nuisance.

Over the years, this small shopping parade has attracted a variety of outlets, and at times over the years, it has been a problematic parade that has attracted anti social behaviour and criminal activity.

Whilst currently, it is far from perfect, it has been a lot worse. We fear that a license at these premises would re-attract similar problems of the past.

The neighbourhood police has done a tremendous job to improve the situation in the area but there are still issues of crime & disorder.

I fear that if this license is granted to this premises it will only add to the problems . There are numerous other off license premises around the Villa Rd area resulting in loitering, anti-social behaviour , street drinking and the need to further add to this is not necessary. Furthermore, parking is a major issue for residents in the area with residents complaining about illegal parking and congestion.

Taking all the above issues into consideration, I am objecting to this licence application.

## **Ban Flamingo cafe's alcohol licence on Villa Road**

We the undersigned residents and business owners are calling upon Councillor Waseem Zaffar, West Midlands Police and licensing to reject this application and reduce the opening hours of this business.

Villa Cross is a conservation area of Birmingham with historical importance to the UK. The area has been tarnished by previous and existing bars which encourage anti social behaviour and provide no parking for their customers.

Illegally parked cars are already causing issues by restricting access to pavements and obstructing residents driveways. Noise levels have increased and properties have been urinated on by drunk customers.

Commercial waste generated by these types of businesses are often fly tipped or left in public view on the main road due to lack of access behind their own premises.

There have been a number of violent crimes which are the direct result of alcohol consumption and most notably several stabbings connected to similar businesses nearby.

It is already difficult to maintain social distancing when walking past existing bars and cafes on Villa Road. Granting this licence will only exacerbate the situation further and encourage more anti social behaviour.

This is a residential area with families, students and housing for vulnerable people. The premises will not be fit for it's intended purpose and we are opposed to the alcohol application made by Flamingo Cafe and Restaurant.

- A **full** birth or adoption certificate issued in the UK which includes the name(s) of at least one of the holder's parents or adoptive parents, **when produced in combination with** an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A birth or adoption certificate issued in the Channel Islands, the Isle of Man or Ireland **when produced in combination with** an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A certificate of registration or naturalisation as a British citizen, **when produced in combination with** an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A **current** passport endorsed to show that the holder is allowed to stay in the UK and is currently allowed to work and is not subject to a condition preventing the holder from doing work relating to the carrying on of a licensable activity.

- A **current** Biometric Immigration Document (Biometric Residence Permit) issued by the Home Office to the holder which indicates that the named person can currently stay in the UK and is allowed to work relation to the carrying on of a licensable activity.
- A **current** Residence Card issued by the Home Office to a person who is not a national of a European Economic Area state or Switzerland but who is a family member of such a national or who has derivative rights or residence.
- A **current** Immigration Status Document containing a photograph issued by the Home Office to the holder with an endorsement indicating that the named person may stay in the UK, and is allowed to work and is not subject to a condition preventing the holder from doing work relating to the carrying on of a licensable activity **when produced in combination with** an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A Certificate of Application, **less than 6 months old**, issued by the Home Office under regulation 17(3) or 18A (2) of the Immigration (European Economic Area) Regulations 2006, to a person who is not a national of a European Economic Area state or Switzerland but who is a family member of such a national or who has derivative rights of residence.
- Reasonable evidence that the person has an outstanding application to vary their permission to be in the UK with the Home Office such as the Home Office acknowledgement letter or proof of postage evidence, or reasonable evidence that the person has an appeal or administrative review pending on an immigration decision, such as an appeal or administrative review reference number.
- Reasonable evidence that a person who is not a national of a European Economic Area state or Switzerland but who is a family member of such a national or who has derivative rights of residence in exercising treaty rights in the UK including:-
  - evidence of the applicant's own identity – such as a passport,
  - evidence of their relationship with the European Economic Area family member – e.g. a marriage certificate, civil partnership certificate or birth certificate, and
  - evidence that the European Economic Area national has a right of permanent residence in the UK or is one of the following if they have been in the UK for more than 3 months:
    - (i) working e.g. employment contract, wage slips, letter from the employer,
    - (ii) self-employed e.g. contracts, invoices, or audited accounts with a bank,
    - (iii) studying e.g. letter from the school, college or university and evidence of sufficient funds; or
    - (iv) self-sufficient e.g. bank statements.

Family members of European Economic Area nationals who are studying or financially independent must also provide evidence that the European Economic Area national and any family members hold comprehensive sickness insurance in the UK. This can include a private medical insurance policy, an EHIC card or an S1, S2 or S3 form.

- Films: no licence is required for 'not-for-profit' film exhibition held in community premises between 08:00 and 23:00 on any day provided that the audience does not exceed 500 and the organiser (a) gets consent to the screening from a person who is responsible for the premises; and (b) ensures that each such screening abides by age classification ratings.
- Indoor sporting events: no licence is required for performances between 08:00 and 23:00 on any day, provided that the audience does not exceed 1000.
- Boxing or Wrestling Entertainment: no licence is required for a contest, exhibition or display of Greco-Roman wrestling, or freestyle wrestling between 08:00 and 23:00 on any day, provided that the audience does not exceed 1000. Combined fighting sports – defined as a contest, exhibition or display which combines boxing or wrestling with one or more martial arts – are licensable as a boxing or wrestling entertainment rather than an indoor sporting event.
- Live music: no licence permission is required for:
  - o a performance of unamplified live music between 08:00 and 23:00 on any day, on any premises.
  - o a performance of amplified live music between 08:00 and 23:00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
  - o a performance of amplified live music between 08:00 and 23:00 on any day, in a workplace that is not licensed to sell alcohol on those premises, provided that the audience does not exceed 500.
  - o a performance of amplified live music between 08:00 and 23:00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
  - o a performance of amplified live music between 08:00 and 23:00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school or (iii) the health care provider for the hospital.
- Recorded Music: no licence permission is required for:

  - o any playing of recorded music between 08:00 and 23:00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school proprietor or (iii) the health care provider for the hospital.

- Dance: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 500. However, a performance which amounts to adult entertainment remains licensable.
- Cross activity exemptions: no licence is required between 08.00 and 23.00 on any day, with no limit on audience size for:
  - o any entertainment taking place on the premises of the local authority where the entertainment is provided by or on behalf of the local authority;
  - o any entertainment taking place on the hospital premises of the health care provider where the entertainment is provided by or on behalf of the health care provider;
  - o any entertainment taking place on the premises of the school where the entertainment is provided by or on behalf of the school proprietor; and
  - o any entertainment (excluding films and a boxing or wrestling entertainment) taking place at a travelling circus, provided that (a) it takes place within a moveable structure that accommodates the audience, and (b) that the travelling circus has not been located on the same site for more than 28 consecutive days.



Staff on duty will be trained and made aware of a challenge 25 policy and the requirements and the need to demand an acceptable form of age ID.

No adult entertainment is permitted at these premises.

All members of staff must receive training regarding the:- Four licensing principles contained in the Licensing Act 2003; Responsible retailing of alcohol, and the law; Protection of children from harm and this must include how to competently check customers identification where necessary; Authorised hours for licensable activities and the conditions attached to the premises licence. All training provided to staff will be recorded and each member of staff will sign and date the training records to confirm they have received and understood the training and on-going refresher training every six months. The staff training records will be maintained at the premises and made available to any Responsible Authority upon request.

To avoid nuisance being caused to neighbours the DPS, or other nominated person/staff, shall monitor the external areas of the premises after 23:00 hours, including the frontage onto Villa Road. If necessary, they shall remind customers to be respectful of neighbours and where necessary they shall limit the number of customers going outside to use the smoking area and take appropriate steps to avoid customers who use the frontage of the premises causing a nuisance.

All external doors and windows shall be kept closed except as necessary for safe and effective access and egress.

There shall be no live music or amplified music, speech or sound other than background music and any such background music shall be inaudible outside the building.

The DPS shall, within 3 months of the date of issue of this licence, submit in writing a noise management plan to Environmental Protection Unit of Birmingham City Council. The noise management plan shall outline the measures to be adopted to reduce the noise impact of activities associated with the premises including deliveries, recycling and refuse collections, smoking areas, customers and taxi pick up. The noise management plan shall be updated regularly and all staff shall be adequately trained in their role in implementing the plan.

No waste or recyclable material, including bottles, shall be moved, removed or placed in areas outside the premises building between the hours of 22.00 and 08.00.

No drinks shall be removed from the premises.

Patrons shall not remove from the premises late night refreshment provided at the premises.

The premises shall have an approved documented dispersal policy (approval needed in writing from the Environmental Protection Unit of Birmingham City Council), which shall be implemented for dispersal at all times the premises are open for licensable activity. The policy shall include the dispersal of customers exiting the premises away from nearby residential properties. The dispersal policy shall be reviewed periodically or in the case of noise complaints relating to dispersal activities and revised as necessary and the revised policy shall be submitted in writing to the Environmental Protection Unit of Birmingham City Council for approval. All operational controls and management actions required by the approved dispersal policy shall be instigated at all times.

There shall be no speakers used for amplified music, speech or sound outside the building.

Protection of Children from Harm - The premises licence holder will implement and operate a Challenge 25 age verification policy to prevent the sale or supply of alcohol to persons under 18 years of age. A copy of the written age verification policy must be signed by all members of staff to confirm they have read and understand the policy and the signed copy must be maintained at the premises and made available for inspection by any Responsible Authority on request.

If the above conditions are imposed onto the licence then West Midlands Police have no objection to this licence application.
