Subject: Remote meetings beyond 7 May 2021

1 Executive Summary

1.1 For members to consider next steps with regards to remote meetings.

2 Recommendations

2.1 The Leader and City Solicitor be asked to add their voices to the calls for the regulations to be extended, to allow physical, remote and hybrid meetings to continue (with provisions for this clearly set out in the Constitution).

3 Background

- 3.1 The Local Authorities (Coronavirus) (Flexibility of Local Authority Meetings) (England) Regulations 2020 came into force on 3 April 2020 and remain in force until 7 May 2021.
- 3.2 In summary, the Regulations allow meetings to be held remotely using video or telephone conferencing or by other remote means. Legislation was needed because existing primary legislation required that meetings must be in person, requiring attendance of all the members at a place together, which was not possible to do in compliance with government guidance on social distancing and restrictions on essential travel, when in force.
- 3.3 The provisions apply to all local authority meetings.

4 Options and Recommendations

4.1 When the regulations expire on 7 May 2021, all members must attend council meetings in person. A number of organisations and councils are lobbying the Government to extend the regulations, some asking for that to be done permanently.

- 4.2 For example, the Local Government Association¹ wrote to the Secretary of State setting out "the clear case for extending the ability for councils to hold meetings flexibly beyond May 2021 while we continue to manage the COVID-19 pandemic, and to make this a permanent power for councils to be able to utilise". They ask legislation is extended to give "councils ... the power to determine if a meeting should take place in person or remotely, and the circumstances for that would need to be established transparently in a councils' constitution, standing orders or policy". The letter can be read here.
- 4.3 The Secretary of State has since said that whilst accepting that the provision has been successful, he has no plans to extend the date as it requires primary legislation and there is no vehicle to do that in time for May. He added that whilst it is not possible at the moment, if there is an opportunity to make it more permanent, he will take it.²
- 4.4 Members are asked to consider their views, and whether the Leader and City Solicitor should be asked to add their voices to the calls for the regulations to be extended, to allow physical, remote and hybrid meetings (with provisions for this clearly set out in the Constitution), whether temporarily or permanently.

4.5 Factors include:

- Short term considerations namely the likelihood of ending of social distancing by May and the impact on Council business and governance if not all members can attend Council meetings;³
- Longer term considerations:
 - o Allowing the council to continue operating in emergency situations:
 - Improved flexibility in how meetings are held could encourage a greater diversity of candidates to put themselves forward
 - The positive environmental impact of not travelling to meetings by car;
 - Provision could be helpful in situations where meetings bring in people from across a wider area (e.g. West Midlands wide meetings); and in allowing members to balance commitments.
- 4.6 A survey of members was undertaken in July 2020, in anticipation of a return to the Council House in September, to which 43 members responded as below:
 - Would you like the option of hybrid/blended meetings (e.g. having both virtual attendees and attendees in person), giving you the option of how you wish to join the meeting?
