1. Purpose of report:

To consider an application to review a Premises Licence.

2. Recommendation:

To consider and determine the review application.

3. Brief Summary of Report:

Review application received on 25th November 2020 from Birmingham City Council Licensing Enforcement in respect of Kingstanding Second City ABC, 834 Kingstanding Road, Kingstanding, Birmingham, B44 9RT.

Representation has been received from West Midlands Police as a responsible authority, and from other persons.

4. Compliance Issues:

4.1 Consistency with relevant Council Policies, Plans or Strategies:

The report complies with the City Council's Statement of Licensing Policy and the Council's Corporate Plan to improve the standard of all licensed persons, premises and vehicles in the City.

5. Relevant background/chronology of key events:

Birmingham City Council Licensing Enforcement applied on 25th November 2020 for a review of the Premises Licence under Section 51 of the Licensing Act 2003 for Kingstanding Second City ABC, 834 Kingstanding Road, Kingstanding, Birmingham, B44 9RT.

A representation has been received from West Midlands Police, as a responsible authority, which is attached at Appendix 1.

Representations have been received from other persons, in support of the premises licence holder. These are attached at Appendices 2 - 6.

Review application is attached. See Appendix 7.

The Premises Licence is attached at Appendix 8.

Site location plans are attached at Appendix 9.

Subject: REVIEW OF KINGSTANDING SECOND CITY ABC

GOOD MORNING LICENSING.

This review refers to Kingstanding Second City ABC a licensed premise at 834, Kingstanding Road, Kingstanding, Birmingham. Premises License number 4335/2. West Midlands Police wish to join this review following what has been discovered by the Licensing Authority.

Complaints have been received by Birmingham City Council Licensing Team that the premises have been playing loud music outside of their authorised hours. Enquiries have revealed that on two occasions music has been played till later than the authorised time and that alcohol has been served again outside of licensable hours.

As part of the investigation CCTV has been requested but not provided with poor excuses being given in each case. The requirement for CCTV and it being produced is a condition on the operating schedule. This is a criminal offence, which carries with it an unlimited fine and or 6 months imprisonment, but more importantly it shows that the premises are not upholding the prevention of crime and disorder objective. Although this is serious enough the premises have also failed to comply with the regulations allowing licensed premises to reopen during the Covid pandemic.

Following a Covid complaint regarding lack of social distancing the premises were requested to show their Covid 19 Secure risk assessment (required under the Coronavirus Regulations) which the premise licence holder was unable to do, or produce since. This is very concerning as the requirement for a risk assessment was designed to show that premises understood the risks needed to open.

These risks that if not properly understood and addressed with the required risk assessment could easily assist the spread of the disease into the local communities and also delay the country getting back to a semblance of normality.

With these failings it shows that the premise licence holder was putting profit before safety, which is unacceptable in normal times, but in these times where the country is suffering significantly during this covid crisis, it can only show their total disregard for the licensing objectives and the trust you place in them to operate a licensed premises.

The premises license holder is failing to comply with the conditions of their license.

The premises license holder has on two occasions put forward the mitigation that the breaches have been committed in their absence. This points to a lack of management at the premises.

It would appear that the premises license holder is not present to manage the premises and has left the premises in the control of people in her absence who are not fit for the role.

Due to the actions of the premises license holder West Midlands Police have no confidence in her ability to promote the licensing objectives. Despite advice being given, the premises license holder has failed to change her working practices. This has led to the persistent breaches of the licensing conditions and the Coronavirus regulations.

West Midlands Police therefore wish to join in this review and support the application made by the local authority licensing officers.

They have signs on the door and the staff are always asking customers to leave quietly at the end of the night so as to not cause a public nuisance.

The premises have failed to uphold the licensing objectives by breaching the hours they are authorised to sell alcohol, provide regulated entertainment and comply with the conditions attached to the licence that are in place specifically to promote the licensing objectives and therefore committing offences under the Licensing Act 2003.

Under the Act a person commits an offence if they carry on a licensable activity without the required authorisation (premises licence, club premises certificate or temporary event notice) or carrying on a licensable activity in breach of a condition in an authorisation.

The penalty for such an offence on conviction can lead to six months imprisonment and/or a fine of £20,000.

Please provide as much information as possible to support the application (please read guidance note 3)

The premises is licensed for recorded music and the sale of alcohol (both on and off the premises) Monday to Sunday between 11.00 am - 01.00 am. The opening hours of the premises are 11.00 am - 01.30 am.

A complaint was received alleging that on 12th October 2019 loud music could be heard outside the venue in a residential property. It was alleged that the noise was preventing the complainant from sleeping even with double glazing. The music did not stop until approximately 1.10am, outside of the licensable hours. It was suspected, by the complainant, that the venue was propping the doors open whilst the music was being played at high volume inside the premises.

I made enquiries and established that there was an outstanding annual fee, in the sum of £180, against premises licence number 4335.

On 25th October 2019 I visited the premises and met with the licence holder and DPS, Michelle Bond. I discussed the complaint with Ms Bond and asked to see the CCTV footage. It was evident from the footage that the DJ was playing music, on 20th October 2019, until 1.15am. The Licence holder stated that neither her or her husband were present at the time, however, the DJ was not the normal one that they used – this was put forward as the reason why the hours had been exceeded. I was informed by Ms Bond that she would sort it out with all DJ's that they used in future and that they would put a notice on doors advising that they cannot be propped open at all. I issued a traders notice (appendix 1) advising Ms Bond of the complaint and the matter of outstanding fees.

The annual fee was subsequently paid in full.

Another similar complaint was received from the same complainant regarding events during the early hours of 1st February 2020. It was alleged that recorded music could be heard until 1.20am.

On 12th February 2020 I visited the premises and spoke to Michelle Bond, I advised that we had received another complaint alleging that they had gone outside of their licensable hours. I asked to see the CCTV. However, Ms Bond said that she had only popped into the premises and had not got the keys to the office with her. The CCTV system is based in the office. I said that I would visit the following Monday evening.

On 17th February 2020 I visited the premises with a colleague, Sarah Lavender. We met Michelle Bond, her husband and Robert Edge, a Licensing Consultant, Ms Bond had asked Mr Edge to attend. Ms Bond immediately admitted that they had gone over their hours and that the DJ had stopped at 1.10am. Mr Edge said that they had drawn up additional measures that they aimed to put in place. Ms Bond's husband asked if I would contact the complainant and tell them they were wrong and that they had not gone until

1.20am. I explained that it was irrelevant what the complainant had said, they had still gone outside of the licensable hours and that they had been advised about an identical incident previously. Ms Bond went on to say that as part of the new proposed measures the Head Barmaid would ensure that that this would not happen again in the future. I asked if it was the normal DJ that was working on the night in question, Ms Bond advised that it was. I explained that last time it had happened I was informed that it was because it was not the normal DJ, it was his brother. Mr Edge said that he was not aware that they had been warned before. We looked at the CCTV footage and noticed that a member of staff was serving bottles of alcohol until approximately 2.00am. Ms Bond confirmed it was the head barmaid that could be seen serving on the CCTV. I requested a copy of the CCTV within the next 7 days. I issued a trader's notice (appendix 2).

On 24th February 2020 emails were exchanged between Ms Bond and myself. Ms Bond sent the footage by email, but I could not access it. Ms Bond confirmed in a later email that she could not access the footage that she had copied. It was agreed that she would copy it onto a memory stick. (email chain is attached as appendix 3).

On 26th February 2020 a memory stick was collected from the premises. However, the footage could not be viewed by this means either.

On 11th March 2020 I sent an email to Ms Bond advising that I could not access the footage on the memory stick. I didn't receive a response. On 13th March 2020 I sent a further email asking for response. Later that day I received an email from Ms Bond ... "Sorry Christina, I thought I had replied already, dont know where thats gone then. The CCTV wouldnt play on mine it said file not supported or words to that effect but I thought that was because it's a Mac Book and not everything works the same on it. The CCTV lasts for 28 days so unfortunately it will have been overridden at the end of February." (email chain is attached as appendix 4).

On 3rd August 2020 a final advisory letter was sent to Ms Bond. (appendix 5)

During early September 2020 information was received alleging that the business was not operating in line with COVID regs. On 24th September Licensing Enforcement Officer Sharon Watts visited the premises. Michelle Bond was present at the premises. Ms Bond was unable to produce a COVID risk assessment stating it was at home, nor could she produce her personal licence or premises licence. A trader's notice was issued to Michelle Bond. The written statement of Sharon Watts, Enforcement Officer, and traders notice are attached (appendices 6 and 7).

REASON FOR REVIEW

I have seen CCTV footage of two separate occasions where amplified music was being played outside of licensable hours.

 The Licence holder, who is also the DPS, was not present on either occasion. Excuses and putting the blame on somebody else have been provided for both occasions.

I witnessed on CCTV footage at the premises that the sale of alcohol took place outside of licensable hours on 1st February 2020. The sale was made by the head Barmaid.

On 24th September 2020 the premises licence could not be produced – contrary to Section 57 of the Licensing Act 2003.

On 24th September 2020 the licence holder/DPS could not produce her personal licence. Contrary to Section 135 of the Licensing Act 2003 - Licence holder's duty to produce licence. Ms Bond offered the reason that she did not know that she had to have it with her. Yet again on this occasion Ms Bond did not have the keys to gain entry to the office.

Michelle Bond was first issued a personal licence during March 2010, therefore being a personal licence holder for 10 years.

A condition attached to the licence:

"The CCTV system shall record and store images for a minimum of 28 days. Images to be made available to West Midlands Police and Local Authority officers upon request."

When I visited on 12th February 2020, I could not have access to the CCTV footage, Ms Bond had not got the keys to the office. This was the case again on 24th September 2020 during the visit made by Officer Watts.

Even when access can be gained to the CCTV system, Ms Bond is not capable of downloading images.

Both of the complaints made about licensable activity going outside hours have been substantiated. However, I cannot put CCTV evidence before you due to Ms Bond's lack of ability to provide copies.

There does appear to be consistent breaches of legislation. Advisory letters have been sent to the premises but are not being adhered to.

Section 136 - Licensing Act 2003 - Unauthorised Licensable Activity

I write further to the visit made to your premises on 17th February 2020 in response to a complaint that recorded music was being played outside of the licensable hours during the early hours of 1st February 2020.

Upon watching the CCTV, it was evident that recorded music was played until 01.10 hours. When asked if it was the normal DJ, you advised me that it was. I asked this because of an explanation you had given me on a previous occasion. However, whilst watching the footage it became apparent that other licensable activity had taken place at the premises on the same date, namely alcohol had been supplied until 02.00 hours when the premises is only licensed until 01.00 hours.

During the visit you advised me that you had a head barmaid who was very good and it would not happen again. However, when we looked at the footage it was in fact your head barmaid who'd sold the alcohol.

I requested that you provide me with the CCTV footage. You did not provide me with the requested footage from the CCTV system in a viewable format. It was apparent that you were unable to download viewable images.

As you are aware, I had visited your premises on a previous occasion, namely 25th October 2019 in relation to an allegation that music was being played outside of licensable hours on 20th October. This was evidenced by watching your CCTV in your presence. You advised me that it was because it was not the usual DJ. You were issued with a notice detailing the breach, copy attached.

You, as the licence holder and as the DPS, are solely responsible for ensuring that the premises is compliant with the conditions of licence. On two separate occasions I have witnessed licensable activity taking place after licensable hours.

It is an offence under Section 136 of The Licensing Act 2003 to carry on or attempt to carry on a licensable activity on or from any premises otherwise than under and in accordance with an

authorisation, the authorisation being the premises licence. The premises licence clearly states the hours that licensable activity can be offered.

Under normal circumstances, I would have either formally interviewed you with a view to instigating legal proceedings through the courts, for which, if proven guilty carries a fine of up to £20,000 and/or six months imprisonment. Alternatively, I may have called for a review of the premises licence due to your failings. Committee have the power to either revoke, suspend or amend the conditions of the licence.

However, due to the pandemic these are not normal times and it is with this is mind that you are issued with this warning letter. This letter and the advice given to you will remain on file.

Should any breaches of the Licensing Act 2003 occur in the future your actions and the contents of this letter will be taken into account when deciding upon an appropriate course of action

Annex 1 - Mandatory Conditions

No supply of alcohol may be made under the premises licence (a) at a time when there is no designated premises supervisor in respect of the premises licence, or (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.

Every retail sale or supply of alcohol made under this licence must be made or authorised by a person who holds a personal licence.

The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises. In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises— (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to— (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or (ii) drink as much alcohol as possible (whether within a time limit or otherwise); (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective; (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective; (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner; (e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).

The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.

The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol. The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy. The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either— (a) a holographic mark, or (b) an ultraviolet feature.

The responsible person must ensure that— (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures— (i) beer or cider: ½ pint; (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and (iii) still wine in a glass: 125 ml; (b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and (c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available."

(1) A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price. (2) In this condition:— (a) "permitted price" is the price found by applying the formula P = D + (D x V), where— (i) P is the permitted price, (ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol; (b) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979; (c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence— (i) the holder of the premises licence, (ii) the designated premises supervisor (if any) in respect of such a licence, or (iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence; (d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and (e) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994. (3) Where the permitted price would not be a whole number of pennies, the permitted price shall be taken to be the price rounded up to the nearest penny. (4) Where the permitted price on a day ("the first day") would be

different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax, the permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

Each individual assigned to carrying out a security activity must be licensed by the Security Industry Agency.

Annex 2 - Conditions consistent with operating schedule

2a) General conditions consistent with the operating schedule

Members of staff will receive regular training in their responsibilities under the Licensing Act 2003, to include use of the proof of age scheme adopted by the premises. Such training to be documented and records shall be retained at the premises and produced to responsible authorities upon request.

No alcoholic drinks will be allowed into the gym area.

Live music to take place indoors only.

Drinks that are taken into the gym area must be in plastic vessels.

2b) Conditions consistent with, and to promote the prevention of crime and disorder

The premises licence holder will provide West Midlands Police Licensing Department 28 days- notice, if they propose to show international football matches {Including World cup} and any local derby football matches.

A refusal log to be maintained at the premises which will be available for inspection by any of the responsible authorities. Staff to record all refusals of sale of alcohol.

The premises will implement and put in practice a drugs policy.

An incident log book will be kept and maintained on the premises, and will be made available for inspection by West Midlands Police and responsible authorities.

CCTV to be installed and maintained to the satisfaction of West Midlands Police. The CCTV system to be in full working order at all times when the premises are open for licensable activities.

The CCTV system shall record and store images for a minimum of 28 days. Images to be made available to West Midlands Police and Local Authority officers upon request.

The premises will carry out a risk assessment for any organised event; this is to include any provision of SIA staff to be used. These are to be made available to West Midlands Police Licensing on reasonable request

If the premises has any late night external promoter event which is not part of the standard operating procedure, then a risk assessment will be completed and forwarded to West Midlands Police Licensing Department at least 28 days, or such other time as agreed with West Midlands Police Licensing Department, before the event. Any additional conditions (in writing) required by West Midlands Police will become a condition of the premises licence for the purposes of that event.

SIA registered door supervisors will be employed at the premises when a risk assessment determines the need.

Door staff profiles will be retained for all SIA staff that are working in the premises or have been working at the premises in the last 3 months. Profiles are to be proof of identity (photocopy of driving licence or passport) and proof of address (utility bill or bank statement). Proof of identity is to be a new photo driving licence, or copy of a passport, these are to be available for inspection on request by a responsible authority.

All external areas of the premises will be checked every hour whilst the premises is open for licensable activity. The premises will implement a system to record this.

2c) Conditions consistent with, and to promote, public safety

No enforceable conditions identified from operating schedule.

2d) Conditions consistent with, and to promote the prevention of public nuisance

Notices to be displayed, reminding patrons to leave the premises quietly, having consideration for local residents.

Any external speakers will be used for background music only.

2e) Conditions consistent with, and to promote the protection of children from harm

The premises will run the Challenge 25 Scheme. Posters reinforcing the operation of that scheme must be prominently displayed at the premises.

Children will not be permitted in the bar/lounge area after 21:00 hours.
