## 1. Purpose of report:

To consider representations that have been made in respect of an application for a Premises Licence which seeks to permit the provision of Regulated Entertainment consisting of live music and recorded music, to operate indoors only, from 11:00pm until 3:00am (Monday to Sunday).

To permit the provision of Late Night Refreshment, to operate indoors only, from 11:00pm until 3:00am (Monday to Sunday).

Premises to remain open to the public from 5:00pm until 3:00am (Monday to Sunday).

## 2. Recommendation:

To consider the representations that have been made and to determine the application.

## 3. Brief Summary of Report:

An application for a Premises Licence was received on 16<sup>th</sup> June 2020 in respect of Ammazan Hub, 1<sup>st</sup> Floor, Unit 1, 284 Witton Road, Birmingham, B6 6NX.

Representations have been received from other persons.

## 4. Compliance Issues:

4.1 Consistency with relevant Council Policies, Plans or Strategies:

The report complies with the City Council's Statement of Licensing Policy and the Council's Corporate Plan to improve the standard of all licensed persons, premises and vehicles in the City.

# 5. Relevant background/chronology of key events:

Lokman Hakim applied on 16<sup>th</sup> June 2020 for the grant of a Premises Licence for Ammazan Hub, 1<sup>st</sup> Floor, Unit 1, 284 Witton Road, Birmingham, B6 6NX.

Representations have been received from other persons. See Appendices 1 - 7.

The application is attached at Appendix 8.

Conditions have been agreed with West Midlands Police and the applicant, which are attached at Appendix 9.

Site Location Plans at Appendix 10.

When carrying out its licensing functions, a licensing authority must have regard to Birmingham City Council's Statement of Licensing Policy and the Guidance issued by the Secretary of State under s182 of the Licensing Act 2003. As a ward councillor I would like to make a strong objection on this application. I strongly believe that by granting this licence we will not be promoting any of the four licensing objectives: Crime and disorder Public safety Public nuisance Protecting children from harm.

Aston is the highest deprived areas in Birmingham which already suffers from criminal activities, drug dealing and anti-social behaviour.

The unit concerned is situated at the rear of a building which is on the main high street in Aston, Witton Road which is a Islamic education Centre known as Dawat Islami. This is a Islamic centre for educational classes for children from the age of 4yrs and above. This is also a Islamic book shop and library. At the rear of this premises we have Abbey Tyres which is next to Ammazon Hub. Abbey Tyres is a tyre centre which is always having cars for tyre purchase and repairs. We have a major issue of parking in the area but in this vicinity there is no parking as there are double yellow lines on the main road. When there are gatherings at the Ammazon Hub there are a lot of cars causing parking issues. The furniture centre which is situated on the main road on Witton Road next to Dawat Islami premises has living accommodation upstairs alongside other shops with upstairs accommodation which are all directly affected. I have received a number of complaints from the residents who live here of noise and nuisance from Ammazon Hub. There are high levels of noise coming from these premises from 5 pm till 3am the next morning. There is dinking and dancing going on all throughout the evening into the early hrs. It has also been pointed out that inappropriate adult activities take place at these premises when females are bought to the premises.

We have a lot of street drinking, rough sleeping and high drug abuse in Aston which causes high levels of anti-social behaviour.

On these grounds I hope you have enough evidence to refuse this application as I believe the applicant Mr Lokman Hakim is not a responsible person to run such a premises.

This has to be stopped with immediate effect.

I live exactly opposite this unit in the flat above **Example 1** In December 2019 the tenants of this Unit opened up as a social club/ venue to hold parties and events.

Ever since whenever they hold an event there they cause me so much trouble because they play loud music and party goers stand outside drinking making noises sometimes at 5am in the morning. This has been happening on a regular basis during the last six months even in the lockdown.

They hire in dancers and carry on playing loud music until 5am in the morning, disturbing myself and my partner.

I have asked the landlord to stop them and he has given them warnings in front of me, but evry time he tells them they say they wont do it agan but they do repeat it.

The landlord says he gave the unit to them as a meeting hub subject to them getting planning permission but they havent applied.

This kind of venue is illegal as it is promoting anti social behaviour and is putting the public at risk as it is in an industrial unit with no safety for the public.

I know of other residents of the surrounding arear complaining about them as well. I would appreciate it if you could refuse this licence and close this premises down with immediate effect.

My name is and i live at Normandy rd, Aston, Birmingham B20 3BA. My house is just behind the application site. I wish to object to the above application as ever since this site was opened in December 2019 it has been used to create public nuisance by playing loud music which can be heard from my house at 3-4 am in the morning. This has happened on a few occasions in December 2019 and then in january, february, March, April and May 2020 during the lockdown.

On a couple of occasions it was so bad that i ended up going around to the site and confronted them. I was told by Mr Lookman that there was nothing i could do because he had permission from the council.

I tried to complain to the council but could not get through. Recently another neighbour told me that there was a notice on their premises referring to an application for a late night music licence. I am shock that i was lied to by Mr Lookman and that they have been carrying out illegal activities at the site.

Whilst i was there at my last visit at the end of May there were about 50 people in and outside the building drinking alcohol and playing loud music. This was about 3am. There were even half naked girls dancing. when i told them to stop it was 3am in the morning they told me to go away and threatened me.

This establishment must be closed down immediately and their application refused because of the antisocial problems it has created because of alcohol and drug abuse taking place there.

The staff will at all times remain aware of their responsibilities for the prevention of crime and disorder on the premises. No sale of alcohol is permitted on the premises. No consumption of alcohol will be permitted. Any person who appears drunk /aggressive will not be permitted on the premises.

c) Public safety

Suitable fire extinguishers, fire alarms and fire exits are maintained.

Floor staff will conduct physical sweep inside the premises to remove hazardous objects/waste as deemed necessary by the management. All staff will be made aware of their responsibilities to other staff and customers in respect of public safety and will take all reasonable steps to ensure the maintenance of all provided safety arrangements and equipment in accordance with the requirements of current installations.

d) The prevention of public nuisance

All deliveries will be received during daytime prior to 6pm to control noise nuisance. In conjunctions with the steps proposed for the prevention of crime and disorder objectives, the Licensees and staff will at all times remain responsible for the prevention of public nuisance in and around the premises.

The License holder will arrange to monitor noise levels from both inside and outside the premises and remedial action will be taken as appropriate. A record of this will be maintained along with a incident log.

Doors and windows will be kept closed as deemed necessary by the management.

e) The protection of children from harm

We recognise the importance of protecting children from harm and this is supported by our commitment to health and safety in the operation and maintenance of the premises. No sale of alcohol will be permitted on the premises. There will be a zero drugs policy.

NOTES ON DEMONSTRATING ENTITLEMENT TO WORK IN THE UK

# Entitlement to work/immigration status for individual applicants and applications from partnerships which are not limited liability partnerships:

A licence may not be held by an individual or an individual in a partnership who is resident in the UK who:

- does not have the right to live and work in the UK; or
- is subject to a condition preventing him or her from doing work relating to the carrying on of a licensable activity.

Any premises licence issued in respect of an application made on or after 6 April 2017 will become invalid if the holder ceases to be entitled to work in the UK.

Applicants must demonstrate that they have an entitlement to work in the UK and are not subject to a condition preventing them from doing work relating to the carrying on of a licensable activity. They do this in one of two ways: 1) by providing with this application copies or scanned copies of the documents listed below (which do not need to be certified), or 2) by providing their 'share code' to enable the licensing authority to carry out a check using the Home Office online right to work checking service (see below).

#### Documents which demonstrate entitlement to work in the UK

- An expired or current passport showing the holder, or a person named in the passport as the child of the holder, is A British citizen or a citizen of the UK and Colonies having the right of abode in the UK [please see note below about which sections of the passport to copy].
- An expired or current passport or national identity card showing the holder, or a person named in the passport
  as the child of the holder, is a national of a European Economic Area country or Switzerland.
- A Registration Certificate or document certifying permanent residence issued by the Home Office to a national of a European Economic Area country or Switzerland.
- A Permanent Residence Card issued by the Home Office to the family member of a national of a European Economic Area country or Switzerland.
- A current Biometric Immigration Document (Biometric Residence Permit) issued by the Home Office to the holder indicating that the person named is allowed to stay indefinitely in the UK, or has no time limit on their stay in the UK.
- A current passport endorsed to show that the holder is exempt from immigration control, is allowed to stay
  indefinitely in the UK, has the right of abode in the UK, or has no time limit on their stay in the UK.
- A current Immigration Status Document issued by the Home Office to the holder with an endorsement
  indicating that the named person is allowed to stay indefinitely in the UK or has no time limit on their stay in
  the UK, when produced In combination with an official document giving the person's permanent National
  Insurance number and their name issued by a Government agency or a previous employer.
- A birth or adoption certificate issued in the UK, when produced in combination with an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A birth or adoption certificate issued in the Channel Islands, the Isle of Man or Ireland when produced in combination with an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A certificate of registration or naturalisation as a British citizen, when produced in combination with an
  official document giving the person's permanent National Insurance number and their name issued by a
  Government agency or a previous employer.

- A current passport endorsed to show that the holder is allowed to stay in the UK and is currently allowed to
  work and is not subject to a condition preventing the holder from doing work relating to the carrying on of a
  licensable activity.
- A current Biometric Immigration Document (Biometric Residence Permit) issued by the Home Office to the holder which indicates that the named person can currently stay in the UK and is allowed to work relation to the carrying on of a licensable activity.
- A current Residence Card issued by the Home Office to a person who is not a national of a European Economic Area state or Switzerland but who is a family member of such a national or who has derivative rights or residence.
- A current Immigration Status Document containing a photograph issued by the Home Office to the holder with an endorsement indicating that the named person may stay in the UK, and is allowed to work and is not subject to a condition preventing the holder from doing work relating to the carrying on of a licensable activity when produced in combination with an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A Certificate of Application, less than 6 months old, issued by the Home Office under regulation 18(3) or 20(2) of the Immigration (European Economic Area) Regulations 2016, to a person who is not a national of a European Economic Area state or Switzerland but who is a family member of such a national or who has derivative rights of residence.
- Reasonable evidence that the person has an outstanding application to vary their permission to be in the UK
  with the Home Office such as the Home Office acknowledgement letter or proof of postage evidence, or
  reasonable evidence that the person has an appeal or administrative review pending on an immigration
  decision, such as an appeal or administrative review reference number.
- Reasonable evidence that a person who is not a national of a European Economic Area state or Switzerland but
  who is a family member of such a national or who has derivative rights of residence in exercising treaty rights in
  the UK including:-
  - evidence of the applicant's own identity such as a passport,
  - evidence of their relationship with the European Economic Area family member e.g. a marriage certificate, civil partnership certificate or birth certificate, and
  - evidence that the European Economic Area national has a right of permanent residence in the UK or is one
    of the following if they have been in the UK for more than 3 months:
  - (i) working e.g. employment contract, wage slips, letter from the employer,
  - (ii) self-employed e.g. contracts, invoices, or audited accounts with a bank,
  - (iii) studying e.g. letter from the school, college or university and evidence of sufficient funds; or
  - (iv) self-sufficient e.g. bank statements.

Family members of European Economic Area nationals who are studying or financially independent must also provide evidence that the European Economic Area national and any family members hold comprehensive sickness insurance in the UK. This can include a private medical insurance policy, an EHIC card or an S1, S2 or S3 form.

Original documents must not be sent to licensing authorities. If the document copied is a passport, a copy of the following pages should be provided:-

(i) any page containing the holder's personal details including nationality;

- (ii) any page containing the holder's photograph;
- (iii) any page containing the holder's signature;
- (iv) any page containing the date of expiry; and

(v) any page containing information indicating the holder has permission to enter or remain in the UK and is permitted to work.

If the document is not a passport, a copy of the whole document should be provided.

Your right to work will be checked as part of your licensing application and this could involve us checking your immigration status with the Home Office. We may otherwise share information with the Home Office. Your licence application will not be determined until you have complied with this guidance.

#### Home Office online right to work checking service

As an alternative to providing a copy of the documents listed above, applicants may demonstrate their right to work by allowing the licensing authority to carry out a check with the Home Office online right to work checking service.

To demonstrate their right to work via the Home Office online right to work checking service, applicants should include in this application their 9-digit share code (provided to them upon accessing the service at <a href="https://www.gov.uk/prove-right-to-work">https://www.gov.uk/prove-right-to-work</a>) which, along with the applicant's date of birth (provided within this application), will allow the licensing authority to carry out the check.

In order to establish the applicant's right to work, the check will need to indicate that the applicant is allowed to work in the United Kingdom and is not subject to a condition preventing them from doing work relating to the carrying on of a licensable activity.

An online check will not be possible in all circumstances because not all applicants will have an immigration status that can be checked online. The Home Office online right to work checking service sets out what information and/or documentation applicants will need in order to access the service. Applicants who are unable to obtain a share code from the service should submit copy documents as set out above.


NOTES ON REGULATED ENTERTAINMENT

In terms of specific regulated entertainments please note that:

- Plays: no licence is required for performances between 08:00 and 23.00 on any day, provided that the audience does not exceed 500.
- Films: no licence is required for 'not-for-profit' film exhibition held in community premises between 08.00 and 23.00 on any day provided that the audience does not exceed 500 and the organiser (a) gets consent to the screening from a person who is responsible for the premises; and (b) ensures that each such screening abides by age classification ratings.
- Indoor sporting events: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000.
- Boxing or Wrestling Entertainment: no licence is required for a contest, exhibition or display of Greco-Roman
  wrestling, or freestyle wrestling between 08.00 and 23.00 on any day, provided that the audience does not
  exceed 1000. Combined fighting sports defined as a contest, exhibition or display which combines boxing or
  wrestling with one or more martial arts are licensable as a boxing or wrestling entertainment rather than an
  indoor sporting event.
- Live music: no licence permission is required for:
  - a performance of unamplified live music between 08.00 and 23.00 on any day, on any premises.
  - a performance of amplified live music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
  - a performance of amplified live music between 08.00 and 23.00 on any day, in a workplace that is not licensed to sell alcohol on those premises, provided that the audience does not exceed 500.
  - a performance of amplified live music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
  - a performance of amplified live music between 08.00 and 23.00 on any day, at the non-residential premises
    of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500,
    and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local
    authority concerned, or (ii) the school or (iii) the health care provider for the hospital.
- Recorded Music: no licence permission is required for:
  - any playing of recorded music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
  - any playing of recorded music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
  - any playing of recorded music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school proprietor or (iii) the health care provider for the hospital.

•	Dance: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 500. However, a performance which amounts to adult entertainment remains licensable.
