UPDATE REPORT ON UNAUTHORISED ENCAMPMENTS

The following report of the Director of Regulation & Enforcement was submitted.

Mark Wolstencroft and John Jamieson were present for the report updating the Committee on work being undertaken to further manage unauthorised encampments in the City since the last report on 20 September 2023. Stephen Gabriel, Martin Dando and Superintendent Jill Davenport, WMP were also in attendance for the update.

This report comprises input from Environmental Health (site repossession), Planning (planning policy and site identification) and Housing (site development and management). A dedicated local team had been established to work on unauthorised encampments.

Officers updated on site provision, transit sites and unauthorised encampments as set out in the report. Senior Managers had been contacted to raise awareness and ensure transit sites were on the agenda.

Superintendent Jill Davenport, WMP from Dudley local policing area gave an update advising when police powers could be used. She advised that unauthorised encampments became a policing matter when communities were affected making reference to the related powers and Guidance. In response to questions regarding when action would be taken by the police, the Committee was advised that WMP had considered circumstances and thresholds when the police could intervene eg the point of incursion and whether any damage had been caused to enter the land.

Councillors raised their concerns about unauthorised encampments experienced in different areas causing distress to residents who were unable to use the amenities owing to the encampment. Reference was made in particular to Woodgate Valley, Billesley Common and Chinnbrook.

Following a comment that even though some of the action police could take was limited, it would be reassuring for WMP to attend the site of the unauthorised encampment, it was noted that it was usual practice for WMP and the Local Authority to attend every unauthorised site to carry out an assessment.

It was felt that it would be useful to have a target date for Proctor Street to be open. It was understood that the size of encampments had increased and feedback was requested when new sites were being considered in the future.

Mark Wolstencroft undertook to discuss Woodgate Valley with colleagues in Parks and Leisure. He also worked with WMP on this increasingly complex issue. Mark Croxford advised that the bar for injunctions had been raised. It was requested that some clear guidance be provided for Councillors to ensure they were aware of their rights in their Wards.

Councillor Sam Forsyth placed on record her disappointment at the lack of operational sites in the City.

- The fee calculation was based on the latest accounts which were not yet finalised but not expected to change much. The fees were based on full recovery to £45K.
- If was queried whether there could be a contingency given in the current year however explained that officers were following best practice. It was clarified that there had been a reduction in income as there had been less traders.

<u>REVIEW OF FPN TARIFFS FOR LITTERING, FLY-TIPPING, DUTY OF</u> CARE, FLY POSTING AND GRAFFITI

The following report of the Director of Regulation and Enforcement was submitted.

Russell Davey presented the report to the Committee requesting that Members review the fixed penalty notices for the offences of littering, flytipping, duty of care, graffiti and fly-posting having consideration to new legislation which came into force on 31 July 2023 increasing the maximum tariff for these fixed penalty notices

Some Members felt that the maximum fine of £400 for unauthorised deposit of waste from a domestic premises did not act as a deterrent and gave examples of fly tipping in their Wards. They also sought clarity about the responsibility of residents to ensure the person they paid to collect their waste was legitimate and discussed enforcement for the offences.

Members gave their views whether the maximum fine for domestic premises should be raised to £1000 instead of £400 adding that this should be for people that were caught in the act of fly tipping. Councillor Sam Forsyth asked the Committee to note that the LGA should be lobbied to increase the maximum fine for commercial or industrial premises from £1000.

It was proposed by the Chair and seconded by Councillor Donaldson that the maximum fine of $\pounds400$ for the unauthorised deposit of waste from a domestic premises should be raised from $\pounds400$ to $\pounds1000$ be put to the vote.

Following a vote on the above it was carried 7 in favour to 4 against and

REVIEW OF LICENSING AND PUBLIC PROTECTION FEES AND CHARGES 2024/25

1 <u>Summary</u>

- 1.1 The Corporate Charging Policy and Financial Regulations require that fees and charges levied by the Licensing and Public Protection Committee be reviewed on an annual basis to ensure the continued full recovery of costs.
- 1.2 It should be noted that some of the fees relating to areas which come within your committee's remit are set nationally through statute, and these cannot be varied by your Committee. These are indicated in the report.
- 1.3 All fees and charges have been set to with the objective of maximising income so far as is possible within legal constraints.
- 1.4 This report deals with all fees and charges within the control of your committee other than the fees charged by the Licensing Service, which are considered in a separate report.

2 <u>Recommendations</u>

- 2.1 That the changes to the fees and charges for Trading Standards Services, as detailed in **Appendix 1**, are approved to take effect from 1 April 2024.
- 2.2 That the changes to the fees and charges for Environmental Health Services, as detailed in **Appendix 2(a)**, are approved to take effect from 1 April 2024.
- 2.3 That the changes to the fees and charges for Animal Welfare Services, as detailed in **Appendix 2(b)**, are approved to take effect from 1 April 2024.
- 2.4 That the changes to the fees and charges for Environmental Health Fixed Penalty Notices, as detailed in **Appendix 2(c)**, are approved to take effect from 1 April 2024.
- 2.5 That the changes to the fees and charges for Pest Control Services, as detailed in **Appendix 2(d)**, are approved to take effect from 1 April 2024.

3 <u>Background</u>

- 3.1 The City Council's Corporate Charging Policy and Financial Regulations require that Chief Officers, at least annually, report to and seek approval from Committee on a review of all fees and charges levied for services provided.
- 3.2 Tables with greyed out boxes indicates the fee is set by statute and is for noting only.

4 <u>Proposals</u>

- 4.1 The fees proposed in this report are calculated to maximise income and recover the full cost of carrying out the various services in line with City Council policy. This includes all overheads, administrative costs, expenses, and any appropriate recharge of officers' time.
- 4.2 The areas covered are as follows:
 - Appendix 1 Review of Charges for Trading Standards.
 - Appendix 2(a) Review of Charges for Environmental Health
 - Appendix 2(b) Review of Animal Welfare charges
 - Appendix 2(c) Review of Charges for FPNs issued by Environmental Health
 - Appendix 2(c) Review of Charges for Pest Control
 - Appendix 3 Review of Charges for Register Office, including statutory fees to note (Table 5).
 - Appendix 4 Review of Charges for the Coroner's Service
 - Appendix 5 Review of charges for Birmingham Account Team (Acivico -Building Consultancy) (formerly Surveying Services)
- 4.3 Where fees in any service area are not covered by the appendices or a recovery of monies is to be levied then the full recharge will be based on the following table. The hourly rate by grade (includes full overhead recovery and central support costs) is broken down by the six salary grading bands the Local Authority appoints its officers under.

Generally, the rates are similar to last year, this is due to a significant reduction in the rate of employers' superannuation contributions (from 35.4 to 27.2%) and also a small decrease in Employers National Insurance. These have been offset by an increase in pay rates and inflationary pressure on running costs, fuel, supplies and overheads.

- 4.4 The hourly rate for officers on grades GR2 to GR4 have increased slightly (£1 to £2) this is due to the methodology applied to the agreed pay award in April 2023 which had a higher value for those grades with the intent to reduce the gap between grades in the structure.
- 4.5 In carrying out this annual review of charges reference has been made to the requirements of the Corporate Charging Policy. Particular attention has been paid to the need to ensure that income is maximised insofar as is possible.
- 4.6 Regarding matters which relate to trading in the open market consideration has been given to competitors pricing and what the market can sustain. Where a fee has been proposed that does not achieve full cost recovery (for instance due to the need to compete with alternative providers), it has been indicated in the relevant appendix.
- 4.7 During the year ahead the financial position will continue to be closely monitored and options identified to resolve budgetary pressures as necessary and alternative savings proposals developed to meet new and emerging pressures.
- 5 <u>Consultation</u>
- 5.1 The fees and charges appended to this report do not require formal consultation.
- 6 Implications for Resources
- 6.1 The proposals represent an increase to income for 2024/25, assuming the same level of work being delivered. The proposed increases are in line with the council-wide strategy for 2024/25 onwards.
- 7 <u>Legal Implications</u>
- 7.1 The City Council's Corporate Charging Policy and Financial Regulations require that Chief Officers, at least annually, report to and seek approval from Committee on a review of all fees and charges levied for services provided. This report also takes account of the legal framework within which certain licence fees must be set.
- 8 Implications for Policy Priorities

- 8.1 The recommendations are in accordance with Financial Regulations, budget requirements and the Corporate Charging Policy.

REVIEW OF CHARGES 2024/2025 – TRADING STANDARDS

- 1.1 In reviewing these fees and charges, officers from the Division have considered:
 - the budget strategy for 2024/25, which is for a 10% increase in income where it is sustainable.
 - the need to ensure that relevant expenditure and income targets are met, and full cost recovery achieved.

1.2.0 Primary Authority Partnership

- 1.2.1 This is part of a national programme to enable local authorities and businesses to work together to help improve consistency in regulation. The programme is overseen by the Better Regulation Delivery Office and enables local authorities to recharge for the time spent on servicing the partnership. Primary Authority Partnerships are agreed on a cost recovery basis.
- 1.2.2 The current charging arrangements which have already been agreed with our current partners are based on an officer's hourly rate. The proposed charge, therefore, reflects the 2024/2025 Grade 5 Officer as per the table in 3.3 of the main report plus expenses.

1.3 Business Support

1.3.1 Where businesses request business support but without entering into a Primary Authority Agreement, the local Authority would seek cost recovery and charge at Grade 5 Officer hourly rate.

* Fees have not been increased from 2023/24 this is a competitive market where other local authorities provide similar services.

1.4 Financial Investigations

- 1.4.1 Accredited Financial Investigators within Trading Standards are able to provide financial investigation services to both internal and external (public sector) clients. It is proposed that where services are provided outside Birmingham Trading Standards that the charge be at a GR5 hourly rate of £88.00 plus expenses. Any incentivisation money resulting from a Proceeds of Crime Act 2002 investigation will be shared according to the Home Office incentivisation scheme. The current Home Office Asset Recovery Incentivisation Scheme (ARIS) stipulates:
 - Under the Home Office Asset Recovery Incentivisation Scheme (ARIS) 50% of the monies recovered from a particular defendant is given to the Home Office and the remaining 50% is distributed amongst the agencies involved in the Confiscation.
- 1.4.2 These agencies will receive the appropriate share (of the 50%) from their asset recovery activities allocated as follows:

Confiscation order receipts - Criminal Justice Service Ministers have agreed that confiscation order receipts will be split three ways thus:

- Investigation (Local Authority) 18.75%
- Prosecution (Local Authority) 18.75% and
- Enforcement (Her Majesty's Court Service) 12.5%.
- 1.4.3 **Cash Forfeitures:** The ARIS 'rules' for cash forfeitures are different in that the agency seizing the cash receives 50% share of the forfeited amount. If the offender

has the ability to pay prosecution costs after the 'confiscation proceedings' have concluded these are also recoverable.

- 1.4.4 **Providing Service to other Local Authorities:** It is proposed that where the services of the Accredited Financial investigator are provided by Birmingham Trading Standards on behalf of another local authority and this has resulted in cash forfeiture, then 25% of the total forfeited amount will be retained by Birmingham Trading Standards.
- 1.4.5 It is proposed that where the services of the Accredited Financial Investigator have resulted in a successful confiscation order receipt the 18.75% investigation allocation will be retained by Birmingham Trading Standards.
- 1.4.6 **Regional Investigations Team:** The Regional Investigations Team is hosted by Birmingham Trading Standards. The grant agreement requires that 50% of the any ARIS payment awarded and received by the hosting Local Authority is returned to National Trading Standards (NTS). It is, therefore, proposed that any successful financial investigation undertaken on behalf of this team will result in the retention of 25% of the remaining ARIS money after payment is made to the NTS. This amounts to 9.375% of the total amount of a confiscation order and 12.5% of total cash forfeiture.
- 1.4.7 **Negotiation:** Financial investigation is a growing service within the public sector and many local authorities are now offering these services. There are many different charging policies and in some circumstances, it may be beneficial to have the ability to negotiate the charges with the client to secure the job. The Director of Regulation and Enforcement and the Head of Trading Standards have the discretion to agree any negotiated changes to the proposed fees and charges relating to financial investigations.

REVIEW OF CHARGES 2024/2025 - ENVIRONMENTAL HEALTH AND PEST CONTROL

- 2.0 In reviewing these fees and charges, officers from the Division have considered:
 - the budget strategy for 2024/25, which is for a sustainable increase in income to meet budgetary pressures.
 - the need to ensure that relevant expenditure and income targets are met, and full cost recovery achieved, and that work is not lost simply due to excessive costs.
- 2.0.1 The non-statutory fees and charges have been set in accordance with the above considerations.
- 2.0.2 For 2024/2025 Environmental Health and Pest Control have again used the rationale of maximising income, based on market forces, to assist in meeting the corporately set income targets and fees inflation for the sections.

2.1 Issuing of Food Condemnation/Surrender Notes by Environmental Health Officers

2.1.1 It is proposed that the fee for issuing condemnation/surrender notes for freezer breakdowns and for similar insurance purposes be increased to £141 per hour (from £128). This is based on the hourly rate for a GR5 officer plus administration support cost. (Non-Business activity VAT exempt (Tax Code A8 applies))

2.2 **Provision of Food Export Certificates**

- 2.2.1 It is proposed that where an inspection of the premises is required, this will be subject to a minimum of £191 (current charge £173) plus an administrative charge of 10%. Inspections that are longer than one hour will be charged at an hourly rate for a GR5 Officer per hour or part of an hour thereafter. Only a local authority authorised officer can issue certificates it is therefore a non-business activity and VAT exempt (Tax Code A8 applies).
- 2.2.2 Where no visit is required, it is proposed that the fee increase will be £125 (current charge £113) for the certificate. Only LA authorised officer can issue certificates it is therefore a non-Business activity and VAT exempt (Tax Code A8 applies).
- 2.2.3 Where Export Certificates have been produced and are no longer required, there will be a charge of £41 cancellation fee (current charge £37) for each certificate produced.

2.3 **Provision of a Veterinary Export Health Certificate**

2.3.1 We will continue to support companies that export products of animal origin from the UK however since 2022 there has been an increase in the number of companies that offer this service. We anticipate that our portfolio of companies will not increase and that we will continue to work only with those which are already supporting. It is proposed that where an inspection of the premises is required, this will remain at the 2023/24 rate of being subject to a minimum of £250 plus VAT (total of £300), private businesses also undertake this work therefore standard VAT rate applies. This is a slightly higher than the current market rate. Any increase beyond this may result in loss of income.

2.4 Food Hygiene Rating Scheme revisits (FHRS)

- 2.4.1 It is proposed to increase the charge for all FHRS revisits that are requested by businesses to obtain a new food hygiene score by 10% to £275 (currently £250).
- 2.4.2 These requests are received following a programmed inspection that gave a lower score than a business would like to trade under and is additional work over and above our statutory duty for food interventions.
- 2.4.3 As this only applies to businesses that are not compliant with legal requirements for hygiene and operation it is proposed to increase the fees, as the current fee is not acting as a disincentive to businesses to maintain standards between programmed inspections. (Non-Business activity VAT exempt (Tax Code A8 applies)).

2.5 Health and Safety

2.5.1 On occasions solicitors request copies of health and safety accident reports. The Health and Safety at Work etc. Act 1974, Section 28, sub-section 9, allows a disclosure by an authorised officer of a "written statement of relevant facts observed by him" (Employment Protection Act 1975). It is proposed to make a minimum charge of £200 (two hours at GR5 plus administration costs) plus the hourly rate per hour or part hour thereafter for the officer compiling the report. (Current charge is £180). VAT will be applied at its appropriate rate, in addition to this cost.

2.5.2 Your officers can deliver a range of bespoke training courses specifically for other local authority officers for example on practical incident investigation. This service assists other local authorities who have less experience and smaller health and safety teams. It is proposed that the charge is increased to £110 per delegate for one day's training [including any refreshments] with a minimum number of ten delegates per course (currently £100). (VAT exempt if only L/A officer's attend. VAT would be payable for external delegates and must be added to their charge).

2.6 **Food and Health and Safety Primary Authority Partnerships.**

- 2.6.1 Environmental Health Food and Health & Safety Teams have set up several Primary Authority Partnerships with national multisite businesses. This is part of a national programme to enable local authorities and businesses to work together to help improve consistency in regulation.
- 2.6.2 The programme is overseen by the Government's Office of Product Safety & Standards and enables local authorities to recharge for the time spent on servicing the partnership. By statute costs incurred by Councils participating in Primary Authority Partnerships are recharged on a cost recovery basis.
- 2.6.3 The current charging arrangements which have already been agreed with our current partners are based on an officer's hourly rate. The proposed charge, therefore, reflects the 2024/2025 Grade 5 Officer hourly rate detailed in the table at 3.3 of the main report plus expenses. (VAT applies but is currently zero rated for this work).

2.7 Environmental Conveyancing Searches

- 2.7.1 Several requests are made (usually by solicitor firms) for environmental information held by the Service to assist in conveyancing. The information must be supplied (where held) under the Environmental Information Regulations.
- 2.7.2 Although no charge can be made for providing the raw information, a charge can be made for the cost of processing the information into a usable report. It is proposed that the fees increase by 10% this year, raising the fees for next year to £99 for a Basic Search and £139 for an Advanced Search. (Tax Code A8 applies no VAT as only LA can give this detail).

2.8 **Statutory Default Work**

- 2.8.1 Where work is carried out in default, reasonable costs of the work are recovered i.e. the officers' time (at their respective hourly rates) plus the costs associated with the work necessarily required from third party agents such as locksmiths or vehicle recovery contractors.
- 2.8.2 It would also include any statutory fees and daily charges that are applicable. It is proposed to charge £135 (previously £120) for administration costs for invoices. This work is undertaken by a GR4 officer, and the costs reflect both the raising of the invoice and chasing up and close down of invoices that are paid.
- 2.8.3 The total time of this is estimated to be 1½ hours on average per invoice. Officer time relating to seizure of sound equipment is charged at a fixed rate of £145 (currently £130). This is designed to minimise the likelihood of seized equipment not being reclaimed by owners, which would potentially result in excessive/on-going storage and disposal costs for the council that may not be rechargeable.

2.9 Attendance at Exhumations

- 2.9.1 It is proposed to increase the fixed fee per from £400 to £450 to be received in advance of an exhumation (Tax Code A8 applies no VAT as only a local authority can oversee exhumation). This is inclusive of early starts and completion of documentation before and after such work. If human remains are to be added to an existing grave (and the above exhumation cost has been paid), this will be charged at the hourly rate for a GR5 officer, otherwise it will be the same as the exhumation cost.
- 2.9.2 New Proposal: Where large numbers of exhumations are to be undertaken on one site, as part of ongoing ground works project, an appropriate reduction has been proposed. The rationale for this is that the pre work is the most time consuming element of the exhumation and therefore a reduction is applied to larger projects.
 - £450 per person for 1 to 10 remains.
 - £300 per person for 11 to 30 remains.
 - £225 per person for 31 remains and over.

Specified costs are for each person to be exhumed.

2.10 Licences for the Distribution of Free Literature

- 2.10.1 The three areas of the city which are designated as consent areas for the distribution of free literature are: the City Centre, Digbeth and Hurst Street. The current charge for consents is £305 and it is proposed to increase this to £336. The income supports the implementation and enforcement of this consent regime and this avoids putting any further burdens on businesses advertising in the City by way of free literature.
- 2.10.2 Under the legislation local authorities may only make reasonable charges for setting up and enforcement activities within the consent zones and the consent

zones are designed to prevent the defacement that can be caused by discarded material. All of the receipts from the scheme are reinvested in its implementation, operation and enforcement and no charge can be levied for clear-up costs. It is proposed that the charge for replacement consent cards is increased from \pounds 53 to \pounds 59. (Non-Business activity VAT exempt (Tax Code A8 applies)).

2.11 **Private water supply monitoring**

2.11.1 New Proposal: Local authorities must carry out risk assessments of larger private water supplies (>10m³ per day or part of a commercial/public activity) and monitor them regularly, including the carrying out water sampling. The Private Water Supplies (England) Regulations 2016 allows local authorities to charge for these services up until set maximum amounts. We currently have two private water supplies in Birmingham. It is proposed that charges for the following works are introduced. (Non-Business activity VAT exempt (Tax Code A8 applies))

REVIEW OF CHARGES 2024/2025 - ANIMAL WELFARE

2.12 Stray Dog Charges

- 2.12.1 The statutory charge prescribed under the Environmental Protection Act 1990 (the Act), where dogs are claimed from the contracted kennels or where dogs are returned directly to their owners is £25 and cannot be altered.
- 2.12.2 The Act also permits local authorities to charge dog owners for all the costs incurred by the seizure and detention of their dog if seized as a stray. We will continue to make an additional £10 charge per dog to cover these costs and continue to charge dog owners all other associated costs, which may include out of hours kennelling charges, veterinary fees, as well as additional officer time, where applicable.
- 2.12.3 We will charge £108 for dog handling services, in respect of restraining or removing dogs for example at an eviction or forced entry. Where the attendance on site extends beyond an hour additional time spent will be charged at GR3 per hour or part thereof. Any additional Dog Wardens that need to attend for multiple or large / difficult dogs, will be charged at an additional GR3 per officer per hour. Non-Business activity VAT exempt (Tax Code A8 applies) for all Public Services, however for private businesses VAT will be applied at relevant rate.
- 2.12.4 Where officers carry out assessments of dogs kept by any person looking to adopt or foster a child, it is proposed to charge the officer's full hourly rate from the start to completion of the assessment, this includes travel time and providing a report on the suitably or otherwise of any dog(s) kept by the potential carers to the adoption/fostering team. (Non-Business activity VAT exempt (Tax Code A8 applies)).
- 2.12.5 Where officers carry out work on behalf of social services involving the removal of animals where their owners have been admitted into hospital or found to be deceased, there will be a charge of £108 to attend and remove animals and a further GR3 grade for the time taken to relocate the seized animal to a kennelling facility and back to their normal duty. Officers hourly rate (GR3) or part thereof will be charged for any subsequent visits required. Office activities (GR4) will be charged at the officer's hourly rate or part thereof. (Non-Business activity VAT exempt (Tax Code A8 applies)).
- 2.12.6 Officers provide a stray dog collection service for Solihull Metropolitan Borough Council. It is proposed to charge £84 to collect and impound a stray dog or return it to its owner, this is based on a GR3 officers time at 1.5 hours per attendance. Should there be any additional requirements in terms of time or two officers needed, this will be charged in addition at the officer's standard hourly rate. Solihull pay directly for all veterinary and kennelling costs (Non-Business activity VAT exempt (Tax Code A8 applies).

2.13 Animal Welfare Licensing

- 2.13.1 The Animal Welfare (Licensing of Activities Involving Animals) (England) Regulations 2018, allow for licences to run for 1, 2 or 3 years. Licence fees must reflect this and the need for a separate application and annual fee. The length of a licence is determined by a 'star rating' of premises, which must be applied by the inspecting officers following inspection and in consideration of previous compliance history. There are also provisions to allow licenced premises to apply for a variation to their licence and request additional inspections.
- 2.13.2 The tables below identify animal related licensed premises and associated reviewed fees. The proposed fees are in-line with charges made by other local authorities and have been based on the average times taken by officers undertaking this work. The yearly licence fee remains unchanged, but there is a small increase applied to all application fees. The reason for the small increase, is that we have a number of non-complaint businesses which we are trying to bring into compliance. An application has been made to the medium-term financial plan for additional staff, as the licensing work has increased as has the enforcement work around licensing. Significant increases in the licence fees are likely to lead to more non-compliant businesses and put an even greater strain on our services. There is a further increase to the application fees in respect of a licence for Hiring out Horses, to reflect the inspections that must be carried out yearly despite them receiving a 3-year licence. The proposed charges as follows.

REVIEW OF CHARGES 2024/2025 - REGISTER OFFICE

3.0 Relevant Background

- 3.0.1 In reviewing these fees and charges, officers from the Division have considered:
 - The budget strategy for 2024/25
 - The pressures that are being experienced by the event and hospitality industry as a result of the Coronavirus Pandemic.
 - Fees and charges levied by neighbouring local authorities.
- 3.0.2 Where applicable, prices for 2025/26 have also been included. This is principally to allow for advanced booking and payment for ceremonies.
- 3.0.3 Some fees relate to services that are traditionally booked well in advance for which the fee will already have been taken.
- 3.0.4 The Registration Service provides several non-statutory services; however, these are in competition with neighbouring Local Authorities and so market sensitivities are considered when setting the fees.
- 3.0.5 Where the recommended fees 2024/25 are reduced, this is in response to competition and to support the service in being commercially viable. The same applies for fees that have a recommended zero increase, particularly where Birmingham are shown to apply higher fees than neighbouring authorities.

3.1 Approved Buildings

- 3.1.1 Birmingham City Council has responsibility for approving non-religious venues for Civil Marriage and Partnerships. Some fees relate to services that are traditionally booked well in advance. For these services the fees are set out for more than one financial year in the table below.
- 3.1.2 There are only two approved premises that have licences due to renew in 2024/25. The fees for new applications have been held at the 2023/24 rate (zero increase) to attempt to attract from new venues, albeit that these fees are still relatively high in comparison to neighbouring authorities. The proposed fees for 2025/26 have increased by 5% as this is considered sustainable within the current market.

3.2 Register Office Ceremony Suite

- 3.2.1 Holding the ceremony in Birmingham is not statutory and the Registration Service faces strong competition from neighbouring Local Authorities and other business premises. The geographic location and surroundings of the Register Office have an influence on the number of couples opting to use the ceremony suites for weddings and civil partnerships, with lower numbers than in previous years.
- 3.2.2 Ceremony Room 3 has the largest capacity of the three ceremony rooms but the trends are indicating that this is least used of the three rooms, supposedly due to decreasing size of wedding parties and couples opting to use alternative venues that accommodate similar numbers but offer additional facilities.
- 3.2.3 Maintaining the cost at a competitive level may increase uptake and this is the reason for a recommended zero increase in 2024/25, with a suggested 5% increase for 2025/26.
- 3.2.3 Statutory fees are set nationally by General Register Office and not by Licensing and Public Protection Committee. They are however provided for information.

- 3.2.3 By setting the fees so far in advance it allows couples, wishing to marry, to plan and budget ahead with confidence, the fee to be paid is the one in force on the day of the ceremony.
- 3.2.4 All ceremony suite fees are subject to room availability.

3.3 Attendance at Approved Premises

- 3.3.1 Fees for registration staff to attend a ceremony taking place at one of the City's approved venues are also set out for more than one financial year for the same reason as above.
- 3.3.2 The fee for attendance on a Public Holiday has been brought in line with the fee for weekend attendance to encourage take up. A slightly increased fee for attendance on Fridays, compared to other weekdays is also being introduced and is in line with some other authorities, due to increased popularity for Fridays.
- 3.3.3 The proposed zero increase is to maintain the competitiveness of the service in comparison to neighbouring authorities and an attempt to encourage couples to use venues and businesses within the city as opposed to choosing venues outside of the city.

the individual would need to apply to the Home Office to request a change of district. The main competition/market sensitivity therefore is the price differential between the statutory ceremony and the private ceremony. An increase of 10% has been applied to these fees.

REVIEW OF CHARGES – CORONER'S SERVICE 2024/2025

- 4.1 Fees that are chargeable are set out nationally in the Coroners Allowances, Fees and Expenses Regulations 2013. There are nationally set at:
 - 1. After inquest, a document disclosed as a paper document is charged at £5 for a document of 10 pages or less, with an additional 50p payable for each subsequent page.
 - 2. A fee of £5 per document where it is disclosed in any form other than email or paper i.e. CD copies of inquests.
 - 3. For a transcription of an inquest of 360 words or less the fee is £6.20, 361-1,439 words is £13.10 and 70p for every additional 72 words or part thereof.
- 4.2 The only locally set fee is the search fee for archive documents. It is proposed to increase the fee to £78 per hour or part there of (Cost of a GR4 officer plus 10%).

REVIEW OF CHARGES – STATUTORY TEAM 2024/2025

(Acivico -Building Consultancy)

- 5.1 The, Statutory Team, which is part of Acivico (Building Consultancy) Limited, carry out a range of professional surveying services for both internal and external client groups that are responsible for property portfolios. The scope of services includes the carrying out of technical functions in support of the discharge of the Council's Building Control allied legislative requirements as detailed in The Building Act 1984 and the administration of demolition contracts required to facilitate the Council's regeneration targets. The group also carry out a variety of enforcement duties where full cost recovery is undertaken when the legislation allows.
- 5.2 The work is normally charged on an hourly basis. The current (2023/2024) charge is £100.00 per hour, and it is proposed that this fee will increase to £110.00 per hour. An increase in the rate is required to cover rising costs and ensure the service is not carried out at a loss. The revised rate recognises that the work is carried out by a mix of grade 5, 6 and a small number of grade 7 surveyors and is therefore a composite rate. The rate is still in line with other professional services carried out within the council (see rates proposed on page 3 item 4.3) and is very competitive with regards to the private sector. The increase is necessary to address the increased cost of labour, increases in other on-costs and the necessity to maintain sufficient resources to handle the Council's requirements.
- 5.3 The charge levied in respect of Private Demolition Notices, which is a fixed fee per notification, is currently (2023/2024) set at £305.00. It is proposed to increase this fee in line with the increases proposed in paragraph 5.2. Therefore, the new fee will be £335.00.
- 5.4 The charge in respect of notices for temporary grandstands, which is required under the West Midlands County Council Act 1980 Section 39, is based on cost recovery in line with the hourly rate for the Statutory Team as above and it is proposed to revise this rate to £110.00 per hour as well.
- 5.5 Work carried out indicates that, within the limitations of operating within a competitive market and statutory framework, the fees proposed should maximise income to the City Council through Acivico as well as providing good value for money to Acivico customers.

THE IMPACT OF EMPTY PROPERTIES AND THE ROLE OF PRIVATE RENTED SERVICES

- 1. <u>Summary</u>
- 1.1 This report sets out the work of the Empty Property Team (EPT) within the Private Rented Service. The service aims to bring empty properties back into use through informal means where possible, but also has a range of legislative powers if needed. The report details the enforcement used and highlights the collaborative working across different Council teams to bring properties back into use.
- 1.2 The Empty Property Strategy 2019 2024 (appendix 1) provides detail of the Team's aims and objectives.
- 2. <u>Recommendation</u>
- 2.1 That the report be noted.

3. Background

- 3.1 An empty property can have a detrimental impact on the local community. Once they fall into a state of disrepair they can attract anti-social behaviour, vandalism, pest and vermin infestation, and can cause damage to neighbouring properties. Nationally, long term empty properties have risen by 12556 to over 261,000 in 2023. This is against a backdrop of increased demand for homes and a rise in families in temporary accommodation.
- 3.2 The Empty Property Team (EPT) has been established to bring empty properties back into use. Officers within the team have an excellent understanding of the housing issues for the area and ensure that they provide a customised service to meet the needs of local residents.
- 3.3 The Team works to the Council's Empty Property Strategy 2019-2024 which sets out the key objectives that will be met for that period.
- 3.4 Bringing empty properties back into use involves a range of powers available to the Council.
- 3.5 The range of legislation includes:
 - Sec. 215 Town & Country Planning Act 1990
 - Sec. 29 Local Government (Miscellaneous provision) Act 1982
 - Sec. 17 The Housing Act 1985
 - Sec. 77 The Building Act 1984
 - Sec. 78 The Building Act 1984
 - Sec. 29 The Local Government (Miscellaneous Provisions) Act 1982,
 - Sec. 17 Public Health Act 1961
 - Sec. 4 Prevention of Damage by Pests Act 1949
- 4. The Process for Bringing Empty Property Back into Use
- 4.1 The service has developed strong links with community groups, the Police and emergency services. Birmingham has also played a leading role in the West Midlands Empty Property Officers Group and the Empty Homes Network. This has enabled us to receive information on empty properties from a variety of sources, including directly from residents.
- 4.2 On receipt of a notification of an empty property, desktop intelligence is undertaken to identify the owner of the property. This will include using the council's own information databases and external data. The owner will be contacted to inform that the authority has been advised about the empty property, and to ask what future plans the owner has for the property.

- 4.3 Where owners are not forthcoming, a visit is made to the property to ascertain the condition of the property. Often gardens are extremely overgrown and there is rubbish/fly tipping blighting the area.
- 4.4 The owner of the empty property is informed about the state of the property and are requested to undertake remedial work and bring the property back into use. They are also informed that if they do not complete the work then the Council may serve them with a legal notice to execute the work and if it is not complied with, then the Council may undertake the work in default and invoice them for payment. If the owner does not pay the cost, then a charge is registered against the property at Land Registry.
- 4.5 Sometimes it is not possible to find the owners of the property as the details may not be on Land Registry or other data sources. In some cases, Officers work with genealogist/tracing agents to identify these owners.
- 4.6 The service approach is to educate and encourage owners to bring properties back into use. However, there are some owners who will not cooperate and the properties continue to deteriorate, which severely impacts the amenities of the area, neighbouring properties, potentially attracting vandalism and anti-social behaviour. In some cases, the buildings are not secure which can encourage ingress which may be a security or fire risk to adjoining properties.
- 4.7 The authority is able to make use of its enforcement powers, which can include making a building safe and secure. Ultimately, where necessary we can use compulsory purchase order (CPO) powers to acquire such properties. Where an owner objects to their property being compulsory purchased, the outcome of the CPO can be decided through a Public Inquiry. Once the CPO is confirmed the properties are sold at auction after which the owners are entitled to compensation which is paid from the proceeds of the auction less any expenses incurred by the Council. The compensation paid to the owner is based on the valuation of the property when it was vested to the Council. The Council holds in reserve excess funds acquired following the sale of properties at auction.

5. <u>The picture in Birmingham</u>

5.1 Council Tax collects and collates the data on empty residential properties in the City. The service has access to this information and is able to drill down to identify family sized properties. As of November 2023, the total empty properties were 14,778. Analysis of the data shows that 10,417 properties would be classed as family accommodation.

5.2 Whilst we will always deal with properties causing a high level of nuisance to the locality, our priority for bringing property back into use is to concentrate on family sized accommodation which have been empty for at least two years or more. Sifting of the data can identify family size accommodation, as detailed Table 1 below:

5.3 During the five-year period of the Empty Property Strategy the target is to bring 350 properties back into use on annual basis. Table 2 below shows how the service has achieved against the target each year. In 2020/2021 and 2021/2022 the target was reduced due to the Covid pandemic, the service exceeded the target despite the Covid restrictions. Due to our work, contrary to the national picture, in Birmingham the number of long-term empty homes is marginally decreasing.

6. Examples of Successful Outcomes

6.1 Witton Lodge Community Association (WLCA)

Witton Lodge Community Association is a landlord and community organisation. Its aim is to provide affordable high-quality homes to support the communities they serve. Where an empty property is identified within the association catchment area, and the owner is agreeable, a referral is made to WLCA. Following on from that over 100 letters have been sent to owners of empty properties informing them of the assistance the Association could provide, resulting in the reduction of empty properties in that area. 6.2 This property in Kings Heath was a deceased estate. The team used its powers under Section 215 of the Town & Country Planning Act to improve the external condition. The beneficiary would not engage in any efforts made by the Council to bring the property back into use. After many years of neglect, vandalism and complaints received, the Council successfully obtained a CPO and the property was put forward for Auction and was bought. The house has now been fully renovated and restored to a family home.





6.3 This bungalow was abandoned, left unsecure and neglected with an abandoned car in the garden by the owners in 2018. After considerable investigation the team successfully traced the owners and engaged with them. They agreed to put the property on the market, which was bought by a neighbour, who has fully cleared and renovated this home in 2023.



6.4 This case in Edgbaston began in 2021 when the tenants had left the property and the landlord had not received the keys. After liaising with the team, the keys were recovered and returned to the owner. Following engagement with the landlord regarding the Empty Property Strategy and the potential for further action, the landlord put the property on the market, and it was bought, renovated and reoccupied in 2023.



7 Future Steps with Empty Properties

- 7.1 The current Empty Property Strategy will end in 2024. There is ambition amongst the service to use all the available powers, including management orders, to increase the supply of family size accommodation, and any future strategy will be developed with this in mind.
- 7.2 Empty Dwelling Management Orders (EDMOs) allows authorities to take over most residential private properties that have been empty for more than six months. The property does not have to be run down or uninhabitable. Once it has been unoccupied for more than six months it may be enough to allow an EDMO to be made.
- 7.3 The Authority will need to obtain approval from the independent Residential Property Tribunal before they can make an interim EDMO. Where an EDMO is awarded against a property, the Council does not have ownership of the property. The owner loses the right to manage the property and the Council would be responsible for the property management which can be for up to a maximum period of 7 years.
- 7.4 Before this power can be implemented, we are in the process of seeking a service partner to contract the housing management element. Making use of this power will help to increase housing for people in housing need and also increase the income from Council Tax.
- 7.5 The service is also developing a strategy to implement Enforced Sales. The benefit of this is that it excludes the need for any compulsory purchase proceedings which can be financially challenging. Under The Law of Property Act 1925, this gives the local authority powers to recover costs it has incurred through works in default and the owner of the property has failed to pay for the work. The benefit of using this procedure is that following the sale of the property, the Council can take its money from the proceeds of sale before any other person.

7.6 Lendology;

- 7.6.1 Often owners of empty properties do not have the financial means to refurbish their properties. Lendology is social enterprise lender who work with local authorities to provide access to low-cost loans to refurbish properties. The organisation is FCA regulated, and owners are only able to borrow money they can afford to pay back. Once a loan is approved, following a formal agreement between the owner and the organisation, a title restriction is place on the property with Land Registry.
- 7.6.2 Local Authorities agree to provide seed funding to lend to owners in their boundary. The amount of the seed funding is dependant of the size of the local authority. The loans are recyclable, as loans are paid back with interest this is made available to offer further loans. The organisation works with 15 local authorities including Bristol and provides an administration function for a further 17 councils who have their own scheme but have contracted Lendology to collect the loans on their behalf.
- 7.6.3 In the new year Lendology will be invited to give a presentation on their work and the benefits to a local authority. Local authorities who currently work with them will also be contacted to learn from their experience which will help to identify if this would a scheme that would be beneficial for Birmingham.

8. <u>Implications for Resources</u>

- 8.1 The work of Private Rented Services is delivered within the resources allocated. Where works are required, the costs are recovered from property owners or via charges on the property. The authority has a capital receipts fund for compulsory purchases and refunds, this is currently in surplus.
- 9. Implications for Policy Priorities
- 9.1 By bringing empty properties back into use, increases the supply of family sized accommodation and contributes to one for the City's strategic outcomes; A Safe Birmingham: through a focus on making the city safer, safeguarding vulnerable citizens, increasing affordable housing, and tackling homelessness.
- 9.2 The service works across council Directorates and with external organisations to achieve this objective.
- 10. Public Sector Equality Duty
- 10.1 Equality issues are accounted for during all activities carried out by officers.

1. Foreword

Like most major cities in Britain Birmingham is faced with an acute and ongoing housing shortage. This gives rise to increased homelessness and housing affordability problems for many people.

Empty properties seriously affect the lives of people in the vicinity and have an adverse impact, driving down values around the problematic property. They attract vandalism and anti-social behaviour and are an unnecessary drain on public services.

Though empty property numbers have declined since Birmingham City Council published its first Empty Property Strategy in 2003 there are currently approximately 9,900 private sector empty homes in the city. This strategy aims to bring more empty homes back into use providing good quality, affordable housing to meet the evidenced housing need in the city.

At a time when local government resources are decreasing it is vital we make best use of available resources. The strategy and action plan that supports it outline how we propose to do this.

Empty homes are not the whole answer to the current housing crisis but government and local authorities cannot ignore their potential and the need to ensure that owners are both encouraged and, where appropriate, required to unlock the potential of this wasted resource.

The success Birmingham has had in tackling empty properties to date has been considerable. We aim to continue this, to ensure the city has the largest, highest quality stock possible to accommodate both its existing and future citizens.

2. Key Objectives

In developing the strategy we have identified a set of objectives we wish to achieve.

- Have a coordinated approach to empty property work to ensure the broadest corporate ownership of the need to address the blight of empty homes
- Ensure delivery of the Empty Property Strategy is linked with the Council Plan 2018 to 2022, the Birmingham Development Plan, the Housing Birmingham Strategy and the Homelessness Prevention Strategy
- Further publicise empty homes initiatives
- Provide encouragement and practical support to empty property owners
- Further develop and adopt enforcement procedures
- Enhance our approach to returning empty homes to use by continuing to work and share experiences with other local authorities
- Utilise funding available to bring empty homes back into use and provide affordable housing solutions across the city for people in housing need.

3. National Context

High levels of empty properties have an adverse impact on communities and the environment. Returning empty homes to use assists in reducing homelessness and overcrowding pressures. It also tackles blight, the fear of crime and in the post Grenfell Tower era, fire safety.

In addition to the direct benefits to families and communities, bringing empty homes back into use plays an important role in meeting the need for new homes and the government's target of delivering 300,000 new homes a year by the mid-2020s.

Alongside measures to increase council tax costs for owners allowing their property to stand empty, the Government has updated local planning polices to ensure they support the development of under-utilised land and buildings.

New Homes Bonus

New Homes Bonus is a grant paid by central government to local authorities for increasing the level of housing. The bonus is based on extra Council Tax revenue raised from new build homes, properties converted into homes and long term empty properties brought back into use. There is also an additional payment if the property is an affordable home.

The scheme is intended to act as an incentive for local authorities to have effective empty homes strategies. Rewards will only be paid for a net increase in housing, meaning local authorities could miss out on rewards for new homes built if empty property levels are allowed to increase.

Birmingham's New Homes Bonus payments for 2017/18 totalled £14.19m. It's clear that at a time when local government resources are diminishing the benefits BCC can accrue from the New Homes Bonus remain significant. It is imperative therefore we seek to maximise the value of the bonus payment.

4. Local Context and Analysis

Birmingham City Council Plan: 2018 to 2022

The Council has a vision for Birmingham as a great city to live in. It states:

'We want Birmingham to be a sustainable city of vibrant culture, flourishing neighbourhoods with good quality housing. A city with clean air, safe and clean streets and green spaces. We want to be a city where citizens have pride in where they live, have a strong sense of belonging and a voice in how Birmingham is run'.

To enable this the Council Plan identifies a number of priority outcomes against which success can be measured.

- Increasing the number of new homes completed in the city across a range of tenures
- Increasing the number of private rented sector properties improved as a result of local authority intervention
- Ensuring an appropriate number of homes built are affordable
- Minimising the number of households living in temporary accommodation.

Returning empty properties to use plays a major role in providing decent, long term homes for citizens.

Birmingham Development Plan 2031

By 2031 Birmingham will need an additional 89,000 homes for its growing population. Adopted in January 2017, the Birmingham Development Plan


sets out the statutory planning framework to guide decisions on development and regeneration to meet that requirement. Returning empty properties to occupation can make up a significant number of the additional homes needed.

Housing Birmingham Strategy

The Housing Birmingham Strategy is the Council's housing strategy and is owned and managed by the Housing Birmingham Partnership. The partnership is open to all parties with an interest in housing in Birmingham and includes social landlords, private landlords and third sector organisations. The strategy seeks to address empty homes in terms of homelessness reduction, improving stock condition and building neighbourhood pride.

Council Tax records indicate that at June 2018 approximately 3,000 of Birmingham's 9,900 empty properties had been unoccupied for less than six months. Figure 1 indicates that in terms of longer term empty homes Birmingham's percentage figure rates as average compared to other large densely populated cities in England.

Breakdown of Empty Properties by Period Empty

Figure 2 illustrates how Birmingham's 9,900 empty homes break down in terms of length of time empty. The 3,000 empty less than six months represents 30% of the total number of properties empty and 1.3% of the city's total private housing stock.

A further 3,500 had been empty for less than two years and as a cumulative total, just under 66% have been empty for less than three years. Numbers continue to drop off steadily after three years. Numbers only rise again where properties empty for nine years or longer have been banded together. This figure includes cases where ownership of empty homes is unknown and difficult to establish.



Empty Property Numbers by Period Empty


Distribution of Privately Owned Properties Empty Longer than Six Months by District

Birmingham has a diverse housing market divided into ten districts. As the level of privately owned housing stock varies considerably between districts it's useful to look at empty properties in individual districts as a percentage of their overall private housing stock.

At June 2018 the city wide average for private sector properties empty longer than six months was 3.1%. Four of the city's ten districts (Ladywood, Edgbaston, Northfield and Hall Green) have an above average empty

property rate. These four districts contain 35.7% of the city's private housing stock but account for 46.5% of its privately owned properties empty for longer than six months.

Fig 3 illustrates the per cent of empty stock within each district.

5. Achievements 20013 to 2018

The Council's Empty Homes Team have been particularly focussed on affordable, family size properties in areas of the city where a high incidence of empty homes and overcrowding has been identified. Precise targets included:

- Reducing the number of problematic and long term empty properties in the city by 1,158.
- Ensuring 60% of properties returned to use citywide were family sized homes (three or more bedrooms) in the more affordable Council Tax bands A-C.
- Ensuring 40% of all properties returned to use were in the housing market areas of East Birmingham and North West Birmingham areas of the city where overcrowding and empty property levels are high.
- Investigation of all reported empty properties and proactive investigation of all identified long term empty properties.

The team has exceeded strategy targets, returning 1,647 problematic and long term empty homes that are unlikely to have been returned to use without intervention. Within the headline target 63% of properties had three bedrooms or more and were in Council tax bands A to C. 37% were in the East and North West Birmingham HMAs.

The team also utilised enforcement powers to secure 198 dwellings to prevent unauthorised entry and ensure they are free from visual nuisance affecting the wider neighbourhood. In addition they have also been successful in securing Government funding to lease and repair 20 previously long term empty properties for use as additional social housing in the city.

Partnership Working

The value of partnership working in effective local government is well known. In addition to exceeding the headline strategy target the team have developed strong links with community groups, the Police and emergency services. Birmingham has also played a leading role in the West Midlands Empty Property Officers Group and the Empty Homes Network.

Empty Property Council Tax Restructuring

To further incentivise the occupation of empty homes Birmingham introduced changes in the way its council tax charges operate in relation to empty properties. Discounts relating to unfurnished properties or properties in need of structural repair have been abolished. Where a property has been empty and unfurnished for two years a council tax charge of 150 per cent is now applied.

The Government has recently announced that with effect from April 2019 local authorities will be free to charge up to 300% Council Tax on similarly qualifying empty properties. BCC Revenue and Finance officers have indicated they will be recommending the introduction of the full 300% rate at that date.

6. Delivering on Aims and Objectives 2019 to 2024

Birmingham's Empty Property Team has a strong track record in returning long term and problematic empty homes to use. For the lifetime of the 2019-24 Strategy we aim to ensure a minimum of 350 empty properties are returned to use each year. This is a challenging target equating to over 25% of the number of properties currently unoccupied for longer than six months in Birmingham.

Proactive Advice, Assistance and Enforcement

In the first instance owners of problematic or long term empty homes are contacted and asked about their future intentions for the property. General advice is offered including signposting to resources to support the owner. Enforcement action is only pursued where less formal, lower level approaches have made no impact or where a property is a hazard to public health. Where the council considers enforcement action to be appropriate the approach will be fair, impartial and incremental.

Enforcement powers at our disposal include:

- Town & Country Planning Act 1990 (Section 215) A notice can be served on the homeowner where a home is considered to be 'detrimental to the amenities of the neighbourhood'.
- Local Government (Miscellaneous provision) Act 1982 Under Section 29 the Council has the power to secure empty homes against access, where there is considered to be a danger to public health.
- Enforced Sale (Law of Property Act 1925) The use of enforcement actions on empty properties can result in the gradual build up of debt if the work is carried out in default of the owner failing to comply with the enforcement notice. Where a reasonable charge has been registered against the property it is possible to force the sale of the property to recover that debt.
- Compulsory Purchase Order (CPO) S17 Housing Act 1985 where owners cannot be traced, or are unwilling to bring their property back into use, the Council can seek to compulsory purchase a property and then sell it on the open market.
- Empty Dwelling Management Orders (EDMOs) The Housing Act 2006 gives local authorities power to apply to the Residential Property Tribunal for an interim management order which may lead to compulsory leasing of the property for a fixed period of time.

As in the 20013-18 Strategy the team will place emphasis on some specific strategic areas and property types;

Affordable and Family Sized Homes

As part of a wider, citywide focus on delivering affordable, family sized homes, Empty Property Officers will continue to ensure that a minimum of 60% of properties returned to use have three or more bedrooms and are in the most affordable A-C Council Tax bands.

Tackling Overcrowding

The Survey of English Housing uses a 'bedroom standard' as an indicator for occupation density, allocating a number of bedrooms to each household according to the age, sex and marital status composition coupled with the relationship of the members to one another.

Data contained in the 2011 Census indicates that Birmingham's citywide average for households lacking at least one bedroom is 8.9%. Of the city's ten districts Ladywood (15.3%) and Hodge Hill (15.2%) stand out as the worst affected. For this reason we will ensure that 40% of all properties returned to use are in these two districts.

Strategy Action Plan and Supporting Actions 2019 – 2024

In addition to the numerical targets outlined in the Strategy Action Plan (Appendix A) a number of supporting actions are identified at Appendix B to support the continuous improvement of empty property work.

Strategy Review and Update

To ensure Empty Property Strategy delivery remains effective a full review will be undertaken each year. As well as monitoring progress against existing targets this will serve as an opportunity to revise strategy targets and supporting actions to reflect changing priorities. Appendix A: Outcomes – NB. TRADING STANDARDS FINALISED PROSECUTIONS BETWEEN APRIL 2023 TO NOVEMBER 2023

1. <u>Summary</u>

1.1 This report summarises the outcome of legal proceedings taken by the Trading Standards service between 1 April 2023 to 30 November 2023.

2. <u>Recommendation</u>

2.1 That the report be noted.

3. <u>Background</u>

- 3.1 The Trading Standards service delivers consumer protection and business support services in the areas of unfair trading investigations protecting vulnerable citizens from rogue traders and unfair commercial practices. Four key priorities have been identified for the trading standards service alongside the broad and varied work undertaken by the service.
 - (a) The prevention of supply of age restricted products to minors remains a key priority for both the Licencing and Public Protection Committee and the Trading Standards Service. In particular this year vape's and nitrous oxide received significant public interest.
 - (b) Acquisitional crime, such as counterfeit and unsafe products, continues to be an important aspect of work to support investment from legitimate traders.
 - (c) Unfair and misleading actions by rogue traders who target vulnerable adults is also a priority for the service, investigating builders that seek to exploit residents charging for unnecessary work or simply not completing work paid for.
 - (d) Targeted work looking at lettings agents, estate agents and landlords to protect tenants and potential renters from unnecessary and illegal fees and charges and illegal actions from traders operating within this sector.
- 3.2 Trading Standards has a toolkit of actions at its disposal such as
 - (a) No action.
 - (b) Informal Action and Advice.
 - (c) Formal Notice or order
 - (d) Seizure of goods and forfeiture Proceedings.
 - (e) Proceeds of Crime Applications.
- 3.3 Ultimately Trading Standards can seek to institute criminal proceedings that can be heard in the magistrates or crown court. The institution of proceedings is more likely to be taken for the following reasons.
 - (a) Situations where it is evident that a vulnerable individual or vulnerable group has been exploited.
 - (b) Obstruction of authorised officers of the service in the lawful execution of their duties.
 - (c) Offences involving deceptions, fraud or negligence.
 - (d) Wilful disregard for the law.
 - (e) Risk to public health /safety
 - (f) Public nuisance
 - (g) Categories of offences which create significant financial burden to the taxpayer or impact at a community-wide level or that undermine public/business confidence in the City.

3.4 A number of instituted proceedings have been concluded where the sentence for the convicted defendant has been a custodial sentence rather than a fine.

4.1 Cases Finalied

5. Implications for legal services

5.1 Legal services are a key partner and are involved in the matters listed in section 4, providing advice, support and presenting matters at court. When a decision is made to institute proceedings, Legal service provide oversight, case management and expert legal support to ensure cases are progressed and that any necessary legal input is provided in a timely manner.

6. Financial Implications

- 6.1 Trading Standards operates within budget and any legal costs recovered are utilised by the service to undertake investigations and projects in prioritised areas.
- 6.2 Whilst costs cannot be a consideration to ensure justice is served, matters that are referred to the crown court due to the seriousness of the offending tend not to provide for cost recovery. It is more likely that compensation for the injured parties will be prioritised over the costs incurred by the prosecuting authority. Further, where the investigation is concluded at crown court land the defendants is convicted, it will be an expectation the authority will consider proceeds of crime investigations and seek restraint of assets.

7. Implications for Policy Priorities

7.1 Enforcement action taken against rogue traders protects legitimate traders from unfair trading practices and increases the likely hood of investment from those business that are not competing with "fly by night" operatives that undermine consumer confidence and the local economy by their practices.

Trading Standards is a key service in tackling rogue traders looking to take advantage of vulnerable residents and individuals and seeking to exploit opportunities that arise within the ghost market.

7.2 Trading Standards Service supports the Regulation and Enforcement Mission Statement: Locally accountable and responsive fair regulation for all – achieving a safe, clean, green and fair trading city for residents, business and visitors. 7.3 Prosecution and removal of rogue traders will help and support communities to flourish.

8. <u>Public Sector Equality Duty</u>

8.1 The actions identified in this report were taken in accordance with the Enforcement Policy of the Licensing and Public Protection Committee which ensures that equality issues have been addressed.

3. <u>Results</u>

- 3.1 During the months of September and October 2023, the following cases were heard at Birmingham Magistrates Court, unless otherwise stated:
 - 319 Environmental Health cases were finalised resulting in fines of £215,624. Prosecution costs of £73,134.80 were awarded.
 - One Licensing case was finalised resulting in a fine of £1,000. Prosecution costs of 2,000 were awarded.
 - Two Trading Standards cases were finalised resulting in a 12 month community order together with 75 hours of unpaid work and a fine of £480. Prosecution costs of £500 were awarded.
 - Five Waste Enforcement cases were finalised resulting in fines of £1,938 together with a 12 month community order and 25 RAR days. Prosecution costs of £6,740.75 were awarded.
 - Appendix 1 details all prosecutions finalised during September 2023 by ward.

 - Appendix 4 lists the enforcement activity undertaken by the Waste Enforcement Team from April 2023 to March 2024.
 - Appendix 5 lists Penalty Charge Notices issued by Parking Enforcement specifically for individuals parking on Taxi Ranks across the City from April 2023 to March 2024. Please note this does not include other parking tickets issued anywhere else in the City.

4. <u>Consultation</u>

4.1 The Enforcement Policy that underpins the work identified in this report is approved by your Committee. The policy reflects the views of the public and business in terms of the regulation duties of the Council. Any enforcement action[s] taken as a result of the contents of this report are subject to that Enforcement Policy.

5. <u>Implications for Resources</u>

5.1 Costs incurred in investigating and preparing prosecutions, including officers' time, the professional fees of expert witnesses etc. are recorded as prosecution costs. Arrangements have been made with the Magistrates Court for any costs awarded to be reimbursed to the City Council. Monies paid in respect of fines are paid to the Treasury.

5.2 For the year April 2023 to March 2024 the following costs have been requested and awarded:

Environmental Health (including Waste Enforcement cases) £202,729.55 has been requested with £171,443.55 awarded (85%)

<u>Licensing</u> £12,532 has been requested with £7,266 being awarded (58%)

<u>Trading Standards</u> £35,475.75 has been requested with £25,164 being awarded (71%)

5.3 For the months of September and October 2023 the following costs have been requested and awarded:

Environmental Health (including Waste Enforcement cases) £93,034.55 has been requested with £79,875.55 awarded (81%)

Licensing £2,468 has been requested with £2,000 awarded (81%)

<u>Trading Standards</u> £1,936.75 has been requested with £500 awarded (26%)

5.4 The following income has been received so far from the courts in 2023/24.

Licensing (HCPH)

£8,126.75 has been received.

Environmental Heath £95,634.33 has been received (including Waste Enforcement cases).

<u>Trading Standards</u> £218.82 has been received.

(Total £103,979.90).

5.5 This will not directly correlate to the values awarded in the same time period as individual cases are often cleared in instalments with the associated fines and court costs taking precedence over the settling of BCC legal costs. Therefore, income received may relate to cases from the previous financial year or earlier.
