Poverty and disadvantage is recognised as a cross-cutting theme of the children and young people's plan. In the economic situation in 2023 in England with the cost-of-living crisis, difficult situations faced by children, young poeple and families, are exacerbated with increased financial stress within households, which can impact on mental health and physical wellbeing, and could continue into the following years.

Combined with other factors, poverty

can heighten other vulnerability. This is a factor that will be carefully monitored and considered throughout the strategic actions of the children and young people plan.

It is well evidenced that crisis intervention is more costly than a preventative approach. Development and implementation of the strategic actions for the children and young poeple plan require place-based and whole system change. Our plan is about working together across the partnership. We face growing demand and pressures on our services and recognise that we must make sure that we collectively understand the needs of our city, combining resources and sharing data to plan how we meet needs most effectively.

The children and young people's plan has been developed through three phases of codesign. It involved combining information from research and consultation with children and young people in 2020 and 2023. Fact finding and research from partners throughout 2022, including 'think tank' workshops on priorities, and engagement with all sectors to develop the framework. Refinements were created through board meetings and system leader away day workshop. Schools and education settings have been involved in feedback on the framework, through the autumn of 2022. An additional survey with 900

children and young people in early 2023 tested and confirmed the framework, and added further voice and lived experience.
