## 5. CABINET MEMBER FOR EDUCATION, SKILLS AND CULTURE

(See document 2).

Councillor Jayne Francis, Cabinet Member for Education, Skills and Culture, Anne Ainsworth, AD for Skills & Employability and Symon Easton, Head of Cultural Development presented the item and answered Members' questions.

The following were among the main points the Cabinet Member raised in her presentation:

- There has been a reconfiguration of the directorate and Dr Tim O'Neill has been appointed as the Director for Education and Skills.
- BEP is commissioned up to the summer of 2020 for school improvement.
- There has been significant improvement in the School Admissions Service and there has been an investment of £120,000 for a new staffing structure. The redesign process will conclude by June 2019. There has also been an investment in the management systems to improve the experience of the families using the service
- School funding is a national issue and to alleviate the financial pressures some schools are closing early. The Cabinet Member has requested officers report back on which schools these are so the Council can work alongside them to help reduce the impact on the children's education.
- There have been significant issues with two local primary schools in recent months regarding a small group of vocal parents concerned about how equalities issues are being taught in schools. Alongside Cllr Cotton, Cabinet Member for Social Inclusion, Community Safety and Equalities, the Cabinet Member is working with parents, schools, media and local MPs to try and have a coherent message in support of those schools. The Cabinet Member together with Cllr Kate Booth, Cabinet Member for Children's Wellbeing, has visited the two schools to give support to the Head Teachers who have been under pressure. The Cabinet Member has also spoken at a conference for head teachers to talk about what as a Council we can do to be more visible and provide support to schools and significant work is continuing on this.

- They have appointed a Libraries Working Group of Councillors who are assisting
  with the review of the library service and they will be reporting over the remainder
  of the year.
- They are awaiting a response from the Millennium Point Trust regarding the proposal of the City Council to take on the lease of Millennium Point so they can sub-let to the Birmingham Museum Trust.
- Martin Green has been appointed as the Chief Creative Officer for the Commonwealth Games and will be responsible for the overall culture programme for the Commonwealth Games.
- The Cabinet Member felt that there is a more coherent dialogue with Commonwealth Games officers regarding the involvement of children and young people and there are real opportunities, such as volunteering.

In discussion, and in response to Members' questions, the following were among the main points raised:

- The Cabinet Member takes on board how organisations can interpret data, such as school funding and officers are looking at how they can improve data and understand the challenges.
- The 10 arts organisations that the Council funds have maintained a strong education and outreach programme. The Council commissions projects in communities and there is also available funding from other organisations.
- They are looking at a new strategy for employment and skills in Birmingham, bringing the services together and looking as to how the services contribute to improving employment and skills. It is expected that the performance information and targets will therefore change.
- Although the demand for the Admissions Service will be reducing (drop in birth rates etc) there are no plans to reduce the service as the redesign has been about improving the service.
- With regards to the suggestion that the Schools Forum decisions are reported to the Committee:
  - Officers will check the legal position as to whether decisions can be reported to the Committee.
  - o The Schools Forum is a public organisation and Councillors and the public should be able to see all the papers and the decisions that have been taken on the website. As per the good practice guide 'Local Authorities should ensure that the website is easy to find and accessible and it is good practice that papers are published a week in advance'. However, the Chair stated that the website is not up-to-date, as the papers for the March meeting are not on and January's meeting states 2018 and not 2019.
- Councillor Sambrook stated that some members of the Committee have previously expressed that how the committee has been set up and structured has not worked properly this year. The Cabinet Member has three Overview and Scrutiny Committees and the Committee has four Cabinet Member areas to look at. It was thought that this is disjointed and can get very complicated and does not assist with scrutinising. The Cabinet Member was asked her views on this and how it can be improved. The Cabinet Member stated that alongside her colleagues she liked to think they worked well together and shared information. However, Councillor

- Sambrook was not the first person to make that suggestion because there are huge areas of overlap and they will take those issues away and report back.
- An education strand for the Commonwealth Games has recently been established and the AD for Skills & Employability will be leading on this.
- The Knife Angel will be installed by the 8<sup>th</sup> May 2019 in Victoria Square subject to the survey for the foundation. There will be a programme around knife crime working with communities etc. Members suggested that schools are informed of this and this could be linked to an invite to a visit to the Council House.

#### 6. CHILDCARE SUFFICIENCY ANNUAL REPORT

(See documents 3 & 4).

Lindsey Trivett, Head of Early Years, Childcare and Children's Centres, Clare Nankivell, Data, Performance & Information Strategy Manager and Sarah Sinclair, Children and Young People Commissioning were in attendance.

Lindsey Trivett, Head of Early Years, Childcare and Children's Centres introduced the item and informed Members that the Council has a statutory duty to ensure there is childcare available for working parents and also sufficient early education places for all 3 and 4 year olds and some 2 year olds and because of the education aspect it has fallen under this committee. Also, they have to report annually to elected members as to what the sufficiency looks like and following this the information has to be available to parents. The report is still draft as they wanted Members' input before final sign off.

Clare Nankivell, Data, Performance & Information Strategy Manager undertook the presentation. In discussion, and in response to Members' questions, the following were among the main points raised:

- The Early Years Foundation Stage (EYFS) (statutory framework for children aged 0 to 5 years) requires all provision to be fully inclusive, so the Council and Ofsted have an expectation that provision should be fully inclusive for all children's needs. Birmingham has the Inclusion Support for Early Years (ISEY) funding system, where there is £1m set aside from the DSG for children who may not necessarily have an EHC plan but have additional needs. The funding is not always sufficient to fund the whole entitlement. However, there is some really good work across the sector being undertaken to support children with SEND.
- With regards to areas where there is an under or over supply, officers have looked at migration and movement across the city, for instance there is an oversupply in Edgbaston and deficit in Harborne, however, families in Harborne are using the provision in Edgbaston.
- The supply for the 2 year olds has been taken up by the Private, Voluntary and Independent (PVI) sector in the main because parents want to access more flexible provision than school settings provide. The implication is that because the children are settled in the settings, parents are then less likely to move them to a school nursery class. Raising awareness with schools on improving the school nursery offer is a key priority for officers.
- With regards to the Council's sufficiency and managing the market role, they
  are going to revise the current processes the Council uses, particularly the
  terms and conditions for early education funding and the process that is used
  when schools want to establish or reduce the numbers of their published
  admission numbers for nursery school age.
- One of the services they offer under the Early Years Support Service is support for home education where a child has additional needs.
- Consultation with parents over the next 12 months is a priority for the service so they can understand why parents are choosing to access or not access their early years entitlement.
- There has been a dip with the take up because they had a big system change with the Early Years Health and Wellbeing contract. However the early years networks are being re-established and they are working with the provider -Birmingham Forward Steps, to pick the work back up.
- They work with the Virtual School for children who are in care so they can access suitable provision.
