1. Purpose:

1.1 To consider a response to a Public Written Question (details included within section 3 of this report).

2. Recommendation

2.1 The Board is asked to consider the Public Written Question and respond accordingly.

3. Written Question Details

- 3.1 We would like to highlight an issue about access to COVID-19 testing raised at a recent #HealthNow Alliance meeting. #HealthNow is a partnership project between Crisis, Groundswell and Shelter that works to address health inequalities faced by people experiencing homelessness. In Birmingham, the #HealthNow Alliance meets monthly to discuss health issues and responses affecting people experiencing homelessness during the COVID-19 crisis. These meetings are attended by peers with experience of homelessness, healthcare commissioners and providers, representatives from Public Health and voluntary sector organisations.
- 3.2 Some Alliance members have raised concerns that homeless communities face system barriers to accessing COVID-19 testing and using the Test and Trace service. As experts by experience and representatives from local homelessness services, we came together to discuss alternative testing models that could overcome these barriers. Our suggestions include:
 - Supplying hostels with self-test kits and training staff to teach residents to self-test.
 - Provision of tests or self-test kits through day services, the Homeless Health Exchange, outreach services and other community hubs.

- Utilising #HealthNow peer researchers and peer advocates to consult with homeless communities about how testing/ Test and Trace would work best for them. Peers could accompany people to test sites or provide information about testing facilities.
- 3.3 We are encouraged to hear that our suggestions align with Public Health's plans. However, we would like to request the following:
 - 1. An update on the Public Health Plans for test and trace for people experiencing homelessness.
 - 2. A response to the suggestion that peers could carry out an exercise to rapidly collect views of local people.
 - 3. Confirmation that Test Kits will be provided to local hostels and day services and that training can be provided to support tests.
