1. NOTICE OF RECORDING/WEBCAST

3. DECLARATION OF INTERESTS

RESOLVED:

The action notes from the meeting held on 6th March 2020 were agreed.

5. COVID 19 UPDATE

(See document No 2).

Cllr Ian Ward introduced the report, noting the extraordinary situation that the Council has been confronted with. He said that the staff, management and members have done outstanding work and all members added their thanks. The Council has written to the Government asking that a business survival fund is started but a response has not yet been received.

In response to questions the following points were made:

- In relation to Business Rates Grants, the Leader noted that there was information on the website and guidance has now been issued. Applications will be invited from Monday.
- There was concern about the lack of transparency in decision-making during the
 emergency. Members emphasised that they were not questioning officer decision
 making in that time but felt that publication could have happened sooner. And it was
 also noted that scrutiny had had no role in the decision-making and there should be
 more involvement as future decisions are being taken.
- The former Gold Commander assured members that Directors were asked to involve Cabinet Members in decision making and set out the circumstances and reasons for the approach to decision-making, noting the volume and speed required for such decisions and the unprecedented nature of the emergency. All decisions are being collated for publication no later than the end of June.
- The Leader reminded members of the speed of response required and the need to redeploy staff, and publishing decisions had to come second to that. The Leader also noted that around 10% of council staff have been self-isolating. The Leader and Gold Commander have had daily meetings, and he paid tribute to Graeme Betts who stepped into the role of Acting Chief Executive and Gold Commander and has done an exceptional job. Cabinet meets informally twice a week and discussed matters collectively and happy to account to scrutiny for those decisions. One example is the advice on the gradual re-opening of schools.
- On further questioning on social care easements, members noted that they had
 found out through the media. The Interim City Solicitor undertook to liaise with
 officers to look at releasing the report. The Chair of Health Social Care O&S
 Committee made reference to a letter he and committee members had sent to the
 Chief Executive saying that members believed they should have been notified of the
 decision and that the length of time to publish the decision was not reasonable.
 There also needs to be a clear statement of scrutiny's role in an emergency.
- The chair said that a piece of work to do after the crisis is over is to review the council's response to learn any lessons.
- Graeme Betts noted that the activation of the emergency plan has been for an extended period and the level of risk was way beyond what we had encountered and "life and limb" decisions were being taken.

- Planning for a future increase in Covid-19 cases should be shared, including how members can advise their constituents.
- The Leader advised that the recovery was not about "going back to normal" in all aspects – there have been gains in air quality and need to work to a fairer city, as some have been more affected than others AS government amends the guidance and lifts the lockdown, there need to be plans about how people can move about the city safely.
- The Chair asked about public briefings, as the government currently do these daily.
 Where local information is required as it may be in the future- how will this be
 communicated effectively? The Leader answered that he will be discussing this on
 Monday, to ensure a close eye is kept on further outbreaks and communicating key
 information effectively. The Chair asked that views of members and the wider
 community were taken into account.
- With regards to sustainable transport, the council needs to look at how we ensure behaviour change to more sustainable modes. The Leader thanked public transport providers for providing free travel for NHS staff.
- Thanks were also given to IT officers for their work in getting all staff and members up and running with remote working.
- It was noted that local government and organisations can often respond more quickly, which also underlines the need to develop further the local structures within the city. The Leader noted that decisions had been devolved where possible for example in relation to the gradual re-opening of schools.
- Moves to a carbon neutral city were also discussed, and the importance of using the recovery to strengthen this. The Leader has asked for a paper on options for meeting the 2030 zero carbon target without further impoverishing communities.
 The Leader agreed that we want to see a cleaner, greener and fairer Birmingham.
- Other issues raised were concerns about people switching to cars when we want to
 encourage sustainable transport, but also the need to protect people and enforce
 social distancing, so as not to discourage people from coming into the city centre.
- There was a request to re-consider the number of people who can attend a funeral.
 The Leader said that, with changing guidance from government, policies are being reviewed.
- Scrutiny also needs to ensure it keeps an appropriate eye on "business as usual" work, e.g. Planning, and other major decisions that are being taken or planned e.g. on waste disposal.
- In response to questions about adult social care, Graeme Betts emphasised that the
 directorate does engage with the independent care sector; and Cllr Hamilton will
 look at membership of the Health and Wellbeing Board. Inequalities in health is
 something we should be putting more emphasis on and will do so as we come out
 of this crisis.
- The NEC have put forward a proposal to be a test bed for the re-opening of the leisure sector and plans for that are underway.

The Chair thanked the Leader for all his endeavours during this difficult time,
