#### 5. THE ACTIVE COMMUNITIES PILOT

(See document 3).

Mark Byrne, Leisure Project & Client Manager, Alexander Stadium and Steven Rose, The Active Wellbeing Society (TAWS) attended for this item and answered Members' questions.

The following were among the main points made during the presentation and discussion:

- The pilot is a partnership directly between Sport England, Birmingham City Council, Solihull Metropolitan Borough Council and TAWS.
- In December 2019 the Phase 2 Investment proposal was approved by Sport England Board:
  - o £7.358m of hard commitment.
  - £2.562 of in-principle commitment.
  - £9.92 out of £90m national funding pot.
- Active Communities is about removing the barriers, promoting resilience and doing the 'social knitting' to provoke active citizenship. Therefore:
  - Creating strong resilient communities.
  - Positioning sport and physical activity as a vehicle for bringing people together.
  - Re-connecting the fragmentation within deprived communities in the sub region.
  - Networked connected communities are made up of individuals who experience and exercise social agency.
- Active Communities have a host of touch points the committee could use to
  go out and engage with the community regarding the Commonwealth Games.
  The reach is broad and deep, as they are using their participatory methods,
  such as Active Streets and Active Parks. This is where conversations can and
  have been held and they will be doing this with the Future Parks Accelerator.
  Therefore, there are platforms that could be used and more details from the
  Committee would assist with the methodology.
- The areas for the pilot have been agreed with Sport England, however the learning and influence is intended to bring about system change, therefore there is opportunity to take the learning outside these geographies.

- In answer to the question as to how they will engage young people who are not in education, members were informed that the work reaches out to communities where they are, their street etc.
- Leading up to the Commonwealth Games TAWS are waiting to know more although they are primed and ready for this.
- The partnership agreed six priority areas and officers will feed back to Sports England the wish that these are expanded.
- This is a two year programme, however they can commit to deliver beyond this, especially as this is a system change and there will be a ripple affect into other areas.

#### **RESOLVED**

The update was noted and members requested.

- The rationale for areas being chosen by the partners [I've checked the 31<sup>st</sup> July 2018 Cabinet Paper and it states 'Six pilot areas across the City and Solihull have been identified as priority areas with the learning gained in these areas then being rolled out across the rest of the sub regions'].
- Share the piece of work that was done in Quinton that has informed the Active Communities pilot.
