Good afternoon

I refer to the variation application by the Greyhound to extend their live music hours by one hour to midnight on Fridays and Saturdays only.

After careful consideration, it is the view of Environmental Health that the change in hours is likely to result in the public nuisance objective not being met. The premises is in a residential area, with a significant number of houses being very close. Although there is no significant history of noise complaints at the premises, a complaint of late amplified music noise has been recently received and is currently undergoing investigation. The building has substantial windows and an entrance door on one façade and breakout noise is likely to be extensive, especially through the door, which would presumably be in frequent use.

As close neighbours of a local pub, it is reasonable that residents should expect some entertainment related disturbance, but the forward creep of hours is not considered to be reasonable in this location.

It has been brought to our attention that the license owner of The Greyhound Inn (Court Lane, Erdington, Birmingham, B23 5JX) have applied for a change to their licencing hours to play live and recorded music from 23:00 to Midnight on a Friday and Saturday.

This application has been poorly advertised and all of us who live adjacent to the Greyhound Inn were unaware that this application even existed. This is due to the notice being displayed out of sight.

The only reason this was brought to our attention is that the Greyhound Inn was playing music up to midnight on 16/12/2023 which was 60 minutes past their current licensing hours of 23:00 and resident of 370 Court Lane checked the license online to find a new application had been submitted.

As residents of Court Lane, we strongly object to this proposal for the following reasons which are relevant even now and will be exacerbated if the license is granted past 23:00:

Currently when the Greyhound Inn have evening events the noise levels can be quite
excessive with the volume of the recorded music and especially the constant thudding of the
base from the recorded music being played which always disturbs residents sleep which
includes 5 young children from the age of 5 and residents who are elderly.

This is amplified when the customers enter and exit the building on a constant basis as the music is playing next to the entrance/exit of the building.

When the music is played on a Friday, Saturday and Sunday the families with young children have to do different things to help their children sleep. These can be:

- Moving the child/children from their bedrooms at the front of the property to the back of the property so they hear less noise.
- Play music in the child/children's bedroom to cover over the music and base coming from the Greyhound Inn.
- 3. Have the TV on in the bedroom for the child/children to fall asleep to.

Also the residents who have no children must adapt their living and sleeping arrangements when the music is played.

This is something which the families should not have to do in a residential area.

 The noise levels over the summer months can be unbearable as the second front door is always wedged open and cannot close.

Due to the music being set up to the left of the entrance/exit the music is blearing into the street which makes it impossible for families to sleep even at the back of their property.

- This building is wholly inappropriate for the use of amplified music at the front of the
 property. The windows are single pane glazing to the front and with the music being set up
 next to the left side bay window which is a few steps from the front door, the music and
 base is very very loud.
- No thought has been paid towards the affect this will have on nearby families, especially the
 ones with young children who have their bedrooms at the front of the property.
- Anti-social behaviour has happened on a few occasions but extending the music time will only make this worse.
- When the new license owners reopened the Greyhound Inn the first few weeks, they were
 playing music to 23:30 which is 30 minutes past the current licencing times. Birmingham
 City Council was made aware of this and they have spoken to the license holders many
 times.
- Even after the Greyhound was reminded of their licensing times, every Friday and Saturday
 the music is being played up to 23:15 so if the license is granted to midnight the music will
 not be turned off until possibly 12:15am.
- There is a current high court order/injunction in place with regards to the music being played from the Greyhound Inn. The below requirements are NOT being adhered to:
 - The second front door is to always remain closed (Not adhered but even more so in the warmer months).
 - The toilet windows are to be always closed when music is played.
 - 3. The amplified music is to be set up at the back of the property.
- Constant noise of car's doors banging shut with customers arriving and leaving the Greyhound Inn.
- Customers drinking, smoking and being very loud with singing and shouting outside the front
 of the Greyhound Inn. This has reduced since the new license owners have taken over but
 with the license time being extended more people will visit and the 'beer garden' can only
 hold so many customers so they will go outside the front.
- During the summer months the Greyhound Inn have repeatedly played loud music
 throughout the early afternoon into the late evenings. Music loud enough that it is
 impossible for residents to sit outside in their own back gardens. This again is made worse
 with the front door being wedged open and the music being played from the front of the
 property.

Very loud noise from the customers when they are leaving the Greyhound Inn. This
constantly wakes up residents who are sleeping.

If the families of Court Lane are already experiencing all the above issues in relation to the current situation of music being played, it will only exacerbate matters if the licensing time is changed to midnight.


We are really concerned that there is a high court order/injunction in place which is not being followed by the new license owners.

The high court order is in place to reduce the impact on residents caused by the playing of amplified music, but it is being completely ignored.

No supply of alcohol may be made under the premises licence (a) at a time when there is no designated premises supervisor in respect of the premises licence, or (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.

Every retail sale or supply of alcohol made under this licence must be made or authorised by a person who holds a personal licence.

The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises. In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or (ii) drink as much alcohol as possible (whether within a time limit or otherwise)(b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective; (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective; (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner; (e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).

The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.

The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol. The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy. The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either (a) a holographic mark, or (b) an ultraviolet feature.

The responsible person must ensure that (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures (i) beer or cider: pint; (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and (iii) still wine in a glass: 125 ml; (b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and (c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.

(1) A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price. (2) In this condition:- (a) 'permitted price' is the price found by applying the formula P = D + (D x V), where - (i) P is the permitted price, (ii) D is the amount of duty chargeable in relation to the alcohol as if the duty charged on the date of the sale or supply of the alcohol, and (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol; (b) 'duty' is to be construed in accordance with the Alcoholic Liquor Duties Act 1979; (c) 'relevant person' means, in relation to premises in respect of which there is in force a premises licence - (i) the holder of the premises licence, (ii) the designated premises supervisor (if any) in respect of such a licence, or (iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence; (d) 'relevant person' means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and (e) 'value added tax' means value added tax charged in accordance with the Value Added Tax Act 1994. (3) Where the permitted price would not be a whole number of pennies, the permitted price shall be taken to be the price rounded up to the nearest penny. (4) Where the permitted price on a day ('the first day') would be different from the permitted price on the next day ('the second day') as a result of a change to the rate of duty or value added tax, the permitted price which would apply on the first day applies to sales or supplies of alcohol which Reference: 166675

take place before the expiry of the period of 14 days beginning on the second day.

Each individual assigned to carrying out a security activity must be licensed by the Security Industry Agency.

Alcohol shall not be sold or supplied except during permitted hours. In this condition, permitted hours means: a. On weekdays, other than Christmas Day, Good Friday or New Years Eve, 11 a.m. to 11 p.m. b. On Sundays, other than Christmas Day or New Years Eve, 12 noon to 10.30 p.m. c. On Good Friday, 12 noon to 10.30 p.m. d. On Christmas Day, 12 noon to 3 p.m. and 7 p.m. to 10.30 p.m. e. On New Years Eve, except on a Sunday, 11 a.m. to 11 p.m. f. On New Years Eve on a Sunday, 12 noon to 10.30 p.m. g. On New Years Eve from the end of permitted hours on New Years Eve to the start of permitted hours on the following day, which would be 11.00 a.m. if New Years Day falls on a weekday or 12 noon if a Sunday. The above restrictions do not prohibit: (a) during the first twenty minutes after the above hours, the taking of the alcohol from the premises unless the alcohol is supplied or taken in an open vessel; (b) consumption of the alcohol on the premises or the taking of sale or supply of alcohol to any person residing in the licensed premises; (c) the ordering of alcohol to be consumed off the premises, or the despatch by the vendor of the alcohol so ordered; (d) the sale of alcohol to a trader or club for the purposes of the trade or club; (e) the sale or supply of alcohol to any canteen or mess, being a canteen in which the sale or supply of alcohol is carried out under the authority of the Secretary of State or an authorised mess of members of Her Majestys naval, military or air forces; (f) the taking of alcohol from the premises by a person residing there; or (g) the supply of alcohol for consumption on the premises to any private friends of a person residing there who are bona fide entertained by him at his own expense, or the consumption of alcohol by persons so supplied; or (h) the supply of alcohol for consumption on the premises to persons employed there for the purposes of the business carried on by the holder of the licence, or the consumption of liquor so supplied, if the liquor is supplied at the expense of their employer or of the person carrying on or in charge of the business on the





Our client wishes to put forward the following additional conditions as part of the variation in response to the remaining objection –

- 1. Staff shall monitor the customers in the external area of the premises on a regular basis and ensure customers do not cause a public nuisance.
- 2. When regulated entertainment, including live and recorded music, is taking place, regular boundary noise checks shall be conducted, and any required action shall be taken. Records detailing the sound checks and any required action shall be recorded. All records must be written and shall be retained on the premises for a minimum of 12 months.
- 3. A direct telephone number for the manager of the premises shall be made available to residents in the vicinity upon request; to call all times the premises are open.
