#### **Support to the Arts Funding 2019-2023**

- Overall £2.67m budget has been ring-fenced until 2022/23
- BCC established a £2m capital endowment but...
- Funding settlements for arts organisations yet to be resolved
- £250k of arts project funding to commission in 2019/20

### **Major Events Funding 2019-20 – 'Signature' Festivals**

- Birmingham Weekender delivered October
- Birmingham International Dance Festival June 2020 supported alongside Arts Council and Dance hub funding

### **Birmingham Culture Compact**

- Draft Terms of Reference agreed
- Next steps recruit Chair and host ACE meet 19 Nov



#### **Museums - Operational matters**

- Proposals submitted for Repairs & Maintenance funds
- BMT contract monitoring current in year perf. update
- Updated lease matters Sarehole Mill, Thinktank
- New BMT Chair appointed

#### **Museums – Capital Programme ambitions**

- New Store / Collections Centre
- Challenges capital funding from key agencies (need FBC)

#### Heritage matters

- Heritage Strategy Refresh under way for 2020
- Birmingham Heritage Week 2020 2023 BCC support



### **Commonwealth Games 2022 Cultural Programme**

BCC working with the OC CWG's team – being recruited Curatorial guidelines to be published Feb 2020

### Film Birmingham Service

Undertaking a feasibility study (funded by GBSLEP) to expand service across region – findings published July 2020



### **Arts in Health & Wellbeing work**

- Work with Adults Social Care and Health to introduce arts offer in Prevention agenda
- Arts & Wellbeing partners' Conference delivered in September 2019
- Assisting Public Health roll out of Food Conversation Campaign

### **Arts in Planning and Public Realm work**

 Work with Planning & Regeneration on Arts plans for major developments including Athletes' Village at Perry Barr and other public realm



### Summary – Priorities for the year ahead

#### **Arts and Culture**

- Resolve financial arrangements from 2020/21 for revenue funded organisations (including Capital Endowment fund) and refresh some of the project funding commissioning schemes
- Establish the new Cultural Compact for the city, including recruitment of a Chair and develop the work programme
- Review and consider findings / recommendations of the feasibility project of the city's Film Birmingham function to expand its services across the region.



### Summary – Priorities for the year ahead

#### **Arts and Culture continued**

- To progress the engagement and delivery of Arts & Culture in Health & Wellbeing activities across the city
- To review the role of cultural officer engagement with Planning & Regeneration and, address the refresh of the current Public Art Strategy as part of that review

#### Museums & Heritage

- Resolve and implement the planned repairs & maintenance requirements for the councils museums building stock
- Resolve lease arrangements with Birmingham Museums Trust for Sarehole Mill and Thinktank Museums
- Assist Birmingham Museums Trust with their wider capital aspirations
- Refresh and renew Birmingham's Heritage Strategy
- Provide support for Birmingham's annual Heritage Week
