I am Police Constable 2413 Reader of the West midlands Police. I am currently based at Lloyd House Police headquarters as a specialist licensing officer.

This statement relates to my interactions with Matthew Eason, the licence holder for Glamorous Showbar on Hurst Street which is currently subject to review proceedings instigated by WMP.

I have been the licensing officer responsible for this venue since Matthew Eason has been operating it.

Glamorous is a small venue, with a capacity of approx. 100 people. It has a street level entrance, which leads down to a single basement style room. Security staff have no direct line of sight to the main room as they are usually based at the front door.

The venue has been a high demand location and there has had to be significant interventions at the premises, with the police working with the licence holder and the security company to attempt to reduce demand at the location and also to ensure that the premises is properly promoting the licensing objectives.

At the recent challenge to Interim Steps on Wednesday 11<sup>th</sup> April, Pc Rohomon and myself presented evidence to the committee following an application by Matthew Eason and his barrister, Sarah Clover, to challenge those interim step of suspension.

During this hearing, Sarah Clover expressed her disappointment that WMP had not 'evidenced their issues with the premise'. She went on to say that there are only two issues relating to door staff and that door staff are not being blamed.

At the time of the hearing, the police evidence bundle was still being collated and was therefore not in a position to be disclosed. As per procedure, this evidence bundle will be available for the full hearing on Tuesday 24<sup>th</sup> April.

During the hearing on Wednesday 11<sup>th</sup> April, Matthew Eason addressed the committee openly and honestly, at one point stating –

*"We can't operate as we did. It didn't work"*

This statement will provide the details of the intervention work done with Glamorous, and highlight key communications with Matthew Eason. It will also evidence why WMP have lost confidence in Matthew Eason as an operator of a late night venue. The acknowledgement made by Matthew Eason at the hearing suggests to me that he knows what makes a good operation and what does not. I intend to further evidence this and suggest

that Matthew Eason has operated responsibly and has taken positive measures to promote the licensing objectives. Crucially however, these steps have not been followed consistently, which has allowed preventable issues to occur at the location.

2017

During 2017, Glamorous became a high demand location for city centre police officers. This was a mixture of calls to service, police intervention outside the venue as well as recorded crime. The fact that the venue operated as a late night bar meant that the demand on police resources was outside of the normal night time economy policing model. I have attached a summary of the offences for the last 3 months of 2017 to this bundle and can produce this as BR/

In October, WMP licensing team objected to a Ten for Halloween at the venue. This led to an exchange of mails and a meeting with the venue. We discussed recent issues at the location and formulated an action plan to reduce demand and to promote the licensing objectives. Matthew Eason accepted that there had been issues and sought to implement new measures to mitigate against this. As per the attached e mail of 18<sup>th</sup> October (exhibit BR ) these measures included –

**Adding a 3<sup>rd</sup> door person on Thursday and Friday from 0300**

**Upgrading CCTV**

**Adding a flood light above the smoking area**

**Regular meetings with Mike from More Secure about security so we can tailor the door staff and their training to us specifically which has included changing staff not suitable.**


The measure around door staff was clearly something that Matthew Eason was aware of back in October. He had proposed specific training and tailored door staff to suit the venue.

A meeting then followed, attended by myself from licensing, Sgt Gregory from the city centre team, venue representatives and representatives from MoreSecure.

Following this intervention meeting, on 30<sup>th</sup> October I received a further e mail from Matthew Eason detailing new measures listed for the premises to promote the licensing objectives. I can produce this e mail as exhibit BR/ This included a 6 point plan as follows –

**Whats New:**

1. We have ordered the new barriers for the smoking area. These are 6ft high by 3m long X 4 with covers on so people in the smoking area cannot interact with people on the street and vice versa i think this will solve a few of the issues we have.
2. We have created a dress code policy which details... No Trackies, No Hoods, No Caps. This was started on Saturday night after i had a chat with the sargeant who was working Friday night where we both agreed we have started to literally let ANYONE in the venue and it's starting to loose it's identity so to resolve this we have created a strict dress code and security staff have been informed that they must not let anyone inside that goes against this. Signage also put up.
3. Linking to the above we have ensured that on busier nights mainly Thursday to Saturday we will have a Manager on the door at all times working with the security staff like they do at the Nightingale and Village. This means we can pick and choose WHO we want in our venue as they approach and it will train the security staff to learn the right clientele for us. This was also started Saturday night and we admitted although we may see a dip in trade from turning away people from the Arcadian we can gain this back by building up the reputation and using our flyering licence ONLY outside LGBT bars further down Hurst Street.
4. Body cameras have been ordered for the door staff as a trouble deterrant i will update you when they arrive and feedback how they have had any affect.
5. Toilets have had CCTV signage put up to deter drug use. This started Saturday and has had a positive effect over the weekend.



6. We have created a Music policy where DJ's have been informed to keep the music under the following categories... (even if they're a drag queen dj) 'Pop and Chart' such as Ariana Grande, Dua Lipa, Little Mix etc, 'Camp, Cheese & 90's' hits such as old Madonna, Spice Girls, BeWitched, Ru Paul and what I refer to as "Reflex Music" (What you might hear in a Reflex) and some old RnB allowed like Rihanna. Under No Circumstances are they allowed to play songs above 132bpm, No Drum N Bass, No Dubstep and No Grime or Garage unless it falls under one of the allowed categories. This music policy will help keep the atmosphere under control INSIDE the venue.

Again, this was a detailed response from Matthew Eason and included a number of positive measures which appeared proportionate to promoting the licensing objectives. It also details that BodyCams have been ordered as a deterrent to trouble.

On 8<sup>th</sup> November 2017, I received an e mail from a different city centre Sgt, Sgt Chris Thomas, asking around intervention work at Glamorous as this venue was a high demand location for city centre officers. I liaised with Sgt Thomas and informed him that a different team had already been assisting licensing with this matter to reduce demand and that a meeting had been held at the venue. This email is attached and can be produced as exhibit BR/

On 18<sup>th</sup> November 2017, a further city centre Sgt, Pete Stephenson sent an e mail to licensing officers criticising a number of venues within the Southside BID area. One of those venues was Glamorous. The feedback was concerning and highlighted a number of issues. The mail is attached and can be produced as exhibit BR/

On 20<sup>th</sup> November 2017, Matthew Eason sent a comprehensive update around the operation of the venue. This mail is attached and exhibited as BR/ The first paragraph of this mail covers security and entry policy –

Since I emailed you last we have made some changes which are starting to have a positive effect. We understand that we have been letting the wrong clientele into the venue and we have made steps to fix this. Firstly we have ensured that a manager or myself is on the door at all times with the security staff ensuring that we help "vet" the incoming people. We have also changed specific security staff members that More Secure provide us that we identified issues with. We found that some of the door staff had befriended some of the clientele we did not want inside the premises so they struggled to knock them back. We had a meeting with Mike from More Secure and changed two of the regular door team for people that are more suited to work late and do not know the client base so we can have a fresh start. This week we have also got a new doorman starting called Jason that we asked More Secure to check out and employ for us as he has an SIA badge and is part of the LGBT community, with him working with the other door staff we can now have a team that is more bespoke to us and with his help can tailor our clientele to who we really want in.

The above again confirms that Matthew Eason is aware of how critical the correct security is to allowing people entry into his venue. He correctly identifies that the staff need to be able to 'knock people back' and not be too familiar with them. Personnel were changed to make them more appropriate. He also explained how he would amend the hours of the security operation. Some of the changes were only by an hour, but it showed that Matthew acknowledged the positive impact that this could have –

We have also increased the hours our security team work which includes the following changes....

Thursday Friday and Saturday the first doorman will now start at 12:00 which is when we open. Previously they started at 1:00

Saturday we have increased security numbers from 2 to 3.

The Rota for the security levels is as follows

Monday - Wednesday and Sunday Doorman 1 1:00-close Doorman 2 02:00-close

Thursday to Saturday Doorman 1 12:00-close Doorman 2 01:00 - Close Doorman 3 03:00 - Close

I will consider increasing the Thursday to Saturday door team to 4 staff over the Christmas period to ensure we have ample cover to stop any issues arising over this busy period. This was also suggested to us by one of your officers at the week just gone which we agree is a good idea. I will have a meeting with More Secure this week to discuss our Christmas period / December security requirements so we can implement this change of



increasing to 4 staff possibly from this weekend as with the german market open there is more people traffic outside at weekends.

Following a meeting with Matthew Eason and Mike from MoreSecure at Novembers Pubwatch I sent an email to Matthew Eason to give formal notice that WMP would be imposing the 04:00 veto if there were further issues at the venue. I have attached a copy of this mail as exhibit BR/

Having updated all of the city centre teams that this mail had been sent to the licence holder of Glamorous, I received a reply from Sgt Peter Stephenson from the city centre team.

**Ben. Is there any way we can just impose this veto and get them to shut at 0400 hours. I don't understand what this is all about as it clearly states in their license that all licensable activity will cease at 0400.**

**We know this is a problem venue and it would vastly reduce our demand if this shut at a reasonable hour (i.e not 0600).**

**This opinion is echoed around the city centre teams.**

At this point I felt like I was defending the venue and that city centre Sgts were frustrated by my actions. In line with the guidance though, I wanted to do everything possible to assist the venue in promoting the licensing objectives and as a team, we thought the imposing the veto was a last resort when all other avenues had been exhausted.

The potential use of the Veto seemed to focus the minds of the venue and they operated with less calls to service.

On 13<sup>th</sup> December, I was sent further detailed correspondence from Matthew Eason describing his operating plans for the Christmas period. This included enhanced security deployments, increasing both the hours of cover and the number of staff deployed.

There then followed a lull in activity at the venue and it appeared to be operating without excessive calls to service.

I am now aware that throughout this timeframe, Glamorous operated with an enhanced number of door staff throughout the busier Christmas period.

It would appear that following the festive period, the security staffing levels were then reduced to the pre December levels. This corresponds with the time when there were raised incident levels at the premises; so similarly, incident numbers began to rise again.

I have produced a separate statement which specifically looks at the crimes that have been generated by this late night venue. There have been 16 crimes recorded at Glamorous, 14 of which have occurred after 02:00.

#### Incidents

There have also been a number of incidents and logs at the premises, some of these naturally overlap with the recorded crime, and some are additional standalone incidents.

Log 242 and 243 09/02/2018 Log time – 04:05 and 04:07 (Early hours of Friday morning)

These are two separate logs regarding the same incident. The logs suggest that a group of males are being



disorderly and attempting to rush the doors at the venue. One male was arrested from this incident who struggled with officers and was subject to Parva spray being used. The circumstances of the arrest are as follows –

PC 0788 BEDDALL (Digbeth) states PIC arrested for resisting arrest having been arrested for another matter. Officers directed to attend Glamorous Bar, Hurst Street, report of violent disorder. On arrival, this PIC and other males were pointed out by other officers as having been involved in the disorder. PC BEDDALL approached the PIC and explained powers of Sect. 50. Officer required PIC's name and address. PIC refused on several occasions to provide details. PIC then shouted a name at the officer, not heard, unable to be noted. Officer repeated request for name and address. PIC refused stating he had already shouted them. PIC began to walk away in company with others involved. At this point PC BEDDALL took hold of PIC and arrested him for this offence. PIC pulled away, struggled with PC BEDDALL and other officers, resisting arrest, refusing to be handcuffed. Subjected to Parva Spray and non-compliant 2 x handcuffs to rear

Log 517 10/02/2018 log time 06:14 (Early hours of Saturday morning)

Call from Ambulance requesting police assistance to Glamorous to reports of an unconscious female. Ambulance attended and located the female prior to police arrival.

Log 334 15/02/2018 log time 06:46 (Early hours of Thursday morning)

Call from a male to say his son had been attacked and robbed at the premises between 04:30 and 04:45. The son was at Queen Elizabeth A&E being checked over. The son had memory loss but was unsure if this was due to concussion or due to alcohol. Watch, phone and wallet were stolen. Callers son declined to make a complaint as he managed to get his phone back after the incident. He does not recall exactly what had happened due to being very drunk.

Log 372 16/02/2018 log time 06:13 (Early hours of Friday morning)

Immediate response log to a sexual assault and disorder at Glamorous, CCTV tracking a vehicle containing offenders. Vehicle is stopped in Highgate. This incident relates to the two recorded crimes on this date. Suspect asleep in Glamorous and woke to a male kissing him.

Log 288 20/02/2018 log time 04:18 (Early hours of Tuesday morning)

Call from member of the public stating his friend's iPhone was stolen in The Village, Hurst Street and that the offenders have been tracked via app to Glamorous. This incident was not crimed.

Log 176 28/02/2018 log time 04:33 (early hours of Wednesday morning)

Raphael from the venue called 999 as 3 males are being disorderly.

Log 198 28/02/2018 log time 05:20 (early hours of Wednesday morning)

Raphael calls 999 again as the 3 males are now back inside the venue.

In relation to the above 2 logs, the venue incident report reads as follows –

**Ben,**

**Here is my report from the duty manager**

**Manager : Raphael**

Three guys came into the club... One had previously been in the venue a few times but the other two hadn't...

The one male kicked the male toilet door aggressively... So I ask security (Andre) to ask him to leave... As the conversation was taking ages I went to see what was taking so long... The group of males excessively apologised so I let them remain in the club knowing that if they behave that way again they will be banned...

Later the other male... Walked upstairs and pushed a member of scene staff on the way and started to urinate

in the smoking area upstairs...

I then told security they had to leave... No questions...

The conversation between the lads and security went on for 25+ mins and the lads refused to leave and kept walking back in and out of the club... They were demanding money back for a round of drinks they had bought... Drunk... And distributed out... Obviously I refused... I then told the security if they let them back through the door one more time and you can't handle it... I'm going to have to phone the police... The security then agreed and asked me to phone the police for support as they thought it was going to kick off badly....

I phoned the police... And while the police were on their way... All three lads stormed back into the club... When the police arrived... in total I believe there was 5 officers ... The police spoke to the group of lads inside the club for about 10 minutes trying to get them to leave... They were clearly a difficult group....

When the lads we're escorted out of the club outside the smoking area... They continued to be spoken to by the police but we're not arrested... They were allowed to just go over the road and into the casino... One police officer explained that "they are not to come back into the club... I don't want them back in" ...

To which my reply was... "Yeah of course they are barred" .... All police officers bar 2 left the scene.... And when the last officer left... Said to the security... If you have any more trouble give us a call back....

As they weren't arrested and still outside our club on the streets... I gave the keys to my security and said "if they come back just lock the doors" ... Low and behold they came back to the club... When my security tried to lock the door... They pulled the door from his hand before being successful and stormed back into the club

I then phoned the police again... As I was asked to by the last officer... And as the group we're clearly difficult as it took 5 police officers to escort them out...

When the police arrived... They didn't get out of the vehicle and just waited outside... When I went to speak to them upstairs... Said that it was ridiculous that they had been let back in... I tried to explain that it was forced entry past the security but the police officer told me that it wasn't... Then said that we need to "get better security" as my security are "friends" with the lads.... They then refused to help and said "I'm not coming in there to get them out for you again... That is your security's job" ...

As I had asked the DJ to stop all music and turn on all lights and closed the venue... In an attempt to get them to leave... The police drove off while they were still in the venue.... And we had to wait for them to leave on their own accord with myself... The staff... And security asking them to leave as we're were closed... Still they were demanding money back for a round of drinks.... Eventually they left

Ben,

I've spoken to management and more secure they are going to look at replacing Andre off the door as I can't have door staff who aren't good enough for the position. However, I will be reviewing CCTV as if they clearly have forced entry a second time I don't appreciate your officers response of "no It's your security's job not ours" when I am asking them for help especially when an officer politely says to us to call back should there be any issues, if the officers dispersed them away from the area properly the first time maybe they wouldn't have come back in? I will investigate none the less and get back to you with what I can see via cctv. In the meantime myself and Mike will ensure proper scheduling on the door team and weed out any weeds so to speak.

I find the above incident report very concerning as there are a number of obvious issues that it raises. The management and door supervision is weak to the point of not being in control of their venue. Raphael describes the males to the 999 call taker and two of the males are wearing baseball caps, which are in clear contravention of the dress code policy that Matthew Eason implemented on 30<sup>th</sup> October. (7)

Issues with this incident report –

Weak management

Incompetent security

Lack of control at the door

No enforcement of dress code (are these the type of customer Glamorous wishes to attract)

Refusal to refund a round of drinks, could this has calmed the situation?

Expectation that police officers are there to resolve issues which the venue have caused.

Further criticism of the door company by Matthew Eason.

Log 165 01/03/2018 log time 02:34 (early hours of Thursday morning)

999 call from Raphael the manager as people are rushing the door. The log states that people are fighting inside the venue and staff are being assaulted.

This incident results in a glass being thrown at officers and the officers at the scene requesting assistance. This means a number of response officers are redirected to this incident as well as a dog unit. This was a very resource intensive incident for WMP.

The officer who was assaulted, PC Julie Beddall submitted a referral form for this incident which is attached as exhibit BR/

This was a very concerning incident so I again raised this with Matthew Eason. The email reply was sent as follows –


**From: Matt eason**

**Sent: 02 March 2018 00:54**

**To: Ben Reader**

**Subject: Re: \*\*\*\*SPAM\*\*\*\* Re: Disorder**

Ben, I believe beva from more secure is going to speak to you Today, i called him directly and put my issues of inadequate door staff to him which is what I believe the problem is, I've given them an ultimatum That I need doorstaff who are able to handle people properly and I've been promised new door staff from tonight, I've also given them a final warning that if they continue to supply me with inadequate door staff I will change company to someone who can. The reason your officers were called out is because the door team were not good enough to remove people from the venue when requested and also one member of door staff being 45 minutes late. It also came to light that rather than say no to admission to people they couldn't handle they just let them in to stop arguments of which I've told beva this isn't acceptable hence asking for a new team of people who are able to do the job. I told Beva that we can't have people on our door that are... in effect "wimps". Our head door lady is back this weekend after being off for 3 weeks due to her badge expiring and struggling to renew it on time, this is now resolved and she will be back Sunday night. I have also made a note of the days these





incidents occurred on and will Do some research into the crowd on Wednesdays to see if it's changed.

I'll have another chat with beva and mike later today to see how they're getting on with the new team scheduling, I'm also considering enforcing the 3am Last admission time that we enforced over Christmas again as it is apparent there are still people around even on early week days after this time that are disorderly. I will also continue to monitor levels of trade to ensure we have adequate security cover and hopefully now we'll be sent decent people to do the job!

**The venue has been raised by my command team on two separate days now so I need to report back to them as to what measures are in place to prevent any further incidents.**

This reply from Matthew Eason is now showing a pattern of blame being put onto individual members of door staff and onto the security company themselves. It talks about 'an ultimatum' and a 'final warning' but this seems to be action that isn't taken seriously. It specifically highlights weak staff and late staff.

Matthew Eason is the licence holder and the DPS, he must accept that he is accountable for the operation of the venue and he cannot simply continue to blame security for the issues. He is paying the security bill and he must be happy with the service he is paying for.

A further incident occurred at the location on Saturday 3<sup>rd</sup> March. There is not a log for this, but the city centre Sgt who was on duty on the night sent me the following email –

**Good morning,**

**I would like to bring to your attention a concern I have in respect of the above premises and an incident I attended:**

**On Saturday 3<sup>rd</sup> March 2018, I was working alongside my team on Southside NTE (1900x0500). At around 0430 hours, a member of the public came up to me and informed me that his niece was inside the premises and she was 17 years old.**

**The member of the public informed me that the doorman was aware of how old his niece was and that they still let her inside the premises.**

**John had spoken with the door staff who had refused to go and look for his niece inside Glamorous.**

**I then spoke with the Duty Manager and informed him of the situation. He quickly went and located the female and escorted her off the premises. She would not speak to police.**

**She was clearly under the age of 18 and I am of the opinion that anyone would see that she was too young to be in a licenced premise. John had stated that one member of the door staff (unknown) is dating her; hence**



her being allowed in under age.

Apologies for the lack of details – the female in question would not speak to police. John, the member of the public, didn't provide me with any of the female's details and it was an extremely busy evening with pockets of disorder all over the area.

I have major concerns that this premise is not being strict with its checking of identification to prove the age of people they are letting into their bar. I am aware that Glamorous has been under the spotlight recently and therefore wanted to highlight these concerns to yourselves.

Again, this incident caused me concern, as it showed a lack of management control and a lack of security control. In relation to the above incident, I received the following reply from Matthew Eason –

Regarding the 17 year old I believe it may be the girlfriend of one of the Security staff (Ibrahim). We have warned him about having her loiter around the door previously as it was distracting him from his job. She was let in with friends one night and she produced a valid looking ID showing her age to be 18, they were thrown out after management requested Ibrahim remove them for being too rowdy and going into the men's toilets. They caused a scene at the door and officers came over from across the street, her friends told officers she was only 17 to try and get Ibrahim into trouble. If this is the correct incident in question I believe as she had valid ID we did nothing wrong letting her in. We have since requested that more secure no longer send Ibrahim to work the door as we have asked him multiple times to not bring his girlfriend to work and been ignored he is no longer working our door.

I will get the reports from the system to you once I've downloaded them also

Yet again, the blame is being placed upon weak door staff at the venue. The tone of the above email is defensive and not taking responsibility for what has happened.

It talks about the group being rowdy and going into the men's toilets. There seems to be a lack of control at the venue.

Ibrahim has been asked 'multiple times' not to bring his girlfriend to work as it 'distracts him from his job'. Again, a problem has been highlighted and not robustly dealt with by the licence holder. This has led to an incident where the police have had to get involved.

On the 5<sup>th</sup> March, I chased Matthew Eason for updates around the venue and the door supervisor issue and received the following update.

He said you were calling him back when you were free,

Changes wise we have fired 2 useless doorstaff (I say fired but whether that just means they've moved them to another venue who knows) but we have a new butch welsh guy and another new doorman and feedback has

been great!

We have also invested in a metal detector wand which we used on every customer this weekend just gone to deter anyone carrying anything inappropriate coming inside as currently in my safe I have 2 knives that were found by customers and handed in at the bar. (I'll bring these to the station this week along with the other lost property I have such as bank cards, ID's and I also have 2 passports)

Also my head lady Suzie is back on the door after her badge renewal came through finally!

I'll ask Beva to call you

Again, there is a suggestion that new door personnel will reduce the issues and that things will improve. It also acknowledges that two knives have been recovered by customers inside the venue which is concerning. Suzie had been put forward as a really positive influence on the door at this venue, however she had not been working due to issues with her SIA badge.

Log 238 07/03/2018 log time 04:39 (early hours of Wednesday morning)

Call from an intoxicated sounding female Inside Glamorous who states she has kicked the toilet door in as someone threw a drink in her face. No complaint was made as this was a 'drunken misunderstanding'

Logs 212, 213, 228 13/03/2018 log time 03:30 (early hours of Tuesday morning)

Door staff being assaulted by a male. This is the incident where 3 section 47 assaults have been crimed, referred to in separate statement.

Log 309 13/03/2018 Log time 06:11 (early hours of Tuesday morning)

Call from Rafael that an intoxicated female has caused criminal damage inside the venue. This has been crimed and referred to in separate statement.

Male initially alleging doorstaff have been physical with him and refused him entry to Glamorous. Not recorded as a police matter and advice given.


Log 192 and 195 19/03/2018 Log time 04:05 and 04:13 (early hours of Monday morning)

Initial log is police CCTV operator observing disorder at the location. Suzie, head of security then calls 999 reporting an aggressive male who will not leave the location. No offences recorded.

Log 189 28/03/2018 Log time 03:01 (early hours of Wednesday morning)

Call from Raphael at the premises, unconscious male who has been bottled. This is the incident that leads to the expedited review.

As previously discussed, this incident was further compounded by a member of door staff not turning up,



meaning the venue only had one member of staff on duty.

West Midlands Police central licensing team is a small team responsible for thousands of licensed premises within the Birmingham City Council area.

In relation to compliance and enforcement, our time is prioritised to those venues that are causing the most call to service and demand, as well as intelligence led initiatives. It is not always possible to quickly identify emerging patterns at every venue. In fact, the vast majority of licensed premises rarely come to our attention.

This review process has given me time to thoroughly look into all of the incidents, logs and crimes at this venue, as well as the responses that the licence holder has sent and referrals from the city centre Sgts that police this location.


What is apparent to me is that the venue has been, and continues to be poorly managed. The licensing objectives are not being properly promoted.

There is a constant theme of failings by the venue management to address issues with their own staff and also the staff supplied by the security company. There appears to be renewed talk of meetings with security, new security staff and new policies being put in place. However, the above has evidenced that the bodycams have not been purchased or used, the dress code is not enforced, the security deployment plan is not being adhered to and that levels of intoxication feature in a number of the recorded incidents.

The intoxication levels do not surprise me, as this venue operates so late. The business model is about attracting customers who have finished an evening elsewhere, so are already in drink. It would therefore follow that the venue should be even more rigorous around their entry policy to ensure that they are promoting the licensing objectives. This is clearly not happening and this leads to issues around public safety and crime and disorder.

On Tuesday 17<sup>th</sup> April, PC Rohomon and myself sat down with Matthew Eason and his licensing consultant, Carl Moore. We explained our concerns and highlighted the pattern of offences taking place after 02:00. We explained why we had lost confidence in Matthew as an operator of a late night venue. We suggested that a significant change to the venues' operation were required to give us confidence that the venue can be operated safely. By this, we do not simply mean new procedures, new policies or even more new door staff as this will just continue the cycle. The incidents and crimes take place across all days of the week.

There needs to be wholesale change of timings, venue identity and personnel to ensure that Glamorous Showbar can promote the licensing objectives.

Hi Ben,

I've just spoken to your colleague Chris regarding our TEN for Halloween that was rejected due to a slight increase in issues at our venue later on in the night.

I wanted to find out if yourself (or whichever colleague) could meet up with myself as the DPS and also Mike/Beaver from More Secure so we can have a chat about the issues so we can resolve them.

It would be useful if you could bring a brief list of the recent logs of any incidents relating to us over the last couple of months so we can look and compare the data to see if there is any patterns emerging such as a specific day of the week or time of the night or specific type of crime happening. We can then use this data to see how we can limit any future issues occurring such as changing the level of door staff where required or enforcing a last admission time also comparing incident dates to who was on shift that night to see if a specific doorman could be causing an issue. I take incidents very seriously and the last thing we want is to have this venue back on the police radar as being a badly ran late bar.

We have recently implemented a few things to limit crime from happening which include...

- Adding a third doorman on Thursday and Friday nights from 3am to assist as we have identified these two nights as the busiest.
- Upgrading the CCTV to 1080HD cameras with a 15fps rate.
- Adding a flood light above the smoking area to deter people loitering in the dark, this has had a positive effect recently.
- Having regular meetings with Mike from More Secure so we can tailor the door staff and their training to us specifically which has included changing staff not suitable.

We have also made note of a few things we can consider starting to do to also stem the affect of disorder which include...

- Changing the smoking area layout and the layout of the barriers upstairs so we can better organise smokers from people waiting to come in, this is currently under discussion with the door staff and some advice from yourselves also could be useful also.
- Enforcing a stricter dress code.

Hi Ben,

As agreed in our meeting i'll send you a weekly email letting you know what we've been up to and an incidents list.

Whats New:

1. We have ordered the new barriers for the smoking area. These are 6ft high by 3m long X 4 with covers on so people in the smoking area cannot interact with people on the street and vice versa i think this will solve a few of the issues we have.
2. We have created a dress code policy which details... No Trackies, No Hoods, No Caps. This was started on Saturday night after i had a chat with the sargeant who was working Friday night where we both agreed we have started to literally let ANYONE in the venue and it's starting to loose it's identity so to resolve this we have created a strict dress code and security staff have been informed that they must not let anyone inside that goes against this. Signage also put up.
3. Linking to the above we have ensured that on busier nights mainly Thursday to Saturday we will have a Manager on the door at all times working with the security staff like they do at the Nightingale and Village. This means we can pick and choose WHO we want in our venue as they approach and it will train the security staff to learn the right clientele for us. This was also started Saturday night and we admitted although we may see a dip in trade from turning away people from the Arcadian we can gain this back by building up the reputation and using our flyering licence ONLY outside LGBT bars further down Hurst Street.
4. Body cameras have been ordered for the door staff as a trouble deterrant i will update you when they arrive and feedback how they have had any affect.
5. Toilets have had CCTV signage put up to deter drug use. This started Saturday and has had a positive effect over the weekend.
6. We have created a Music policy where DJ's have been informed to keep the music under the follwing categories... (even if they're a drag queen dj) 'Pop and Chart' such as Ariana Grande, Dua Lipa, Little Mix etc, 'Camp, Cheese & 90's' hits such as old Madonna, Spice Girls, BeWitched, Ru Paul and what i refer to as "Relfex Music" (What you might hear in a Reflex) and some old RnB allowed like Rihanna. Under No Circumstances are they allowed to play songs above 132bpm, No Drum N Bass, No Dubstep and No Grime or Garage unless it falls under one of the allowed categories. This music policy will help keep the atmosphere under control INSIDE the venue.

Stuff that happened:

Monday:

- Fake ID Confiscated from a girl was put into our safe for handing in to the police station.
- Group of somalian males warned to move away from the smoking area trying to sell drugs to customers.

## Tuesday

- Police attended when 2 males and 2 females left the venue who were fighting over one of the males taking a bag from one of the females.
- 5 People asked to move away from the smoking area for intimidating customers.

## Wednesday

- 4 people removed throughout the night for being too intoxicated

## Thursday

- Refused Entry to 2 guys who one has no ID and the other was using a fake ID which was confiscated and added to the safe for handing in to police.
- Quote from security book "06:15 Told customers to leave after finishing their drinks and it all went to plan until they came outside the building where all of a sudden we had 10-15 somalian males harrasing people leaving, a fight broke out between customers and somalians" police presumeably did not attend

## Friday

- Police were outside taking to me (matt/dps) and fight happened in the smopking area police helped remove the guy who became abusing to the sargeant (not a good idea) guy was told to leave the area.
- Whilst police still outside a guy came outside claiming he was on the dancefloor floor being kicked by a group of males, myelf and a PC went to check the cctv we were both happy the incident did not happen as no evidence of it was seen on CCTV (waste of time)

## Saturday

- No Incidents Logged, 2 people removed throughout the night for being intoxicated.

## Sunday

- 1:55AM Two older customers asked to leave about 40-50 years old because they were stealing drinks from customers (minesweeping) left without fuss
- 3:30AM Male removed from venue after having 3 complaints from females that he was touching them inappropriately
- 4:30AM Male and female removed from venue after being overheard on the phone in the smoking area buying drugs, she was quoted to have said "i only want £20 worth" to the caller. After being challenged by security they left with no fuss.


I have written this up from the black book and i will ask from now on the security staff can be more specific so i can write down more details.

At least 2-3 of those are smoking area related and i cannot wait for the barriers with covers to arrive so we can stop people communicating with smokers. Also feedback from customers on Sunday night was positive with one person saying they had noticed we had tightened up our door and it felt like they were in a "proper gay bar" which is what we want it to be.

I will email you again next monday night with this weeks run down!

Hi Licensing team, I have the following to report about this Friday evening.

Bars in question were :

GLAMOROUS

This venue wasn't busy at all and there was a fight outside which other door supervisors came across to help stop. It turns out this was between 1 of the promoters that was off duty and in a night out at the venue and one of their DJ'S who was also on a night out. They were both spit up and verbally and physically trying to get back to each other. Alcohol had been involved and the managers were trying to play it down. No arrests were made.

This venue has been a concern for me and is looked unfavourably on by the other bars in the . The manager is regularly undermining the door supervisors to allow people they are blocking to enter the premises, purely for financial gain. I have heard that other bars will knock back customers, who walk straight across and into . This is why the head doorman . I get the Impression that the door supervisors are trying to do their best and are being stopped by the manager and promoter.

I spoke to a new door supervisor about how he feels with support from the manager. He stated he has currently been drafted in by the owner to watch and report back about how the club is being run. He stated he has witnessed first hand this undermining and has a meeting with the owner today to feed this back.

### GLAMOROUS

This place is still a nightmare and the last 2 days, men have been coming from the basement club covered in blood. Last night (No log) one male came out of the club with his face pouring with blood and ran away from the club and officers. The Doorstaff tried to cover this up by saying hed been splashed with something red or similar. No victim or offenders were traced but this was a clear injury sustained in the club.

Tonight, I saw 2 men violently dragging each other around outside the club on the footpath and it looked like punches were going to be thrown. They were falling into the new smoking area screens and none of the door supervisors were trying to stop them. I had to rugby tackle them which stunned them enough fot staff to pll them apart and it turns out they were friends and had been in a fight insode the club, with one of the males reportedly being hit with a bottle, which caused a 1 cm gash on his forehead and his face was covered in blood. He was very angry and stated he had been set about in the club by a group of males and was furious. Both he and the male he was arguing with were best friends and were heavily intoxicated and were chewing their faces off indicating cocaine use. We sent staff inside and they confirmed our victim was the main aggressor and had caused the row, came around the back and blindsided one of a group of males before a large fight broke out on the dance floor area, which went behind a pillar, blocking any further assaults. There was a single door supervisor in the middle of all of this and in my opinlon was not safe on his own with two warring parties. There were 2 door supervisors on the front door while all this was going on and they did not get any messages to assist him. I spoke to the doorsupervisor who had been in the middle of it and he felt unsafe and felt there should be 4 minimum to have support up and down . (Log number 512 of 18/11/2017).

From the above reports, I think that GLAMOROUS should adopt a no glass policy at all as it is a complete dive and isn't being supervised or managed correctly. As their crowd were emptying out at 0550, the majority of their crowd were people we had seen coming out of other Arcadian bars absolutely hammered at 0400 and we advised/ thought they were far too drunk and should have gone home, never mind be accepted into another bar.

██████ need reminding of their responsibilities and possibly a meeting to agree some new standards to move forward. This may be happening by the feedback from the secret doorman the owner has employed.

Sorry for the long email. For a quiet night, I had a lot to say.

Hi Ben,

Apologies for missing my update last week!

Since I emailed you last we have made some changes which are starting to have a positive effect. We understand that we have been letting the wrong clientele into the venue and we have made steps to fix this. Firstly we have ensured that a manager or myself is on the door at all times with the security staff ensuring that we help "vet" the incoming people. We have also changed specific security staff members that More Secure provide us that we identified issues with. We found that some of the door staff had befriended some of the clientele we did not want inside the premises so they struggled to knock them back. We had a meeting with Mike from More Secure and changed two of the regular door team for people that are more suited to work late and do not know the client base so we can have a fresh start. This week we have also got a new doorman starting called Jason that we asked More Secure to check out and employ for us as he has an SIA badge and is part of the LGBT community, with him working with the other door staff we can now have a team that is more bespoke to us and with his help can tailor our clientele to who we really want in.

There has still been a few incidents at the venue which i can go through the log book with you below and let you know how we plan to lower this further so we have little or ideally NO incidents. I feel personally that it will be a gradual decline as the customer base we are knocking back mainly from the arcadian will gradually stop trying to get in as they realise they wont get in. The dress code we created 3 weeks ago has already had a positive affect and we put signage up in the doorway to let people know that tracksuit bottoms and hoodies are not permitted, this has had a huge affect and already are starting to see a nicer clientele in the venue but we still have more work to do.

I showed our new barriers with covers to the sargeant and for the first two weeks we trialled using two of them however we have now decided that two is not enough and will be using 3 from this week. We have already seen a positive effect from using the barriers as they are very tall and with the covers on means customers smoking cannot interact with people walking past. The barriers are also padlocked to newly fitted hooks in the wall to stop people tamering with them and sneaking in. They also have High Viz feet to stop people tripping over the bases. We have now also provided the security staff with ear pieces for the internal radio's. This means that we can now communicate with them discretely and more easily. We have also increased the hours our security team work which includes the following changes....

Thursday Friday and Saturday the first doorman will now start at 12:00 which is when we open. Previously they started at 1:00  
Saturday we have increased security numbers from 2 to 3.

The Rota for the security levels is as follows

Monday - Wednesday and Sunday Doorman 1 1:00-close Doorman 2 02:00-close  
Thursday to Saturday Doorman 1 12:00-close Doorman 2 01:00 - Close Doorman 3  
03:00 - Close

I will consider increasing the Thursday to Saturday door team to 4 staff over the Christmas period to ensure we have ample cover to stop any issues arising over this busy period. This was also suggested to us by one of your officers at the week just gone which we agree is a good idea. I will have a meeting with More Secure this week to discuss our Christmas period / December security requirements so we can implement this change of increasing to 4 staff possibly from this weekend as with the German market open there is more people traffic outside at weekends.

The log for W/C 6th is a bit empty and we have now ensured that the new security staff know to log everything in the book including venue checks. I am also aware that the incident you mentioned about on Friday involved a customer using a bottle as a weapon, so far Glamorous has always used polycarbonate glassware but since we opened in 2015 have allowed bottles to be sold in glass. I will be speaking to my suppliers this week to see if we can obtain PET bottles of products to limit this ever becoming an issue. Over the coming festive period i am also considering decanting glass bottles into plastic so we don't have any issues. I will also as DPS be in attendance on the door with management and security every thursday to saturday specifically to assist in making decisions about who we let in. I can promise you i will tighten up on who we let into the venue and if you wish to meet with us again this week just give me a call or email and i can meet with yourself and the sargeant whenever you like. We are also still looking to purchase body cameras for security as a deterrant and i will look into those this week also.

Matt,

Thank you for the below feedback and for our open discussion yesterday at Pubwatch with Mikey from MoreSecure.

I take on board that you have recently implemented the following –

New head door person (Suzie)  
Increase in numbers of door staff  
Enhanced flood lights outside of the premises to discourage undesirables loitering near to the venue  
A new external barrier system to reduce interaction between customers and people loitering near to the venue  
A drag artist on the front door to reinforce the customer profile that you wish to attract  
Increased number of refusals of the post Arcadian crowd around 04:00 when they migrate across

As I explained, your venue is currently a high demand location, the recent comparison that I shared was that your venue had more calls to service than Walkabout on Broad Street (which is significantly larger and open for more hours)

The recent level of demand leads WMP to believe that the venue have not been doing enough to promote the licensing objectives.

I will refer you to a condition of your licence as follows

The premises will have a standard operating hour of 4 a.m. i.e. licensable activities will cease at that time. If the premises wish to operate past this hour the Designated Premises Supervisor or premises licence holder must give 28 days notice to Birmingham Central (Steelhouse Lane) police station. The notice is to include a full risk assessment for the event. The notice can be in any written form. West Midlands Police (Birmingham Central licensing team) retain the power to veto any such extension if any of the licensing objectives have been or are likely to be compromised.

The imposition of the veto is not something that WMP would take lightly, however, if there is not a significant reduction in incidents at Glamorous then this veto will be imposed.

Please take this as formal notice that this condition will be implemented on Monday if there are issues over this weekend that compromise the licensing objectives.

Incident Details	<p>At about 02.30 hours on 1/3/18 officers were called down to Glamorous Show Bar, Hurst Street to a report of disorder and persons forcing entry at the door. We were told that persons were being violent to the door person but also that there were two separate incidents of disorder all taking place in the doorway at the same time.</p> <p>On arrival, the disorder was over and I have asked to look at the CCTV to establish what happened.</p> <p>Having looked at the CCTV there appears to have been two males having a verbal altercation in the foyer which has ended up with one male breaking the finger of the other.</p> <p>At the same time in the foyer, in a completely separate incident, the door man can be seen trying to stop 3 x IC3 males from going into the bar, one of which throws a number of punches at the doorman during which the other two males sneak downstairs into the bar.</p>

The male throwing the punches then leaves prior to our arrival. Rafaele, the assistance manager stated that he only had one member of doorstaff working and that the other one hadn't shown up.

It was obvious from viewing the incidents at the foyer that no one had any control of what had happened and who was entering the bar. I appreciate the door man came under attack and subsequently withdrew back into the bar at one point but no other members of staff had any control over the bar.

Whilst dealing with the incident where a male had received a broken finger, I was asked by Rafaele to assist his doorman who had found the two males who had sneaked in downstairs drinking and not was trying to eject them.

As I went down the stairs the doorman was being followed out by the 2 males who still had drinks in their hands as then left the premises but then refused to hand over the drinks.

The doorman did very little to control what was happening, nor explaining to the males that they were being ejected, leaving myself and Sgt Sean Stanley to then take the drinks from the males and try to explain why they had been taken out the bar.

As a result of this, one of the male threw the glass at another officer and the second male then grabbed hold of myself and then struck me to the arm resulting in both males being arrested.

It was a complete fiasco.

	<p>Following this, a second door person arrived to start work, however this was around 03.00 by this time.</p> <p>In short, it would appear that the staff and door staff do not have control over the own door into their bar. It was only a week or so earlier we were called to the bar for 6 persons rushing the door.</p>
Which of the licensing objectives do you believe are applicable?	<p>Safety and crime.</p> <p>one member of doorstaff was not adequate to deal with the incidents of disorder or was sufficient to control entry into the premises and as such promote public safety or prevent disorder and crime.</p>
