## In first paragraph:

## After first paragraph add:

This response has been funded by around £64m in additional funding from Government through the Household Support Fund, supplemented by one-off funding of £5m from the Council's Financial Resilience Reserve.

The £5m provided by the Council is only 10% of the money they are spending on Labour's failed ERP system and only 0.65% of the money they may have to spend to fix Labour's equal pay crisis.

Taken together, the cost of Labour's approach over ERP and Equal Pay equals £3450 per average household in Birmingham, money that could have been spent on making a real difference to those struggling with the cost of living.

## In point 2:

Delete 'Tory' and add to end of sentence 'to the greatest extent still possible given the financial crisis Labour have created in Birmingham with their handling of ERP and Equal Pay.'

## In point 3:


Replace with 'The Council will write to the government to request continued and additional support to address the cost-of-living crisis, whilst also working together on a solution to Labour's financial crisis.'

## CITY COUNCIL TUESDAY 11 JULY 2023

**1. After “equal pay liability,” insert:**

this Council is taking a range of urgent actions to address the unsustainable growth in Equal Pay liability, improve governance and strengthen organisation capacity, including:

- Appointing three Strategic Expert Advisers to support the Council’s Directors and Cabinet
- Formally commissioning an independent Governance Review in collaboration with the Department for Levelling-Up, Housing and Communities
- Commissioning an independently chaired, internal management review to ascertain the root causes of the failure to effectively implement Oracle
- Setting out plans to instigate a judge-led inquiry to determine the causes of the equal pay liability growth since 2012, to begin following the outcome of the Governance Review
- Implementing mandatory spending restrictions

To oversee this work, a new Strategic Delivery Board will be created to develop and deliver plans for improvement. To ensure openness and transparency, the Strategic External Advisers will produce an independent report on a quarterly basis with an update on progress and an analysis on whether there is adequate grip and pace in relation to the delivery of the change that is required.

- 2. After “this Council commits to” DELETE “an item of not less than 1 hour at each Council meeting going forward updating members and allowing a debate on progress against actions to address the crisis.” AND REPLACE WITH:**

bringing these reports to Full Council each quarter to update members and allow a debate on progress against actions to address the crisis.

Council Business Management Committee is asked to consider revisions to the Council’s Constitution to accommodate this.”

The Council also believes that ordinary residents, particularly those most in need and those most left behind, should not have to pay for the Council's financial crisis.


Further, there are ongoing existing challenges, particularly in the Council's housing service, that urgently need to be addressed.
