Brief description of the policy, service or function covered by the EIA	a commissioning strategy for externally provided day opportunities has been developed to ensure that the Council's statutory duties to meet care and support needs including having a diverse range/quality of services available for citizens under the Care Act 2014 can be met. The main proposal in the strategy is the intention to procure a new Flexible Contracting Arrangement. This is intended to stabilise the market, provide incentive to improve quality and outcomes for citizens and allow the Council to plan both financially and in terms of the types and volumes of services needed in future.

Please describe the impact to the age characteristic	In the context of the Commissioning Strategy for externally provided day opportunities the age characteristic applies to those adults who are eligible for care and support from Adult Social Care in line with the Care Act 2014, and who are age 18+. there is also a group of adults who self fund their care and use the same services. Currently 1256 adults access externally provided day opportunities. It is important to note that Day Opportunities support autistic people, those with a learning disability, physical disabilities, acquired brain injury, older adults including those with dementia. Age is considered when supporting each citizen to choose the best service for them to ensure that they can achieve the best outcomes for them.
	As part of the recent co-production there was a focus on understanding day opportunities for older adults, 50+. this is the group where frailty, loneliness and dementia are significant issues and services have to ensure that these issues are responded to effectively. This was informed by national research carried out by Kings College London and Bristol University. Being older doesn't mean that the programme of day opportunities has to be dull and the adults interviewed still had interest in being mentally and physically active and engaged. 30% of people accessing day opportunities fall into the older adults group.
	Similarly, for young adults, 18-30, including those leaving special education want to access day opportunities to be amongst their own age group, with interest in technology and being out in the community. a focus group set up to look at the young adult group identified the following issues:
	<ul> <li>Lack of age-appropriate day time support for younger adults including access during school and college breaks</li> <li>Lack of Information, Advice and Guidance for the age group in one easily accessible location</li> </ul>

	The commissioning strategy is primarily focused on working with the external provider market to stabilise and support the market via a new contracting arrangement and will involve co-producing a service specification that will factor in the diverse status of those who access day opportunities; but alongside this there is scope to address the issues listed above which cut across all age groups in some context.


The proposed commissioning strategy and procurement of a Flexible Contracting Arrangement will set the foundation for quality and value, applying clear commissioning expectations and defined outcomes for citizens. when coproduced the service specification will include the messages that came out of recent engagement with disabled citizens, which included:

What people do now and what they would like to do in the future: One size did not fit all - there was a wide range of preferences and citizens were able to say what they enjoy doing on a regular basis. These ranged from arts and crafts, games, and quizzes, to practical skills and support in daily living. People also wanted to learn and develop new skills, gain qualifications and to find work. Citizens also wanted and enjoyed trips into the community and doing sports and leisure activities. However, continuity and certainty were also important. Families / carers needed continuity in terms of time, location and activity as they needed to plan lives, work other caring responsibilities around these. Staff also needed a level of continuity to enable planning in terms of resources, staffing and transport.

There was a strong sense that services were essential in enabling friendship, community, and mutual support to each other. Long standing friendships and connections were made and citizens wanted these to continue. Citizens said they felt safe, welcomed and could be themselves within services. Many did not feel that they were understood or welcomed in the wider community. We were asked "Can the council help with improving community facilities, transport and raising awareness on promoting the rights, needs and aspirations of citizens with disabilities?"

To support citizens in a person centred and impactful way the staff and services needed to adapt and develop continually. They need to be able to support across a wide range of disciplines as well as those related to the client groups they serve.

As referred to in the "Age" section, the list of issues impacting on the younger disabled group, but which cut across those who are older, will be addressed as part of the commissioning strategy. Co-production with Experts by Experience will be applied across the implementation of the strategy.











	The commissioning strategy is primarily focused on working with the external provider market to stabilise and support the market via a new contracting arrangement and will involve co-producing a service specification that will factor in the diverse status of those who access day opportunities.

As the proposed commissioning strategy is implemented there will continue to be a commitment to co-production so should any unanticipated negative impacts be identified with regard to age then consideration will be given to mitigating against them. tis is why this EA will be reviewed quarterly at least.  The Empowering People Team, a group of co-production volunteers recruited from people who use day opportunities, carers, staff from day centres and others with lived experience, will continue to be active partners for co-production.

Please describe the impact to the sex characteristic	Externally provided day opportunities are accessible to those adults who are eligible for care and support from Adult Social Care in line with the Care Act 2014, and who are age 18+. There is also a group of adults who self fund their care and use the same services. age and disability are the key characteristics that impact on this. in terms of gender, we do not have data on the gender split. this will be collated when the commissioning strategy is implemented. the limited information that is available on people using services suggests a probably 50/50 split in females/males. Currently there is no recording about
	Day Opportunities are expected to respond sensitively when support requires gender specific support e.g. personal care so that privacy and dignity are protected. similarly, if a service user as gender specific support needs related to cultural or faith backgrounds these will be managed appropriately.  There is only one gender specific service that supports South Asian women. otherwise in previous consultation

Please describe the impact to the ethnicity and race characteristic	currently, data is not held about the race and ethnicity of people using day opportunities from the commissioning perspective. The new Commissioning Strategy will address this. In conversation with people who use services and their carers over recent co-production the Council has been told that it is important that race and ethnicity is respected and reflected in the day opportunities environment and not just acknowledged when celebrating festivals etc. There has not been any reporting of adverse experiences re: race and ethnicity.
	the older adult sector has two providers that support Asian elders, one for Chinese elders and one for Caribbean elders. collectively they support 103 older adults. The services developed primarily to support elders with cultural and language needs specifically.  There is one service that supports South Asian women. this was developed to support gender related issues.

This was specifically referenced with regard to adults with a learning disability.
