RATIONALE FOR DECISION DATE	To enable the procurement process to be reopened in May.

## **DECISION SUMMARY**

To agree to have an additional tendering process for NHS Health Check and Smoking Cessation enhanced services in May 2024. As per the procurement strategy approved on 23 February 2023, there have been two previous rounds of tendering through the flexible contract agreement (FCA). Due to the recently introduced Provider Selection Regime, Birmingham City Council is able to follow a direct award process for the next stage of the procurement – specifically Direct Award process 'B' under the new Provider Selection Regime.

Round 2 of the FCA was publicly advertised on 31 October 2023 seeking expressions of interest from organisations who wished to tender. The deadline for tender submissions was 3<sup>rd</sup> January giving GPs, Pharmacies and other qualified organisations 8 weeks to complete their bids. 39 submissions were received for Lot 1 NHS Health Checks. 40 submissions were received for Lot 2 Smoking Cessation Service. Contracts are expected to go live on 1 April. Based on these submissions it is estimated that 21 GP Practices in Birmingham will still not be contracted to deliver NHS Health Checks and 154 GP Practices/Pharmacies will still not be contracted to deliver smoking cessation services following Round 2.

Feedback from GPs and Pharmacies has highlighted that the sector found the tender process challenging. A significant number of Providers found accessing the tendering portal and completing the Supplier information forms challenging. These issues have contributed to some organisations not completing the tender and a subsequent reduction in provision across the City. With the direct award process being taken for this next stage the requirements in terms of the tendering portal and Supplier information forms may be reduced to some extent, with due diligence still being adhered to.
