1.	Yes	Director of Neighbourhoods (Acting)	Reduced licence fees for traders on the Rag Market and Open Market. To apply a 50% reduction in licence fees for non-essential traders and a 25% reduction for essential traders, considered on a case by case basis where traders can demonstrate loss of income. This reduction to apply to the current lockdown period, backdated to the commencement of the Tier 4 restrictions in Birmingham (30 <sup>th</sup> December 2020 until the end of the current national lockdown) and any future lockdown periods related to Covid 19.	To support those traders experiencing severe financial hardship due to trading restrictions incurred during lockdown periods. Without further support it may no longer be financially viable for some traders to return to the markets which will impact on the overall viability of the markets post lockdown. To support the strategic outcome “Birmingham: an entrepreneurial city to learn, work and invest in”.	Maximum cost (if all traders applied and were eligible) would be in the region of £8,000 a week. From 30 December 2020 to 31 March 2021 (presuming this is the end of the national lockdown) the total cost would be in the region of £104,000. This will be funded through Covid-19 grant funding.
