It has been bought to my attention by a notice stuck on a rubbish bin (see enclosed picture) in the carpark of McDonalds Restaurant that they are seeking planning permission to extend their opening hours to 11.30pm which I do believe they are operating already I also believe that this was a temporary arrangement given to them last year, never the less they are operating these hours now!

to McDonalds there are 8 other family Crest View my home is homes in Crest View, I think the way of informing people simply by sticking a letter to a rubbish bin is a very poor standard of communication and letters should be sent to all the local residents! Even so the problems that we have from McDonald's really only effect our family house, I live here with my wife and we are both senior citizens. We have lived here for over thirty years long before McDonald's arrived, we also have raised our family here, we are both now retired. One of the problems, and we have many with McDonalds, is the fact we go to bed at about 10 pm we are often woken at night by cars flashing their headlights/sounding their horns and gatherings on the carpark well into the night and early hours of the morning although this does not happen every night it does happen, and then at 6am in the morning we are often woken again by the sounds of cars and some are sounding their horns for attention at the drive in part of McDonalds, there are other problems too with noisy deliveries three times a week, but that's in the morning, we often have food stuff thrown over the fence and with all the other leftovers often encourages rats, we do have the rat catcher in every so often. It's also no surprise to see people/taxi drivers urinating on the car park and in front of my house, the car park is open without security for 24hrs seven days a week, all sorts of stuff goes on there which I don't really want to talk about. Most people park in the road to eat their fast food and often leave their left overs there too.

I am asking you <u>please do not allow</u> McDonalds to open any later than they do now, we think 6am is too early and certainly 11.30pm far too late when there are people living just a few yards from McDonalds we have simply had more than enough problems as it is....this area used to be so quiet in days gone by!

- 1. Access to our property
 - a. Access up and down our road is already compromised due to persistent parking on the road by employees and customers of McDonalds.
 - b. We have had to go into McDonalds and ask owners to move their vehicles so that we can use the road to get to and from our property.
- 2. Noise
 - a. The microphone system used to take the drive-through orders can be heard from our property and that of our neighbours.
 - b. Further noise pollution from car and motorbike engines ticking over and being revved up.
 - c. The sound of extremely raised voices whilst occupying the car park.
 - d. Radios excessively loud whilst occupants consume their meals; these noises already disturb us throughout the working day particularly early morning and late evenings.

This restaurant is keen to work in partnership with the local police service to prevent crime and disorder.

CCTV

McDonald's operates a robust CCTV Policy to ensure compliance with Data Protection Legislation and to assist the Police with the prevention and detection of crime. At all stores where CCTV is in operation appropriate signage reflecting this information is displayed.

McDonald's operate digital motion activated CCTV systems where images are retained on a hard drive system. All CCTV equipment is of a standard suitable to record images of a proper quality, it meets the industry standard and has LGC Forensics or Kalagate Certification. As part of the digital system an alarm will sound if the equipment is faulty or not recording, thereby alerting management for the need to intervene. The CCTV system is regularly serviced by qualified maintenance technicians.

Access to the CCTV system will be provided to Police Officers at their request.

Staffsafe

A Staffsafe™ system with both audio and visual monitoring capability will be installed in the restaurant, this system, can be activated by either fixed or mobile panic buttons. Once activated the system links the restaurant to an external monitoring centre capable of intervening to resolve crime and disorder issues and/or provide the appropriate advice or instruction to support and protect the restaurant's staff and customers.

At this restaurant all shift managers have safety and security training; including Maybo SIA accredited Conflict Management Training.

Public Safety

This restaurant is keen to work in partnership with the local Fire Service and Environmental Health Officer to ensure public safety.

This restaurant has safety systems in place to protect the safety of customers and staff at all times (such as Staffsafe). 

Thank you for your enquiry regarding your Licence Application for an extension of hours for light night operation from 23:00 to 23:30 7 days a week on behalf of McDonald's Restaurants Ltd, School Road, Yardley Wood, Birmingham .

As the Local Planning Authority we would note that this application seeks to extend the late night opening hours in line with a Planning Approval 2014/05606/PA granted on 30th September 2014 and would therefore be acceptable. However, I would point out that your application states (in section L) that the proposed hours of operation would be from 05:00 to 23:30 hours 7 days a week. I therefore draw your attention to Condition 9 of the attached condition notice (for 2014/05606/PA a variation of the original approval 2002/00001/PA) which restricts trading hours to 06:00 to 23:30 7 days a week. Can you please clarify whether this is a clerical error.

Should your client commence trading at 05:00 (I note from the McDonald's website that the current opening is at 06:00) then this would place them in breach of their Planning Permission and leave them open to Enforcement action. Looking at the planning history for the site there have been two applications for early morning opening at 05:00 in 2008 (Mon to Sat) and in 2012 (7 days) both of these applications were refused on the grounds that the proposed development would adversely affect the amenities of occupiers of dwellings/premises in the vicinity by reason of noise and general disturbance. Given the close proximity of residential development to the site I consider it unlikely that any further planning application to extend the opening hours from 06:00 to 23:30 would be successful.







- Permitted hours during which licensable activities can take place and on compliance with the conditions attached to the premises licence.

The training provided to staff will be recorded and each member of staff will sign and date their training records to confirm they have received and understood the training provided. Refresher training will be completed and documented every 6 months.

The staff training records will be kept at the premises and made available to any Responsible Authority upon request.

Prevention of Crime & Disorder

The premises licence holder will have in place a written drugs policy, search policy, incident handling policy, dispersal policy, drink & drunkenness policy and noise policy prior to any licensable activity taking place at the premises.

All staff members will be trained on each policy. The training provided to staff will be recorded and each member of staff will sign and date their training records to confirm they have received and understood the training provided. Refresher training will be completed and documented every 6 months.

The staff training records will be kept at the premises and made available to any Responsible Authority upon request.

Protection of Children from Harm

The Premises shall adopt a Challenge 25 Scheme and signage shall be displayed on site advising customers of the scheme. All staff shall be trained on the Challenge 25 scheme. The training provided to staff will be recorded and each member of staff will sign and date their training records to confirm they have received and understood the training provided. Refresher training will be completed and documented every 6 months.

The staff training records will be kept at the premises and made available to any Responsible Authority upon request.

As you will see the conditions generally relate to measures already offered in the application but they have been worded in a manner which makes them more meaningful and enforceable.





I was seconded to the Serious and then the Midland Regional Crime & Drugs Squad where I later specialised in drugs and intelligence gathering operations. I left the Midland Regional Crime Squad in 1997 and returned to West Midlands Police where I was stationed at Steelhouse Lane Police Station CID. Following an injury in 1999 I became the Licensing Officer for the Chinese Quarter in Birmingham, I held this position for four years.
- 2. Upon leaving the police in 2006, I set up C.N.A. Risk Management Ltd, a licensing consultancy company providing advice and assistance to operators of licensed premises including: advising on and submitting licensing applications; producing operational management protocols and risk assessments; security advice; mystery shoppers and drugs testing.
- 3. From my experience gained during my time as a police officer responsible for licensing issues, I am aware of how important partnerships between the operators and authorities are. For this reason, a significant amount of my time is spent acting as a liaison between my clients and the responsible authorities. I have attended a number of Licensing hearings as an expert witness in the four licensing objectives.

- 5. C.N.A. Risk Management were instructed by Solicitor Heath Thomas of Harrison Clark Rickerbys Solicitors to visit the premises known as The Arthouse, a multi-purpose venue in Bissell Street, Highgate, Birmingham. I was to look at the operational side of the venue and to see what issue if any the venue would pose. My company have also been instructed to put in place management protocols and procedures to ensure that the premises meet the licensing objectives, in particular, the prevention of crime and disorder and promotion of public safety.
- 6. In conducting my investigation into possible issues at The Arthouse I have found that in Bissell street on a Friday & Saturday there are what we call 'Boy Racers' driving slowly past the front of Arabian Nites, a venue which is located in the same building, occasionally sounding their horns. This is capable of being a nuisance which may amount to Anti-Social Behaviour.
- 7. I have been liaising with West Midlands Police, Environmental Health and the Highways Department with a proposal to eradicate ASB in Bissell Street, by setting up a temporary road closure each weekend from 9pm through to 4am.
- 8. - 7. I park my car near my home and near the premises, and I am able to say that I have experienced no problems with my car. Neither have my neighbours, and it is simply incorrect to say that we have been hit on many occasions. 

In fact, no local residents frequent Arabian Nites, and it is only it hat has been there and I aware that she has verbally abused staff and customers so much so that a report was made to West Midlands Police. On all of the occasions I have been to the premises or in the vicinity of the premises. I have never experienced verbal abuse.

- 16. There is a suggestion that the premises is associated with drug taking and drinking of alcohol. These premises do not sell alcohol, and neither do they permit drug taking. However, drug taking and drinking of alcohol is all over Highgate, and it is not a problem that is either caused by or associated with licensed premises which in my opinion serves only to control the drinking of alcohol.
- 17. There is also a suggestion that there has been criminal damage to wheely bins. I am not aware of this.
- 18, I have not witnessed any aggressive confrontations from youths in their cars.
- 19. also alleges that there is drug taking in parked vehicles. I have not witnessed any of this, When I have been to the premises and in its vicinity, there is no one in any of the cars parked by the premises.
- 20, I disagree with the suggestion that any residents have been threatened as a consequence of Arabian Nites. I have never been threatened or felt threatened in any way in connection with licenced premises and in particular the Arabian Nites.
- 21. The letter suggests that couples are making out on the doorsteps of residents, and again, I have never seen anything like that.
- 22. Parking on grassland and pavements is a common problem within Highgate. This problem particularly exists on Fridays, when the mosque is particularly busy. As a resident of Highgate, we have simply become used to it.

- 23. As regards graffiti, I am aware of graffiti in Northwood Grove, but this is not a problem associated with licensed premises and neither is Arabian Nites the source of any graffiti in the area.
- 24, Regarding the allegation of litter and fast food and bottles, this is not a fast food premises, and I am aware that Arabian Nites does not permit bottles to be taken out of their premises. The allegation is simply unfounded.
- 25. I have not experienced nor am I aware of a persistent problem of people urinating or fouling in or around residents' premises and cars.
- 26. The suggestion that litter and drug use items are left in the Grove because of licensed premises is again unfounded. Aluminium canisters can be found anywhere in Highgate, it is not a problem that has come here because of Arabian Nites, it has always existed in the community.
- 27. As to noise and shouting, car horns sounding at 4am, I have been present at Arabian Nites when it has been closing. I have witnessed people saying goodnight to one another and the occasional car horn but I disagree that this would cause a nulsance to residents.
- 28. There have been occasions of cars sounding and revving their engines, but 1 am aware that Arabian Nites proposes to operate a road closure on Fridays and Saturdays each week, and 1 am confident that this will resolve any concerns relating to noise from vehicles in the vicinity.


