### To Add to Recommendation:

"while expressing significant concern at the omissions, euphemisms and underachievement recorded in the report of the Cabinet member for transportation.

Council notes, in particular, the following:

The very slow pace in developing school exclusion zones, with just six additional zones planned (3.1.33);

lack of progress towards or acknowledgement of the following target, added to the Council plan 2019-2022 by full Council: "identify schools which are exposed to air pollution problems and work with the school to identify intervention strategies to reduce exposure of the children."

a lack of information about road safety schemes (3.1.35) and lack of urgency in the introduction of new Average Speed Cameras (3.1.36);

reference to "improvements" in the Highways PFI programme (3.1.48) when the programme is struggling to maintain the current infrastructure;

an unsupported claim that the city's carbon emissions reduced by 40.6% in 2019 (3.2.3);

the failure to acknowledge significant delays in the Perry Barr "Highway improvements" scheme (3.1.38) and the claim that demolition of the Perry Barr flyover was "successful" when the replacement infrastructure is far from completed;

the failure to acknowledge the significant deficiencies in the charging collection system set up for the Clean Air Zone (3.2.18);

failure to report on progress on the Perry Beeches flood alleviation project (3.2.28-3.2.36)

failure to provide a figure for net increase in tree numbers or to report on number of tree removals offsetting the 31,000 new trees, reported in 3.2.41;

the absence of progress on establishing and supporting electric vehicle charging facilities citywide (not referenced in report).'

This Council notes the recent Government publication of the Integrated Rail Plan for the Midlands and the North, which includes huge potential opportunities for Birmingham.

This Council considers the Government's proposals for Midlands Rail Hub best meet the IRP strategic objectives as they could:

- help improve connectivity and increase capacity by creating new opportunities for services into Birmingham from the South West, and interchange with HS2 at Curzon Street;
- improve access to Birmingham and interchange to HS2, supporting levelling up of economies more widely across the country;
- · provide new, faster cross-country links, encouraging mode shift away from road;
- · improve air quality and reduce carbon emissions; and
- ensure new infrastructure maximises value for money by complementing the new high-speed line to the East Midlands.

The Council supports the Government's commitment to progress work on options to complete the Midlands Rail Hub, focusing on improved services to Hereford, Worcester, Coventry, and allowing more services to access Birmingham Moor Street station (via the South Western Bordesley/Camp Hill Chord). This could give passengers from Bristol, Cardiff and beyond easy interchange to HS2 at the adjacent Curzon Street station, deliver increased capacity at Birmingham Snow Hill Station, and additional commuter services on the Camp Hill Line.

The Council notes that the only way to encourage a modal shift to residents becoming less reliant on the car is to offer as much option within the public transport system and to recognise that for some, privately owned vehicles are a necessity and should be accommodated for in any plans and new station builds (such as the inclusion of park and ride car parks at new stations and expansion of Park and Ride at existing ones wherever feasible).

This Council further notes and welcomes:

The passing of the Domestic Abuse Act in 2021 by the Conservative Government which created a statutory definition, recognised children as victims, created a new offence of non-fatal strangulation and widened other offences including revenge porn, prohibited GPs and other health professionals from charging a victim of domestic abuse for a letter to support an application for legal aid and established in law the Domestic Abuse Commissioner, to stand up for victims and survivors, raise public awareness, monitor the response of local authorities, the justice system and other statutory agencies and hold them to account in tackling domestic abuse;

- new maximum life sentences, under the recently passed Borders Bill for people smugglers and facilitators who often entrap people into modern day slavery and £11 million in spending to help tackle this heinous crime.
- The Conservative government showing its commitment to help women with complex domestic abuse needs in Birmingham by appointing Birmingham as one of the 11 trials in the Respite Room pilot.
- The National Living Wage (NLW) will rise to £9.50 from 1 April 2022. This represents an increase of 59 pence or 6.6 per cent and will support hard working Birmingham residents.

#### We call on the executive to:

Introduce all PSPOs being considered by the Community Safety Partnership
Operation Group and plan for more PSPOs across the city, where needed, to help
empower local police and Council officers to tackle ASBO behaviour in Birmingham.

Council finally calls on the Community Recovery Board to introduce a local by design approach which empowers local communities to have a real control in the design and delivery of local services as it is communities, not the city council, who should drive change.

The following to be added under item 2:

'2.3 To resolve to move from a pilot and project based approach, to one which seeks to deliver net zero at scale and make it the default approach across all Council departments' strategies and policies.'

Section 16 to be amended as follows:

1) Replace the paragraph at the start of 16.2 with the following:

'It is clear the Council needs to move at even greater pace to meet route to zero commitments. The Route to zero team will support the council in scaling up pilots and projects so they become the default approach across the council, in particular, where there are already good pilot projects and initiatives elsewhere. For example: making Passiv Haus the new build specification for BMHT by summer 2023, and trialling whole house retrofits to Passiv Haus equivalent standard.

The R20 team will provide leadership, inspire, and enable carbon emissions reduction for the Council and City as a whole, and will work collaboratively to achieve the significant scale of activity required across key emissions sectors. Working collaboratively with City Council departments, fostering existing external relations, and facilitating new public/private sector partnerships to build investment and delivery capacity will need to sit at the heart of the R20 approach. Key actions to empower and advance collaborative activity will include:'

- 2) Add the following 7<sup>th</sup> bullet point under 16.2:
  - 'Moving from assessments, projects and pilots, to changing the council's approach at scale, so zero carbon becomes the default.'
- 3) Amend 1st bullet point under 16.3 to read as follows:
  - 'Scaling up delivery of whole house retrofits in social housing, using a self-funding approach, with agreed targets of social homes to be retrofitted by summer 2022.'
- 4) Amend 5<sup>th</sup> bullet point under 16.3 to read as follows:
  - 'Creating a total zero waste strategy, including food waste collections, use of anaerobic digestion and in-vessel composting, as a way of dealing with the city's organic waste.'

- 5) Add additional bullet points under 16.3 as follows:
  - 'Develop plans and commence a trial of whole house retrofits to a Passiv Haus equivalent standard by the end of 2022.
  - Scaling up Passiv Haus building of council housing by further updating the new build specification for BMHT to Passiv Haus standard.'
- 6) Amend 4<sup>th</sup> bullet point under 16.6 to read as follows:
  - 'Undertaking a carbon management assessment of Council assets to identify
    opportunities and challenges to decarbonising the City's own emissions, supporting
    asset management decision making, including audit of all council buildings to
    assess and enable installation of Solar PV by the next report to Full Council.'
- 7) Add 7<sup>th</sup> Bullet point under 16.6:
  - 'Implementing a total zero waste strategy ready for the end of the new waste contract in 2034, with the Tysleley incinerator closing in 2034, and removing any need to extend the new waste contract to 2039.'

Insert at the end of (i) Add "This Council further notes that the way to encourage residents to make more sustainable choices to their everyday lives is to increase the offer of public transport before penalising those who wish, and in some cases need, to use a private vehicle and not targeted with extra charges/taxes. The current Birmingham Transport Plan includes a number of measures, such as the potential closure of the A38 Queensway Tunnels which would cause havoc in the city centre and reduce air quality. Further to this the Active Travel Fund scheme includes the City Centre Segments Scheme would also damage business, cause chaos for residents and harm the city centre. The Council resolves to also remove the Low Traffic Neighbourhood Schemes where there is no community support for it to continue.

This Council notes its regret at a decade of failure on recycling in this city, which has seen Birmingham become one of the worst performers nationally. Combined with the Labour Administration's disastrous failure to properly plan for the replacement of the Tyseley Incinerator, this has resulted in excessive quantities of our city's waste being inefficiently burnt each year. Council believes that in order to deliver the route to zero objectives requires a significant step change in services provided by the City Council in relation to recycling and waste disposal with a modern, reliable weekly residual waste collection service that is expanded to include food and green waste, free bulky waste collections, an expanded range of materials that are recyclable at the kerbside e.g. tetra pak (eg milk cartons) and recycling reward schemes."

This Council also notes that:

- The Birmingham Transport Plan (adopted October 2021) includes a key principle of 'prioritising active travel in local neighbourhoods', so that walking, cycling and active travel will become the first choice for most people making short journeys in their local neighbourhoods and cars will no longer dominate street life around homes and schools.
- Travel habits adopted in childhood can shape the behaviour of future commuters and travellers.
- At school drop off and pick up time, many of the vehicles close to schools are those of parents and carers on the 'school run'.
- School admissions policies can affect the distance children travel to school and how families choose to travel.
- Partnership work between the Council, schools and parents/carers is essential to deliver reductions in traffic at the school gate.
- Many parents and carers integrate the 'school run' into a longer trip, such as to a workplace.
- Delivery of wider transport improvements, as set out in the Birmingham Transport Plan is essential to deliver reductions in traffic at the school gate.
- The Council is using Clean Air Zone revenue funding to tackle these issues, sharing the benefits of the Clean Air Zone with communities across the city.
