4. **Budget 2020-** The Ward Councillors introduced the budget proposals for 2020 and encouraged residents to go on line and have their say. The Ward Councillors proceeded to read out the budget headings from the consultation ,Councillor Mahmood then asked the residents to consider what services were important to them .The residents discussed the budget proposals and said that waste and litter were the important issues to them ,they also identified the following specifically.
 - a) Free bulky waste collections should be reinstated
 - b) More street cleaning.
 - c) More bins by shops and bus stops in the Ward.
- Action** – The residents views to be forwarded to the Consultation.
5. **Ward Plan** – The Cllrs re capped on the previous Ward meetings where the Ward Plan had been discussed, Cllr Donaldson gave the group an opportunity to read the document and as a group they then went through the draft document page by page .Cllr Donaldson noted a couple of minor amendments before the group agreed the Ward plan for 2018 to 2022.
6. **Petition – Prior to this item Councillor Donaldson declared that she was unable to take part in this discussion as she was on the Planning Committee**
Cllr Mahmood gave an update on the Brockhurst Road H.M.O planning application and petition saying the objection had gone in on the grounds of insufficient parking and that he would attend the planning committee meeting to represent the Ward if the case arose.

7. **Residents issues and resulting actions** – Littering and trade waste in Hodge Hill generally but practically around the Fox and Goose area and shops ; lack of litter bins by shops and bus stops in the ward ;volume of waste between the Fox and Goose and Druids lane ; obstructive parking on the pavement and grass verges at Coleshill Road and Ventnor Ave . **Actions** Cllr Donaldson to email Assistant Director for Waste with regard to street cleaning in the Ward ;Cllr Donaldson to report a fallen/vandalised bin outside 124 Stechford Road .
