## **Councillor's Updates**

- 2. Thank you to J.L.R for helping with Jones Wood and Stephens Pool.
- 3. **Wishaw Lane playing fields** Attempts to gain match funding to maximise advantage from available 106 funding continue. It also looks as if there will be a sports club that will be ready and willing to take on and run any sporting facilities that can be provided.
- 4. **The development of the SUE (Langley) and Peddimore sites.** A consultation group had been established, to allow views on supplementary planning documents to be put forward, and to act as a conduit for informing the wider community of progress.

## Stephens Pool - Access to Employment a bid from Kingstanding Regeneration Trust

Councillor Wood and John Mole explained that a local charity had summitted a bid to regenerate a Stephen's Pool by Berryfields Road, Cllr Wood added that Jaguar Land Rover employee's had already been working on the site to clean the pool and Severn Trent Water Authourity have committeed to testing the Water at the site for free. John Mole went on to explain that The Kingstanding Regeneration Trust (KRT) is a charity established in 2007 who work with our local communities and partner organisations to design and deliver initiatives that create employment and learning opportunities for residents and young people while improving existing and creating new green spaces for community use. John said that this project was for young people who were more inclined to utilise their skills in a physical environment rather than going down an academic route and would provide the young people with professional training and a NVQ2 entry level qualifications in the world of horticulture. John went on to say that K.G.T had put a bid in for the full £48,000 of local innovations fund for New Hall.

#### Residents views -

• Jones Wood was successful due to the amount of Volunteers ,how would this been addressed? John Mole said that one of KGT's specialisms was to develop Volunteer groups to keep project sustainable.

- When is the LIF deadline? John said projects had to be approved by Cabinet Committee Local Leadership by December 20<sup>th</sup> 2017.
- Whats the approval process ?John explained that firstly all three ward councillors had to agree on the project(s) to put forward to this fund ,then the Neighbourhood Development Team would assess the viabilty of the project and write an assessment for the members of Cabinet Committee Local Leadership and the final stage was for those Councillors to approve or reject the proposal.

Councillor Barrie said that himself, Cllrs Wood and Yip had discussed the project and would be recommending this project throught to the next stage of the process.

### **Consultation on Signal Hayes Community Facility**

Councillors Barrie and Wood gave a brief overview and summing up on the Signal Hayes Development and to the changes that had been previously proposed for a Community Facility. Rather than a constructed managed site(Taylor Wimpey and the Y.M.C.A) that had been original been agreed upon and which formed part of the planning consent. There was now a proposed deed of variation to provide a sum of £3.5 million for the local community to invest in a community facility. There a lengthy discussion between all party's Residents of Signal Hayes, Walmley Residents Association, Residents of Webster Way, Local Volunteers, the Ward Councillors, Y.M.C.A representative and a representative of Taylor Wimpey. The mains concerns were over the size of the fund it was felt inadequate by some residents, it's administration, the type of facility that would be agreed by planning officer and the consultation.

Action: Cllrs Barrie and Wood requested residents to email them with their concerns and proposal as well as asking all present to leave their contact details so that they could call a specific meeting on this issue and take all the communities concerns forward to the planning officers.

## **Residents Questions**

- Do you have any details on the Walmley Golf Course Development? Councillor Barrie said that local residents to the Golf club had been contracted and there was currently a consultation going on. The proposed development was for a new clubhouse, 14 houses and 30 + retirement apartments.
- Residents raised their concerns over a van parked at the side of Eachelhurst road that opposite the old Esso garage which is covered in advertisements for a local business which is distracting for drivers. Councillor Wood said that this had already been highlighted to them and were in the process of arranging enforcement action.
- One of the No right sign on Walmley Ash Road by the Band M store not visible due to overhanging trees and possible the no entry sign in the wrong place Councillor Wood to raise with Amey
- Concerns raised over rumours of the proposed all weather pitch with the addition of flood lighting at the Deanery School. Councillors advised this will need planning consent.
- Weaver Ave Local residents concerned over speeding vehicles at all hours of the day and night .Cllr Wood to refer on the local Police team.
