#### **Presentations**

- Barford Tiger Hockey Club Dr Sakhdav Gill and four young members of the Barford Tigers gave a brief presentation on the Club which is celebrating its 50<sup>th</sup> Year. He explained how the club had been reaching out to the community over the last 50 years and how the club has supported young people to develop their character through activities that keeps them away from becoming involved in crime etc. The benefits they gained are:

### Ward updates

**Local Police Team** –PC Willis updated the Councillors and residents on the crime figures for the Ward .In comparison for the same period in 2015 crime was up. Robbery there were 23 more reported incidents; burglary 18 more reported incidents; Vehicle crime 12 more incidents and 24 more reported incidents of Domestic Violence. PC Willis also took residents and Councillors questions.

Private Landlords - Roy Hasleden from the Private Rented Sector team took questions from the residents, Handsworth Wood Residents Association and the Ward Councillors .Roy explained the scope of the teams work with regard to HMO's and provided the audience with lists of licenced properties and Hostels in the Handsworth Wood area. Some of the issues residents were experiencing were out of the Private Rented teams scope (ASB, rubbish and drinking in front gardens), Roy signposted the residents to the correct departments .This lead on to a discussion were residents felt that private landlords should be licenced as some were not acting responsibly and that there should be more proactive support for migrants and the newly arrived as several cultural issues need to be addressed.

Councillor Hamilton asked if the Handsworth Wood could be considered for a pilot scheme similar to what was currently underway in Selly Oak with regard to the licencing of private landlords, Roy said that he would take this request back to his manager for consideration.

Early Years Health and Wellbeing Offer

Thank you for your correspondence regarding the future of Children's Centres in the Handsworth Wood ward.

As you may be aware, the commissioning of a new service model to meet the health and wellbeing needs of children and families during their early years is part of a major transformation programme. The Directorate is currently rethinking the way that we deliver all Early Years Services in Birmingham.

The latest position is that the City Council has just commenced the procurement process for the a new integrated health and wellbeing service to support children and families during their early years. Delivery of this new integrated offer is a key component of the Children's Improvement Plan. The new approach will create:

- A more targeted model of service delivery to ensure that additional support is provided to those families who need it the most.
- A new model that is focused on services and outcomes for children and families rather than buildings.

  A more integrated model of service delivery with system leadership being provided by a lead organisation.

At this stage it is not possible to say what changes there will be to individual children's centres. We are keen to ensure that the valuable support they provide to children and families is maintained however acknowledge that to do this with a reduced budget some significant changes will be necessary. It is likely that to maintain services we may have to reduce the number of buildings we operate of and work more closely with communities. As we move through the procurement process the details of the proposed new model will become clearer. Where these include changes to specific children's centre we will undertake a period of formal consultation to enable local people and others to express their views.

There is information available on the City Council's website including the service specification, commissioning strategy and needs analysis along with consultation documents and presentations given at three market shaping events which were held to inform all stakeholders about the Council's intentions.
