To permit the provision of Late Night Refreshment, to operate indoors only, from 11:00pm until 02:00am (Sunday to Thursday) and 11:00pm until 04:00am (Friday and Saturday).

Premises to remain open to the public from 09:00am until 02:30am (Sunday to Thursday) and 09:00am until 04:30am (Friday and Saturday).

I only know of the application by chance as someone happened to see it posted on the lamppost outside the premises.

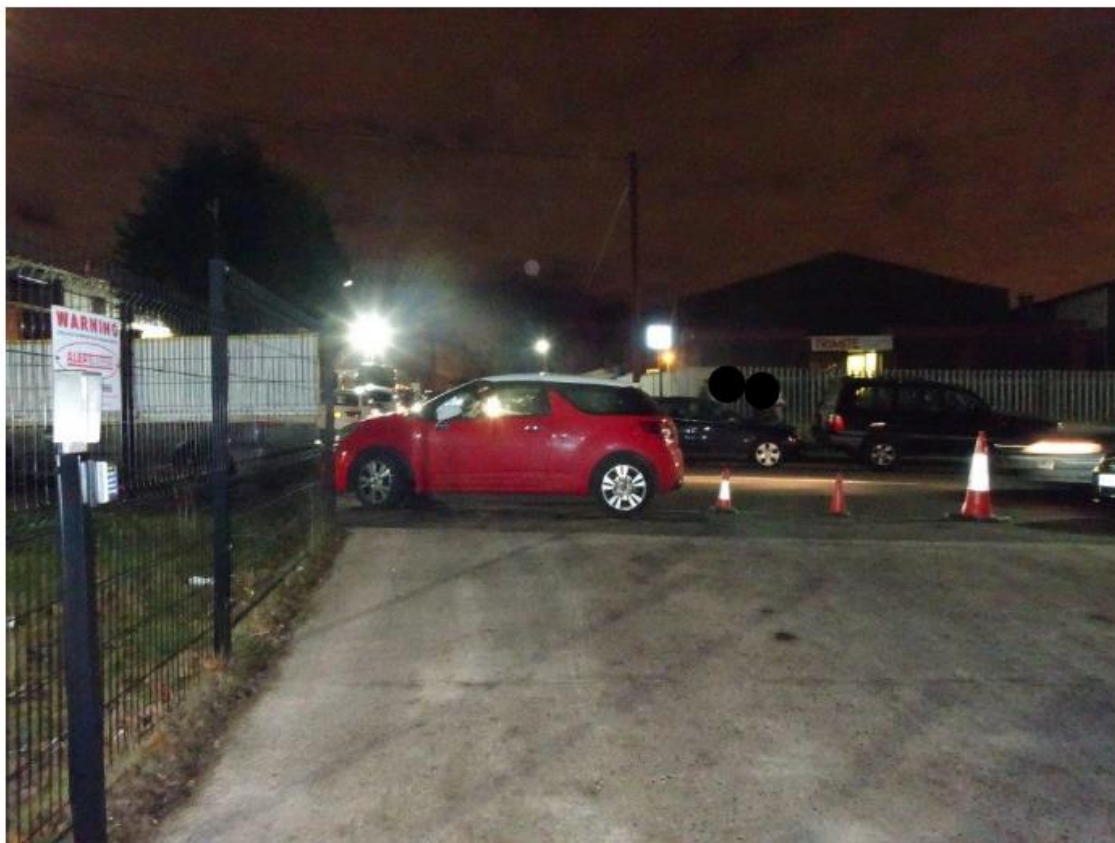

Generally we will take on the existing license conditions imposed and these have been extracted and form part of the sections below. We feel that due to the lack of problems historically and the location of the venue being in a non-residential area, along with the types of events being considered and our robust policies, procedures, experience and training that we be allowed to open an extra 2 hours on weekends (until 4am). Likewise for NYE events only this be also extended as requested.

A full general risk assessment has been undertaken by external health and safety consultants bespoke to the venue.

Likewise a venue specific training course is being developed to include coverage of the licensing objectives, basic first awareness and fire safety training.

In addition there will be a range of event risk assessments to cover the basic types of general events being considered. For those event outside the scope of these then a specific event risk assessment will be undertaken prior to the event.

b) The prevention of crime and disorder

The premises licence holder shall install, operate and maintain a CCTV at the premises in agreement with the police. The system will enable frontal identification of every person entering the premises. The system shall record in real time and operate whilst the premises are open for licensable activities. The recordings shall be kept available for a minimum of 31 days and will be made available immediately on request to an authorised officer or a police officer (subject to the Data Protection Act 1998) throughout the preceding 31 day period following any incident. The premises licence holder shall ensure a member of staff with knowledge of the CCTV will be present on site whilst the premises are open to aid any enquiry from a police officer or authorised officer requiring recent CCTV recordings with the minimum delay when requested. Appropriate signage will be displayed, in a prominent position, informing customers that they are being recorded on CCTV.

A general risk assessment will be in place for each type of event at the premises; these will include measures to mitigate risk of crime and disorder.

Special events will likewise have a specific risk assessment in place prior to the event being authorised.

SIA will be on duty for events beyond 2300hrs involving the sale of alcohol. These will be provided by external security company and profiles of all door staff will be made available.

All SIA will wear their badges externally and wear HiViz in external areas.

Numbers of SIA will be dictated by the risk assessment, at the very least 1 per 100.

c) Public safety

A full fire risk assessment has been undertaken for the premises that includes a range of capacities allowed dependant on the use of the building internally and floor space etc. This has been undertaken by external professional consultants.

A fire alarm system is in place throughout as well as fire fighting equipment for use by staff.

All staff will undertake fire training upon induction and fire warden training for selected persons.

Emergency lighting and fire exit signage is in place throughout as well as other fire measures.

Maximum allowable capacities will be communicated prior to the event as part of the risk assessment and these will be monitored by door staff to also include staff members.

Any TDS (including staging) and/or temporary electrical sound equipment or similar will be signed off before use by a repressible person.

d) The prevention of public nuisance

Regulated entertainment shall take place indoors only.

No deliveries will take place between 21:00 and 06:00 hours.

After 23:00 all entrance doors and windows will be kept closed to allow for immediate access and egress to the premises.

Notices shall be displayed at all exits requesting patrons to leave the premises quietly.

All regulated entertainment and similar shall take place indoors.

Access to outside smoking area will be via two sets of doors to eliminate/reduce noise emanating from the venue. Smoking area will be manned by stewards to keep noise levels low. Smoking area located so as to not cause nuisance.

There are no residential properties in the immediate vicinity.

e) The protection of children from harm

A challenge 25 policy will be adopted at the premises and signage shall be displayed with regard to this.

The premises licence holder shall ensure that the training that is given to staff to be documented and refreshed every 6 months and that the training records are made available upon request to an authorised officer or police officer.

Staff shall be trained in the relevant legislation of the Licensing Act 2003 with regards to age verification, children and alcohol.

A refusal register shall be maintained at the premises and made available for inspection by a police officer. This log shall include the date, time and signature of staff member who refused the sale. The refusal register shall be signed by the designated premises supervisor on a monthly basis.

- Indoor sporting events: no licence is required for performances between 08:00 and 23:00 on any day, provided that the audience does not exceed 1000.
- Boxing or Wrestling Entertainment: no licence is required for a contest, exhibition or display of Greco-Roman wrestling, or freestyle wrestling between 08:00 and 23:00 on any day, provided that the audience does not exceed 1000. Combined fighting sports – defined as a contest, exhibition or display which combines boxing or wrestling with one or more martial arts – are licensable as a boxing or wrestling entertainment rather than an indoor sporting event.
- Live music: no licence permission is required for:
 - o a performance of unamplified live music between 08:00 and 23:00 on any day, on any premises.
 - o a performance of amplified live music between 08:00 and 23:00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - o a performance of amplified live music between 08:00 and 23:00 on any day, in a workplace that is not licensed to sell alcohol on those premises, provided that the audience does not exceed 500.
 - o a performance of amplified live music between 08:00 and 23:00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
 - o a performance of amplified live music between 08:00 and 23:00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school or (iii) the health care provider for the hospital.
- Recorded Music: no licence permission is required for:

 - o any playing of recorded music between 08:00 and 23:00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school proprietor or (iii) the health care provider for the hospital.

- Dance: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 500. However, a performance which amounts to adult entertainment remains licensable.
- Cross activity exemptions: no licence is required between 08.00 and 23.00 on any day, with no limit on audience size for:
 - o any entertainment taking place on the premises of the local authority where the entertainment is provided by or on behalf of the local authority;
 - o any entertainment taking place on the hospital premises of the health care provider where the entertainment is provided by or on behalf of the health care provider;
 - o any entertainment taking place on the premises of the school where the entertainment is provided by or on behalf of the school proprietor; and
 - o any entertainment (excluding films and a boxing or wrestling entertainment) taking place at a travelling circus, provided that (a) it takes place within a moveable structure that accommodates the audience, and (b) that the travelling circus has not been located on the same site for more than 28 consecutive days.

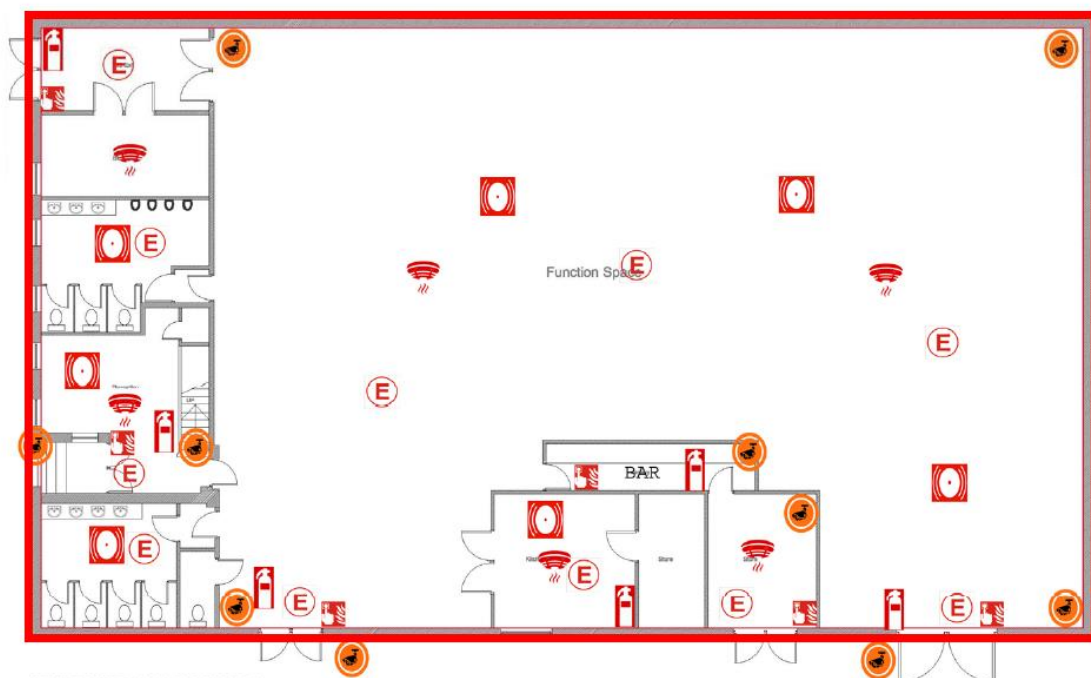

- If the premises wish to operate after 02:00, then the licence holder needs to provide a minimum of 7 days notice to WMP licensing.

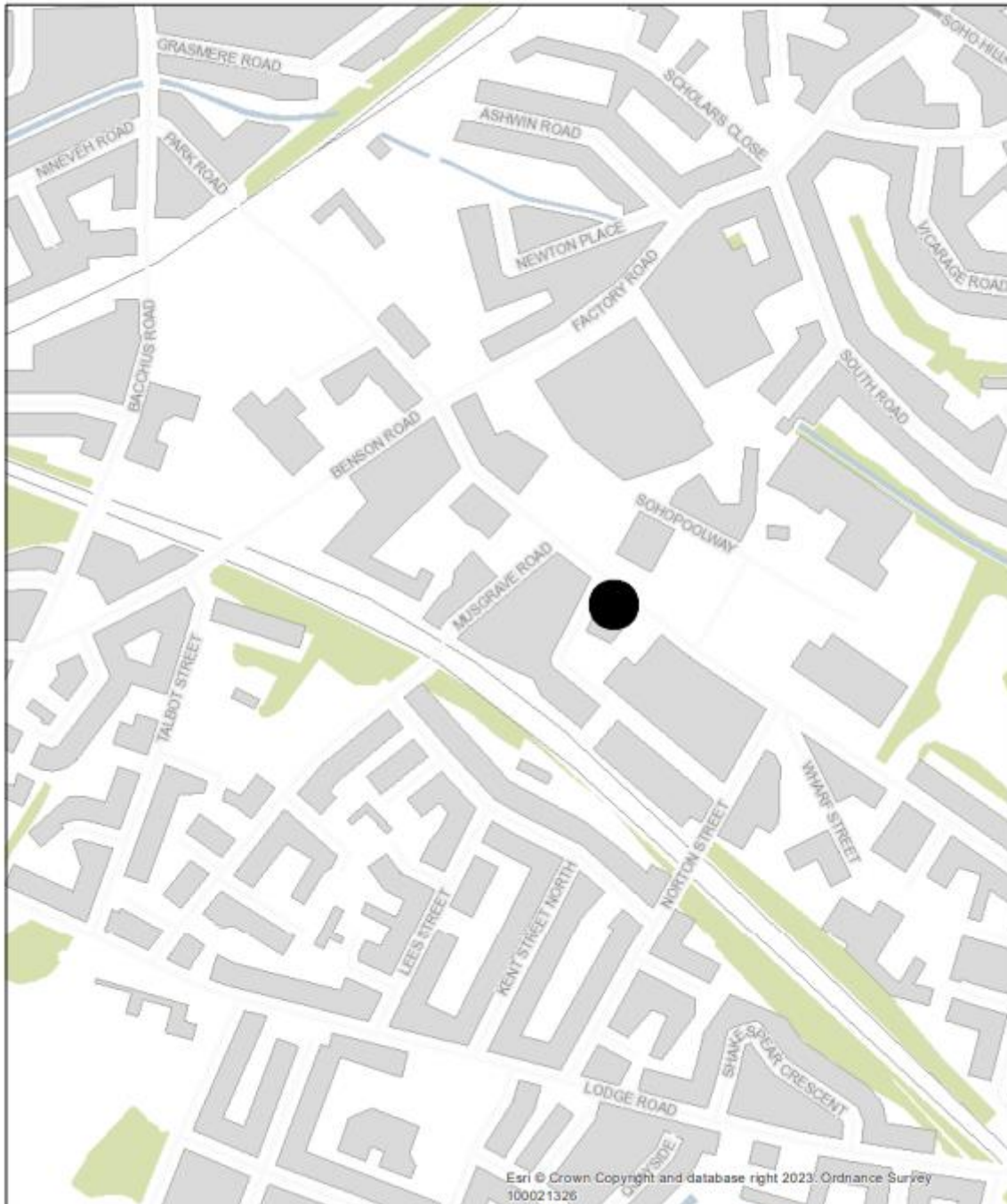

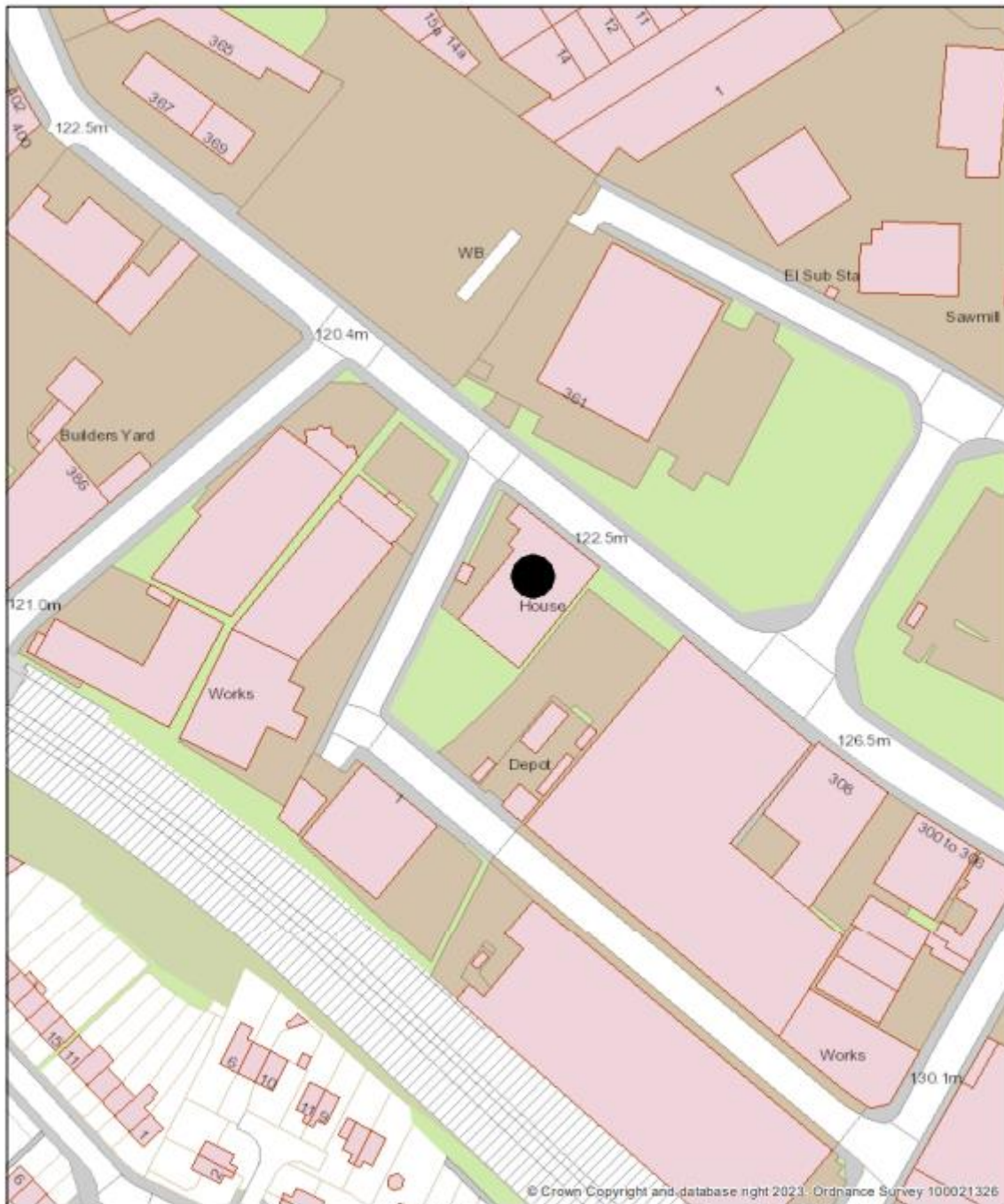

1. This form is to be used for the NOTIFICATION of up to 2 gaming machines of categories C and / or D under Section 282 of the Gambling Act 2005, or the GRANT / VARIATION / TRANSFER of a gaming machine permit under Section 283 and Schedule 13 of the Gambling Act 2005.
2. All references to 'Premises Licence' refer to a Premises Licence under the Licensing Act 2003 authorising the sale of alcohol for consumption on the premises.
3. The premises must be licensed under the Licensing Act 2003 to sell alcohol for consumption on the premises.
4. A 'Premises Licence holder' is a person holding a Premises Licence under the Licensing Act 2003.
5. The gaming machines must be located on these licensed premises and there must be a bar for serving alcohol to customers on the premises, without the requirement that alcohol is served only with food.

 - Category D: Maximum stake = 10p or 30p non-monetary / Maximum prize = £5 cash or £8 non-monetary
8. The holder of a licensed premises gaming machine permit must comply with any relevant Code of Practice issued by the Gambling Commission under Section 24 of the Gambling Act 2005. Policy and Procedure Overview

We understand when considering this application that the Licensing Authority will consider the 3 objectives of the Gambling Act 2005 and therefore have set out below the policies and procedures JD Wetherspoon undertakes in its pubs to promote these objectives. In addition, the Gambling Commission's "Gaming Machine Permits Code of Practice" is complied with.

1. Protecting children and other vulnerable people from being harmed or exploited by gambling.

To ensure that no persons under the age of 18 are permitted to play on our gaming machines, we abide by a Challenge 21/25 policy in all of our premises. Under this policy, all of our employees are trained to ask any customer who appears to be under the age of 21/25 years to provide valid proof of age that they are over the age of 18. When in use, Door Supervisors are also fully briefed on our policy and what is expected of them in the implementation of the same.

JD Wetherspoon has adopted the industry standards and the recommendations of the Gambling Commission and recognises only the following forms of identification as valid forms of proof of age:

- Valid National passport (any nationality)
- Valid Photographic Drivers' Licence
- United Kingdom 'PASS' accredited age identification card with photograph.
- UK Military ID
- Valid photographic European ID
- Ireland Age Card (Republic of Ireland only)
- NI Electoral Identity Card (Northern Ireland only)

We apply this policy to all age restricted activities on our premises.

All employees receive induction training on our Challenge 21/25 policy when they commence employment with the Company and then receive regular refresher training. All employees complete video training, quizzes and sign a letter to confirm that they have had this training and understand their responsibilities. Records of all training is retained centrally at head office via our online training platform. Staff training records are regularly reviewed by the pub management team and members of our Retail Audit department to ensure that the training system is being satisfactorily completed.

Staff compliance with our Challenge 21/25 policy is tested by a number of means:

1. Management review of a 'refusals log' which records when and how often bar staff are recording when a sale has been refused.
2. Independent mystery visitors who are aged 18 and 19 years are sent into our pubs to test compliance with our Challenge 21/25 policy.

Our Challenge 21/25 policy is also actively promoted within the premises using self-adhesive signs at every entrance and on/around gaming machines.

All front of house staff are aware of their responsibility for preventing underage gambling.

All machines are situated in a place where their use can be supervised and in front of the bar where possible to increase visibility.

Information shall be made available to customers on how to gamble responsibly and how to access information about and find help in respect of problem gambling. The Gamcare Charity's details are made available by way of a sticker on each of the gaming machines.

JD Wetherspoon ensures that there is always a duty manager working on every shift. This means that there is always a senior member of the team on duty to assist with the monitoring and supervision of persons using the machines should customer interaction be required.

2. Preventing gambling from being a source of crime or disorder, being associated with crime or disorder, or being used to support crime.

The power to all gaming machines is turned off after the pub has closed to ensure potential thieves are not attracted by the lights in the pub.

JD Wetherspoon pubs also have two types of alarm systems, the panic alarm and intruder alarm, which cover the majority of the pub including the customer area where gaming machines are located.

The monitored intruder alarm covers the main entry points when the pub is closed. It is mainly activated by a forced entry into the pub triggering the door contacts or motion detectors. This pub is internally described as having a 'level 1 response' to its alarm system, meaning police response. This is an automated system which feeds through to Secom central station, our alarm consultants, who notify the police and the registered key holders of the pub.

JD Wetherspoon prides itself on provide safe, well run premises for all people to enjoy themselves in. Over our estate of over 800 pubs we spend considerable time and resources ensuring they are all well equipped with adequate and appropriate CCTV coverage.

3. Ensuring that gambling is conducted in a fair and open way.

All of our AWP machines are located in well supervised areas and are regularly monitored by staff and door staff.

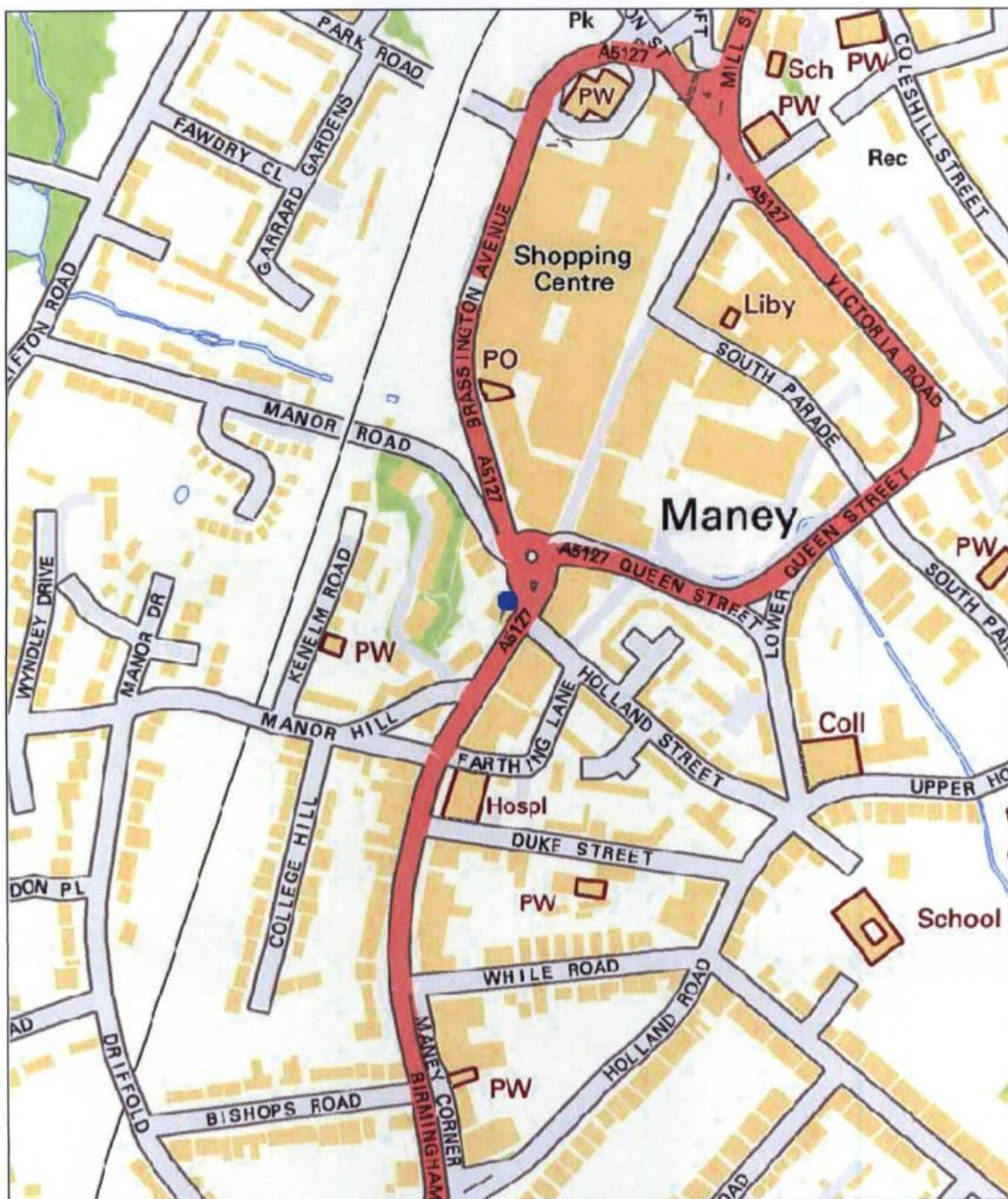

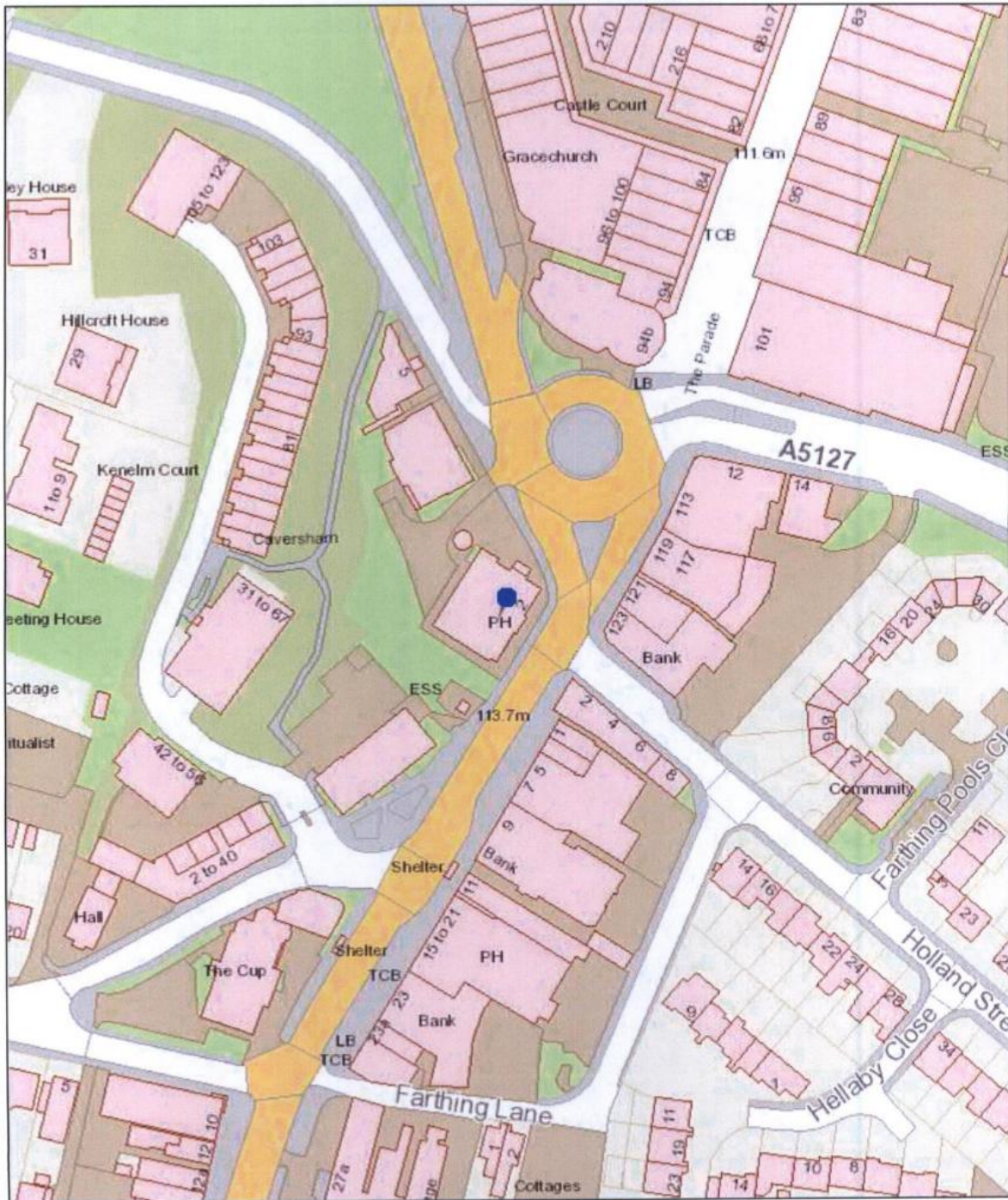
