






Children and Families Directorate

- 1,757 staff covering 26 service areas
- Supporting 320,000 children with universal services
- 10,500 children and young people have an EHCP
- 4,400 vulnerable children receive services from Virtual School



Improvement Journey

- DfE appointed commissioner John Coughlan CBE overseeing key improvements in SEND services
- Re-established Birmingham Children's Partnership working with all key agencies in the City to support our children and families

Strategic Priorities

- 1. Strengthen approaches to identify, recognise and respond to the vulnerability of specific groups of children and young people
- 2. Transform and improve services for children with Special Educational Needs and Disabilities in line with statutory requirements and to deliver sustainable, well performing services, with inclusion of children and young people at the heart
- 3. Transform and improve Children and Young People's Travel to deliver a sustainable, well performing service, with outcomes for children and young people at its heart
- 4. Ensure services are sustainable, compliant with statutory requirements, and designed to deliver best outcomes for children, young people, families, and communities

Progress

- Education and Skills directorate renamed as the Children and Families
 Directorate. A clear emphasis on placing children and families at the heart
 of our focus and services.
- Stability and permanence to directorate management team
- Focus has been on getting the basic rights baselining of all 26 service areas to inform improvement plan

- SEND and improvement update on our accelerated progress plan is being shared with O&S today
- There is much work to address the significant weaknesses that were identified in our last Ofsted / CQC inspection
- SEND Strategy refresh
- SEND Improvement Board chaired by DfE appointed Commissioner (CM attends) monitors the APP
- Staffing increase in key areas SENAR, HTST has seen notable improvements in performance



Birmingham Children's Trust

- Performance of our BCT continues to improve
- Number of focused inspections and recent inspections have shown improved proress
- Appendix 1 in report sets out priorities and progress
- Good practice is firmly embedded in programmes such as Stronger Families, EmpowerU Hub, Early Help offer Preparation for Adulthood. Introduction of the Practice Model for the Trust build on relationshipbased practice and much more.
- Quality Assurance Framework firmly embedded

Corporate Parenting

BCT challenges

- Financial challenges growth in numbers of children in care
- Increases across residential care and supported accommodation and finding good care placement
- Risk in complexity of need of children and young people in our care
- Resources being stretched recruitment and retention both local, regional and national shortage of social workers

Provider/Organisation	Contract purpose
Birmingham Education Partnership	School improvement. BEP is commissioned by the council to deliver school improvement and development to schools.
Birmingham Community Healthcare NHS Foundation Trust	0-19 healthy child programme. BCHT provides health visiting, school nursing. Commissioners commission the healthy child programme with BCHT on behalf of public health.
Birmingham Children's Trust	BCT provides children's social care, early help and youth offending services for the council.
StreetGames	StreetGames are the lead organisation the council commissions to coordinate (and provide some elements) of the Holiday Activities and Food Programme. They subcontract with smaller organisations city wide to deliver the range of activities and food into local communities
Birmingham Community Healthcare NHS Foundation Trust	BCHT delivers a number of therapy services on behalf of the council. These include Speech and Language Therapy and Occupational Therapy Services. These support children and young people with SEND.
