Sarah Smith declared that she is the Chair of All Saints Multi Academy Trust (MAT), and BTMAT, and is a member of Fioretti Trust, which all have Birmingham schools.

5. SEND

Sue Harrison, Director, Children and Families, Bob Harrison, Project Manager, and Johanna Condon, Interim Head of SENAR Operations (online) were in attendance. Apologies for non-attendance were received on behalf of Sabiha Aziz, Chair, Parent Carer Forum.

Sue Harrison highlighted that SEND is a partnership priority, the conversations they are having around the national agenda, and the discussions with school leaders to agree what good inclusion looks like.

Bob Harrison commented on the evolution of local strategies and improving capacity of places and spaces, capacity of settings able to support effectively, and the capacity of professionals, with a joined up approach to supporting children and families.

A point of accuracy is that the national average of children and young people with an EHCP plan educated in mainstream is approximately 40% and not 50% as previously stated (page 5).

Details of what they learned from the co-production workshops for SEND and Inclusion strategies, the key data, and the national trend is seeing an increase in EHCPs.

Sue Harrison highlighted that the data does not capture the school support provided for those that do not have an EHCP and they are exploring ways to capture this. Updates for objectives 1, 2, 3 and 4, and the golden threads within objectives to deliver the greatest impact, with the LGA having offered peer to peer support, and SENDIASS review and actions, were also provided.

During the discussion and in response to queries raised by Members, the main points included:

- Feedback from schools is more positive as officers are in post offering advice to schools.
- There is a lot of work around children who are awaiting a special school placement and the role of the Home Bridging Team, and the dedicated team for children awaiting a special school placement was given.
- Accountability for those children in the wrong settings awaiting a special school placement: the final drafts will go to the SEND Improvement Board in November 2022 for sign off in December 2022, and then they will go to Cabinet. It is anticipated it will be operational from March/April 2023.
- Staffing pressures and capacity: the permanent structure is being modelled.
- Support for young people at risk of exploitation: this is part of the breaking down barriers work they are undertaking and the Children's Trust and EmpowerU, Home Bridging Team, the Council's Pupil Referral Unit (PRU) – City of Birmingham School, Lindsworth School etc., support this.
- Officers are working with school leaders on restorative practice with primary schools regarding children who have been excluded. The Council have the power to direct schools to take on pupils and the restorative practice work will assist with this.
- The Inclusion Strategy and reassurances regarding white working class boys and African Caribbean children under achieving: Officers are developing local provision and they will be focusing on these particular groups. They are looking at learning lessons, and the Child Criminal Exploitation Inquiry, and the Employment and Skills Inquiry, can explore this in more detail.
- The Head of Service for SENDIASS has accepted the recommendations and the DfE Commissioner for SEND will be attending the committee meeting in October. Progress will be reported on and members were assured that parents and carers will have access to an independent service.
- The Chair shared the concerns that the Committee has not been party to the
 review and the detail on which the recommendations were made. Inviting the
 Head of Service for SENDIASS to the October meeting was discussed, and it
 was agreed that a meeting should be set-up with the DfE Commissioner for
 SEND, Director and Chair to discuss officer attendance at the October meeting
 and what information can be shared with the Committee.
- They are working on a SEND Strategy, SEND Sufficiency Strategy, and an Inclusion Strategy and timescales for when the Committee can expect them was requested.
- The Cabinet Member suggested that when meeting the DfE SEND Commissioner it may be worth looking at future reporting arrangements and timings of the SEND Improvement Board and this committee.
- They have put in a bid for three new special schools.

- Schools can come back with reasons why they think they cannot support the child in their school, which the Council responds to by providing information on how support can be provided to meet the needs of the child.
- Officers do monitor children that are on part-time timetables, although this is reliant on the schools providing the information.
- Information on how many children are affected by part-time timetables, and figures on children who haven't got a suitable school place, and support that is being provided, was requested.

6. CABINET MEMBER FOR CHILDREN, YOUNG PEOPLE AND FAMILIES

(See documents No. 3 and 4)

Cllr Karen McCarthy, Cabinet Member, Children, Young People and Families gave the presentation and provided a summary of her portfolio, strategic priorities, progress, corporate parenting, the national lack of secure placements, and commissioning. The Cabinet Member highlighted that the cost of living crisis and the impact on children with additional needs is concerning.

During the discussion and in response to queries raised by Members, the main points included:

- The Directorate's response to how we can help families on the cost of living crisis: Cllr John Cotton, Cabinet Member, Social Justice, Community Safety and Equalities will lead on this work across the city. Cllr Karen McCarthy is having a discussion as to whether to establish a separate group for children, and the Council needs to have a plan in place. All Councillors and stakeholders will need to be kept informed on this.
- Item 9. Commissioning in the report (page 45) refers to BEP and the length of the contract and what BEP are doing about exclusion rates was queried. The BEP contract is coming up for review, and it is vital that exclusions should be

about finding the best place for the child, and BEP will be vital in providing reassurance and offering support to schools. The Director will get back with details regarding when the contract was renewed and the duration of the contract.

- Helping hard to reach children: objective 4 is looking at pathways and what the right type of provision at the right time is for the child.
- The five commissioned partners are accountable to the Council. The Lead Commissioners can report to O&S and a representative from the organisation can be invited on a voluntary basis to attend. It was agreed that Tim Boyes, Chief Executive, BEP would be invited to a future meeting.
- A Member felt that more mental health provision was needed, and the Cabinet Member is interested in exploring this with partners. The Committee's Joint Task & Finish Mental Health Inquiry will also be looking at this.
- A Member expressed concern that the Holiday and Food Programme (HAF)
 eligibility criteria was only for children entitled to free school meals. Moving
 forward Councillor Karen McCarthy and Cllr John Cotton are mindful of the
 greater need.
- The structure chart for the Children and Families Directorate was requested.
- Baselining of services within the Directorate had been completed and a request was made for this to be shared with the Committee.
- The deadline for the funding bids for three free schools is October 2022 and details, including other timescales was requested.
- Information on how many excluded primary school children have unmet SEND needs / EHCPS was requested.
- The Children's Trust is an item on the November 2022 committee meeting and the following will be discussed:
 - Resources projected, but unfunded, growth in numbers of children in care, and a significant rise in the complexity of need of those in our care, for whom the market fails to provide placements and who require, as a result, bespoke high-cost care packages was raised.
 - Information on Appendix 2: Birmingham Children's Trust summary of performance 2021/22 (page 52) PI 13 % of agency social workers (including team managers) not met the targets.
- There are schools that do not take pupils with SEND which then puts pressure on other schools.
- Information was requested on the number of places that Special Schools accept above their Planned Admission Number. Do the plans for future Special

- School places take into account these numbers in addition to places required to meet the needs of children who are currently not in a Special School?
- The Cabinet Member was asked if she can attend the 5th April 2023 committee meeting which is when the Children's Trust will be attending to provide an update on their priorities and performance. The Cabinet Member stated that if she cannot attend in person then she will attend on-line.



Update and discussion



Children's travel – start of term headlines

- Significant progress has been made to mitigate the issues that affected the start of the academic years in 2020 and 2021.
- Comprehensive preparations took place over the summer, and an operations centre was based at Woodcock Street for the first week of term.
- 99.5% of routes ran successfully on the first full day. 99.7% on 08/09 and 99.9% afterwards.

Children's travel – start of term headlines (cont)

- Encouraging feedback was received from stakeholders including the PCF and special school headteachers.
- It has been recognised that communication with families, schools, and providers has significantly improved.
- The press and social media activity were notably down on previous years, and the team received far fewer family inquiries and complaints.



Children's travel transformation.

- An Improvement Programme was launched in March 2021. A Programme board meets on a monthly basis to drive change.
- The programme's workstreams are matched to six themes. These incorporate areas of additional focus on contracts and commercial management, financial efficiencies and policy and compliance.
- A change to the structure of the service has strengthened the management team. Additional work is being undertaken to ensure the service has the right permanent organisational design and culture.
- We are building better ways to communicate. Creating focus groups and feedback loops to co-create with children, parents, carers, and suppliers, ensuring the right mechanisms are in place to communicate more effectively with children, parents, carers, schools, and staff.





Children's travel (cont)

- An Assistant Director has been recruited on a 2-year fixed term contract. Bringing more permanency to the role.
- New processes to strengthen DBS assurance have been agreed. This involves the DBS checking process being undertaken by BCC.
- Complaints are being dealt with efficiently or effectively, are within the timelines of complaints handling data. This function has also recently been moved to the Customer, Communications and Engagement team to ensure alignment with our child centric approach.





Children's travel (cont)

- A new procurement model will look to provide greater consistency in the marketplace and enable new contracts to be reviewed and issued with terms that are suited to market conditions.
- Contracts will offer suppliers stability and consistency whilst also being heavily weighted towards performance.
- A robust mobilisation plan has been delivered successfully, building the foundations for the future transformation activity that will take place with the service.
- We are developing an enhanced, child centric service in a manner that is efficient and economically viable.

3 Background

- 3.1 "Scrutiny is based on the principle that someone who makes a decision...should not be the only one to review or challenge it. Overview is founded on the belief that an open, inclusive, member-led approach to policy review...results in better policies in the long run." (Jessica Crowe, former Executive Director, Centre for Governance and Scrutiny).
- 3.2 Developing an effective work programme is the bedrock of an effective scrutiny function. Done well, it can help lay the foundations for targeted, inclusive and timely work on issues of local importance, where scrutiny can add value. Done poorly, scrutiny can end up wasting time and resources on issues where the impact of any scrutiny work done is likely to be minimal.
- 3.3 As a result, the careful selection and prioritisation of work is essential if the scrutiny function is to be successful, add value and retain credibility.

4 Work Programme

- 4.1 Appendix 1 sets out the future work programme for this Committee. This provides information on the aims and objectives, together with lead officers and witnesses, for each item. - 4.3 The Health and Social Care O&SC on the 20 September 2022 received the update on the Period Poverty Inquiry. It was agreed that the recommendations had been implemented however the update report identified an issue regarding student attendance at school during their period. Two schools had held workshops with students which found that 40% of young women who attended had at one point stayed of school because of their period and after the discussion 23% thought they still would not come to school if they were on their period. This was an issue that members wanted to consider further, and it was agreed that the Chairs of the relevant Committees would meet to consider how to take this forward.
- 4.4 The Chairs of the Health and Social Care and the Education and Children's Social Care O&SC met, and it was agreed that this would be proposed as an item for the Education and Children's Social Care O&SC to consider at a future meeting, and that the members of the Health and Social Care O&SC would be invited to attend for this item. If agreed by the Committee for inclusion in the work programme the focus of the report would be on the learning / good practice that has been identified and how this being shared with schools across the city.
- 4.5 The Young People's Substance Use Service was an item on the 24 November in 2021 committee meeting. That was the first time it had been included in the Committee's work programme, as it had previously been included as part of the Health and Social Care O&SC work programme. However, it was felt it needed to have its own dedicated slot as part of Education & Children's Social Care O&SC because it is an under 18's service so sits better within this programme as opposed to adults and because of the vulnerabilities of those accessing the service, potential safeguarding and links to other young people's services.
