Cllr. Deborah Harries informed the Committee that she had been contacted by Dave Wagg regarding the lack of provision within her ward.

6. EVIDENCE GATHERING: SPORT BIRMINGHAM

(See document No. 3)

The Chair informed the Committee that Cllrs. Mick Brown and Gareth Moore (members of the Task & Finish Group for the Promoting Health and Wellbeing – A Commonwealth Games Legacy Inquiry) had submitted their apologies.

The Chair welcomed Mike Chamberlain, Chief Executive, Sport Birmingham, and Nikki English, Development Manager – Inclusion, Sport Birmingham, who were in attendance to provide evidence to the Inquiry.

Mike Chamberlain highlighted that they were the 'Active Partnership' for Birmingham, part of an England-wide network of 43 partnerships, significantly funded by Sport England as a 'System Partner' to help address inactivity, and particularly inequalities that exist in the provision of sport and physical activity through partnership working. Information on their strategy, mission, values, priorities, collaborative structures, and examples of their current work were provided.

Nikki English gave a presentation to the Committee which included the level of participation in Birmingham, details of the Together Fund, and their close working relationship with organisations such as Sense and Mencap to address barriers to participation.

One of the Commonwealth Games legacies has been closer partnership working. The partners were working on a signposting platform so people can access local inclusive opportunities and this would include wayfinding. This was scheduled to be launched next month and it was acknowledged that this needed to be promoted and sustainable, so the information was kept up-to-date.

During the discussion and in response to queries raised by Members, the main points included:

- The funding available via the Together Fund would be promoted and delivery needed to happen by the end of September 2023. Members were encouraged to notify them of any groups that may be interested in applying for this funding.
- Managing investment into Birmingham Schools Opening Schools Facilities funding 2022-2024:
 - This was funded by the Department for Education (DfE).
 - Schools need to submit a plan on how they will use funding for sports and physical activity.
 - Sport Birmingham employ a PE Adviser to help influence schools to enrich their curriculum.
 - A summary document for this funding, including the total amount was requested.
- Recommendations arising from this Inquiry could include:
 - Sport Birmingham worked with all the delivery partners, however, it
 was acknowledged that the relationship with the Council was not fully
 developed. This needed to be a relationship that added value and
 recognised and addressed the importance of inactivity of disabled
 people with Councillors and officers.
 - There was a need for wider Public Health involvement and the Moving Lives, Healthy Minds project was referenced. This included signposting to quality provision, intensive guidance so the experience was good for them, and working with the Birmingham & Solihull Mental Health Trust. Therefore, recommendations to keep this issue high on the agenda and connections with other organisations was key.

- They were looking to develop a network for disability and were currently looking at providers and organisations outside the sector.
- The ability to proactively engage with the city was about capacity building, especially where there were gaps in provision, and the need to work with neighbouring providers to plug those gaps.
- The Sport England legacy funding for the Commonwealth Games was £1m and focused on the five most deprived wards.
- Best practice regarding accessibility for disabled people included the need for a qualified workforce who understood the audience and being able to provide carers and buddies. They work with partners, such as Midland Mencap.
- Sport Birmingham may be able to share a breakdown of disabilities in April 2023 from the Disability Sports Forum.
- The 'See My Voice' project has just finished, and they were leading coordination of volunteering for the International Blind Games 2023.

The Chair thanked them for their attendance and contribution to the Inquiry and suggested Sport Birmingham attend a future committee meeting.

Adult Social Care Engagement Group

- Raise awareness, enthusiasm and engagement in all aspects of the Commonwealth Games (pre / during and post games legacy)
- Enable the Directorate to deliver against the key Corporate Objective of 'Birmingham residents gaining the maximum benefit from hosting the Commonwealth Games'
- Support the sharing of information, ideas and opportunities with relevant individuals and groups
- Organised Webinars so Citizens and community organisations could learn more about volunteering and other opportunities.





Accessibility
