3. Local Innovation Fund

Neil De Costa updated the meeting on the L.I.F, 3 proposals that had received approval

- Handsworth In Bloom.
- The Handsworth Wood Community Development Trust Jobs and Skills.
- The Handsworth Wood Community Development Trust Health and Well-being.

Neil, went on say that the Ward had received an additional 4 proposals from:

- Outdoor Gym Laurel Road
- Open Air Gym and learning facility Uplands allotments
- Spring Housing's Hestia House Community Resource
- Outreach support work through sport Diamonds F.C

These four proposals gained the backing of the three elected members to receive the remainder of the Wards allocated fund and to move forward to the next stage of the process and to seek approval at Cabinet Committee - Local leadership.

Finally Neil added that as part of the funding process all seven recipient groups would be required to come back to a future Ward meeting and explain how the funding has been spent and what has been achieved.

Some residents questioned the process and were critical of some aspects of the process, they said the lesson to be learnt would be to publicise such future funding more vigorously and award the whole allocation in one stage not two.

4. Policing and Anti-Social Behaviour

P.C Moody reported that at the last N.T.G. meeting Fly tipping; Parking issues; Speeding and A.S.B were the main issues of the Ward.

P.C Moody also said that as a consequence of recent terrorist's threats and levels being increased, the local officer resources have been reduced.

Councillor Atwal lead the questions to PC Moody on the ever present problem of lorries, vans and other commercial vehicles being parked in residential areas, unloading goods to local businesses and even being repaired. He said that this problem was long standing and residents were fed up with blocked pavements and road and that the inconsiderate Parking was causing problems for wheelie chair users ,mobility scooters and pushchairs forcing the people to use the road. Councillor Hamilton reminded and asked residents to report all these incidents to the local Police team and gave the contact details of the local PCSO. There was a discussion on how this long standing problem could be resolved, both physical and enforcements deterrents were discussed. Residents also believed the number of H.M.O's in the Ward was adding to this problem. Neil De Costa suggested a join day of action between the Police and B.C.C. which both residents and Councillors agreed would be a good start.

Action –To arrange a day of action to address the problem parking issues in the Ward.

After this item there was a delay to the meeting due to a protest from residents and non –residents objecting to the closure of the Fairway Centre in Northfield.
