The reason for our objections as Councillors is that; we have received representation at our Advice Bureaux from residents concerned that the extension of hours would create more public nuisance and greater disturbance. For example, the noise from patrons as they walk to their cars and the added nuisance of car headlights shining into the rooms of homes on Wheelers Lane as they manoeuvre along the private driveway out onto Wheelers Lane, at a time much later than at present.

This part of Kings Heath is very residential, (apart from the Transport Club) with residents believing that by approving the application, it would be equivalent to bringing the City Centre night-time economy into residential Kings Heath.

Re Variation of license for Transport Social Club , Wheelers Lane to Westbourne Leisure Night Club , Wheelers Lane for extension of hours and supply of alcohol on /off residential area premises.

I wish to make representation against certain levels of the criteria requested by Westbourne leisure. I also request an acknowledgement of my email and any potential dates for appeal.

Local Resident Concerns;

The effect, change of character, appearance and preservation of the residential area.

1 Noise

Generally amplifies , vehicle, music , human activity, length of opening hours will undoubtedly extend noise pollution , inconvenience and disturbance levels .

2 Public Safety ,Well Being and Quality of Life The anticipated impact upon the local environment with the major extension in opening hours as requested for the premises to become a night club rather than a social club. Such a radical change of use of premises is certain to impact upon ,social,,economic and cultural phenomena operated by a night club economy.

The provision of alcohol ON/Off premises (as stated in the application) and entertainment over such extended night club hours will undoubtedly assist in the escalation of anti social behaviour as detailed in many official studies are significant contributory factor in crime and disorder. This in turn more than likely will impact upon Human Resources and public services which are already overstretched.

3.Pollution

There are six schools in the immediate area. Five of these schools in the same road as the proposed night club. The impact of further vehicle emissions by those attending and departing the night club area could have devastating consequences for such young lives. The shear capacity of such a change in venue will create more private hire private ownership and coaches. The logistics of such frequent amounts of traffic are an issue for local residents. The levels of anticipated and existing traffic in a juxta pose to primarily a residential area are just not acceptable or comprehendable. The parking of these vehicles will also be a major concern along with the accessibility to the venue. The local council has already spent exceptional amounts of money on drainage on the areas outside the property.

4 Light Intrusion.

Under the definition of a night club with majorly extended hours the intrusion of lights need to be understood and fully reflected in decision making .We are speaking of a residential area .People live and need to get up for employment ,school etc.There will be traffic with head lights coming and going until approx 2 a.m. and beyond . Disturbed sleep for those living and working close by .This is not to give further consideration to security ,decorative and flood lights for sports facilities

5 Knowledge of the Conurbation and Population There is a public house ,private hire and social club ,within less than a mile of the venue. These establishments supply alcohol but their hours fall short of the proposed night club Opening hours. If one is to apply a level of logic it poses the question; Where can we go for further entertainment and alcohol?

I rest my case on this level. Suffice to say it does not take a great deal of imagination to anticipate potential outcomes .

Research reflects that due to the nature of a social club as opposed to a night club folk tend to congregate outside a night club, waiting for taxis etc. Research consistently shows peek times for violent offending is week-end nights and peek locations around clubs directly /indirectly contributing along with limited transport facilities (There are no public transport facilities available at closure times of the night club)All this will possibly make extra demands upon public services.

6 Planning

The infringement of accessibility, spacial density, design layout, infra structure, parking, transport, residential rateable value and more unknown factors at this stage. Application for the Variation of Licence at the Transport Stadium, Wheelers Lane, Kings Heath, Birmingham B13 0ST.

I object to the grant of the variation of licence of the above named premises for the following reasons.

The premises are not situated in an area with low level residential occupancy such as Broad Street or Digbeth, the latter being where Westbourne Leisure Limited had the previous premises and licence. The Stadium is closely surrounded on three sides by high and low rise flats/apartments and general housing.

The entrance/exit road belonging to the stadium runs alongside the residences situated in Hollybank Road. Part of the car park, belonging to the Stadium is close to Haig Place albeit separated by a service road and barrier wall in places. The busy entrance/exit is sited in Wheelers Lane opposite the houses in upper Wheelers Lane.

The variation of licence, to the hours of 1 and 2 a.m., will not only involve the usual influx of visitors to the Stadium in the early evening but also cause an extra influx when normal licenced premises are closing, not only in the local neighbourhood but, from across Birmingham. Having worked in night clubs I can vouch for this late night increase in trade. This will create an unnecessary disturbance which will have an impact on the residents, and their children, of the neighbouring properties described above.

This same disturbance will be repeated in the early hours of the morning when, the bars are closed and the premises are closing down.

Finally, the car parking at the Stadium must be inadequate for their present usage as there is often "overflow" car parking, opposite the club, outside the houses in Wheelers Lane. There are numerous occasions of parking on the grass which causes damage. This could however be controlled by enlargement of the car parking at the Stadium or concrete verges or kerbs placed around the grassed areas.

The blocking of resident's drives by inconsiderate drivers does occur but mainly when the former Stadium authorities held a special day e.g. summer fete.

My main concern and objection, to the variation of licence, is the disturbance it will cause to the residents who live closely to the perimeter of the Stadium. There is a strong feeling amongst neighbours that the usage of the Stadium, under its new owners, will increase greatly over time. This will exacerbate the detrimental impact of extending the licencing hours.

The Transport Stadium was recently bought by the Irish Centre having moved from their premises in the Digbeth area of the City. While the Centre was popular venue in the City centre any extended or late licensing hours may not have caused a nuisance or disturbance but are not appropriate in this residential area for the following reasons:

Increased noise levels from the entertainment into the early hours and the potential noise levels from customers using the outside smoking areas.

We wish to object to the above application to extend the hours of operation for the Transport Club, Now called the Irish Centre, in Wheelers Lane Kings Heath.

We have lived in Wheelers Lane for over 20 years and have had no major objections to the current licensing hours and the Transport Club being used as a social club with occasional events in the function room. Even with these current hours we do get disturbed some weekends when parties run late with doors & window open then this can increase as people start to leave, DJ/Band start to pack up before the event/music is over and cars leaving. Even with doors and windows closed we still hear the thud, thud of the music base as the sound proofing of the building is not good with a very large window on the side of the function room which does little to supress any noise. This building is not good at supressing Loud Music.

Although some people may view Wheelers Lane as a main transport route after around 10:30 at night when the traffic dies down it is a quiet residential area and any excess noise travels and can cause a nuisance to local residents, including us, and disturb sleep.

Therefore we want to object to the above application to extend the License for supply of alcohol and entertainment to 01:00am Sunday to Thursday & 02:00am on Friday & Saturday on the grounds stated below and noting the background above. This extension could mean that people could be leaving this venue as late as 1:30/2:30am

- This part of Kings Heath is a residential area and this extension to the operation hour
 every night of the week and weekend is totally out of place. It turns this Social Club
 in a residential area into a Night Club / Night Time Economy. We believe this will
 cause Public Nuisance to local residences, well after midnight, any & every night of
 the week.
- This is a quiet residential area and late at night noise can travel clearly across the sports field and will cause a nuisance disturbing local residents and their families which will include children. At these late times / early hours in the morning this will be:
- Noise from the premises as the building is not very sound proof with a large window in the function room that is not good at supressing the type of noise you get from

loud music. This noise can be heard by local houses and will disturb local residents late at night/early hours of the morning. Remember this is a residential area with children who have to get their sleep and go to school in the morning and others who have to get up early for work and would appreciate a good, full, night's sleep.

- Noise from the premises, despite any controls, doors will always be opened as people come and go and noise at this late hour will travel and disturb local residents
- Noise from people outside the building late at night, the worse for drink, using the smoking area. Have witnessed this before.
- Noise from people late at night, the worse for drink, running around the sports field. Have witnessed this before.
- ➤ Noise from people leaving the building / premises at these late hours. Could be after licence end time therefore as late as 1:30-2:30am
- Noise from vehicles leaving at these late hours, could be a large number at the same time. Also car doors slamming.
- As this is an open area we have and can also be disturbed by the head lights from vehicles on the car park and also leaving the premises.
- At these proposed times there is very little/very limited public transport available so will we have people wandering around the road outside looking for transport or trying to hall/call a taxi. More possible disturbance in the early hour "night time economy".

As stated we have no problem with the current operational hours but this application to extend to the early hour of every day of the week will completely change the nature of this venue from a local Social Club to a City Centre night club and issues that is will attract and cause nuisance to a residential part of Kings Heath.

- Boxing or Wrestling Entertainment: no licence is required for a contest, exhibition or display of Greco-Roman

Annex 1 – Mandatory Conditions

Every retail sale or supply of alcohol made under this licence must be made or authorised by a person who holds a personal licence.

No supply of alcohol may be made under the premises licence (a) at a time when there is no designated premises supervisor in respect of the premises licence, or (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.

The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises. In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises— (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to- (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or (ii) drink as much alcohol as possible (whether within a time limit or otherwise); (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective; (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective; (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner; (e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).

The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.

The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol. The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy. The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either— (a) a holographic mark, or (b) an ultraviolet feature.

The responsible person must ensure that— (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures— (i) beer or cider: ½ pint; (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and (iii) still wine in a glass: 125 ml; (b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and (c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available."

- (1) A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.
- (2) In this condition:— (a) "permitted price" is the price found by applying the formula P = D + (D x V), where—(i) P is the permitted price, (ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol; (b) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979; (c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence—(i) the holder of the premises licence, (ii) the designated premises supervisor (if any) in respect of such a licence, or (iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence; (d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and (e) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.

- (3) Where the permitted price would not be a whole number of pennies, the permitted price shall be taken to be the price rounded up to the nearest penny.
- (4) Where the permitted price on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax, the permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

Each individual assigned to carrying out a security activity must be licensed by the Security Industry Agency.

Annex 2 - Conditions consistent with operating schedule

2a) General conditions consistent with the operating schedule

The Premises Licence holder shall ensure that all staff are trained and have knowledge of all licensing issues concerning them under the 2003 Licensing Act 2003 and a log of this training will be maintained. The training log can be inspected by any responsible authority on request.

The provision of Regulated Entertainment will take place indoors only.

2b) Conditions consistent with, and to promote the prevention of crime and disorder

Digital CCTV will be installed at the premises to the reasonable satisfaction of West Midlands Police. The System must be operational at times when licensable activity is taking place. The system must have an image download capability. All recorded images must be kept for a minimum of 28 days. Full access to recordings must be given to Responsible Authorities immediately upon request.

The Premises Licence holder shall ensure that a notice stating that 'no sales of alcohol to persons under 18 years of age' will be displayed at the premises.

The Premises Licence holder shall ensure that a notice stating that 'It is illegal for persons to buy alcohol on behalf of persons under 18 years of age' will be displayed at the premises.

The Premises Licence holder shall ensure that a notice will be displayed on the premises stating that 'Persons attempting to purchase alcohol on behalf of persons under 18 years of age will be banned form the premises'.

2c) Conditions consistent with, and to promote, public safety

No enforceable conditions identified from operating schedule.

No enforceable conditions identified from operating schedule.

A 'Challenge 21' policy will be operated on the premises.

'Challenge 21' signs will be displayed on the premises, with at least one sign on the entrance to the premises and one to be displayed behind all bars.

The Premises Licence holder shall ensure that all staff are trained on the 'Challenge 21' policy.

The Premises Licence holder shall ensure that all alcohol refusals will be noted in a refusals register.

The only acceptable forms of identification will be a passport, photo driving licence or a recognised proof of age card.
