





f) Examine and improve the approach to protecting properties during and immediately after flood events such as the provision of sandbags.







Delete all after 'This Council believes that the EBacc,' and replace with


along with the focus on core subjects in Attainment and Progress 8 measures is helping to raise educational standards in schools, particularly for disadvantaged and female pupils, by focussing on an academically rigorous core curriculum that has been shown to improve both post 16 education take-up and future career prospects.

Schools should provide a curriculum with an academically rigorous core for all, plus broader opportunities in the arts and sport. The eBACC provides that rigorous core, with scope around it for individual schools, and individual pupils to decide what is best for them to enrich their broader curriculum.

The Council and Birmingham schools should be ambitious for our young people and this should include encouraging take up of arts and creative subjects outside of the core eBACC where that is right for pupils, but should not further restrict the flexibility of schools by imposing extra requirements for subjects that do not fulfil the core purpose of the eBACC.
