## CITY COUNCIL TUESDAY 6<sup>th</sup> November 2018

In para 8 line 4 after "impact on Birmingham" delete the remainder of the para and insert a full stop.

Then insert the following paragraphs:

"Should parliament vote down the Government's Brexit deal or the talks end in no deal, this Council believes this would constitute a loss of confidence in the Government. In these circumstances, the best outcome for the country is an immediate General Election.

If there is no immediate General Election, Council supports all options remaining on the table, including campaigning for a public vote that includes the option to remain.

If the Government is confident in negotiating a deal that working people, our economy and communities in Birmingham will benefit from, they should not be afraid to put that deal to the public.

Council reaffirms its policy that those eligible and aged 16 or above should be entitled to vote."

At the end of the motion, add

"The Council resolves that the Leader of the Council will write within seven days to all the Members of Parliament in the City, the Members of the European Parliament for this region and to the Mayor of the West Midlands to make the Council's position clear."

Delete all from sixth paragraph onwards and replace with:


Council recognises that the citizens of Birmingham voted to leave the EU in 2016 in what they were very told would be a once-in-a-generation referendum and that further in the 2017 General Election, 94% of voters voted for parties with a manifesto commitment to honour the referendum result, including ending free movement and membership of the single market and customs union.

Council further, therefore, re-affirms its commitment to work towards getting the best possible Brexit deal for Birmingham, including ensuring that any powers and funding coming back from Brussels is devolved straight down to a region and city level. Council also confirms its desire to continue to be a member of Eurocities, in common with several other non-EU cities, to maintain our city's links and influence with our European neighbours whilst also expanding our links globally to other cities across the Commonwealth and the rest of the world."
