1. Purpose of report:

To consider the representations that have been made in respect of an application for a Premises Licence which seeks to permit the Sale of Alcohol (for consumption on the premises) to operate from 08:00am until 11:00pm (Monday to Sunday).

Premises to remain open to the public from 8:00am until 11:30pm (Monday to Sunday).

2. Recommendation:

To consider the representations that have been made and to determine the application.

3. Brief Summary of Report:

An application for a Premises Licence was received on 22nd August 2022 in respect of Violet, 205 Holyhead Road, Handsworth, Birmingham, B21 0AS.

Representations have been received from 2 responsible authorities and from other persons.

5. Relevant background/chronology of key events:

Evelina-Elana Bejenaru applied on 22nd August 2022 for the grant of a Premises Licence for Violet, 205 Holyhead Road, Handsworth, Birmingham, B21 0AS.

Representations have been received from West Midlands Police Local Neighbourhood Team and Birmingham City Council Licensing Enforcement, as responsible authorities. See Appendices 1 & 2 respectively.

Representations have been received from other persons, which are attached at Appendices 3 & 4.

The application is attached at Appendix 5.

Conditions have been agreed with West Midlands Police Licensing Department and the applicant, which are attached at Appendix 6.

I am Police Sergeant 21956 Philip Southern currently stationed at Handsworth Police Station, Thornhill Road, Handsworth, attached to the East Handsworth & Lozells Neighbourhood Priority Team. This is a ward that falls under the Perry Barr Constituency and is part of the Birmingham West Neighbourhood Policing Unit (BW NPU). I have been a Police Sergeant on that team since March 2021 and have worked on BW NPU 6 and a half of my 8 years of service. In that time, I have become intimately familiar with Handsworth in general and the Soho Road/Holyhead Road in particular. This statement is a Community Impact Statement in relation to the licensing application (The Application) for "Violet Café" 205 Holyhead Road, Birmingham, B21 0AS to obtain a license for the sale of alcohol on premises pursuant to the Licensing Act 2003.

The purpose of this statement is to object to The Application on the basis that it will negatively impact an area already affected by a significant degree of anti-social behaviour (Public Nuisance), Crime and Disorder including acts of public place violence (Public Safety). The area has amongst the highest proportion of houses of multi-occupancy (HMO) and exempt accommodation in the West Midlands and is classified as a "most deprived decile" (Index of Multiple Deprivation 2019, Consumer Data Research). This mean that the Soho Road/Holyhead Road, with its numerous shopping establishments, betting shops and established licensed premises, is a draw for individuals with complex, unsupported, needs who lead chaotic lives.

The Soho Road/Holyhead Road has a wide variety of shops and cafes catering to a multi-cultural society ranging from Afro-Caribbean, African, South East Asian and Eastern European establishments. In order to look after the community's interests the businesses have formed the Soho Road/Holyhead Road Business Improvement District (BID). Due to the many issues that present on the Soho Road/Holyhead Road the BID

along with other partners such as the Nishkam Gurdwara and a Street Watch coordinated by West Midlands Police conduct patrols of the road utilising concerned citizens as well as SIA registered security officers equipped with body worn video (BWV) and a number of CCTV cameras.

As one of the Neighbourhood Teams that cover the Soho Road/Holyhead Road we work closely with the BID and other partners, conducting joint patrols and sharing information. As part of our work on the Soho Road/Holyhead Road it has become apparent, due in part to its proximity to social housing, that the location draws individuals who engage in a range of activities that contribute to Public Nuisance and Crime & Disorder. The main issues highlighted are:

 Anti-social behaviour including drug taking, public drunkenness and disorderly behaviour, prostitution and associated public indecency and persistent begging.

• Crime ranging from shop lifting to public place violence including the use of weapons and resulting in serious injuries up to attempted murder and grievous bodily harm.

In addition, information from partners and community, has identified that the location is already being used for licensable activity without a license including the sale of alcohol, gaming machines and operating a "Sheesha" lounge. This does not give the Police confidence that any conditions applied as part of a license would be adhered to.

The Soho Road/Holyhead Road is one of the highest demand locations on BW NPU and indeed one of the highest across the whole of the West Midlands Police force area. This significant demand and crime generally coalesces around existing licensed premises such as International Supermarket, The Cross Guns PH, SK Wines and Moreish.

This then forms the principle part of our objection to The Application, that the opening of another licensed premises will be another location that will encourage groups engaged in Public Nuisance and Crime & Disorder to centre around and even base themselves from. The establishment is likely to be itself a target of Crime & Disorder; the already established licensed premises regularly request Police assistance due to thefts and aggressive customers. There is also no mention in the application of SIA registered Door Supervisors particularly in the evenings/nights. I am concerned that without such safeguards The Applicant cannot ensure the safety of their employees or the public including its own customers.

The location may also cause a strain on finite Police resources, already in a period of unprecedented demand and still significantly smaller and inexperienced compared to 2010, in an area policed by small neighbourhood teams who have large, complex areas to cover in addition to the Soho Road/Holyhead Road. The will be of detriment to the wider area who will be unable to access policing resources as readily.

We have conducted numerous operations involving both uniform and plainclothes officers as well as specialist resources such as drones and Police dogs; and partners including the BID and Birmingham City Council. We have conducted community events with partners and a strong Police presence. Despite this, criminality is persistent and ongoing even whilst police are conducting said operations with individuals seemingly having little fear of the Criminal Justice System. This has led to a lack of confidence in the Police and the CJS, by shop keepers and the wider public who use the Soho Road/Holyhead Road business district, to address those issues. I am certain that what is reported to us is but a small part of the issues that the area faces with many crimes and incidents going unreported due to that lack of faith.

The Soho Road/Holyhead Road has been the subject of a number of dispersal orders authorised by a Senior Police Officer under s34 of the Anti-Social Behaviour, Crime and Policing Act 2014 and there is an ongoing application for a Public Space Protection Order aimed exclusively at the road to attempt to tackle the persistent issues highlighted above.

In conclusion I make this statement to assist and inform the licensing authorities of the challenges faced in the area and the demands placed upon the Police and community partners. It also makes plain the reasons for our objections to this licensing application and why it is inappropriate and would have a detrimental affect on the area particularly when measured against the Licensing Objectives relating to Public Nuisance, Public Safety and Crime & Disorder.

A Challenge 25 policy will be strictly followed by all staff.

Staffs are trained as appropriate in respect of relevant licensing law.

CCTV is installed covering the premises.

b) The prevention of crime and disorder

The images recorded by the CCTV system shall be retained in unedited form for a period of not less than 30 days. The licence holder will ensure a high definition, colored CCTV camera system is installed, operational and recording whilst the premises is open to the public.

CCTV images must be securely stored, display an accurate date/time stamp and retained for a minimum of 30 days. Cameras must cover all areas that the public have access to, including the entrance/exit and pavement area immediately outside the premises.

The licence holder will ensure that there is always a member of staff trained and available to download images/footage immediately or an agreed timescale if requested by the police or the Licensing Authority.

The licence holder will ensure all refusals and incidents are recorded and logged. These records will be kept on site and made available to the authorities upon request.

The Challenge 25 policy will be adopted and there will be documented training of all staff (paid or unpaid) before they are allowed to sell alcohol. These records will be made available to the authorities upon request.

All staff shall be trained on the four licensing objectives and a training record kept on the premises. The training record will be made available to responsible authorities on request.

Any person who appears drunk /aggressive will not be permitted on the premises.

c) Public safety

A fire alarm system will be installed to meet BS 5839 Part 1 current standards.

An emergency lighting system will be installed to meet BS 5266 current standards.

Firefighting equipment will be available in the premises to meet BS 5306 current standards.

Floor staff will conduct physical sweep inside the premises to remove hazardous objects/waste as deemed necessary by the management.

The Designated Premises Supervisor is aware of his responsibilities to the staff and customers in respect of public safety and will take all reasonable steps to ensure the maintenance of all provided safety arrangements and equipment in accordance with the requirements of current installations.

d) The prevention of public nuisance

Notices will be displayed at the exit of the premises asking patrons to leave the premises quietly.

All deliveries will be conducted prior to 7pm to control noise nuisance.

In conjunctions with the steps proposed for the prevention of crime and disorder objectives, the Licensees and staff will at all times remain responsible for the prevention of public nuisance in and around the premises.

The Designated Premises Supervisor will arrange to monitor levels of noise from both inside and outside the premises and remedial action will be taken as appropriate.

Doors and windows will be kept closed as deemed necessary by the Designated Premises Supervisor.

e) The protection of children from harm

The Designated Premises Supervisor and staff will at all times remain aware of their responsibilities under the objective, including that alcohol shall not be sold to anyone under the age of 18.

Staff on duty have will be trained and made aware of these requirements and the need to demand an acceptable form of age id.

The premises will operate Challenge 25 policy.

No adult entertainment is permitted at these premises.

NOTES ON DEMONSTRATING ENTITLEMENT TO WORK IN THE UK

Entitlement to work/immigration status for individual applicants and applications from partnerships which are not limited liability partnerships:

A licence may not be held by an individual or an individual in a partnership who is resident in the UK who:

- does not have the right to live and work in the UK; or
 - is subject to a condition preventing him or her from doing work relating to the carrying on of a licensable activity.

Any premises licence issued in respect of an application made on or after 6 April 2017 will become invalid if the holder ceases to be entitled to work in the UK.

Applicants must demonstrate that they have an entitlement to work in the UK and are not subject to a condition preventing them from doing work relating to the carrying on of a licensable activity. They do this in one of two ways: 1) by providing with this application copies or scanned copies of the documents listed below (which do not need to be certified), or 2) by providing their 'share code' to enable the licensing authority to carry out a check using the Home Office online right to work checking service (see below).

- An expired or current passport showing the holder, or a person named in the passport as the child of the holder, is A British citizen or a citizen of the UK and Colonies having the right of abode in the UK [please see note below about which sections of the passport to copy].
- An expired or current passport or national identity card showing the holder, or a person named in the passport as the child of the holder, is a national of a European Economic Area country or Switzerland.
- A Registration Certificate or document certifying permanent residence issued by the Home Office to a national
 of a European Economic Area country or Switzerland.
- A Permanent Residence Card issued by the Home Office to the family member of a national of a European Economic Area country or Switzerland.
- A current Biometric Immigration Document (Biometric Residence Permit) issued by the Home Office to the holder indicating that the person named is allowed to stay indefinitely in the UK, or has no time limit on their stay in the UK.
- A **current** passport endorsed to show that the holder is exempt from immigration control, is allowed to stay indefinitely in the UK, has the right of abode in the UK, or has no time limit on their stay in the UK.
- A current Immigration Status Document issued by the Home Office to the holder with an endorsement
 indicating that the named person is allowed to stay indefinitely in the UK or has no time limit on their stay in
 the UK, when produced in combination with an official document giving the person's permanent National
 Insurance number and their name issued by a Government agency or a previous employer.
- A birth or adoption certificate issued in the UK, when produced in combination with an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A birth or adoption certificate issued in the Channel Islands, the Isle of Man or Ireland when produced in combination with an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A certificate of registration or naturalisation as a British citizen, when produced in combination with an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.

- A current passport endorsed to show that the holder is allowed to stay in the UK and is currently allowed to
 work and is not subject to a condition preventing the holder from doing work relating to the carrying on of a
 licensable activity.
- A current Biometric Immigration Document (Biometric Residence Permit) issued by the Home Office to the holder which indicates that the named person can currently stay in the UK and is allowed to work relation to the carrying on of a licensable activity.
- A current Residence Card issued by the Home Office to a person who is not a national of a European Economic Area state or Switzerland but who is a family member of such a national or who has derivative rights or residence.
- A current Immigration Status Document containing a photograph issued by the Home Office to the holder with an endorsement indicating that the named person may stay in the UK, and is allowed to work and is not subject to a condition preventing the holder from doing work relating to the carrying on of a licensable activity when produced in combination with an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A Certificate of Application, **less than 6 months old**, issued by the Home Office under regulation 18(3) or 20(2) of the Immigration (European Economic Area) Regulations 2016, to a person who is not a national of a European Economic Area state or Switzerland but who is a family member of such a national or who has derivative rights of residence.
- Reasonable evidence that the person has an outstanding application to vary their permission to be in the UK
 with the Home Office such as the Home Office acknowledgement letter or proof of postage evidence, or
 reasonable evidence that the person has an appeal or administrative review pending on an immigration
 decision, such as an appeal or administrative review reference number.
- Reasonable evidence that a person who is not a national of a European Economic Area state or Switzerland but
 who is a family member of such a national or who has derivative rights of residence in exercising treaty rights in
 the UK including:-
 - evidence of the applicant's own identity such as a passport,
 - evidence of their relationship with the European Economic Area family member e.g. a marriage certificate, civil partnership certificate or birth certificate, and
 - evidence that the European Economic Area national has a right of permanent residence in the UK or is one
 of the following if they have been in the UK for more than 3 months:
 - (i) working e.g. employment contract, wage slips, letter from the employer,
 - (ii) self-employed e.g. contracts, invoices, or audited accounts with a bank,
 - (iii) studying e.g. letter from the school, college or university and evidence of sufficient funds; or
 - (iv) self-sufficient e.g. bank statements.

Family members of European Economic Area nationals who are studying or financially independent must also provide evidence that the European Economic Area national and any family members hold comprehensive sickness insurance in the UK. This can include a private medical insurance policy, an EHIC card or an S1, S2 or S3 form.

Original documents must not be sent to licensing authorities. If the document copied is a passport, a copy of the following pages should be provided:-

(i) any page containing the holder's personal details including nationality;

(ii) any page containing the holder's photograph;

(iii) any page containing the holder's signature;

(iv) any page containing the date of expiry; and

(v) any page containing information indicating the holder has permission to enter or remain in the UK and is permitted to work.

If the document is not a passport, a copy of the whole document should be provided.

Your right to work will be checked as part of your licensing application and this could involve us checking your immigration status with the Home Office. We may otherwise share information with the Home Office. Your licence application will not be determined until you have complied with this guidance.

Home Office online right to work checking service

As an alternative to providing a copy of the documents listed above, applicants may demonstrate their right to work by allowing the licensing authority to carry out a check with the Home Office online right to work checking service.

To demonstrate their right to work via the Home Office online right to work checking service, applicants should include in this application their 9-digit share code (provided to them upon accessing the service at <u>https://www.gov.uk/prove-right-to-work</u>) which, along with the applicant's date of birth (provided within this application), will allow the licensing authority to carry out the check.

In order to establish the applicant's right to work, the check will need to indicate that the applicant is allowed to work in the United Kingdom and is not subject to a condition preventing them from doing work relating to the carrying on of a licensable activity.

An online check will not be possible in all circumstances because not all applicants will have an immigration status that can be checked online. - Plays: no licence is required for performances between 08:00 and 23.00 on any day, provided that the audience
 does not exceed 500.
- Films: no licence is required for 'not-for-profit' film exhibition held in community premises between 08.00 and 23.00 on any day provided that the audience does not exceed 500 and the organiser (a) gets consent to the screening from a person who is responsible for the premises; and (b) ensures that each such screening abides by age classification ratings.
- Indoor sporting events: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000.
- Boxing or Wrestling Entertainment: no licence is required for a contest, exhibition or display of Greco-Roman
 wrestling, or freestyle wrestling between 08.00 and 23.00 on any day, provided that the audience does not
 exceed 1000. Combined fighting sports defined as a contest, exhibition or display which combines boxing or
 wrestling with one or more martial arts are licensable as a boxing or wrestling entertainment rather than an
 indoor sporting event.
- Live music: no licence permission is required for:
 - o a performance of unamplified live music between 08.00 and 23.00 on any day, on any premises.
 - o a performance of amplified live music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - o a performance of amplified live music between 08.00 and 23.00 on any day, in a workplace that is not licensed to sell alcohol on those premises, provided that the audience does not exceed 500.
 - a performance of amplified live music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
 - a performance of amplified live music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school or (iii) the health care provider for the hospital.
- Recorded Music: no licence permission is required for:
 - o any playing of recorded music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - o any playing of recorded music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
 - any playing of recorded music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school proprietor or (iii) the health care provider for the hospital.


- Dance: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 500. However, a performance which amounts to adult entertainment remains licensable.
- Cross activity exemptions: no licence is required between 08.00 and 23.00 on any day, with no limit on audience size for:
 - any entertainment taking place on the premises of the local authority where the entertainment is provided by or on behalf of the local authority;
 - o any entertainment taking place on the hospital premises of the health care provider where the entertainment is provided by or on behalf of the health care provider;
 - o any entertainment taking place on the premises of the school where the entertainment is provided by or on behalf of the school proprietor; and
 - any entertainment (excluding films and a boxing or wrestling entertainment) taking place at a travelling circus, provided that (a) it takes place within a moveable structure that accommodates the audience, and
 (b) that the travelling circus has not been located on the same site for more than 28 consecutive days.
