2 Recommendations

Executive Summary

That the Chief Executive makes the urgent decision to;

2.1 Approve the allocation of £3,724,711 infection control funding to Birmingham care providers.

31/5765 issued by the Minister of State for Care on 21 October 2021.

To confirm the allocations of the Infection Control and Testing Fund – Round 3 (1 October 21 – 31 March 22) in accordance with the Grant Determination Notice

1

- 2.2 Approve the allocation of £2,169,418 testing funding to Birmingham care providers.
- 2.3 Approve the allocation of £442,990 vaccine funding to Birmingham care providers.
- 2.4 Approve the allocation of £40,000 to the Council to administer the Infection Control and Testing Grant.
- 2.5 Approve the allocation of £80,000 to day centres for infection control measures.
- 2.6 Approve the use of £250,000 to commission an extension to the Infection Prevention Control service for the regulated adult social care market across Birmingham (subject to separate procurement governance).
- 2.7 The details of these allocations are in accordance with the Grant Determination Notice and are set out in 7.3.1 and Appendix 3 below.

3 Background

- 3.1 The Adult Social Care Infection Control Fund was first introduced in May 2020. It was extended in October 2020 and was a Section 31 ring-fenced grant designed to support adult social care providers with infection control measures.
- 3.2 The Rapid Testing Fund was introduced in January 2021 to support additional rapid lateral flow testing of staff in care homes and to enable indoor visiting.
- 3.3 Both of these funds were then consolidated into the Infection Control and Testing Fund 1 from April 2021 June 2021.
- 3.4 The Infection Control and Testing Fund 2 was further extended from 1 July 2021 to 30 September 2021.
- 3.5 The Infection Control and Testing Fund Round 3 was further extended for the period 1 October 2021 31 March 2022 and is the subject of this report.
- 3.6 This new grant has similar conditions to the previous funds.
- 3.7 The purpose of the fund is to; continue to support adult social care providers to reduce the rate of Covid-19 transmission within and between care settings through effective infection and control practices; to increase uptake of staff Covid and Flu vaccination; and to support testing of staff and visitors in care settings to identify and isolate positive cases and enable close contact visiting where possible.

4 Options considered and Recommended Proposal

- 4.1 There are limited alternative options due to the Grant Conditions specified.
- 4.2 For the discretionary elements of each funding allocation, the rationale is contained in column C of Table 3 in 7.3.4 below. These clearly demonstrate the funding split is based on evidence of the impact of the pandemic on the care market.

5 Consultation

- 5.1 The Cabinet Member for Health and Social Care has been consulted on this and is in agreement with the proposed recommendations. The Cabinet Member is the chair of the Health and Well-being Board.
- 5.2 The Leaders of the key Political Parties have been consulted on this decision and no objections have been received.
- 5.3 The Infection Control Fund Round 3 will support the national COVID-19 Response: Autumn and Winter Plan 2021 and local health and social care system-wide winter plans.

6 Risk Management

- 6.1 The following risks have been identified in relation to this decision and have been mitigated as follows:
 - 6.1.1 Financial risks the Council is required by Government to operate this Grant in accordance with the Grant Conditions. The risks of administration, debt recovery and potential fraud sit with the Council. These risks are being mitigated through regular reporting from care providers, issuing of Grant Conditions to care providers, regular communication and reminders to care providers and proactive dialogue prior to encourage compliance before debt recovery commences.
 - 6.1.2 Reputational risks as set out in 7.2, the Council is making this decision as the earliest opportunity to ensure essential funds can reach the sector in a timely and effective manner.
 - 6.1.3 Legal risks –there may be legal risks associated with taking this Emergency Decision, however the reasons for this are set out in 7.2 below. Furthermore, this approach has been agreed by the Corporate Director Adult Social Care, the Cabinet Member for Health and Social Care and the leaders of the key Political Parties have also been consulted.

7 Compliance Issues:

- 7.1 How are the recommended decisions consistent with the City Council's priorities, plans and strategies?
 - 7.1.1 The Infection Control Fund Round 3 will support the national COVID-19 Response: Autumn and Winter Plan 2021 and local health and social care system-wide winter plans.

7.2 Legal Implications

7.2.1 The Infection Control and Testing Fund is a Section 31 Grant that is ringfenced exclusively for actions which support care providers to tackle the risk of Covid-19 infections and enable close contact visiting.

- 7.2.2 The Department for Health and Social Care considers this grant, and the measures it is intended to support, are consistent with the UK's international obligations on subsidy control. This is because the measures will help detect/reduce incidence of Covid-19 and are over and above that which care providers would normally be expected to provide.
- 7.2.3 This decision is being taken pursuant to Part B, B6, 6.6 and Part E4 of the Council's Constitution 4.2 Emergency Reports which confirms that in an urgent situation, an executive decision may be agreed by the Chief Executive following consultation with the Leaders of the Political Groups. An urgent decision being defined as one which could not reasonably have been foreseen or anticipated prior to the most recent Cabinet or Committee meeting, and which needs to be considered before the next meeting of the Cabinet/Committee. This decision is considered an urgent situation for the following reasons:
 - 7.2.3.1. The conditions of the grant expect local authorities to transfer payments to providers within twenty working days or as quickly as possible, there is therefore not time to wait for the next Cabinet meeting.
 - 7.2.3.2. The Council received the funds on 25 October 2021 (Infection control and vaccination) and 11 November 2021 (testing) and this decision is being made at the earliest opportunity to ensure funds reach care providers in line with the Grant Conditions and expectations of Government and the provider market.
 - 7.2.3.3. The Council is largely passporting the funds to care providers on behalf of Government.
 - 7.2.3.4. The conditions of the grant issued to the Council from Government set out the sums to be paid, the method for allocating these and the conditions which must be met prior to distribution of funding for 70% of the funding. On this basis, there is very limited discretion for the Council to decide how to distribute these funds.
 - 7.2.3.5. Where there are discretionary elements of the fund, these are also restricted to the purpose set out in the Grant Conditions.
 - 7.2.3.6. As the ongoing impact of the pandemic and winter pressures for care providers and their staff continues, these funds will provide essential financial support to care providers in paying their staff when isolating and reducing movement of staff between parts of the care market all essential parts of managing these outbreaks and preventing further outbreaks.
 - 7.2.3.7. Providers have been made aware by Government of the funding and many will have already incurred expenditure from 21 October when guidance was published. Any delays in distribution will impact on the

cashflow of these already challenged providers and may also impact on their ability to put in place appropriate infection control measures.

7.3 Financial Implications

7.3.1 The Grant will be paid in two instalments and totals £6,651,119 for Birmingham. It has been split into three elements all of which have slightly different requirements and purposes – infection control, testing and vaccination as set out in Table 1 below:

- 7.3.2 The Grant runs from 1 October 2021 to 31 March 2022 and will paid in two sums (60% in October 2021 and 40% in January 2022). The first instalment was received by the Council on 25 October 2021 and 11 November 2021 and could not be distributed until all elements were received.
- 7.3.3 The Council must report spend to the Department of Health and Social Care at regular intervals and the following timetable has therefore been set:

7.3.4 The Grant conditions require the following approach to allocation/payment of funding:

- 7.3.5 The allocations of funding are to be made conditional upon care providers having completed the National Capacity Tracker for 2 consecutive weeks and to continue updating weekly (excluding day centres and the IPC service who cannot access the National Capacity Tracker). To maximise the funds that can be allocated and potentially paid, all care providers, except those contained in Appendix 1 and Appendix 2 will be allocated funding. Payments will be made once compliance is reached and for the majority this payment will be immediate. For those providers who have not yet completed the National Capacity Tracker in 2 consecutive weeks, payments will be withheld. If they have still not completed the National Capacity Tracker before 17 December 2021 their allocation will be added to the discretionary element sum (B) for the second payment and passported to providers in line with the BCC Allocation of Discretionary Element (C) methodology.
- 7.3.6 In line with Grant conditions, for those providers who have not provided sufficient information on spending returns or have not repaid unspent grant funds in relation to the Infection Control and Testing Fund Extension (July 21 Sept 21) Grant by 17 December 2021, the Council will withhold payments and their allocation will be added to the discretionary element

- sum (B) for the second payment and passported to providers in line with the BCC Allocation of Discretionary Element (C) methodology.
- 7.3.7 In line with Grant conditions, for those providers who do not provide the necessary returns for this Grant by 15 April 2022, a process of recovering the funds will commence in line with the Council's usual income and debt recovery processes.
- 7.3.8 To reduce the administrative burden on care providers and the Council, Grant recipients will no longer be required to provide a signed assurance statement to the Council. Instead, the Grant Conditions will be issued to all care providers and published on the Council's provider web pages at www.birmingham.gov.uk/stm. Spending of the funds by any organisation will be deemed acceptance of those conditions. Providers will then be required to provide spend returns in line with the reporting timetable set by the Council to meet DHSC reporting deadline set out in 7.3.3 Table 2.
- 7.3.9 Local authorities may use a small amount of the infection control allocation (capped at 1% of the discretionary IPC allocation) for reasonable administrative costs associated with distributing and reporting on this funding and £40,000 will be deducted for this purpose.
- 7.3.10 To provide continued to support to day centres to remain open and continue to increase the number of service users they are able to support, £80,000 will be allocated from the Infection Control allocation discretionary element. This is based on previous allocations, spend and also data from providers which requested approximately £73,000 of funding for this purpose.
- 7.3.11 The Council has commissioned a dedicated care homes Infection Prevention Control Service since 1st December 2020 and was designed to provide a baseline audit of every care home in Birmingham as well as a reactive service to support Covid outbreaks. The service is progressing well and have currently completed 144 full care home audits out of 277. However, due to the ongoing demand for reactive support and expected further support over the winter period, the service is unlikely to complete the baseline audit for every care home by 31 March 2022. Given the positive impact this service is having providing dedicated support and training and upskilling of the sector a further £250,000 is being allocated to pay for the completion of IPC audits, training for all care homes and a responsive service over the winter period.
- 7.3.12 Based on the above approach, the Council will therefore distribute the funds as summarised in Appendix 3.
- 7.3.13 The Council has a Covid financial support package in place for the care sector until 31 March 2022 and any potential overlaps in funding will be identified through the approval process, to reduce the opportunity for double funding and to maximise use of the Grant funding.
- 7.4 Procurement Implications (if required)

- 7.4.1 There are no direct procurement implications associated with this decision. A separate report will be prepared in relation to the Infection Prevent Control Team extension as this decision is simply seeking allocation of the funding at this time.
- 7.5 Human Resources Implications (if required)
 - 7.5.1 There are no Human Resources implications associated with this decision.
- 7.6 Public Sector Equality Duty
 - 7.6.1 An Equality Impact Assessment has not been carried out as duties contained in the Equality Act 2010 do not apply to care providers as registered companies.
