On 12 December 2016 the Cabinet Member for Clean Streets, Recycling and Environment jointly with the Strategic Director, Economy: i) Approved the City Council's response to the Joint consultation by the Department for Environment, Food and Rural Affairs (Defra) and the Department for Transport (DfT) on the "Implementation of Clean Air Zones in England"; ii) Noted that, following the judgement in the recent Judicial Review of the Government's air quality plan for nitrogen dioxide in UK (2015), Government has been required to produce an updated national air quality plan by 31st July 2017.
