





The Council notes its disappointment that the Erdington Levelling Up fund bid was not approved. The Council further notes that this bid was the only one of the four submitted not to receive a Council contribution and the only one not to be successful.

The Council calls on the Executive to support round two bids for Erdington High Street, Northfield High Street and Sutton Coldfield Town Centre, that include financial contributions from the City Council, just as the Council did for Hall Green, Ladywood and Hodge Hill Constituencies, and to work with Councillors in Edgbaston Constituency to consider a bid for Harborne High Street.

Further the Council calls on the Executive to prepare and submit bids for round two of the Community Ownership Fund to support community use of heritage assets such as the Royalty Cinema in Harborne.

"The Birmingham City Council Plan 2018-2022 sets out the vision for Birmingham to be an entrepreneurial city to work and invest in, as well as a great and fulfilling city to live in. Within this context, local centre high streets are social and economic engines that benefit the city and wider city-region; they are places people call home and may increasingly be places that people work in rather than travel from for work; they are places where people mix, socialise and share experiences; and they are places that deserve a renewed sense of purpose as local community awareness of 'what's on their doorstep' has increased during the Covid-19 lockdowns."



The Council welcomes proposals to extend a London style ban on antisocial pavement and grass verge parking across the country. This Council calls on the Highways Department to work with local Councillors and residents, in Ward meetings, to determine which roads within Wards are suitable for a ban on antisocial parking, as they hold the local knowledge. Therefore, the Council calls on officers to lobby Government to allow a default ban on antisocial parking upon pavements and grass verges with appropriate exemptions where local knowledge dictates.

This Council also notes the Birmingham Transport Plan considers closing the A38 tunnels. This Council feels this would be bad for the City and calls on the Executive to keep the A38 tunnels open to private vehicles, through traffic and traffic coming in and out of the City Centre.
