**PROSECUTIONS AND CAUTIONS – JULY 2016**

1. Summary
  - 1.1 This report summarises the outcome of legal proceedings taken by Regulation and Enforcement during the month of July 2016.

### 3. Results

#### 3.1 During the month of July 2016 the following cases were heard at Birmingham Magistrates Court, unless otherwise stated:

- There were no licensing cases finalised during July 2016. Fourteen simple cautions were administered as set out in Appendix 1.
- Fifty-five Environmental Health cases resulted in fines of £39,925 and prosecution costs of £18,787 were awarded as set out in Appendix 2. No simple cautions were administered.
- One Trading Standards case resulted in a total fine of £3,500. Prosecution costs of £4,000 were awarded as set out in Appendix 3. No simple cautions were administered.
- Appendix 4 lists cases finalised by district in July 2016 and cases finalised by district April-July 2016.
- Appendix 5 lists the enforcement activity undertaken by the Waste Enforcement Team from April-July 2016.

### 4. Consultation

#### 4.1 The Enforcement Policy that underpins the work identified in this report is approved by your Committee. The policy reflects the views of the public and business in terms of the regulation duties of the Council. Any enforcement action[s] taken as a result of the contents of this report are subject to that Enforcement Policy.

### 5. Implications for Resources

#### 5.1 Costs incurred in investigating and preparing prosecutions, including officers' time, the professional fees of expert witnesses etc. are recorded as prosecution costs. Arrangements have been made with the Magistrates Court for any costs awarded to be reimbursed to the City Council. Monies paid in respect of fines are paid to the Treasury.

#### 5.2 For the year April 2016 to July 2016 the following costs have been requested and awarded:

##### Licensing

£8,887 has been requested with £7,109 being awarded (79%)

##### Environmental Health

£70,105 has been requested with £60,132 being awarded (85%).

##### Trading Standards

£30,876 has been requested with £6,700 being awarded (21%).

£20,776 has been requested with £18,787 being awarded (90%).

Trading Standards
