1. Purpose of report:

To consider the representations that have been made in respect of an application for a Premises Licence which initially sought to permit the Sale of Alcohol (for consumption off the premises) to operate from 06:00am until 12:00midnight (Monday to Sunday).

After discussions with West Midlands Police the applicant has agreed to amend the scope of the application. The Sale of Alcohol (for consumption on the premises) will operate from 08:00am until 11:00pm (Monday to Sunday). Their agreed times are attached to the report at Appendix 6.


