- 3. Community Chest update Cllr Parkin
  - Request from Friends of Rectory Park Proposed project: Labour and materials to reinforce the retaining timber sleeper wall of the Memorial Garden in Rectory Park total cost £3000.

## 4. Highways – Keith Smith from Kier

- Highway maintenance work is carrying on as normal, however due to the section 114 notice the large schemes i.e. planned resurfacing work were on hold and being double checked by B.C.C.
- Berryfields Road resurfacing on hold due to s114 notice process with anticipated delay of three months plus, with temporary repairs if areas become dangerous.
- Discussion on cost implications of delays ,cost of materials such as tarmac and emergency patching .
- Springfield Rd- resident reported an unsafe tree in front the Jehovah's witness church. Action Keith to investigate

**5.** Local Police update – The local Police team were unable to attend however they provided the following written update read out by Cllr Parkin . *Cllr Parkin*,

Please accept and pass on my apologies for not being able to attend the meeting, please let me know any future dates as I am keen to meet the local residents.

Our intel systems only allow us to breakdown the comparative figures on a ward by ward basis so I have included the below crime comparison figures YTD ending 30<sup>th</sup> September. You will below the statistics are looking healthy with a reduction across almost all crime types – most notably for residential burglary and serious youth violence.

You will see there is +46.88% increase in Robbery offences, the majority of these offences relates to the town centre whereby school/college kids have been targeted for there mobile phones. As a team we have made considerable efforts to work in partnership with the secondary schools and the college to deliver assemblies and make the kids aware. The team have also been out every day with the British Transport Police and safer travel during school kick out times to prevent any further offences, the team have already identified a number of the individuals involved and are working hard to ID the rest of them. several corporate messages have been sent out via mainstream social media channels. In regards to anti-social behaviour, the repeated area of concern appears to be off road motor bikes, the team do patrol when they have the opportunity to either identify or deter however given the geographical area and lack off appropriate resources to deal with these matters makes it difficult to tackle. As a team we are requesting the use of the force's off-road motorbike team, traffic and drones to help us however these are in high demand as we share our frustrations with many other neighbouring wards who are also competing to have use of them. Where residents have video evidence, my ask is that this is emailed through to us, alternatively they can use 101 or webchat to log their report and my team will pick this up. Numerous residents have voiced there

concerns over the use of 101, however I have been advised that the force contact centre has received an uplift in staff so the time it takes to answer a call should be reduced.

In relation to the rough drinkers which frequent New Hall Valley and the town centre, the team has identified the establishment responsible for supplying the alcohol and have requested this to stop, we will enforce licencing legislation if its proven that he has continued to supply, we will also be speaking with other stores such as B&M and Aldi to ensure they are aware also. We have identified the individuals that are drinking and have started to issue them with community protection warnings which we can escalate if there is sufficient evidence.

As Christmas approaches we will be working with the local venues to ensure they will be offering a safe and enjoyable space for people to visit, we are also looking at staffing to ensure we have appropriate cover in case of any incidents. Where licence holders fall short of their conditions I will pursue this with the licencing team. I am already receiving temporary event notices from venues asking to increase their opening hours over the Xmas/New year period, whilst the finical decision rests with licencing I will raise any areas of concern. Planning is still underway so I will keep you up to date.
