1. Purpose of report:

To consider relevant representations that have been made in respect of an application to vary the Premises Licence plan.

The application seeks to make the following amendments to the plan:

- To licence the external area in order to permit a bar to be placed within the garden area.

The terminal hour for use of the bar in the external area shall be 22:30hours (Monday to Sunday).

The application also seeks to remove the following condition from the premises licence:

- "The licensee will ensure that text and/or radio pagers, where already used will continue to be used on the premises during the hours of operation."
- "The licensee will ensure that there will be no promotions that encourage illegal, irresponsible or immoderate consumption of alcohol."
- "The licensee will extend existing policies to cover the increase in hours of operation".
- "The licensee will promote the protection of children from harm through an approach to managing the risk of under-age drinking." This is to be replaced with the following condition "The premises will adopt a Challenge 21 policy and any person wishing to purchase alcohol who appears to be under 21 shall be asked to produce an acceptable form of identification such as photo-card driving licence, international passport, a PASS hologrammed/ultraviolet feature card, Military ID card or Biometric Residence Permit."

The applicant is not seeking to vary the licensable times under the scope of this application.

I wish to object to the proposed plans **“to vary the layout of the premises of the Hop Garden pub, 19 Metchley Lane, Harborne, B17 0HT to include the garden area within the licensed area so that the premises can operate an external bar”**. My wife and I live in one of the houses adjacent to the Hop Garden and the level of outdoor noise from the pub’s garden has become extremely intrusive and is disrupting our lives.

The Hop Garden is a small pub in a residential area of Harborne with a garden that runs parallel to neighbouring gardens, including our house. For the last 18 months the pub’s garden area has been completely enclosed in a large canvas tent, so that the Hop Garden is now much bigger but almost entirely outdoors. This has resulted in a significant increase in the noise level from the Hop Garden, which is intrusive for neighbouring homes. This has been particularly stressful because the Hop Garden runs live music events in its garden involving extremely loud amplified bands. When these events are running it is impossible to spend any time in our garden. Even indoors with all the windows closed and TV on, the dominant noise is from the Hop Garden’s live music. The manager of the Hop Garden is aware of the pub’s noise intrusion and circulated a letter to neighbouring homes which stated that he would *“..inform my neighbours of any future garden events that could result in raised noise levels i.e. live music, so that you can plan for it”*. In other words, to avoid any noise from the Hop Garden neighbours should think about leaving the area. This is totally wrong. Nobody should be forced to leave their homes because of noise from a pub beer garden.

The Hop Garden now operates almost all of its business in a standard garden in a residential area, resulting in a big increase in outdoor noise within our neighbourhood. Expanding the licensed area to include the garden area would result in a year-round external bar within the garden area. This would further increase the already high noise levels from the pub, and further intrude on the lives of people in neighbouring homes.

Re: Licence Application to vary the layout of the premises of the Hop Garden Pub, 19 Metchley Lane, Harborne, B17 OHT to include the garden area within the licenced area so that the premises can operate an external bar ("the Application")

I am writing to raise the following concerns regarding the Application:

- **The prevention of crime and disorder** – We live in close proximity to the Hop Garden Pub and since the refurbishment of the beer garden and introduction of a side entrance on Alma Passage we have noticed individuals drinking alcohol on Metchley Lane and Alma Passage. We are also now finding discarded alcohol containers, bottles, glasses and broken glass near our house and around Metchley Lane and Alma Passage. We believe that this is likely to continue/increase should the Application be granted.
- **Protection of children** – We have two small children and, due to the close proximity of our garden to the Hop Garden, we believe that the increase in noise from Hop Garden's beer garden (which is likely to occur should the Application be granted) will have an adverse impact on their ability to enjoy our outside space.
- **The prevention of public nuisance** – As stated above, we believe that granting the Application will result in an increase in noise both for ourselves and the other residential properties that adjoin the Hop Garden. We also believe that there could be an increase in individuals smoking and drinking alcohol outside the pub (particularly in Alma Passage) and an associated increase in discarded alcohol containers and broken glass on the public pathways that surround the Hop Garden.
- **The promotion of public safety** - As stated above, because we believe that granting the Application could result in an increase in individuals drinking alcohol outside the pub and an associated increase in discarded alcohol containers and broken glass on the public pathways that surround the Hop Garden, we believe that granting the application could have an impact on the promotion of public safety.

We understand, particularly following the impact of the recent Covid 19 restrictions, that there is a need for local businesses to make changes to help them develop and thrive and we are very much supportive of the Hop Garden taking steps to do this. We would therefore welcome collaborative discussions between ourselves, other local residents and the owners of the Hop Garden to work out a way forward which would allow them to expand in a way that recognises our concerns and also minimises the impact to local residents and the public.

- Films: no licence is required for 'not-for-profit' film exhibition held in community premises between 08.00 and 23.00 on any day provided that the audience does not exceed 500 and the organiser (a) gets consent to the screening from a person who is responsible for the premises; and (b) ensures that each such screening abides by age classification ratings.
- Indoor sporting events: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000.
- Boxing or Wrestling Entertainment: no licence is required for a contest, exhibition or display of Greco-Roman wrestling, or freestyle wrestling between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000. Combined fighting sports – defined as a contest, exhibition or display which combines boxing or wrestling with one or more martial arts – are licensable as a boxing or wrestling entertainment rather than an indoor sporting event.
- Live music: no licence permission is required for:
 - o a performance of unamplified live music between 08.00 and 23.00 on any day, on any premises.
 - o a performance of amplified live music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - o a performance of amplified live music between 08.00 and 23.00 on any day, in a workplace that is not licensed to sell alcohol on those premises, provided that the audience does not exceed 500.
 - o a performance of amplified live music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
 - o a performance of amplified live music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school or (iii) the health care provider for the hospital.
- Recorded Music: no licence permission is required for:
 - o any playing of recorded music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - o any playing of recorded music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
 - o any playing of recorded music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school proprietor or (iii) the health care provider for the hospital.



Annex 1 – Mandatory Conditions

No supply of alcohol may be made under the premises licence (a) at a time when there is no designated premises supervisor in respect of the premises licence, or (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.

Every retail sale or supply of alcohol made under this licence must be made or authorised by a person who holds a personal licence.

The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises. In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises— (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to— (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or (ii) drink as much alcohol as possible (whether within a time limit or otherwise); (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective; (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective; (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner; (e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).

The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.

The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol. The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy. The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either— (a) a holographic mark, or (b) an ultraviolet feature.

The responsible person must ensure that— (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures— (i) beer or cider: ½ pint; (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and (iii) still wine in a glass: 125 ml;

(b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and

(c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.”

(1) A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.

(2) In this condition:—

(a) “permitted price” is the price found by applying the formula $P = D + (D \times V)$, where— (i) P is the permitted price, (ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;

(b) “duty” is to be construed in accordance with the Alcoholic Liquor Duties Act 1979;

(c) “relevant person” means, in relation to premises in respect of which there is in force a premises licence—

(i) the holder of the premises licence, (ii) the designated premises supervisor (if any) in respect of such a licence, or (iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence;

(d) “relevant person” means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and

(e) “value added tax” means value added tax charged in accordance with the Value Added Tax Act 1994.

(3) Where the permitted price would not be a whole number of pennies, the permitted price shall be taken to

be the price rounded up to the nearest penny.

(4) Where the permitted price on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax, the permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

Each individual assigned to carrying out a security activity must be licensed by the Security Industry Agency.

The admission of children under the age of 18 to film exhibitions permitted under the terms of this licence shall be restricted in accordance with any recommendation made: (a) By the British Board of Film Classification (BBFC), where the film has been classified by that Board, or (b) By the Licensing Authority where no classification certificate has been granted by the BBFC, or, where the licensing authority has notified the licence holder that section 20(3)(b) (s74(3)(b) for clubs) of the Licensing Act 2003 applies to the film.




Thank you very much for taking the time to meet with Brendon and I yesterday.

As discussed, I have attached an external area management and dispersal policy which I hope will address the concerns raised during our meeting.

In addition to this, I propose to offer the following conditions which would be imposed upon the premises licence if the application were granted:

- The premises will implement an external area management and dispersal policy;
- The management of the premises will ensure that a dedicated contact number is available for residents of Metchley Lane to report any issues of noise or disturbance.
- There will be no live music in the external areas of the premises after 7:30pm;
- When live music is taking place in the external area of the premises, staff will undertake regular checks around the perimeter of the premises to assess the levels of noise and ensure that no disturbance is caused to local residents.

I have set out below the additional conditions already agreed with the Police and Environmental Health and these will hopefully provide some extra reassurance regarding the use of the external areas:

Conditions already agreed with the Police:

1. No music will be played outside after 2100 hours each day;
2. The premises cctv system will cover the garden area of the premises whilst the premises is open.

Conditions already agreed with Environmental Health:

1. The exterior bar shall operate no later than 22:30 hours Monday to Sunday
2. All deliveries will be received between 06:00 and 18:00.
3. After 23:00 all doors shall be kept closed except for the purpose of access/egress during the performance of regulated entertainment.
4. After 23:00 all windows shall be kept closed.
5. The Licence Holder shall erect prominent, clear and legible signage inside the premises requesting patrons to be considerate of local residents when leaving the premises.
6. Any music taking place in internal or external areas of the premises shall not be at such a level to cause a detriment to the residential amenity around the premises.

I would be grateful if you could please consider the attached policy and the conditions offered and confirm whether this is sufficient to address your concerns or if there is anything further you may wish to discuss. I am happy to speak on the phone, via email or via Zoom/Microsoft Teams if there are any further concerns.

If you are happy to accept the proposed conditions and the attached policy, I should be grateful if you could please confirm this to the Licensing Authority (cc'd into this email) and confirm that your representation can be withdrawn upon that basis.

External Area Management and Dispersal Policy

Introduction

The management of the Hop Garden are committed to trading in a way that causes as little disruption or disturbance to local residents as possible.

All management and staff will be made aware of the terms of this policy and the importance of effecting effective management of the external area and as quiet a dispersal at the end of each evening's trading as possible.

There are a number of conditions on the premises licence which are designed to assist with this and again management and staff will be familiar with these.

The principal aim will be to ensure that the external area is managed effectively and that at the end of trade, customers are moved away from the premises and encouraged to disperse quickly and quietly away from the premises, respecting the rights of local residents.

Management of the external area

Staff will make regular checks of the external areas to ensure that any noise emanating from the area is not excessive or likely to cause disturbance to local residents.

When music is being played in the garden, staff will also make regular checks at the front of the premises to assess the level of noise from music in order to ensure that residents are not disturbed.

The exit from the beer garden onto Alma Passage already ensures that customers are dispersed away from the majority of residential properties where possible. Staff will undertake checks of Alma Passage at the start of trade, during the evening's trade and at the end of the trading period to ensure that any litter associated with the premises is cleared.

There will be a maximum of 8 live music events in the beer garden, per year.

End of Evening Operational Policies

Where appropriate the premises will use volume levels, type of music and variation of lighting levels and advice to encourage the gradual dispersal of customers during the latter part of trading.

Management and staff will encourage customers to leave gradually and as quietly as possible.

Notices will be displayed at exits requesting customers are mindful of local residents and leave the area as quickly as possible.

Contact with management

The management of the premises will ensure that a dedicated contact number is available to residents living within the neighbouring properties to the Hop Garden. This will ensure that

residents have a dedicated point of contact at all times the premises is trading and, in particular, this will allow residents to contact the management team when the external area is being used for by customers and when music is taking place in the external area.
