5.	Icknield Port Loop Development - Update		
	 Councillor Bore gave a brief update on the current situation with the lcknield Port Loop development and made the following main points; An agreement between BCC, Urban Splash and Places for People had been signed with the outline for phase 1 of the development (Wiggin Street) due to come forward at the end of the year. The delay had been in signing off the necessary agreement between partners as it had to fit into the Master Plan for the area. The swimming pool – the city council had to provide a site & planning permission by end April 2017 therefore discussions with Serco would proceed with the IPL residential development. BCC would bring developers together so all were working in conjunction. Community gain was scheduled for contributions towards Ladywood Health & Community Centre, provision for a 		

		
	 secondary school, upgrading of Summerfield Park & George Dixon School, although this might be revisited. Edgbaston Reservoir master plan had also been commissioned to include the Tower Ballroom & former rubber works. Information would be gathered and first stage consultation envisaged for March 2017 at which time a special meeting, with Edgbaston ward would be arranged for all affected residents. This would also tie in with IPL and the swimming pool. In response to a question it was confirmed that initial master planning had ensured no intrusion onto the damn. Item for a future meeting when planning application etc submitted. There would also be the statutory consultation on the planning applications as they were submitted. In response to a question regarding a website the meeting was advised that details were on the council's website although the rate at which it was updated was queried. St Johns and St Peters Church was offered as a venue for the consultation meeting. 6.	Garden Square Development	
	 A detailed presentation was made and the following main points raised; Listed buildings & mature trees would be retained and a garden square created using remnants of existing Victorian gardens Office space would be replaced on a like for like basis and the Plough & Harrow would be linked in New residential properties and cafes/shops would be incorporated and the car park would be removed from the centre of the development and a multi-story replacement built. Following further preparatory work planning permission would be sought in 12 months with an anticipated start in 2018 In response to questions the following answers were given; Consideration would be given with BCC about how this development fitted with the Birmingham Cycle Revolution. The office buildings would have cycle facilities The current 'wind tunnel' effect had been planned out and

	Concerns were raised regarding the proximity of the new office buildings to residential properties and a request made for smaller buildings. It was also noted that many existing office buildings were empty and existing shops were struggling. It was also feared that a new multi- story car park would add to the traffic chaos in the area, especially when events were held at the Barclaycard Arena.	
	Councillor Bore explained office space was empty as it was low grade and this needed to be replaced with high grade accommodation. It was confirmed that the space available would not be increasing and the height of the office accommodation was decreasing. The same number of car park spaces would be available as currently.	
	It was suggested that car parking be put underground where possible eg Broadway Plaza and that a relationship be developed with local schools to take account of local history. There was a rat problem in the area which should be considered before demolition started.
