1. Purpose of report:

To consider representations that have been made in respect of an application for a Premises Licence which seeks to permit the Sale of Alcohol (for consumption on the premises only) to operate from 1:00pm until 11:00pm (Sunday to Thursday) and 1:00pm until 2:00am (Friday and Saturday).

To permit the provision of Late Night Refreshment, to operate indoors only, from 11:00pm until 2:00am (Friday and Saturday).

Premises to remain open to the public from 1:00pm until 11:00pm (Sunday to Thursday) and 1:00pm until 2:00am (Friday and Saturday).

2. Recommendation:

To consider the representations that have been made and to determine the application.

3. Brief Summary of Report:

An application for a Premises Licence was received on 3rd December 2019 in respect of Channel Coffe & Restaurant, 145a Stratford Road, Sparkbrook, Birmingham, B11 1RD.

Representations have been received from Birmingham City Council Licensing Enforcement as a responsible authority and from other persons.

4. Compliance Issues:

4.1 Consistency with relevant Council Policies, Plans or Strategies:

The report complies with the City Council's Statement of Licensing Policy and the Council's Corporate Plan to improve the standard of all licensed persons, premises and vehicles in the City.

5. Relevant background/chronology of key events:

Betty Bayu applied on 3rd December2019 for the grant of a Premises Licence for Channel Coffe & Restaurant, 145a Stratford Road, Sparkbrook, Birmingham, B11 1RD.

A representation has been received from Birmingham City Council Licensing Enforcement as a responsible authority. See Appendix 1.

Representations have been received from other persons. See Appendices 2 - 5.

The application is attached at Appendix 6.

Conditions have been agreed with West Midlands Police and the applicant, which are attached at Appendix 7.

Site Location Plans at Appendix 8.

Good afternoon,

With regard to the application submitted by Mr Rahman for the grant of a premises licence at the above premises, Licensing Enforcement received a complaint regarding the premises on 17/06/2019 alleging the premises were carrying out licensable activities without a licence mainly the serving of alcohol.

A visit to the premises was conducted by Licensing Enforcement in July 2019 in company of colleagues from Environmental Health, West Midlands Police and West Midlands Fire Service, the following matters were identified -

Gary Callaghan Licensing Enforcement Officer gave advise to the premises writing on traders notice 25836/7 by Licensing enforcement regarding the requirement to obtain a premises licence for licensable activities after a speaker was playing recorded music and alcohol was found in a fridge and also in the hallway, see attached photos.

Steve Graham Fire Safety Inspecting officer identified the following matters -

- The rear fire exit door was covers by a roller shutter. This exit is required due to the depth of the building.
- The fire alarm and detection system was not working due to having no power going to the alarm panel. It
 had not been serviced for some time. The fire extinguishers had not need serviced.
- Although a fire risk assessment need not be recorded, the owner had not carried one out. I will be sending a
 letter the business owner and the landlord to get the issues sorted.

Alison Whelan From Environmental Health identified the following matters -


- They were warned and given advisory information regarding the Sheesha (smoking in a smoke free premises)
- Due to the presence of cockroaches in the premises and the fact that it was operating as a food business the
 premises was served with a Hygiene Emergency Prohibition Notice to cease trading. A revisit was conducted
 on 11/07/19 and has shown that cockroaches are still active so a Hygiene Emergency Prohibition Order was
 granted to cease the premises until the risk to health has been removed.
- I have a suspicion they may have traded but at the moment it is only a suspicion.


I am aware that complaints have been made to Environmental Health about noise emanating from the premises but they have been unable to investigate the matter as it is my understanding that the complainant did not wish to make the matter formal.

I have seen the conditions that have been agreed with West Midlands Police and these do go some way towards measures that will ensure the premises uphold the licensing objectives however licensing enforcement do still have concerns given the previous issues identified and will be seeking further information to be submitted from responsible authorities regarding the current situation, due to annual leave I have been unable to clarify this matter with them currently.

There is a strong management and security procedures in place which encompasses the four licensing objectives as below. A Challenge 25 policy will be strictly followed by all staff. Staffs are trained as appropriate in respect of relevant licensing law. The open nature of the cafe allows for good viewing coverage. CCTV is installed on the premises.

b) The prevention of crime and disorder

CCTV is installed inside the premises. CCTV will be recording at all times the premises are open for any licensable activities and images will be held for a minimum of 28 days and made available immediately on request by any of the Responsible Authorities. The Premises License Holder will ensure that a trained member of staff will be on duty and be available to download the CCTV to any of the Responsible Authorities.


