1. Purpose of report:

To consider an application to review a Premises Licence.

3. Brief Summary of Report:

Review application received on 18th November 2019 from the Chief Inspector of Weights & Measures in respect of Selly Acre News, 1049-1051 Pershore Road, Stirchley, Birmingham B30 2YH.

Representations have been received from both West Midlands Police and Licensing Enforcement as responsible authorities.

4. Compliance Issues:

4.1 Consistency with relevant Council Policies, Plans or Strategies:

The report complies with the City Council's Statement of Licensing Policy and the Council's Corporate Plan to improve the standard of all licensed persons, premises and vehicles in the City.

5. Relevant background/chronology of key events:

The Chief Inspector of Weights & Measures applied on 18th November 2019 for a review of the Premises Licence under Section 51 of the Licensing Act 2003 for Selly Acre News, 1049-1051 Pershore Road, Stirchley, Birmingham B30 2YH.

Representations have been received from West Midlands Police and Licensing Enforcement, as responsible authorities. See Appendices 1 and 2.

Review application is attached. See Appendix 3.

The Premises Licence is attached at Appendix 4.

Site location plans are attached at Appendix 5.

West Midlands Police have received the licence review application submitted on behalf of the chief inspector of weights and measures for "Selly Acre News – 1049-1051 Pershore Road, Stirchley, Birmingham. B30 2YH.

West Midlands Police wish to support the application made, and also provide further evidence of breach of conditions, poor management, further drugs being found on the premises.

On the 25th September 2019, West Midlands Police licensing officer in conjunction with Neighbourhood team officers conducted a licensing inspection of Selly Acre News.

During the inspection officers found

A cigar tin, by the till containing 45 pills – labelled Sildamax, and in the same tin £72.60 cash

Breaches of the premise licence -

CCTV not recording for the required number of days

Staff working behind the till and serving alcohol who had not been trained in licensing

Weapons or instruments that could be used as weapons stored behind the till (baseball bat and golf club).

To put some context into what was found --

The cigar tin, which contained the blue pills and the cash was found by the area where staff were serving, they were easily accessible, the tin was open with no lid on it.

Having checked Sildamax, it is a drug that can only be dispensed to other persons via a pharmacy. Whilst an individual can buy their own they cannot be sold on. This has been checked through the MHRA (who control such issues).

It is noted that this was not the first time this had happened, and they were found during the inspection in August. There is a very short time line between both inspections.

The member of staff behind the till, who had a very cavalier approach to everything stated they were his, however this is not believed.

The PLH who was on the premises at the time, indicated the staff member just did what he wanted with the pills. He had to be reminded who was in control of these licensed premises.

The licence has very clear and precise conditions around CCTV and staff training. The CCTV was found not to be recording for the required 31 days. This is a very simple thing to check as when you go onto the playback it hi-lights the days where recordings have been kept. This is just another example of how poor the management is at the premises.

The person behind the till was seen serving alcohol, he was asked how long he had worked at the premises and he said to officers '3' months. Yet a check of the refusal register showed entries with his initials against dated in 2018.

When officers asked about his training as he had clearly been at the premises for some time it was found that he had not received any form of training. The staff tried to distance himself into how long he had been there even though evidence showed otherwise, and yet he had not received any training but was being allowed to sell alcohol.

Behind the till officers found a baseball bat and a golf club. The premise licence holder said they were for sale, the club had a price ticket on it, but the baseball bat did not. Neither products where in an area where the public would have had access, where with easy reach of the staff.

West Midlands Police support the review by trading standards, it is clear that the premise licence holder is both content for his staff to do what they like, does not comply with the conditions on his licence, which are conditions that are easy to check and comply with.

West Midlands Police would also support a suspension or revocation of the premise licence

Further to the review of the above premises licence made by Paul Ellson (on behalf Donna Bensley Chief Inspector of Weights & Measures)

I hereby wish to make a representation in respect of the premises named above.

The Premises licence holder and designated premises supervisor CHANGEZ HUSSAIN has a duty and responsibility to promote the 4 Licensing Act 2003 objectives and adhere to the premises licence conditions attached to "Premises Licence 3795/3.

Condition 2a) General conditions consistent with the operating schedule.

States the following:

No alcohol or tobacco will ever be purchased from sellers calling at the premise. Exceptions to the condition would be purchases made from authorised representatives who have made prior appointments to visit the store.

The visit made by Trading Standards Officer Paul Ellson and Police officers on 29th August 2019 and findings would indicate that the shop is not complying with the above condition, there should have been no illicit products found at the premises during the inspection. The PLH/ DPS_CHANGEZ HUSSAIN should be in control of the running of the business or in his absence his staff should have been aware of the conditions of licence and his staff informed of the risk of having illegal tobacco on the premises (No UK duty paid on the items found)

A further visit made on the 25th September 2019 by Police also found a quantity of Viagra type medication which was seized. I would have thought after the first visit on the 29th August 2019 the PHLH/DPS CHANGEZ HUSSAIN would have been in greater control of the shop and his staff fully up to speed and fully aware of the matters highlighted previously, this would indicate that he is either complicit or has not taken his responsibilities seriously.

Furthermore on 10th December 2019 at 11:09 hours a visit was made to the shop by the Police and myself to undertake a Licensing Act 2003 compliance inspection, upon arrival the staff member on duty was identified by the Police Officer PCSO Tom Odell as the person they had encounter on previous visits. I could see behind the counter what appeared to be the Summary Licence displayed and asked him if he could produce the Premises Licence " which under the Licensing Act 2003 legislation is required to be kept on the premises and produced on request to an authorised officer. advised me it is normally kept in a folder behind the counter and started searching behind the counter, after being unable to find the " Premises Licence " he telephoned CHANGEZ HUSSAIN who tried to assist him in finding the said paperwork, a further search again resulted in him being unable to produce the " Premises Licence" advised that CHANGEZ HUSSAIN was on his way into the shop, he will be about 15 minutes, while waiting I went through the conditions of licence attached to the" Premises Licence 3795" (I had taken a copy of the Premises Licence with me) advised the cleaner or other staff member must have moved the folder, it was behind the counter

From experience I asked him if the "Premises Licence" had been put behind the Summary Licence displayed, got the Licence down from display where I observed that the paper work being displayed was the first 2 pages of the Premises Licence and not the Summary Licence.

A number of breaches of conditions were identified. during the initial inspection undertaken with while we waited for CHANGEZ HUSSAIN to come to the shop.

Namely:

No staff training records produced to a responsibility authority immediately on request or 6 monthly refresher training

An incident register which should be maintained at the premises

At any time when there is no Personal License holder on the premises there must be at least one member of staff on duty inside the premise who has been authorised by the DPS. Any such person should have seen, read and be fully aware of the conditions of the premise licence and take all steps to ensure that such conditions are adhered to whilst they have responsibility for the premise.

A record should be kept detailing, the name and address relative to the person left in charge of the premise and the times and dates when the authority to cover exists, in writing.

These should be individual entries covering short periods of time only and should not exceed more than a three week period.

The authorised person should also sign on each occasion that he/she has physically seen inspected and is fully aware of all the conditions attached to the premise licence. The DPS should sign to acknowledge that they agree to the authorised person being in charge of the premise for any times specified. The records of these matters should be kept fully updated at all times.

All Records shall be retained at the premises for a period of no less than 12 months and made available to responsible authorities on request.

Challenge 25 posters will be displayed at the premises to reinforce this policy. Posters will be placed at each till, each area alcohol is stocked and at the point of entry to the shop. the posters will be displayed prominently and in sight of customers and staff – Only 1 poster was being displayed at point of entry to store.

Unable to produce a refusal register .

At 11:45 hours CHANGEZ HUSSAIN came into the shop and a started searching behind the counter searching for the "Premises Licence " and associated paperwork requested, the said paperwork was again not readily available or located easily, this resulting in us again waiting around in the shop, this was a surprize considering the previous visits made and CHANGEZ HUSSAIN aware that Trading Standards had called for a review of the "premises Licence"

CHANGEZ HUSSAIN did manage to find some paper work

Summary Licence found and displayed - However he was unable to find other pages of "Premises Licence "

Staff Training paper work for 3 staff members dated 26/09/19 only

Refusals Register which he said he also uses as an incident register (last entry recoded October 2019)

I issued a Traders Notice No 26311 detailing the breaches of conditions which was signed by CHANGEZ HUSSAIN, we eventually left the shop at 12:20 hours

I therefore support the review under the following Licensing Act 2003 objectives

Please state the ground(s) for review (please read guidance note 2)

On the 27 August 2019 a complaint was received from Police Community Support Officer O'Dell concerning a number of shops in the Selly Oak area that were allegedly selling illicit tobacco products. This was given reference 9476825.

A visit took place on 29th August 2019 at 1800hrs by me along with PSCO O'Dell, PC Thomson and PC Jones. There was an Asian male who gave his name as Zamar HUSSAIN and his date of birth as 21/12/81; he stated that he was an employee of the owner Mr Changez HUSSAIN.

Mr Changez HUSSAIN, is the Premises Licence Holder (PLH) (licence number 106358) and the Designated Premise Supervisor (DPS) (personal licence number 3795).

I informed Mr Zamar HUSSAIN that a complaint had been received and asked him directly if he had any illicit tobacco products on the premises. I explained what I meant by illicit tobacco, such as not having duty paid etc. Mr Zamar HUSSAIN stated that he did not do that.

I advised that an inspection would take place and issued him with the relevant paperwork. I then conducted an inspection.

I noticed a plastic Sainsbury's' bag hanging from a hook behind the counter. This bag contained a quantity of illicit tobacco:

- 1 Sleeve of Richmond Cigarettes containing 10 packs of 20 cigarettes
- 1 Sleeve of Pect Cigarettes (Russian) containing 10 packs of 20 cigarettes
- 1 Sleeve of Regal Cigarettes containing 10 packs of 20 cigarettes
- 3 x 25g Packs of Benson & Hedges (Russian) hand rolling tobacco

In total of 600 cigarettes and 75g of hand rolling tobacco.

The inspection progressed and blister packs of a Viagra type medication with a brand name of Sildamax was discovered on a shelf under the counter; there were approximately 300 tablets.

Mr Zamar HUSSAIN stated that the tobacco products were for his personal use and that the Sildamax was 'for a mate.' A Traders Notice number 13554 was issued and the items were sealed in evidence bags and we left the premises.

Please provide as much information as possible to support the application (please read guidance note 3)

The tobacco found at the site during the inspection would indicate that the information the Police had received was indeed correct and that illicit tobacco was being sold from the shop.

All the tobacco products were illegal under the Standardised Packaging of Tobacco Products Regulations 2015 and the Tobacco and Related Products 2016 and cannot be sold or supplied in the UK. Irrespective of whether the tobacco found was counterfeit in nature.

None of the tobacco is in the correct packaging and none of it has the mandatory health warnings on, in fact two of the lots, the Pect and the Benson and Hedges have Russian Cyrillic script on the packaging and one has to consider provenance of the tobacco and its' contents; these items were never intended for the UK market.

UK Excise duty paid would not have been paid on them.

Mr Zaman HUSSAIN'S claim that it was for personal use is a usual excuse that those found in possession of illicit eigarettes/tobacco give; in my opinion 30 packs of eigarettes that are different brands suggest that this is not the case. He had initially stated that there were no illicit eigarettes on the premises. If they were personal products they should not have been in the premises.

The PLH should have exercised greater control over his staff and informed them of the risk of having such tobacco on the premises; the only reason to have such tobacco on the premises is to make a quick, untraceable profit.

In the conditions of licence in section 4.2 of the premises licence it states quite clearly that:

'No alcohol or tobacco will ever be purchased from sellers calling at the premise. Exceptions to the condition would be purchases made from authorised representatives who have made prior appointments to visit the store'

This surely would indicate that no illicit products should be at the premises.

There have been no previous reported incidents concerning the PLH/DPS. However on 25 September 2019 West Midlands Police visited the premises and seized a further quantity of Viagra type medication. In both circumstances this type of medication should not be sold or supplied from what is basically a small off-licence; it shows a disregard for the safety and protection of the general public.

Selling and dealing such illegal items is part of an underground criminal network who sell and exchange all kinds of illegal products, fund more serious criminal enterprises and cheat revenue as well as undermining legitimate businesses. The provenance and safety of the products are also unknown.

Taking the above matters into consideration, Trading Standards would ask that the Committee consider this application for a review and take any action open to them which could be to temporarily suspend or permanently revoke the licence.

Annex 1 – Mandatory Conditions

No supply of alcohol may be made under the premises licence (a) at a time when there is no designated premises supervisor in respect of the premises licence, or (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.

Every retail sale or supply of alcohol made under this licence must be made or authorised by a person who holds a personal licence.

The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol. The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy. The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either— (a) a holographic mark, or (b) an ultraviolet feature.

(1) A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price. (2) In this condition:- (a) "permitted price" is the price found by applying the formula P = D + (D x V), where- (i) P is the permitted price, (ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol; (b) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979; (c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence— (i) the holder of the premises licence, (ii) the designated premises supervisor (if any) in respect of such a licence, or (iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence; (d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and (e) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994. (3) Where the permitted price would not be a whole number of pennies, the permitted price shall be taken to be the price rounded up to the nearest penny. (4) Where the permitted price on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax, the permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

Annex 2 - Conditions consistent with operating schedule

2a) General conditions consistent with the operating schedule

No alcohol or tobacco will ever be purchased from sellers calling at the premise. Exceptions to the condition would be purchases made from authorised representatives who have made prior appointments to visit the store.

Staff Training - All staff will be trained for signs of persons who are intoxicated and made aware of licensing legislation regarding the sale of alcohol to persons intoxicated. Also regarding under age sales, proxy sales and legislation regarding the consumption of alcohol purchased from the premises and consumed in the vicinity. All this training must be recorded on premises and be made available to responsible authority immediately on request.

Signage displaying to customers to "Respect Local residents, please leave quietly" to be on display around location and especially at the exit.

2b) Conditions consistent with, and to promote the prevention of crime and disorder

CCTV - It will be digital recorded for up to 31 days and will be made available on request to all licensing authorities. There will always be a member of staff on duty who is trained and able to show and download images from the system during opening hours. It will be in recording operation during opening hours and it will cover all licensable activity areas of the premises.

The CCTV system must be installed and operate internally to cover all areas that licensable activities take place and where alcohol is displayed within any public area.

2. The CCTV unit shall be positioned in a secure part of the licensed premise. Access to the system should be allowed immediately to the Police upon request.

3. A competent trained person in the use of and operation of the CCTV will be in attendance at the premises at all times that licensable activities take place and be able to fully operate the CCTV system to be able to down load in a recognised format any information requested by the Police.

The CCTV system clock should be set correctly and maintained (taking account of GMT and BST). A facility will be available for the Police to remove from the CCTV system a copy of any material relevant to any on-going Police investigation.

All CCTV images will be retained for a period of not less than 31 day

An incident register of all occurrences and ejections from the premises will be maintained at the premises and all details of public order offences will be recorded.

All persons involved in the sale of alcohol will receive initial and subsequent 6 monthly refresher training by the Designated Premises Supervisor or an appropriately accredited training provider with regards to the law in relation to the sale of alcohol. This will be recorded in a staff training register and will include, signature of the member of staff, the DPS or an appropriately accredited training provider together with the date.

At any time when there is no Personal License holder on the premises there must be at least one member of staff on duty inside the premise who has been authorised by the DPS. Any such person should have seen, read and be fully aware of the conditions of the premise licence and take all steps to ensure that such conditions are adhered to whilst they have responsibility for the premise.

A record should be kept detailing, the name and address relative to the person left in charge of the premise and the times and dates when the authority to cover exists, in writing.

These should be individual entries covering short periods of time only and should not exceed more than a three week period.

The authorised person should also sign on each occasion that he/she has physically seen inspected and is fully aware of all the conditions attached to the premise licence. The DPS should sign to acknowledge that they agree to the authorised person being in charge of the premise for any times specified. The records of these matters should be kept fully updated at all times.

All Records shall be retained at the premises for a period of no less than 12 months and made available to responsible authorities on request.

When trading past 23:00hrs then at least one SIA security staff will be on duty after 23:00hrs onwards until 06:00hrs.

The SIA authorisation badge will have to be worn on an upper arm in clear view.

A signing in log would have to be kept up to date reference the working of the SIA security staff. Profiles of security staff will be kept on the premises and available to any responsible authorities upon request.

The profile will include a copy of their SIA licence and photographic identification if photographic ID is not available then a current utility bill no more than three months old will be acceptable.

2c) Conditions consistent with, and to promote, public safety

No enforceable conditions identified from operating schedule.

2d) Conditions consistent with, and to promote the prevention of public nuisance

The Licence Holder shall ensure that there is signage requesting patrons to leave the premises quietly.

Entrance door - will be fitted with an electronic locking device or similar that will be utilised between the hours of midnight until close at 05:00 daily. This will ensure staff have control of customers entering the premises.

2e) Conditions consistent with, and to promote the protection of children from harm

A Challenge 25 policy will be adopted in order to reduce the potential for underage sales of age restricted products including alcohol. If a customer appears to be under 25 years of age and cannot prove that they are eligible to purchase the age restricted item with a valid UK or Ireland Photocard Driving Licence, a valid Passport or PASS accredited proof of age scheme card, they will be refused service.

Challenge 25 posters will be displayed at the premises to reinforce this policy. Posters will be placed at; each till, each area alcohol is stocked and at the point of entry into the store. The posters will be displayed prominently and in sight of customers and staff.

A Refusals Register is to be used to record all incidents when a sale is refused. The register is to be kept in the store at all times unless it is requested by authorised officers of responsible authorities. The Refusal/Challenge Register is to be checked and signed off by the Designated Premises Supervisor every two weeks.

All staff working at the premises involved in the sale of age restricted products including alcohol will receive on-going training and will be refreshed at least every 6 months. This will be recorded in a staff training register and will also include a written test of knowledge. The Training records must be made available to authorised officers of responsible authorities on request. Records shall be retained at the premises.





A representation has been received from West Midlands Police, as a responsible authority. See Appendix 1.

Review application is attached. See Appendix 2.

The Premises Licence is attached at Appendix 3.

West Midlands Police have received the review application, submitted on behalf of the chief officer of Weights and measures for BCC. West Midlands Police fully support this application, and are particularly disturbed to read the evidence surrounding this review application and the apparent lax attitude that the licensed premises pay towards the licensing objectives.

West Midlands Police are concerned that after officers from our response unit found a 15yr old intoxicated female in a park, with her friends stating to officers that she had bought the alcohol from D&B wines. This information was then passed to both trading standards and BCC licensing enforcement.

Whilst not wishing to repeat the information in the review application (which is fully supported by us), it is apparent that Trading Standards and BCC licensing enforcement has given ample and sufficient advice to the premises, whilst not receiving any credible engagement back. Months after the advice was given a test purchase operation was undertaken, and it is noted that the volunteer was in the same age and gender bracket of the person found in the park, and the premises sold alcohol to the child.

It has to be noted again that the type of alcohol sold is a type and brand of alcohol popular with younger drinkers.

West Midlands police are concerned that the person who sold the alcohol to the test purchaser was the same individual with whom officers had given advice to in a previous visit

It would appear that the DPS/PLH has a very distant operating style where staff are left in charge, with little or no command of the English language, staff with no understanding or comprehension of the licensing legislation.

The sale of alcohol to minors is a serious offence and issue. Alcohol is classed a drug and has wide ranging effects on the body, which are easily exacerbated in the young as they are not accustomed to the effects. This puts people in very vulnerable states as clearly seen with the incident where response officers found the 15yr old girl, to the point where they are more susceptible to things happening to them.

The Licensing Act has a list of serious offences contained within the 182 guidance. Sec 11.27 deems a serious offence to be

For the illegal purchase and consumption of alcohol by minors which impacts on the health, educational
attainment, employment prospects and propensity for crime of young people

Sec 11.28 states that even on the first review application, revocation should be seriously considered. Even if this review was just from following a failed test purchase, West Midlands Police would be seeking revocation, however as there are aggravating features to this application West Midlands Police believe that the only option available is for the premise licence to be revoked.

West Midlands Police fully support the application made by Trading Standards and wish to join in the review application

On the evening of 1 September 2019 police officers from Newtown police station response team were called to an incident in Summerfield Park and found a 15 year old girl unconscious due to alcohol consumption.

Her friends stated that she had gone into D&B Wines, 201 Dudley Road, Winson Green, Birmingham, B18 7QY and had been sold vodka and Lambrini wine. The girl was apparently clearly underage, not much over 5ft tall and would in no way have passed a Challenge 25 test.

This information was passed to both Trading Standards and Birmingham City Council licensing by Police Officer 22046 MOORE. A complaint was raised and given reference number 9483904

Following on from this on 18 September 2019 a joint visit was made to the shop by officers from both agencies; officer being Trading Standards Enforcement Officers John BRADBURY and Floyd ROWE with Licensing Enforcement Officer Sharon WATTS

A trader's notice number 13037 was issued to the premises licence holder by Trading Standards advising that it was illegal to sell alcohol and tobacco to persons under eighteen, it also advised that trading standards undertake test purchases and if a sale was made then a review of the licence would be requested.

Officer WATTS was concerned that Mr Adi Romulus ILEANA, who was in charge at the shop at the time, did not appear to speak English and was unable to say if he had been authorised to sell alcohol or explain his responsibilities regarding the premises licence.

The DPS/PLH, Mr Marius MICLESCU was not present at the time of the visit and officers were advised that he was abroad.

Trading Standards had a further meeting with the wife of Mr MICLESCU on 27th September 2019 as they were still concerned about the running of the premises. Further advice was given about preventing underage sales of alcohol or tobacco products.

On Saturday 2 November 2019 Trading Standards undertook a test purchasing exercise. They were assisted in the exercise by a 14 year old female volunteer.

At approximately 12.50 pm the volunteer was able to purchase a large bottle of 4% alcohol WKD blue from the shop. The sale was observed by Trading Standards Officer Martin WILLIAMS.

The person who sold it to her was Adi Romulus ILEANA. He did not ask her for any ID or what here age was.

On returning to the shop officers found that Mr ILEANA was unable or unwilling to give any explanation as to why he made the sale. (Eventually a family member had to be called to act as an interpreter). There was no statutory 'under 18 tobacco' notice on display in the shop or challenge 25 poster. Officers also found 3 packs of illicit hand rolling tobacco in a small fridge in the shop that appeared to be counterfeit. The Premises Licence Holder who is also the Designated Premises Licence Holder was not available. There was no other personal licence holder on the premises.

Please provide as much information as possible to support the application (please read guidance note 3)

The sale of alcohol to persons under the age of 18 is a serious offence under The Licensing Act 2003.

It also has serious consequences when it gets into the hands of young people as illustrated in the sale made to the first young girl in this case.

This shop had at least two warnings from Trading Standards not to sell alcohol to underage people.

There is no excuse at all for making the sale to the volunteer; it appears to be a badly run premises with no control by the PLH/DPS.

The original incident in itself should have been a sufficient deterrent. Particularly as the incident had made the 15 year old girl unwell and could have ended up much worse.

It appears that the man left in charge at the shop, Mr Adi Romulus ILEANA cannot or does not wish to communicate to the authorities. He also appears unable to be aware of his responsibilities under the licensing Act.

The person who is the DPS and PLH, Marius MICLESCU was not present in the shop on any of the visits by Trading Standards which is also of concern as he does not appear to be taking any responsibility. On one occasion he resorted to using his wife to speak to Trading Standards and on two others a young man had to be called to interpret for him.

Previous history of this shop.

The current licence for this premises was granted on 7 September 2017.

On 1 October 2018 Trading Standards received a complaint from a member of the public that the shop was selling fake cigarettes and was also selling alcohol to underage people. This was given reference 9154759.

Following this information an officer went to D&B Wines on 19 October 2018 and gave advice on illicit cigarettes and alcohol. Whilst at the shop the officer witnessed three attempted sales of single cigarettes by the person serving.

A trader's notice number 12689 was issued to the licence holder Mr MICLESCU on this occasion and an information pack was given including tobacco and alcohol notices to display. A poster advising not to sell single cigarettes and challenge 25 posters were also sent to the shop a few days later. Neither Mr MICLESCU nor the then DPS Mr Sukhwant BAHIA were present. There was no other personal licence holder on the premises.

Recommendations.

Given the history and number of times this shop has been warned about underage sales and how to comply with Trading Standards and Licensing Laws I do not think under the current management things will change for the better.


The serious incident with the 15 year old girl is as a direct consequence of the shops refusal to act responsibly and comply with the law.

I would ask that the Committee consider all outcomes at their disposal but due to the seriousness of the matters would recommend that the best course of action is for the licence to be revoked.

Annex 1 – Mandatory Conditions

No supply of alcohol may be made under the premises licence (a) at a time when there is no designated premises supervisor in respect of the premises licence, or (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.

Every retail sale or supply of alcohol made under this licence must be made or authorised by a person who holds a personal licence.

The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol. The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy. The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either— (a) a holographic mark, or (b) an ultraviolet feature.

(1) A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price. (2) In this condition:- (a) "permitted price" is the price found by applying the formula $P = D + (D \times V)$, where-(i) P is the permitted price, (ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol; (b) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979; (c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence— (i) the holder of the premises licence, (ii) the designated premises supervisor (if any) in respect of such a licence, or (iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence; (d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and (e) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994. (3) Where the permitted price would not be a whole number of pennies, the permitted price shall be taken to be the price rounded up to the nearest penny. (4) Where the permitted price on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax, the permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

Alcohol shall not be sold or supplied except during permitted hours. In this condition, permitted hours means: a. On weekdays, other than Christmas Day, 8 am. to 11 pm. b. On Sundays, other than Christmas Day, 10 am. to 10.30 pm. c. On Christmas Day, 12 noon to 3 pm. and 7 pm. to 10.30 pm. d. On Good Friday, 8 am. to 10.30 pm. The above restrictions do not prohibit: (a) during the first twenty minutes after the above hours, the taking of the alcohol from the premises, unless the alcohol is supplied or taken in an open vessel; (b) the ordering of alcohol to be consumed off the premises, or the despatch by the vendor of the alcohol so provide ordered; (c) the sale of alcohol to a trader or club for the purposes of the trade or club; (d) the sale or supply of alcohol to any canteen or mess, being a canteen in which the sale or supply of alcohol is carried out under the authority of the Secretary of State or an authorised mess of members of Her Majesty's naval, military or air forces;

Alcohol shall not be sold in an open container or be consumed in the licensed premises.





It is noted that when officers went back into the premises the person behind the till who had made the safe could not offer any explanation to the officers why he had done this, I see that this

has now change in the recent bundle submitted by the premises. I will draw the committees attention that at the time, when it was fresh in the mind, No explanation was given.

The impacts on the sale of alcohol to children are very serious, not only is it a serious offence under the licensing act as covered in the section 182 guidance, the effect on the child's health, development, propensity to being/committing crime is considerable.

In the police log, there are references to one of the girls being unconscious through the consumption of alcohol, and then covered in her own sick. This puts her in a far greater risk of being a victim of crime, she is very vulnerable, all through alcohol that they had reportedly bought from D&B wines.

It is not only the Police log that shows these impacts, a simple search through Google shows a wealth of organisations expressing the concerns of alcohol and children. I have selected a few from recognised organisations.

These premises were given advice, the premise licence holder who is the DPS has played a very hands off approach, and it is noticeable that now this review has been called he is trying to make out he has not.

I have seen the bundle from the premises and the wish that the licence shouldn't be revoked as this will bring untold hardship on their family, I am afraid the actions of the premises have brought untold hardship on others and put their lives at risk.

Premise licence holder are bestowed a great deal of trust to ensure they sell what is an actual drug in a legal and save way, these premises even with advice have failed to uphold that trust.







Should my child drink alcohol?

Children and young people are advised not to drink alcohol before the age of 18.

Alcohol use during the teenage years is related to a wide range of health and social problems.

However, if children do drink alcohol underage, it shouldn't be until they are at least 15.

Health advice

The Chief Medical Officer has provided guidance on the consumption of alcohol by children and young people (PDF, 1.5Mb) (Link: http://www.cph.org.uk/wp-content/uploads/2013/09/Guidance-on-theconsumption-of-alcohol-by-children-and-young-people.pdf). This can help parents make decisions about their children and their relationship with alcohol.

Health risks:

- Drinking alcohol can damage a child's health, even if they're 15 or older. It can affect the normal development of vital organs and functions, including the brain, liver, bones and hormones.
- Beginning to drink before age 14 is associated with increased health risks, including alcohol-related injuries, involvement in violence, and suicidal thoughts and attempts.
- Drinking at an early age is also associated with risky behaviour, such as violence, having more sexual partners, pregnancy, using drugs, employment problems and drink driving.

Advice for parents:

has all second a state -----

- If children do drink alcohol, they shouldn't do so until they're at least 15 years old.
- If 15 to 17 year olds drink alcohol, it should be rarely, and never more than once a week. They should always be supervised by a parent or carer.
- If 15 to 17 year olds drink alcohol, they should never exceed the recommended adult weekly limit (14 units of alcohol). 1 unit of alcohol is Page 66 of 126

about half a pint of normal-strength beer or a single measure (25ml) of spirits. A small glass of wine equals 1.5 units of alcohol. Read more about <u>alcohol units (Link: /live-well/alcohol-support/calculating-alcohol-units/)</u>.

 If your child intends to drink alcohol, using positive practices such as incentives, setting limits, agreeing on specific boundaries and offering advice can help.

Talking to your child

Talk to your child about the dangers of alcohol before they start drinking. You can use the points below as guidance.

- Make it clear that you disapprove. Research suggests that children are less likely to drink alcohol when their parents show that they don't agree with it.
- Don't shout at your child, because it will make them defensive and could make the situation worse. Stay calm and firm.
- Make it clear that you're there for them if they need you, and answer any questions they have.
- Talk to your child about how alcohol affects judgement. Drinking too much could lead them to doing something they later regret, such as having unprotected sex, getting into fights or drink driving.
- Warn your child about the dangers of <u>drink spiking (Link: /live-well/healthy-body/drink-spiking-and-date-rape-drugs/</u>) and how to avoid it.
- If your child wants to drink alcohol, advise them to eat something first, not drink too much and have a soft drink between alcoholic drinks.
- Make sure your child tells you where they're going and has a plan for getting home safely. If they're planning to drink, make sure they're with friends who can look after them.

What the law says

The police can stop, fine or arrest a person under 18 who is drinking alcohol in public. If you're under 18, it's against the law:

- to buy or try to buy alcohol
- for an adult to buy or try to buy alcohol for you
- to drink alcohol in licensed premises, such as a pub or restaurant

However, if you're 16 or 17 and accompanied by an adult, you can drink (but not buy) beer, wine or cider with a meal.

If you're 16 or under, you may be able to go to a pub or premises that's primarily used to sell alcohol if you're accompanied by an adult. However, this isn't always the case and it can depend on the premises and the licensable activities taking place there.

It's illegal to give alcohol to children under 5.

Does my drinking affect my child?

We ask two experts to talk about the major part parents play in making sure their children develop a healthy relationship with alcohol.

Dr Sarah Jarvis - GP, expert in child health issues and a medical adviser to Drinkaware

"Drinking alcohol during childhood can have a serious effect on a child's development, causing a range of health and social problems. Drinkaware's new research suggests a strong link between the frequency of young people's underage drinking and their exposure to drinking at home. So it's clear that parents play a crucial role in making sure their children develop a healthy relationship with alcohol."

The UK chief medical officers (CMO) recommend that an alcohol-free childhood is the healthiest and best option. The law on alcohol and young people is different across the United Kingdom.

"Evidence shows that young people who start drinking at an early age drink more, and more frequently, than those who delay their first alcoholic drink, so it is important that parents try to delay their child's first drink as much as they can."

Drinkaware research¹ shows that only one in 10 (10%) of middle-earning (ABC1) parents are aware of the CMO guidelines on delaying drinking to the age of 15, but when presented with this guidance nearly 7 in 10 parents in England, Wales and Northern Ireland (69%) agreed with the recommendations.

"Experts advise that parents shouldn't try to de-mystify alcohol by allowing children to try it, especially around special occasions like Christmas. Instead, they can talk openly and honestly about alcohol with their children, highlighting the effect excessive drinking can have on your health.

"With tens of thousands of young people needing treatment every year in A&E departments because of alcohol, getting parents talking to their children in this way is the first step towards bringing these numbers down.

"In my experience, what conveys the stark realities of alcohol misuse to parents is to talk frankly about the effects that drinking from a young age has on their child's health.

"But what will strike a chord with young people is hearing about the short-term effects and dangers of drinking. Alcohol can be polsonous to anyone who drinks too much in a short space of time but children are especially vulnerable because of their smaller size. The serious health effects of alcohol on children can be seen when their blood alcohol levels get too high. This can cause their brain to stop controlling the body's vital functions and, in the worst case scenario, they could stop breathing, fall into a coma or choke on their own vomit.

"Knowing about the impact on their concentration and ability to learn can also strike a chord with young people. Drinking to excess can also affect their future prospects through social media. More than half of young people have untagged themselves in online pictures when they were drunk and in embarrassing positions – these pictures are out there forever for their potential future employers to see.

"By making your child aware of the impact of drinking on their body, you can help to give them the confidence to make more informed and healthy choices about alcohol as they get older."

Sue Atkins - parenting expert, writer, speaker, broadcaster, coach and author.

"Some parents might feel hypocritical laying down rules about alcohol when they worry they drink a little too often or much themselves. But it's important for parents to make the difference between adults drinking and children doing so. It's useful to explain that alcohol is only for adults because their bodies have finished growing, and even adults have rules about how much they can drink."

"Parents should try to be aware of how much they are drinking in front of their children, especially on holiday or at special occasions such as Christmas, as children do notice changes in their parents drinking habits.

"If you do drink too much on an occasion and end up nursing a hangover, don't try and hide the symptoms, instead talk openly to your child about how you're feeling, letting them know the effects would be worse for them as they're smaller and developing. This way they know too much alcohol can have a negative consequence and you avoid making alcohol a taboo subject.

"But, equally, parents should hide their own alcohol consumption from their kids. Setting a good example and demonstrating a moderate approach to drinking, while communicating the harmful effects of alcohol on children, is a good approach to alcohol education. If a parent doesn't drink themselves, they can still provide alcohol education using other people's drinking habits as a stimulus – either out of the home or on TV."

- I am the owner and manager of a business known as D & B wines situated at 201 Dudley Road Winson Green Birmingham B18 7QY.
- The premise known as 201 Dudley Road Winson Green Birmingham B18 7QY is licensed to sell alcohol.
- 4. I hold Personal licences to sell alcohol and I am the designated Premises Supervisor (DPS) for the business.

- I confirm that between 2018-2019, my wife Anna Maria and Mr Adi Romulus Ileana were trained and authorised by me to sell in my shop, as such I will refer to them as worker.
- 6. I confirm that Ana Maria Capatina and Mr Adi Romulus Ileana are trained by me to enable them to assist me with customer service role and they understand the wider social responsibilities involved in the sale of alcohol:
- 7. As the DPS who is responsible for day to day running of the business, I have always impressed on my assistance to follow all procedures, this being to ask for proof of Identification before any sale is executed to customers. We also have visible warnings in the shop which state that ID checks are required before a purchase is made.
- Sometime in November 2019 a trader's notice with reference number 13565 was issued to my business D & B Wines, stated thereon that on 2nd November 2019 alcohol was sold to an underage girl by my staff Mr Adi Romulus Ileana.
- 9. I confirm that on 2nd November 2019, upon my return from a cash and carry shop were I went to buy some items for the business, Mr Adi Romulus Ileana informed me that on the said relevant date a man was in the shop floor acting suspiciously.
- 10. Mr Adi Romulus Ileana informed me that he was concerned that the man was taking too long to find what he wanted to buy, as he picked up one item after the other and placing them back. Mr Adi Romulus Ileana said, as the man was acting suspiciously, more attention was placed on him and it was during this time that a lady entered the shop and went straight to the shop floor and picked up a bottle of WKD blue 4% alcohol and brought it to the till for purchase.
- 11. Mr Adi Romulus Ileana informed me that as he was focused on the man who he said was acting suspiciously and he did not ask the lady to provide her ID as always usually do in line with our sale policy and that the lady did not appear underage in his view at the time.

- 12. All alcohol products with higher percentage are kept behind the counter hence customers cannot access them directly, this must be requested from the salesperson and ID checks are automatically requested.
- 13. Mr Adi Romulus Ileana informed me that shortly after the lady purchased the WKD and left the shop, the man who was acting suspicious then left the shop without buying anything. Shortly after the same man and another man returned to the shop alleging that alcohol was sold to an underage girl.
- 14. A further general check was carried in the premises and 3 packets of tobacco were found in the premise but in the private compartment were Mr Adi Romulus Ileana keeps his personal things. The tobacco was said to be counterfeit and Mr Adi Romulus Ileana had confirmed to me that the tobacco were for his personal use and he had bought them because they were cheap.
- 15. I state that the counterfeit tobacco found do not belong to my business at all and they were not in fact located in the cigarette shelf but were found in an old fridge were Mr Adi Romulus Ileana kept his personal belongings.
- 16. Although Mr Adi Romulus Ileana explained the circumstances which caused the oversight on his part in respect of the sale to the underage girl on 2nd November 2019, I have since terminated his service from my business.
- 17. With regards to complaint reference number 9128646 dated 01/10/2018, I deny that fake cigarettes were sold. I state that a customer bought a packet of Sterling cigarettes from my shop and then came back to return the cigarettes after opening the packet, my sale assistant refused to accept the cigarettes and the customer then threatened that he will get us in trouble by alleging that fake cigarettes were sold to him.
- 18. With regards to complaint reference number 9154759 dated 19/10/2018 being allegation of attempted sale single cigarettes. I state that the salesperson was

replaced, and I have further emphasised on my staff about the serious nature of such breach. Warning Postal are displayed in the premise.

- 19. I have also arranged for my wife Anna Maria Capatina to do the Personal Licence Course and will then apply for a Personal License.
- 20. With regards to complaint reference number 9482445, being allegation that a 15 years old girl who was found in the Summerfield park is alleged to have bought alcohol from D & B wines, I deny that the said girl bought alcohol from my shop.
- 21. I therefore request that my Premise licence and my Personal licence not to be revoked as this will cause untold hardship on me and my family.

- Between 2018-2019, I was working as a shop assistance at D & B wines situated at 201 Dudley Road Winson Green Birmingham B18 7QY.
- 4. The premise known as 201 Dudley Road Winson Green Birmingham B18 is licensed to sell alcohol.
- 5. My boss Mr Marius Miclescu holds Personal licences to sell alcohol and he is the designated Premises Supervisor (DPS) for the business.

- 6. I confirm that I was trained by Mr Marius Miclescu on the rules and procedures of selling alcohol to the public. My boss has always emphasised on the wider social responsibilities involved in the sale of alcohol.
- 7. During my training, I was strictly informed that all customers must show their ID before alcohol sale is executed.
- 8. Although I do not speak English language fluently, I was used to saying to every customer who comes to buy alcohol in shop, 'show me ID Please' and I will point to the warning sign displayed in the shop which states that ID is required for purchases of alcohol and cigarettes.
- 9. On 2nd November 2019, a man attended D & B wines whilst I was selling on the till alone. A man attended the shop was acting suspiciously as he picked one item after the other without coming forward to the till to pay or asked me for assistance.
- 10. I became concern about the man 's movement in the shop and I then paid more attention to him. The man was taking too long to find what he wanted to buy and he was acting suspiciously.
- 11. During this time a lady entered the shop and went straight to the shop floor and picked up a bottle of WKD blue 4% alcohol and brought it to the till for purchase.
- 12. I was still focused on the suspicious man and by way of oversight I did not ask the lady who was on the till to provide me with her ID as I have always done to other customers in line with our sale policies.
- 13. The lady did not appear underage in my view, but this is not an excuse for me not have asked her to provide me with her ID as I have always done. This was a complete oversight on my part as I was distracted due to the man's suspicious behaviour in the shop.
- 14. I confirm that all alcohol product with higher percentage are kept behind the counter hence customers cannot access them directly, these products must be requested from the salesperson and ID checks are automatically requested.

- 15. Shortly after the lady purchased the WKD and left the shop, the man who was acting suspicious then left the shop without buying anything. Shortly after, the same man and another man returned to the shop alleging that alcohol was sold to an underage girl.
- 16. A further general check was carried in the premises and 3 packets of tobacco were found in the private compartment, in an old fridge located at the back of shop were I normally keep my personal belongings.





Sealed bag with plastic seal reference 09798 containing 2 x 50g pouches of Golden Virginia hand rolling tobacco.


I examined these pouches of hand rolling tobacco.

1. Purpose of report:

To consider an objection notice to the Temporary Event Notice (TEN), which seeks to permit the sale of alcohol (for consumption on and off the premises), and the provision of late night refreshment on 18th January 2020, to operate from to 4:00pm until 12:00midnight.

2. Recommendation:

To consider the objection notice made by Environmental Health.

3. Brief Summary of Report:

A Temporary Event Notice was submitted by Kieran Dewar and received on 3rd January 2020, in respect of 16, Lonsdale Road, Harborne, Birmingham, B17 9RA.

An objection notice has been received from Environmental Health.

4. Compliance Issues:

When carrying out its licensing functions, a licensing authority must have regard to the Guidance issued by the Secretary of State under section 182 of the Licensing Act 2003.

4.1 Consistency with relevant Council Policies, Plans or Strategies:

The report complies with the City Council's Statement of Licensing Policy and the Council's Corporate Plan to improve the standard of all licensed persons, premises and vehicles in the City.

5. Relevant background/chronology of key events:

Kieran Dewar submitted on 3rd January 2020, a Temporary Event Notice in respect of 16, Lonsdale Road, Harborne, Birmingham, B17 9RA.

The Temporary Event Notice, including an Events Management Plan, is attached at Appendix 1.

An objection notice has been received from Environmental Health, see Appendix 2.

Site location plans are attached, see Appendix 3.

Under the licensing system of TENs, no actual permission is required to carry out a licensable activity on a temporary basis. An applicant must merely give notice of his intentions to operate a licensable activity to the licensing authority.

However, the police or local authority exercising environmental health functions may intervene to prevent such an event taking place or agree a modification of the proposed arrangements, and their intervention may in some cases result in the licensing authority imposing conditions on a TEN.

Where a TEN is submitted, the licensing authority must consider the objection(s) at a hearing before a counter notice, or a notice including a statement of conditions can be issued.

Conditions may only be applied if the TEN is in connection with licensable activities at licensed premises. It must be noted a Premises Licence is not currently in force for 16, Lonsdale Road, Harborne, Birmingham, B17 9RA.

When giving a TEN, consideration should be given to the following four licensing objectives:

- 1. The prevention of crime and disorder
- 2. Public safety
- 3. The prevention of public nuisance; and
- 4. The protection of children from harm

Litter/Cleansing Services/Grounds Maintenance

Before during and after the event , event staff will do regular toilet cleans bins and ashtrays will be placed out front with regular checks emptied and maintained. pipelines and equipment will be cleaned to current standards and correct detergents will be used. Before and after the event the front of shop will be assessed for risks and swept every night after the event.

Entertainment

We plan to have a docking station/bluetooth speaker in the bar area at the back of the shop for the customers to play songs if requested or for background music. The music never to be played above 80B. Between opening hours until close. TV for sports events to be shown live.

Security/Stewarding Companies/CCTV

We will not be using any companies as staff will be vigilant of any nuisance or anti social behavior and apply best practice to keep the public safe. We will also keep a log book and record all incidents. West Midlands Police will be notified if serious offences were to occur. During the Events CCTV will be located inside an around the premises to help in assisting in public safety.

Safeguarding children and vulnerable groups

Children will not be allowed on premises during event times. All staff will be trained by Survive to Thrive to identify vulnerable groups of age who attend the event. Appropriate practices to suit the vulnerable adult. Log the incident and outcome.

Noise Management

The main noise pollution from the events will be groups of people talking inside and outside when customers pop outside for cigarettes. Signs will be posted clearly around the bar and at the exit to respect neighbours and keep noise levels down when leaving the event or going outside to smoke. Staff members will be vigilant to noise levels outside and customers loitering longer than a cigarette will be politely asked to come back inside or move on. The bar will have a smart phone on site with a decible reader app and staff will make regular sound checks and log data (auditable.) Acoustic foam will be used where possible to absorb internal noise. If necessary we will install thick curtains on the glass front window to draw after 6PM. The noise levels from and docking station/radio/speaker will be monitored on a decible reader on smartphone behind bar at all times.

Licenses

No event organisers have any personal licenses at the moment. Kieran Dewar has Bll certificate. Volunteer Michael Fitzpatrick has license but will only be volunteering outside of event hours to do on site training. Richard Glenn has ten years experience working as an assistant manager in The Redditch Rd Off Licence 1983 - 1993 (355 Redditch Rd Birmingham)

Communications

The venue will have its own mobile phone which will be accessible to the public through advertisement and available to the police should they need to contact us for any reason. The venue will be called Stories Microbar and it will be clearly signed at the front. Inside the venue we will have various signage to combat underage drinking / drugs and promote being courteous to our neighbours.

The bar will be promoted through social media such as facebook, youtube and twitter and instagram as well as word of mouth in the community.

Traffic Management

The unit is set well back from the main road and as our clientele will be drinking alcohol we don't expect them to be driving / parking at or near the venue. We are a small set up and intend doing our own stock pick ups / deliveries off peak using a car which we can park on the road at the front. All deliveries will be off peak.

Medical and first aid cover

We have all had first aid training over the years but none of us recently. We have a full first aid kit on site. We've noted that the local Waitrose has a defibrillator and nebuliser for use in an emergency.

Fire risk assessment

The front door is our main fire exit but there is also a secondary exit at the back of the premises which could be used, Fire exits will be clearly labelled. The room will have a smoke alarm and a co2 fire extinguisher on hand. We will have at least 750mm regulation width escape to all fire doors.

In case of emergencies all staff will be trained in crowd dispersal and a high visibility jacket will be worn in these scenarios. This would also be logged in the incident book. If necessary we will have an independent fire assessment by the fire service.

Police

We will have a mobile phone and will be contactable by the police. We will also work alongside the police licensing dept in respect of licensing laws and procedures. We will have an auditable incident log on site and should an incident occur it will be logged and handed over to all members of staff so we know if someone has been barred. We will also have CCTV we or the police can look back on should an incident occur.

Anyone suspected to be under the influence of drugs will be asked to leave and barred. Anyone suspected of selling drugs will be asked to leave and any CCTV footage will be passed to the police.

All drugs related incidents will be logged in the incident book.

Waste Management

We have an account with First Mile waste management, who have 24/7 collection service. We will arrange waste collection in off peak times to cause minimum distribution to the roads. We will also self manage and recycle waste when necessary.

I am responding on behalf of the Environmental Health team as a responsible authority. I have received an application from Kieran Dewar for a TEN for alcohol sale (on and off), regulated entertainment and late night refreshment at 16 Lonsdale Road, Harborne, Birmingham, B17 9RA on 18 January 2020 between the hours of 12:00 and 01.00.

There are a number of issues with the TEN application and the supporting Event Management Plan (EMP) as follows:-

- 1. The TEN is for 18 January 2020 although the hours extend into 19 January 2020
- The application is for pop-up microbar but the EMP plan refers to the event as a Private Hire 40th Birthday
 The application requests hours of 12.00 01.00 for 45 people but the form also refers to relevant
- entertainment from 12.00 23.59 (I would seek further information on the relevant entertainment) 4. The EMP describes Stories micro bar as an event set up by 3 individuals who want to provide a range of
- 4. The EMP describes Stories micro bar as an event set up by 3 individuals who want to provide a range of premium alcoholic beverages and soft drinks in a small comfortable setting for upto 7 days over the Christmas holidays this is not what the application is seeking
- 5. The dates and times on the EMP differ from the application and are January 18th 2020 16:00 to 00:00.

The premises are very small and are located in a block of single storey retail units in a residential setting. This department has received complaints regarding noise late in the vent and in the early hours of the morning from both music from the premises and patron noise from outside the premises affecting residents in the locality. The measures in the EMP do not appear to be adequate to control the noise and therefore given the proximate residential use, location, on-going noise compalints and late terminal hour I am concerned that permitting the TEN for the hours as requested would not meet the public nuisance licensing objective.

I would object to the grant of the TEN on the basis of the of impact on the licensing objective of the prevention of public nuisance and I am prepared to attend a licensing hearing if required.
