#### ADDMISION

- All reservations will be booked through email or text.
- The management will only allow 55 people in one sitting.
- Queuing will not be allowed outside the premises. People wishing to come into the venue when capacity has been reached will be asked to provide a mobile phone number and wait elsewhere till there is a space.
- The Management have strict entry guidelines. Dress Code is one of them. Management will have the right to refuse entry to anyone they feel will not be suited to the venue.
- There will be an SIA registered Door Supervisor inside the entrance/reception to the venue on the ground floor. The door supervisor will also act as a Meet & Greeter to customers and showing them to the basement.

#### **PREMISES**


- Customers will enter through a secret door and down a well-lit staircase with bannister. This will lead them to a further door at the bottom of the stairs where the applicant, if not otherwise engaged will be greeting them as host to show them to their tables.
- There will be 3 waiting staff & 2 bar staff on duty together with the host.
- Once seated customers will be handed drinks menus & water by the waiter and shown through the menu and answer any questions.
- No customer will be allowed to stand at the bar, management & staff will kindly move them away.


# SMOKING


- If a customer wishes to smoke outside then they will get a numbered key fob from the door supervisor at reception who will if required place drinks in his custody until the customer returns from smoking.
- Only 6 key fobs will be in existence which will control numbers smoking outside. Only 6
  people allowed to smoke outside.
- Door supervisor at reception will monitor customers outside for any issues relating to the four licensing objectives. If any of the objectives are breached then it will be at the discretion of the Door supervisor if the customer is allowed to return to the venue.
- Customers on returning to the venue after smoking will return the Key fob back to the Door supervisor and any drinks returned to them so that they may return to their seat.


#### END OF EVENING


- All customers on leaving the venue will be advised to leave the premises quietly and to have consideration for the local residents
- Customers will also be asked to pre book taxis from the venue.
- Rubbish will be placed in the storage part of the bar and will be removed the following day to prevent noise.
- Once customers have vacated the venue staff will ensure that cigarette butts and other litter from outside the venue will be collected and disposed of.
- Taxis for staff will be organised by the management who will ensure patrons leave safely, this will also be monitored by the Door Supervisor.









#### 1. INTRODUCTION

- 1.1 We assess sound transmission from the proposed basement bar at 32 Water Street, Birmingham to adjoining dwellings.
- 1.2 We reference performance criteria in Birmingham City Council's Planning Consultation Guidance No.1 'Noise & Vibration'.
- 1.3 Details of other significant guidance and criteria are provided in Appendix A.
- 1.4 Appendix B contains supporting information.




#### 2. PROPOSALS

#### **Proposals**

- 2.1 Proposals are for a basement bar which will operate on Friday and Saturday evenings between 18:00 and 01:00.
- 2.2 The premises will include an installed sound system suitable for background music. The bar will not be a venue for live amplified music nor entertainments using sound systems provided by others.
- 2.3 The bar will have a maximum capacity of 60 however, after installation of fixed seating in the premises, we expect this number to be approximately 40.

#### Premises Location

2.4 We show the location of the proposed bar which is in the basement of 32 Water Street.




2.5 The proposed location of the bar in the basement is significant to its strategy for the control of break-out sound.



#### Access

2.6 To reach the bar, patrons will pass through three sets of doors which we indicate below:



- 2.7 The new main door to the basement entrance includes a steel frame, double glazing and achieves good seals.
- 2.8 Proposals are for the entrance to be attended by staff during operating hours.
- 2.9 Access and egress for smokers to the outside will be controlled using a key system administered by management to a limit of five people at any one time. Drinks will not be permitted outside.

#### Sound System

- 2.10 A modest sound system is proposed with six speakers distributed around the venue including four 8" units and two 6" units. No bass (12") or sub-bass units are proposed. The use of a distributed system means that less sound power is required, which will assist in achieving adequate noise control.
- 2.11 The system is intended and suitable only for background music played to typical conversational bar levels.



#### ASSESSMENT

- 3.1 The location of the bar at basement levels means that airborne sound transmission to dwellings via the floor/ceiling slabs can be suitably controlled by the intervening office level and car park.
- 3.2 The transmission of amplified sound to dwellings above will be determined by structure-borne routes and this is the focus of our assessment.
- 3.3 Our assessment is based on calculation as access to dwellings could not be arranged.

#### Structure-Borne Sound - Amplified Music

- 3.4 We provide a summary of our calculations of structure-borne sound transmission from the basement of 32 Water Street and propose a limit for the control of amplified sound in the bar.
- 3.5 Structure-borne sound transmission is most efficient at low frequencies and our assessment is based on data and calculations in the 63 Hz octave band.


We have taken a conservative view of the attenuation provided by the structure (50dB at 63 Hz) and this could be 55dB or higher.

When we compare the dB Leq allowable in the basement venue to music noise levels in an existing cocktail bar we see that the noise limits are comparable, and so it will be practical to limit the noise to the proposed level.

#### Resulting Amplified Music Limit

3.6 Based on the outcome of our calculations shown above, amplified music in the basement bar should be controlled to following limits.





Calculated amplified music limit for 32 Water Street compared with measured levels in a similar type venue with higher capacity

3.7 The calculated spectrum of limits for amplified music corresponds to an A-weighted continuous equivalent level of 98 dB  $L_{Aeq,5min}$ .

#### Description of Method

- 3.8 We have assessed the likely level of structure-borne sound transmission based on measurements and subjective assessment of similar scenarios to that at 32 Water Street.
- 3.9 As the proposed club is in a basement, so the floor and walls have ground-contact and are heavily damped, we estimate the structure-borne level difference in the 63 Hz octave band to be 50 dB *D*. This is based in part on detailed measurements we have undertaken in another residential/music venue building.
- 3.10 We have used this value of sound isolation to weight a typical measured amplified music spectrum for a nightclub to calculate a limit in the bar which can achieve Birmingham City Council's requirements for the control of amplified sound to attached dwellings.
- 3.11 Birmingham City Council's requirements are described in Appendix A.

#### Airborne Sound - Amplified Music

#### Sound Locks

- 3.12 A sound lock will be created between the basement bar and street level which contains three doors as described on the plan draws above.
- 3.13 The entrance doors will be attended during normal operation of the premises to help ensure that doors will remain closed as much as reasonably practicable.
- 3.14 We expect that amplified music from the basement bar will be inaudible at street level at times when at least two or all three sets doors in the sound lock are closed.



#### **Smokers at Street Level**

- 3.15 We provide a summary of calculations to assess the potential impact of noise from people directly outside the entrance to the bar.
- 3.16 Proposals are that people would exit the bar to smoke at street level no more than 5 at a time.

3.17 With closed windows to dwellings the likely internal levels due to people outside the club would be further reduced.

#### 4. DISCUSSION

#### **Limits for Amplified Sound**

- 4.1 We have compared the calculated limits for the control of amplified sound in the basement of 32 Water Street with levels measured in a similar venue with a higher capacity. The noise limit is set at 63 Hz so as to control the loudness of the "bass beat".
- 4.2 The proposed level corresponds well with levels in other comparable venues. However, it is likely that amplified sound in the basement bar at 32 Water Street will be lower than in other venues given its smaller occupancy.
- 4.3 The levels used for comparison were measured in a Birmingham Cocktail bar which is significantly larger with over 150 people at peak periods during Saturday night when our measurements were made.

#### **Egress to the Street**

- 4.4 The access and egress of people will be closely controlled by management who will be required to encourage the responsible behaviour of its patrons on leaving the premises as is common practice under licensing requirements in Birmingham.
- 4.5 The capacity of the proposed bar is low compared with other nightclub venues nearby and the number of people exiting on to Water Street at any one time is unlikely to represent a significant increase or change in the character or level of noise experienced on a normal Friday or Saturday night in an inner city location.



#### **Smoking Area at Street Level**

- 4.6 We have calculated indicative levels for a group of smokers outside 32 Water Street at street level.
- 4.7 It should be noted that sound from small groups of people outside the bar is unpredictable and can vary significantly from the scenario used in our assessment. As such it reasonable to expect that a duty of care should lie with the venue management to control excessively noisy behaviour. Given the likely occupancy of the bar it is also reasonable to expect that control of excessive noise from people can readily be implemented.

#### **National Planning Policy Framework**

The National Planning Policy Framework (NPPF) states that planning polices and decisions should aim to:

- Avoid noise from giving rise to significant adverse impacts on health and quality of life as a result of new development.
- Mitigate and reduce to a minimum other adverse impacts on health and quality of life arising from noise from new development including through the use of conditions.
- Recognise that development will often create some noise and existing businesses wanting to develop in continuance in nearby land use since they were established.
- Identify and protect areas of tranquility which have remained relatively undisturbed by noise and are prized for their recreation and amenity value for this reason.

The National Planning Policy Framework refers to the Noise Policy Statement for England (NPSE).



#### **Noise Policy Statement for England**

The Noise Policy Statement for England (NPSE) provides guidance regarding acceptable noise burden and gives three assessment levels to help categorize this:

- No Observed Effect Level (NOEL)
- Lowest Observed Adverse Effect Level (LOAEL)
- Significant Observed Adverse Effect Level (SOAEL)

#### No Observed Effect Level

This is the level of noise below which no effect can be detected and there would be no discernible negative effect on health or quality of life.

#### Lowest Observed Adverse Effect Level

This is the lowest level of noise above which adverse effects on health and quality of life can be detected.

#### Significant Observed Adverse Effect Level

This is the level above which significant adverse effects on health and quality of life can occur.

Design proposals and planning decisions should always seek to avoid noise impact which could be categorized as SOAEL.



#### Planning Practice Guidance - Noise

Planning Practice Guidance: Noise (PPGN) provides guidance on how planning can manage potential noise impacts with information to support the NPPF and NPSE approach.

PPGN includes the following table which summarises the noise exposure hierarchy based on the likely average response.


