1. Purpose of report:

To consider a relevant representation that has been made in respect of an application to vary the Premises Licence, which seeks to amend the conditions relating to the closure of the beer garden so as to permit the beer garden servery to operate to 10:30pm and the beer garden to close at 11:00pm.

The application seeks to amend the following conditions:

- All sales of alcohol from the servery shall cease at 21.00 hours
- The beer garden shall be cleared of all patrons by 21.30 hours and staff shall ensure that patrons are escorted inside the building (save for use by smokers as per the below)
- The beer garden may be used by patrons after 21.30 to smoke, but they will not be allowed to take drinks into the beer garden.

The applicant is not seeking to vary the licensable times under the scope of this application.

2. Recommendation:

To consider the representation that has been made and to determine the application.

3. Brief Summary of Report:

Variation application received on 9th June 2021 in respect of the New Inn, 74 Vivian Road, Harborne, Birmingham, B17 0DJ.

A representation has been received from West Midlands Police, as a responsible authority.

5. Relevant background/chronology of key events:

Marstons Plc applied on 9th June 2021 to vary the Premises Licence for the New Inn, 74 Vivian Road, Harborne, Birmingham, B17 0DJ.

A representation and witness statement have been received from West Midlands Police, as a responsible authority, which is attached at Appendix 1.

The application is attached at Appendix 2.

The current premises licence is attached at Appendix 3.

Site Location Plans at Appendix 4.

Good Afternoon Licensing,

In relation to the above The New Inn is a public house located in Vivian Road in Harborne which is a residential setting.

On 9.7.18 Licensing Committee A imposed conditions on the premises following a review procedure.

Four of these conditions were:

Alcohol sales from the servery in the beer garden must cease at 2100 hours each day, The beer garden must be closed and cleared other than for people smoking at 2130, There could be no regulated entertainment in the beer garden at any time, There must be a dispersal policy as agreed with Environmental Health.

On 3rd June 2021 the applicant has submitted a full variation to the license request. The request is to increase the time that alcohol can be sold in the beer garden till 2230 hours and increase the time that patrons can remain in the beer garden until 2300 hours each day.

West Midlands Police believe that if the variation were to be granted that this would undermine the decision of the licensing committee and would lead to an increase in crime and disorder, public nuisance and be detrimental to children living within the area. The area has not changed since the conditions were put in place and the issues that the conditions were put in place to prevent would be more likely to occur with the increases in time proposed.

West Midlands Police would therefore wish to object to the variation on the grounds of:

Crime and Disorder, The prevention of Public Nuisance The Protection of Children from Harm

I am Police Licensing Officer 60264 Mark Swallow of the West Midlands Police Force currently stationed at Lloyd House Police Station.

Part of my role is to evaluate applications for variations in premises licenses and make appropriate reccomendations to the Local Authority in relation to them.

This matter relates to the New Inn Public House, Vivian Road, Harborne. B17 0DJ. This location is a residential road with the public house situated at its junction with Greenfield Road surrounded by houses.

On 9.7.18 Licensing Sub Committee A sat and adjudicated that all alcohol sales from the beer garden servery at the premises should cease at 2100 hours each day and that the beer garden at the premises should be cleared of all patrons by 2130 hours each day save for use by smokers. This was following numerous complaints and anti- social behaviour associated with the use of the beer garden by the premises and many of these complaints came from residents. The complaints encompassed noise from the patrons of the premises, noise from people leaving the premises and anti-social behaviour such as urinating in peoples gardens in the vicinity of the premises.

On 9.6.21 I received an application on behalf of the premises for a full variation in the premises license. The application was to increase the time that sales of alcohol should cease from the servery till 2230 hours each day and increase the time that the beer garden should be cleared of patrons to 2300 hours save for use by smokers. The applicant has not offered any further control measures as conditions to the license to prevent the issues that have been mentioned.

Since the time of the Committees adjudication there have not been any calls from residents in regards to the issues that occurred previously. It is clear that the closure of the servery and beer garden at the times stipulated has meant that the behaviour of people using the facility has improved. If the application were to be granted there is a real risk that the improvement in behaviour from patrons of the premises will

detereorate and the issues that previously occurred will occur again. There is a clear relationship between time and peoples behaviour. The circumstances are the same as when the adjudication was made. The pub is the same, the locality and demographic of people living in the area is the same and the clientel of the pub is the same. The application makes reference to the benefits of using outdoor spaces as a response to the Covid 19 Pandemic all the measures that have been in place as a result of the Coronavirus Regulations 2020 and 2021 in relation to the hospitality industry are being removed and therefore limits on the use of indoor space and limits on numbers both indoors and outdoors will no longer be in place. The application does not recognise any risk with the variation requested and does not propose any measures in order to mitigate the potential risk posed. In view of what has happenned previously and the real potential for this to occur again coupled with the applicants complete failure to recognise this I believe therefore that the application should not be granted.M.SWallow.

Annex 1 – Mandatory Conditions

No supply of alcohol may be made under the premises licence (a) at a time when there is no designated premises supervisor in respect of the premises licence, or (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.

Every retail sale or supply of alcohol made under this licence must be made or authorised by a person who holds a personal licence.

The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises. In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises- (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to- (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or (ii) drink as much alcohol as possible (whether within a time limit or otherwise); (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective; (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective; (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner; (e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).

The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.

The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol. The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy. The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either— (a) a holographic mark, or (b) an ultraviolet feature.

The responsible person must ensure that— (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures— (i) beer or cider: ½ pint; (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and (iii) still wine in a glass: 125 ml; (b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and (c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available."

(1) A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price. (2) In this condition:- (a) "permitted price" is the price found by applying the formula $P = D + (D \times V)$, where - (i) P is the permitted price, (ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol; (b) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979; (c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence- (i) the holder of the premises licence, (ii) the designated premises supervisor (if any) in respect of such a licence, or (iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence; (d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and (e) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994. (3) Where the permitted price would not be a whole number of pennies, the permitted price shall be taken to be the price rounded up to the nearest penny. (4) Where the permitted price on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax, the permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

The admission of children under the age of 18 to film exhibitions permitted under the terms of this licence shall be restricted in accordance with any recommendation made: (a) By the British Board of Film Classification (BBFC), where the film has been classified by that Board, or (b) By the Licensing Authority where no classification certificate has been granted by the BBFC, or, where the licensing authority has notified the licence holder that section 20(3)(b) (s74(3)(b) for clubs) of the Licensing Act 2003 applies to the film.

Each individual assigned to carrying out a security activity must be licensed by the Security Industry Agency.

Annex 2 – Conditions consistent with operating schedule

2a) General conditions consistent with the operating schedule

No adult entertainment or services, with the exception of two A.W.P. machines, to be provided at the premises.

The provision of regulated entertainment and late night refreshment to take place indoors only.

2b) Conditions consistent with, and to promote the prevention of crime and disorder

Any person exercising a security activity (as defined by paragraph 2(1)(a) of schedule 2 of the Private Security Industry Act 2001) shall be licensed by the Security Industry Authority.

Any person exercising a security activity as defined above will be employed at the premises at the discretion of the designated premises supervisor/holder of the premises licence.

Any person exercising a security activity as defined above will clearly display his name badge at all times whilst on duty.

No customers apparently carrying open bottles upon entry shall be admitted to the premises at any time the premises are open to the public.

Where C.C.T.V. is installed with recording facilities such recordings shall be retained for a period of 30 days and made available within a reasonable time upon request by the Police.

Alcoholic and other drinks may not be removed from the premises in open containers save for consumption in any external area provided for that purpose.

2c) Conditions consistent with, and to promote, public safety

The Licence Holder will comply with the reasonable requirements of the Fire Officer.

The Licence Holder will comply with the reasonable requirements of the Building Control Officer.

2d) Conditions consistent with, and to promote the prevention of public nuisance

Prominent, clear and legible notices shall be displayed at all exits requesting the public respect the needs of local residents and to leave the premises and area quietly.

Noise or vibration shall not emanate from the premises so as to cause a nuisance to nearby properties.

Persons under the age of 16 will be admitted only if accompanied by an adult and are not permitted to enter the premises after 22:00 hours.
