
<u>Crimes Committed in Shenley Green B29 4HH February 2016 – December 2016</u>



March 2016





April 2016



Anthony Kimber, Director of Property and development at Bournville Village Trust, 350 Bournville, Bournville, Birmingham B30 1QY confirm that:

Mr Kamalakannan (the new tenant), took over the lease of the shop by way of an assignment in December 2016. The tenant told me that he paid a total of approximately £130,000 for the business although I cannot confirm this.

Mr Kamalakannan said he is new to Bournville and was not aware of the background to the Estate.

The next contact we had with the tenant was when a local resident notified us of the notice that had been put up in the shop regarding the licensing application. Richard Hughes, my Estates Manager then went up to the premises to speak to the Tenant. Richard told me that on arriving at the premises he noted that the notice had been put on the door at a very low height (around level with his knees) and it was not particularly visible.

At no time prior to the application did the tenant contact the Trust as his landlord to consult or discuss the application. I also understand that no such consultation took place with any of the local residents or surrounding community.
