### 1 Executive Summary

- 1.1 To seek the determination of a statutory proposal by The Interim Executive Board (IEB) of Al-Furqan Primary School (the School) to
  - Change the category of the School from Voluntary Aided (VA) to Voluntary Controlled (VC).

### 2 Recommendations

2.1 That the Cabinet Member for Children, Young People and Families, having considered the statutory guidance, approves the statutory proposal to change the category of the School from Voluntary Aided (VA) to Voluntary Controlled (VC).

### 3 Background

- 3.1 Al-Furqan Primary School (the School) is a Voluntary Aided school situated on Reddings Lane, Birmingham, B11 3EY, which is within Hall Green North ward and the Hall Green constituency of Birmingham.
- 3.2 The School was rated 'Good' by Ofsted in June 2017.
- 3.3 The School currently offers 630 pupil places for pupils.
- In November 2012, Ofsted judged the School to be 'Inadequate'. In February 2013 Ofsted deemed the improvement plan put forward by the school to be "not fit for purpose". As a result of this the Council, with the consent of the Secretary of State for Education, appointed an Interim Executive Board (IEB). The IEB has been in place at the School since April 2013.
- 3.5 The following concerns were identified following the inspection by Ofsted in 2012:

  Leadership and Management, Quality of teaching and Achievement were all judged 'Inadequate'
  - Behavior and Safety of Pupils was judged as 'Requires Improvement'
- 3.6 Regular Ofsted monitoring inspections took place from November 2012 and two subsequent full inspections have been carried out: one in November 2014, when the School was judged as 'Requires Improvement' and the second in June 2017 when the School was judged to be 'Good'.
- 3.7 Since the IEB has been overseeing the strategic direction of the School it has improved in all the areas listed in 3.5 to become good, and has also made further improvements in the following areas:

Safeguarding practice

Financial management and control

3.8 At the time of the Inadequate judgement, the Head teacher was one of the trustees of the Al Furqan Education Trust (AFET), the School's foundation. Other AFET trustees also had significant involvement in the day to day management of the school and the use of the school premises. Since the IEB has been in place,

AFET representatives have visited the School on a half-termly basis to ensure that the school's religious ethos is being maintained, (see also FAQ p7). If the change of category were approved, the Council would support the School with the process of constituting a normally constituted VC Governing Board, which would replace the IEB. AFET would appoint two members of the Governing Board as foundation governors, whose role would include ensuring that the ethos of the School is maintained.

- 3.9 The funding for the change of category is described in section 9 of this report.
- 3.10 In compliance with the DfE guidance, a statutory notice and complete proposal were published on 9<sup>th</sup> June for the prescribed four-week consultation, referred to as the "representation period". The representation period commenced with the publication of a statutory notice in the Birmingham Post newspaper, a notice on the School's website, on the Council's Birmingham BeHeard consultation website and notices published on all the school entrances. In addition, there was notice to stakeholders and groups by letter and email (see also section 5 Consultation).
- 3.11 During the representation period, comments on the IEB's proposal could be submitted in writing to Education Infrastructure via the BeHeard website online-survey, by email or letter. A copy of the public notice can be found in **Appendix 1** of this report.

Responses received by the close of the representation period, on 21st July 2022, are summarised as follows:

A total of 95 responses were received - 21 in favour, 69 opposed, 5 neither/don't know.

The responses were from - 2 pupils, 58 parents, 2 governors, 13 staff members, 10 local residents and 10 others.

The outcome of the consultation is set out in **Appendix 3** to this report.

The main objections to the proposal were regarding:

- Concern that the school would lose its religious character / ethos (\* responded to in FAQ document);
- Opinion that there has been a lack of engagement / communication between parents and AFET – (this was raised by parents during the stakeholder meeting – Council officers explained that members of AFET had been invited to the meeting but had declined to attend);
- Suggestion that the IEB continue to explore options to remain VA (\* responded to in FAQ document);
- Concern about communication with stakeholders that have English as second language - (mitigated by drop in sessions – one set of parents came with a translator so they could ask questions)
- Concern that there should be parent membership on IEB / VC board (\*responded to in FAQ document);
- Concern that the ethos of the school should be reflected in the VC
   Instrument of Government (a draft loG was shared with all stakeholders

- during consultation to illustrate that a change of category from VA to VC would not change the school's ethos)
- Concern that the school will change its Religious Education curriculum or lose its IQA (Islamic, Quranic and Arabic) curriculum (\* responded to in FAQ document);

A frequently asked question document (Appendix 5) was developed and published following the pre-publication period (informal consultation) which addressed the common concerns, opinions and suggestions, including those marked with a \* above.

Officers are aware of a petition that was opened online from February 2022 in opposition to a then speculated change of category. This petition was not submitted by way of a formal representation during the consultation process and has never been formally submitted to the Council. The petition is opposed to the proposed change of category and has been signed by approximately 800 people.

- 3.12 The Education and Inspections Act 2006 and Regulation 7 of The School Organisation (Prescribed Alterations to Maintained Schools) (England) Regulations 2013 (the Prescribed Alterations Regulations) state the Council must have regard to any guidance issued by the Secretary of State when making a decision on such proposals. The relevant statutory guidance is: Making Significant Changes ('prescribed alterations') to Maintained Schools statutory guidance for proposers and decision-makers October 2018, published by the Department for Education. The Education and Inspections Act 2006, and Paragraph 5 of Schedule 3 to the Prescribed Alterations Regulations allows for the proposals to be:
  - approved;
  - approved with modification;
  - approved subject to meeting a prescribed condition; or
  - rejected.
- 3.13 If the proposal for Al-Furqan Primary School is approved, it is planned that the School category will change from voluntary aided (VA) to voluntary controlled (VC) on 1<sup>st</sup> January 2023.

### 4 Options considered and Recommended Proposal

- 4.1 It is recommended that the proposal to change the category of the School from voluntary aided (VA) to voluntary controlled (VC), from 1<sup>st</sup> January 2023, is approved.
- 4.2 Various options have been taken into consideration and examined by the IEB including:
  - 4.2.1 remaining VA;
  - 4.2.2 changing category to VC; and

- 4.2.3 conversion to an Academy.
- 4.3 Having evaluated the options, the IEB believes that a change of the category of the School to VC is the preferred option for the School as it continues its improvement journey.

During the period since the School achieved 'Good', there has been no evidence that a governing board with a majority of members appointed by the Al-Furqan Education Trust (AFET) would be able to replace the IEB or maintain and continue the improvement journey of the School.

4.4 If this proposal is rejected, the IEB and the LA will need to consider alternatives for the School. This would include the possibility of the conversion of AFPS to an Academy.

### 5 Consultation

5.1 The statutory proposal was consulted upon in line with the requirements set out in the relevant guidance from the Secretary of State (as noted in 3.11 of this report). The outcome of the consultation is set out in Appendix 3 to this report.

### 5.2 Internal:

Information on the proposal was shared with all Birmingham Ward Councillors (see appendix 4) with additional correspondence sent to councillors in the wards where most Al-Furqan pupils live, namely, Acocks Green, Billesley, Bordesley Green, Hall Green North, Hall Green South, Moseley, Small Heath, Sparkbrook and Balsall Heath, Sparkhill and Tyseley & Hay Mills wards. Officers from services across the Council which includes Admissions, Finance, School and Governor Support, Human Resources, Legal, Planning, Research and Statistics Officers and colleagues in Education Infrastructure were also consulted.

#### 5.3 External:

Information on the proposal was shared with: pupils, parents/carers of pupils, staff and members of the IEB of Al-Furqan Primary School, Birmingham Schools, AFET, The Association of Muslim Schools, Professional Associations and Trade Unions, Neighbouring Local Authorities, The local Member of Parliament and Ward Councillors, Local NHS partners, The Department for Education – School Organisation and the Office of The Schools Adjudicator and by public notice in a newspaper (as described in section 3.12 of this report).

### 6 Risk Management

- 6.1 As also described in section 4.4 of this report: if the proposal is rejected, the School will remain a Voluntary Aided school.
- 6.2 If this proposal is rejected the IEB would then have to consider all options again before proposing a solution for the continued improvement of the School. The options would include: to do nothing; conversion to an Academy; or to remain VA. However, it is important to note that the option of doing nothing is untenable as

the IEB cannot continue to remain in place (see Appendix 2 p2 for details). As described in 4.3, the IEB do not believe that remaining VA is in the best interest of the School as there is no evidence that a governing board with a majority of members appointed by the Al-Furqan Education Trust (AFET) would be able to replace the IEB or maintain and continue the improvement journey of the School.

### 7 Compliance Issues:

- 7.1 How are the recommended decisions consistent with the City Council's priorities, plans and strategies?
- 7.1.1 The proposal to change category of Al-Furqan Primary School from VA to VC would meet the following aims of the Council:
  - Give all children from every background and community the best start in life with a clear pathway to achieve success and realise their potential;
  - To fulfil landlord responsibilities to ensure that schools are Health and Safety compliant and fit for purpose;
  - To meet the aims set out in the Council's Education Services Delivery and Improvement Plan.

### 8 Legal Implications

- 8.1 This report relates to the powers in sections 18 and 19 of the Education and Inspections Act 2006 and Regulation 4(3) and paragraph 16(b) of Schedule 2 of The School Organisation (Prescribed Alterations to Maintained Schools) (England) Regulations 2013 (the "Prescribed Alterations Regulations"), whereby the governing body of a voluntary school can propose a change of category from VA to VC. Under section 21(2)(f) of the Education and Inspections Act 2006 and paragraph 3 of Schedule 3 of the Prescribed Alterations Regulations, the Council is the decision maker for this statutory proposal.
  - 8.2 The recommendations in this report facilitate the discharge of functions contained within section 13A of the Education Act 1996 whereby the Council has a duty to ensure that their education functions are exercised with a view to promoting high standards, ensuring fair access to educational opportunity and promoting the fulfilment by every child concerned of their educational potential.

### 9 Financial Implications

- 9.1 There are no direct costs related to a change of category (the school branding and uniform would remain the same).
- 9.2 The change in category would result in the School not being able to apply for the Condition Improvement Funding directly from Department of Education (DFE) for Capital works. If the proposal is approved, the Local Authority will receive

- additional Schools Condition Allocation funding to fund any Capital works required at the school.
- 9.3 There is no change to the Devolved Capital allocation. This will still be paid directly to the school by the Dfe.

### 10 Procurement Implications (if required)

10.1 Not Applicable

### 11 Human Resources Implications (if required)

- 11.1 If the proposal to change the category of the School from VA to VC is approved, Birmingham City Council will become the employer of the staff at the school, rather than the Governing Board/IEB. The transfer of undertakings (protection of employment) process (TUPE) will be undertaken.
- Any changes to existing terms and conditions resulting from the transfer would be in full consultation with the trade unions and teaching associations.

### 12 Public Sector Equality Duty

An updated Equality Assessment initial screening was carried out in October 2018 (EQUA221) against The School Organisation Change process, which identified that a full impact assessment was not required. No events have occurred since then which would require the preparation of a fresh screening in respect of The School organisation process. This proposal relates to citizens of school age and of Muslim faith; however, this proposal does not change the age range nor designated religious character of the School. The recommendations in this report are likely to advance equality of opportunity between persons who share a relevant protected characteristic and persons who do not share it and foster good relations between persons who share a relevant protected characteristic and persons who do not share it and it has been decided that a full equality analysis is not required.

Proposal of the Interim Executive Board of Al-Furqan Primary School Change of status from Voluntary Aided to Voluntary Controlled

Notice is given in accordance with Section 19(3) of the Education and Inspections Act 2006 that the Interim Executive Board of Al-Furqan Primary School intends to make a prescribed alteration to Al-Furqan Primary School, Reddings Lane, Birmingham B11 3EY from 1<sup>st</sup> April 2022.

It is proposed by the Interim Executive Board to change the status of the school from Voluntary Aided to Voluntary Controlled. The proposed alteration would not change the religious character of Al-Furqan Primary School – it would remain designated as a Muslim Faith School. The proposed changes would alter the composition of the Governing Body and would transfer some responsibilities for the employment of staff and maintenance of school premises from the Trustees and the Governing Body to the Local Authority. #### Introduction

Al-Furqan Primary School (AFPS) is an Islamic faith primary school in the Hall Green North ward of the Hall Green district of the City. The designated religious character of the school is Muslim. The school admits up to 90 pupils per year in reception.

### What changes are proposed?

The Interim Executive Board working in full collaboration with the Local Authority (LA) is proposing to carry out the following change to AFPS;

 Change the category of the school from Voluntary Aided (VA) to Voluntary Controlled (VC)

### Why do we want to do this?

In November 2012, Ofsted judged the school to be "inadequate". An Interim Executive Board (IEB) has been in place at the school since April 2013 in place of the former Governing Board.

(An IEB is a small board appointed for a temporary period, by a Local Authority with the consent of the Secretary of State for Education, to replace the Governing Board and to lead a school that is judged to be in urgent need of improvement.)

When the school was inspected by Ofsted in 2012 (report can be found <a href="here">here</a>) the inspectors identified the concerns listed below. The IEB has taken action and made significant improvements in all of the listed areas.

- Leadership and Management was judged as Inadequate. The inspection report said:
  - "The school's leaders, including governors, have low expectations of what pupils should be achieving and do not have a good enough understanding of how pupils are progressing. They are unaware of weaknesses in teaching, so they are not improving its quality or managing teachers' performance adequately.
  - Lines of communication with many parents and carers have broken down, leading to high levels of dissatisfaction."
- Quality of teaching and Achievement of pupils were both judged Inadequate. The inspection report said:
  - "Much of the teaching in Years 1 to 6 is inadequate, which leads to widespread underachievement.
  - Teachers do not expect enough of pupils or give them work that is matched to their abilities.
  - Teachers set homework only sporadically and do not mark books well enough, which does not help pupils know how to improve their work.

- Groups of pupils are taught for long periods by teaching assistants and they do not make enough progress.
- In some lessons, insufficient resources, especially books, slow pupils' progress."
- Behaviour and Safety of Pupils was judged as Requires Improvement. The inspection report said:
  - "Some older pupils misbehave when teaching is weak."

In addition, improvements have been made by the IEB in the following areas:

- Safeguarding practice
- Financial management and control

Regular monitoring inspections have been carried out by OFSTED since November 2012, when the school received their judgment of "inadequate". Two subsequent full inspections have been carried out, one in November 2014, when the school was judged to "require improvement", and the second in June 2017, when the school was judged to be "good".

The IEB has been overseeing the strategic direction of the school. Various options have been examined including remaining VA, changing category to VC, and conversion to an Academy.

The IEB believes that a change of the category of the school to VC is the preferred option for AFPS as they continue their improvement journey. During the period since the school achieved 'Good', there has been no evidence that a governing board with a majority of members appointed by the Al-Furqan Education Trust (AFET) would be able to replace the IEB or maintain and continue the improvement journey of the school. The council and a new VC governing board would continue to work closely with AFET, and AFET would appoint two members of the governing board as foundation governors, whose role would include ensuring that the ethos of the school is maintained. The expectations regarding this are also set out in the draft proposed Instrument of Government which is also provided as part of the consultation.

The view of the IEB and Al-Furqan Education Trust at present is that a voluntary aided shadow governing board is not the right option for the school at this time. This may be reconsidered following the outcome of the next stage of consultation. [For more details about this, please the FAQ document.]

### When will these changes happen?

If the proposal is approved by the decision makers (following full consultation) it is intended that the proposal to change the category of Al-Furqan from Voluntary Aided to Voluntary Controlled will come into effect from 1st January 2023.

How will the proposal improve educational standards and increase parental choice? If the proposals are approved, a new Governing Board will be formed upon implementation of the change of category of the school to VC. A new VC Governing Board would build on the improvements made by the IEB and will provide stability for the school going forward.

### Will there be any effect on other schools, academies and educational institutions within the area?

There will be no effect on other schools, academies and educational institutions in the area. It is a change to the category of the school only. The admission number is not increasing, and the faith character of the school will remain unchanged.

### What are the project costs for this proposal and how is it funded?

The only project costs for the proposed change to voluntary controlled category is the cost of the public notice in the Birmingham Post. The notice is posted in the public notice section of the paper on the first day of the statutory consultation. This is a statutory requirement under the school organisation process.

#### How will this affect staff?

If the proposal to change the category of the school from VA to VC is approved, Birmingham City Council will become the employer of all the staff. The transfer of undertakings (protection of employment) process (TUPE) will be undertaken.

Any changes to existing terms and conditions resulting from the transfer would be in full consultation with the trade unions and teaching associations.

### How will this affect pupils at the school?

The pupils should not notice any changes, should the proposal to change to VC be approved. The implementation of the permanent VC Governing Board would further help the school to build on the improvements that the IEB have implemented over the past 8 years.

### Will there be any change to the admissions arrangements?

Yes, Birmingham City Council (as the Local Authority) will manage and coordinate the admissions at the school.

Birmingham City Council admission arrangements for Voluntary Controlled schools will apply.

### Proposed Oversubscription Criteria for Al-Furqan Primary School as a Voluntary Controlled School.

If the proposal to change the category of AFPS to VC is approved, where applications for admissions exceed the number of places available, the following criteria (in descending order) will be applied;

Any child with an Education, Health and Care Plan is required to be admitted to the school that is named in the plan. This gives such children overall priority for admission to the named school. This is not an oversubscription criterion.

- 1. Children who are in the care of the Local Authority (looked after children) or were previously looked after or provided with accommodation by them (e.g. children with foster parents) (Section 22 of the Children Act 1989) and including previously looked after children from outside England.
- Children with siblings (who will still be attending Al-Furqan on the date the child who
  is applying is admitted) at Al-Furqan. The Local Authority 'Sibling' definition has
  been adopted.
- 3. For all other children of Islamic faith, priority will be given to those children whose parent/guardian is a practising Muslim. This will be confirmed by the parent/carer filling in the Local Authority supplementary information form and relevant sections completed by the Imam of their local Mosque.
- 4. Children who live closest to the school.

**NB** (i): If there is oversubscription within a category priority will be given to those children living closest to the school. The local authority's 'distance' definition has been adopted. Distances are calculated on the basis of a straight-line measurement between the applicant's home address and the main school gate on Formans Road. The Local Authority uses a computerised system, which measures all distances in metres. Ordnance Survey supplies the co-ordinates that are used to plot an applicant's home address and the address of the school.

### NB(ii)

- Looked after children of all faiths are given priority in the case of over subscription policy.
- Birmingham City Council (as the admissions authority) does not include criteria regarding children of staff as this would bring a level of inequity into the system and would potentially deprive a local child of a place, giving it instead to the child of a member of staff.

It is important to note that staff members' children who are already on roll at the school would not be affected, and their sibling priority would also remain in place for any siblings seeking

places at the school (with a sibling still in attendance at the school when admission is sought).

### Will there be a change to the Religious Education (RE) at the school?

No, if the proposal to change the category of the school to VC is approved, the school will continue to teach the agreed Birmingham LA syllabus for RE.

### Will there be a change to the curriculum of the school?

No, the school will continue to teach the National Curriculum. In addition, the school teaches Islamic, Quranic and Arabic studies (IQA). Arabic is the Modern Foreign Language that is taught at the school. This is in addition to the National Curriculum and the current governing board are clear that this enhances the school.

### What changes will be made to the Governing Board at the School

Prior to the IEB being established at the school, AFPS had a VA Governing Board. The majority of the members on a VA school's Governing Board were appointed by the Al Furqan Education Trust (AFET)

If the proposal to change the category of the school to VC is approved, the Governing Board will be made up as follows:

- at least two parent governors, elected by the parents
- the Headteacher, unless the Headteacher chooses not to be a governor
- one staff governor, elected by the staff
- one local authority governor, nominated by the local authority and appointed by the board
- at least two (but no more than one quarter of the total) foundation governors, appointed by the AFET.

The board can also appoint as many co-opted governors as they consider necessary. In relation to co-opted governors, there are restrictions on the proportion of governors who, in broad terms, are also staff at the school. When counted together, the Headteacher, staff governor and any co-opted governors who are also members of staff must not exceed a third of the total membership of the governing board.

### Will this definitely happen?

There is government guidance and a statutory process the IEB must follow to make this type of change to a school. The IEB is consulting in two parts, as follows:

### Part 1: Informal Consultation ('pre-publication' period): Completed.

Part 1 was completed between Tuesday 25<sup>th</sup> January and Monday 14<sup>th</sup> February 2022. All comments received during the pre-publication period have been considered by the IEB when deciding to continue to part 2.

(Please note: Comments received during part 1 were for the IEB to consider in collaboration with the Local Authority; and are not intended for the final decision maker\*.)

A FAQ document was produced for stakeholders as a result of the comments received during part 1. This is available from the school and the BeHeard consultation webpage (see section: How do I make my views known).

### Part 2: Formal Consultation ('representation period'): Current.

The current part is the representation period, a formal consultation (statutory: required by law). A public notice and this proposal document have been published Thursday 16th June 2022 and allows four weeks for anyone to comment in writing (see the section below: "How can I make my views known"?).

Representation period is from **Thursday 23<sup>rd</sup> June 2022** until **Thursday 21<sup>st</sup> July 2022** (\*Please note: Only comments received during part 2 will be forwarded to the decision maker for their consideration.)

### **Decision process:**

Following the end of part 2, the formal consultation ('representation period'), a report must be produced and passed to the decision maker to consider. The decision maker for this IEB proposal is the Local Authority (the Cabinet Member for Education, Skills and Culture.) Should the decision maker not reach a decision within two months of the end of the representation period, i.e. by **21st September 2022**, the proposal must be passed to the Office of the Schools Adjudicator for a final decision, for which there will be no right of appeal by the IEB or the LA.

It is only after the final decision that we would be able to say with certainty whether the school will change the category to VC with effect from 1st January 2023.

### What will happen if this proposal is rejected?

If this proposal is rejected the IEB and LA will need to consider alternatives for the school. This would include the possibility of the conversion of AFPS to an Academy.

### How can I make my views known during part 2: representation period?

Comments are welcome from anyone interested in this proposal.

Comments must be received within the four-week period:

from Thursday 23<sup>rd</sup> June 2022 until Thursday 21<sup>st</sup> July 2022.

# Al-Furqan Primary School: Proposal to change from voluntary aided to voluntary controlled

# Frequently Asked Questions (last updated Monday 20th June 2022)

The Interim Executive Board (IEB) is proposing to change the category of Al-Furqan Primary School from voluntary aided (VA) to voluntary controlled (VC) in January 2023.

This document sets out answers to the frequently asked questions that have been raised during the consultation process, grouped into the main themes.

This document will be regularly updated throughout the consultation process.

The purpose of this document is to respond to questions and comments raised during the first (informal) stage of the consultation process.

### The proposal

### Why is changing the school to voluntary controlled being proposed?

The Interim Executive Board (IEB) has been overseeing the strategic direction of the school since 2013. Various options for the school have been considered, including remaining voluntary aided, changing category to voluntary controlled, and conversion to an academy. The IEB believes that a change of the category of the school to voluntary controlled is the best way to ensure that the school continues to improve.

### Why can't the school continue with the IEB?

Interim Executive Boards (IEBs) are not intended to be a long-term solution for a school.

An IEB is a small board appointed on a short-term basis to turn around a school that is judged to be in urgent need of rapid improvement. An IEB replaces the governing board of the school and its main function is to provide interim expertise and high-quality governance. This must support future improvement in the school, including the promotion of high standards of educational achievement.

The IEB at Al Furqan replaced the governing board in 2013, after the school was judged to be inadequate under the VA Governing Board structure in place in 2012. The IEB has been in place ever since.

# Why can't the school remain voluntary aided as it is now a 'Good' school (Ofsted 2017)?

The IEB and the council have improved on the various matters that were previously inadequate under the direction of the VA governing board. During the period since the school achieved 'Good', there has been no evidence that a governing board with a majority of members appointed by the Al-Furqan Education Trust (AFET) would be able to replace the IEB or maintain and continue the improvement journey of the school. The council and a new VC governing board would continue to work closely with AFET, and AFET would appoint two members of the governing board as foundation governors, whose role would be to ensure that the ethos of the school is maintained in accordance with the trust deed.

# If the school became voluntary controlled, what would change and what would stay the same?

Religious character – Muslim	Stay the same. The designated religious character of the school is mandated in an order signed by the secretary of state and cannot be changed by the school or the council.
Curriculum, RE and IQA	Stay the same.
Collective worship	Stay the same.
Staff	Change. Staff will be employed by the council (staff will still be appointed by the governing board). Please also see section below on: How would the school ensure that teachers recruited in the future uphold the faith of the school?
Governance	Change. VC governing board members: <ul> <li>1 Local Authority governor,</li> <li>2 parents,</li> <li>The Head Teacher,</li> <li>1 staff member,</li> <li>2 Foundation governors appointed by AFET,</li> <li>Co-opted governors (number to be decided by the governing board)</li> </ul>
Finance	Change. Funding for building and land maintenance would come from the council, rather than from the DfE. All other funding (e.g. pupil funding) would stay the same.
Land	Stay the same. The VC governing board would continue to have control of the land in the same way as the IEB. (AFET will continue to hold the land on trust for the school).

### When will it happen?

If the IEB decides to proceed to the formal part of the consultation, the documentation will set out timescales for this in line with the prescribed school organisation rules and any further consultation with staff regarding their transfer from Trust to council employment.

### Will the council make all the decisions for the school going forwards?

No, the VC governing board would make decisions. The governing board will direct the school according to the formal document, "the Instrument of Government" and their statutory duties.

## If the school became voluntary controlled, could the council just change things?

No. The governing board would be able to direct and make certain changes. For other changes, the governing board and the council would have to follow specific processes, policies or laws (e.g. this School Organisation process for proposing changes like VA to VC).

## How many responses would mean that the proposal would be approved / rejected?

The responses are not counted like a vote - there is no number or percentage of responses that would automatically mean the proposal is rejected or approved. The responses are for consideration by the proposer (i.e. the IEB) and the decision maker (Birmingham City Council).

### What would happen if the proposal is rejected?

The IEB would then have to consider all options again before proposing a solution for the continued improvement of the school. The options would include: to make no change; academisation; or remaining VA. However, it is important to note that the option of making no change is untenable as the IEB cannot continue to remain in place (see p2 for details). The IEB are also clear that they do not believe that remaining VA is in the best interest of the school (see p2 for details).

### Religious character

#### Will the Muslim status of the school change?

No, Al-Furqan would keep its Muslim status as a VC school (the "designated religious character"). This is mandated in an order signed by the secretary of state and cannot be changed by the school or the council.

### Will there be a change to Religious Education (RE) at the school?

No, the school would continue to teach the same curriculum that it does now - this is the Birmingham Agreed Syllabus for Religious Education. This syllabus is agreed by representatives from all major faith groups, including Muslim representatives.

#### Would the school continue to teach IQA?

Yes, the school would continue to teach Islamic, Quranic and Arabic studies (IQA) along with the National Curriculum. As part of the IQA, Arabic would continue to be the modern foreign language taught at the school.

The IEB's proposal is made on the basis that the teaching of the IQA and the Arabic language would continue, as these are important and enhancing elements of the school. The ethos of the school will be set out in the proposed Instrument of Government.

### How would the school ensure that teachers recruited in the future uphold the faith of the school?

The Equality Act 2010 prohibits religious discrimination in employment. However, there are some limited exceptions for VA and VC schools which have a religious designation – **Sections 58-60 SSFA 1998**.

VA schools may give preference for appointment, remuneration or promotion to teachers who hold religious opinions, attend religious worship, or are willing to give religious education in accordance with the tenets of the school's religion. In terminating teachers' employment, VA schools may also have regard to any conduct incompatible with the tenets of the school's religion. However, VA schools must not disqualify anyone from being employed at the school as non-teaching staff because of their religious opinions or whether they attend religious worship.

In VC schools, the staff must include "reserved teachers" who are specifically appointed to give religious education and selected for their fitness and competence to give religious education in accordance with the trust deed or the tenets of the school's religion. The foundation governors must be consulted on these appointments. The same exceptions to the Equality Act 2010 apply to reserved teachers at VC schools as to teachers at VA schools. In the appointment of head teachers at VC schools, regard may be had to that person's ability and fitness to preserve and develop the religious character of the school, and this applies regardless of whether the head teacher will be a "reserved teacher". Apart from these exceptions, no member of staff at a VC school may be discriminated against on the grounds of their religious opinions or whether they attend religious worship.

### **Staff**

#### How will this affect staff?

The council would follow a special legal process to become the employer of all the staff: the Transfer of Undertakings (Protection of Employment) process (TUPE). Any changes to existing terms and conditions resulting from the transfer will be in full consultation with the trade unions and teaching associations.

#### Would staff still be able to go on Hajj?

An application by a member of staff employed or engaged at the school for leave of absence (unpaid) to perform Hajj for a period of ten days between the 2<sup>nd</sup> of Dhul Hajj and 11<sup>th</sup> of Dhul Hajj would be supported, subject to the need to ensure the safeguarding of pupils, the maintenance of educational standards and performance, and the proper and effective use of the school's financial resources.

### **Admissions**

### Would the admission arrangements for the school change?

Yes, the council would manage and coordinate the admission arrangements. This would mean some changes to the admissions and "oversubscription criteria". Please see the proposal document for the full details of the changes that would happen.

### How would the admission arrangements affect children of staff who already attend the school?

Staff members' children who are already on roll at the school would not be affected. The "sibling priority" would also stay the same for any of their siblings applying for a place at the school (provided that a sibling would still be in attendance on the date the other sibling is admitted).

### Governance

What issues did the IEB identify at the school when they took over governance? Can the IEB please be transparent about all the issues they picked up at the school when they took over the governance?

In 2012 a VA governing board with a majority of members appointed by AFET was leading the school, and the head teacher was a member of AFET.

When the school was inspected by Ofsted in 2012 (report can be found <a href="here">here</a>) the inspectors identified the concerns listed below. The IEB has taken action and made significant improvements in all of the listed areas.

- Leadership and Management was judged as Inadequate. The inspection report said:
  - "The school's leaders, including governors, have low expectations of what pupils should be achieving and do not have a good enough understanding of how pupils are progressing. They are unaware of weaknesses in teaching, so they are not improving its quality or managing teachers' performance adequately.
  - Lines of communication with many parents and carers have broken down, leading to high levels of dissatisfaction."
- Quality of teaching and Achievement of pupils were both judged Inadequate. The inspection report said:
  - "Much of the teaching in Years 1 to 6 is inadequate, which leads to widespread underachievement.
  - Teachers do not expect enough of pupils or give them work that is matched to their abilities.
  - Teachers set homework only sporadically and do not mark books well enough, which does not help pupils know how to improve their work.
  - Groups of pupils are taught for long periods by teaching assistants and they do not make enough progress.

- In some lessons, insufficient resources, especially books, slow pupils' progress."
- Behaviour and Safety of Pupils was judged as Requires Improvement.
   The inspection report said:
  - "Some older pupils misbehave when teaching is weak."

In addition, improvements have been made by the IEB in the following areas:

- Safeguarding practice
- Financial management and control

## What has the Trust had to do with the school since the IEB was in place? What have they been doing since 2012?

Representatives of the Trust have visited the school to review the teaching of the IQA on a half-termly basis.

The Trust entered into Transfer of Control agreements with the IEB to regulate the shared use of the publicly funded Primary School site until the Trust's private Girls' School, Boys' School and Nursery vacated the site.

The Trust entered into a Transfer of Control agreement with the IEB for community use of the primary school's prayer hall outside school hours, and set up a mosque management committee to liaise with the IEB about this

The Trust and IEB have worked together to enable the Trust to apply for public funding for capital projects/building works on the school site.

### How much input would the Trust have if the school becomes voluntary controlled?

AFET would appoint two foundation governors to sit on the new VC Governing Board.

### Who would be on the new governing board?

- 1 Local Authority governor
- 2 parents
- The Head Teacher
- 1 staff member
- 2 Foundation governors appointed by AFET
- As many co-opted governors as the new Governing Board agrees is necessary to effectively govern the school

#### When would the new governing board be ready?

A new board would be in place ready to take over governance of the school as soon as it converted to become VC.

## What will the new Instrument of Government (IOG) look like? Can you share it with the parents in advance?

The proposed draft IOG is attached to this document.

### What is a "shadow governing board" and has this option been explored; why isn't there one?

In 2010 the DfE issued regulations that confirmed that local authorities can determine in each individual case whether it is appropriate to put in place a shadow governing board, or move straight to establishing a normally-constituted governing board.

A shadow governing board would be appointed by the council to work alongside the IEB for a minimum period of 6 months. The 2010 Regulations specify that the shadow governing board must exercise any functions which have been delegated to them by the IEB.

Once the IEB ceases to operate, the shadow governing board acts alone as the governing board of the school for a minimum period of 6 months, but no longer than 13 months. At the agreed time, the shadow governing board is then replaced by the normally-constituted governing board.

The members of a shadow governing board include the Headteacher, an LA governor, a Staff governor, at least 2 Parent governors, and Foundation governors. The number of Foundation governors will vary depending on the type of school. All shadow governors are appointed by the council but the council must first consult the body entitled to appoint foundation governors. Additional co-opted governors can be appointed, as necessary. All appointed shadow governors are required by the 2010 Regulations "to have the skills required to contribute to the effective governance and success of the school".

The IEB of Al-Furqan Primary School is proposing to change the school's status from voluntary aided to voluntary controlled.

The view of the IEB and Al-Furqan Education Trust at present is that a voluntary aided shadow governing board is not the right option for the school at this time.

This may be reconsidered following the outcome of the next stage of consultation.

### Land and buildings

What will happen to the school site and buildings if the school changes from voluntary aided to voluntary controlled?

The Trust would continue to hold the land on trust for the purposes of the primary school but the new VC governing board will have control of the land and buildings.

### How to contribute

### How can parents submit comments; and how will parents be kept informed?

Parents will have another opportunity to submit comments during part 2 of the consultation process if the IEB decides to proceed to the next (formal) stage of the consultation. The IEB will write to parents with all the details needed at that time.

Details of a consultation webpage will also be shared, which will include updates and progress at certain points of the process.
